# LP Scores at Town Hall Meeting

We all know that when placed on an equal footing with the two major parties, the Libertarian Party can not only hold its own,

but it can best its rivals. Such was the case on March 16th, when Colorado LP Chairman David Aitken joined five other political leaders at a "Town Hall Meeting" sponsored by KNUS radio. Talk show host Bob Heckler was moderator for the three

hour event, broadcast live from the Westin Tabor Hotel in Denver.

Judging from the applause for Aitken, the audience was highly appreciative of the Libertarian perspective. Aitken consistently scored points by espousing individual liberty, personal responsibility, the right to bear arms, privatization of schools, and other Libertarian ideals.

Colorado Taxpayers Party Chairman Doug Campbell also was very well received, but representatives of the Democratic, Republican, and Communist Parties were clearly on the defensive throughout the evening. The United We Stand America delegate fared respectably well.

Representatives Drew Clark, Boulder County Republican and concealed carry reform sponsor, and Penn Pfiffner, Lakewood Republican and former LP State Chair, will address the

Libertarian Party's second annual Right to Bear Arms Rally.

Featured speaker David Kopel will be presented with the LP's 1993 Friend of Liberty Award. Kopel, attorney, Director of the Independence Institute's 2nd Amendment Project, and author of the acclaimed book, *The Samurai*, the Mountie, and the Cowboy, is one of the country's most knowledgeable and eloquent experts on 2nd Amendment issues.

KHNC talk show host Norm Resnick and Firearms Coalition head Bill Pittman are among the other confirmed speakers. The rally takes place at the State Capitol on Sunday, April 17, from 1 p.m. until 3:30 p.m.

In fact, the audience reacted so favorably to the positions of the Libertarian and Taxpayers Parties that one dissenter claimed the audience was stacked, which host Bob Heckler immediately refuted. (The free event was open to the general public and had been well publicized on KNUS for several weeks.)

#### From the Editor

If you're heartened by the current "get tough with criminals" vogue and like the idea of "three strikes and you're out," I urge you to pick up the March issue of *The American Spectator*, R. Emmett Tyrell, Jr.'s irreverent journal of conservative opinion.

TAS's New York correspondent, William Tucker offers some sobering thoughts on this fashionable idea in an article entitled "Three Strikes and You're Dead." He argues convincingly that it is important to have a sentencing differential between crimes of different severity, and critically important that there be such a differential for murder. Tucker makes his argument as part of his advocacy of the death penalty, but it holds water regardless of how you feel about that matter.

If a criminal faces life imprisonment for rape or armed robbery, and faces the same life sentence for murder, he has everything to gain and nothing to lose by killing his victims. "Three strikes and you're out" is likely to cause a significant rise in the homicide rate, not exactly the result its advocates intended.

"Be careful what you wish for," someone once said. "You might get it."

The only practical solution to this dilemma, to my mind, is to have a significant number of armed, peaceful citizens on the streets, prepared to administer the death penalty at the point where there can be no doubt that it is being applied to the right person and for good reason.

#### **Affiliate News**

#### — Aurora —

Libertarians in Aurora are planning to appeal their suit alleging Aurora's violation of Amendment 1, since the court ruled in favor of the city recently. (See story on page 4.)

The Aurora affiliate will be putting its efforts into expanding its membership by getting a good meeting place, scheduling speakers that will attract visitors, and encouraging members to bring friends along to the meetings.

#### ----- Boulder -----

Science fiction author L. Neil Smith addressed the BCLP last month on gun control and the media. Smith criticized the media for playing up images of violent crime in order to drum up public support for gun control, and claimed that there is an unhealthy relationship between the media and politicians.

Nederland Libertarian Judd Ptak has been opposing the county's plan to encourage recycling by subsidizing trash pickup. He has also been suggesting changes to new county zoning regulations to mitigate some of their most restrictive provisions. Ptak is considering running for State Senate district 13 this fall.

#### —— Denver ——

The March meeting of Denver Libertarians featured John Voss, Director of the National Commodity and Barter Association. Voss kept the audience spellbound as he chronicled the long history of IRS abuses and harassment against NCBA. Voss and several co-defendants are scheduled to go on trial later this year for the crime of accepting checks from people and turning them into Federal Reserve Notes.

The crowd stayed well beyond the usual ending time for Denver meetings, asking Voss many questions about the Federal Reserve System, the IRS, and NCBA's past legal triumphs over the latter. The Fully Informed Jury Association, of which Voss and his wife, Sharon, are supporters, also came up for discussion. Chairman Richard Combs suggested that, once a firm trial date is known, it might be possible to arrange for some FIJA activists to pamphleteer the courthouse on the appropriate days.

Other business covered at the meeting included the April 17 Right to Bear Arms Rally. David Segal emphasized the critical importance of turning out a large crowd for that event. First, the 2nd Amendment is in increasing danger throughout the country. Second, the rally is a significant opportunity for the LP to reach out to people who may be sympathetic to our ideas. Third, the rally can, if successful, further enhance the party's credibility among other groups as an effective organization and a useful ally.

#### ----- Jefferson County -----

The Jeffco group is still publishing its monthly newsletter, distributing FIJA flyers every Monday in front of the courthouse, and operating its "Jefferson Forum" speakers

series. In March, David Kopel spoke on the topic of asset seizures

#### Southern Colorado Libertarian Party —

The newly organized Southern Colorado Libertarian Party, a coalition of Fremont and El Paso county libertarians, is actively pursuing several petition drives:

Doug Bruce is heading a petition drive to stop city funding for a convention center/arena in Colorado Springs, and to sell off other city-owned assets. Other local libertarians are working on a petition to impeach President Clinton, a petition to recall an El Paso County Commissioner, and a petition demanding that the Colorado congressional delegation substantiate the constitutionality of a nationalized health care plan.

The group is working on two political campaigns, cooperating with Doug Bruce in raising money for the Election Reform Amendment campaign, and fighting a proposed zoning ordinance in eastern El Paso County.

Finally, efforts to build a stronger local organization include a series of informal education sessions, and a planned outreach booth at the Black Forest Festival in June.

# Aurora Wins Round One of Vote Battle

Arapahoe Country District Court Judge Thomas Levi ruled in favor of the City of Aurora in a suit filed over alleged violations of the Taxpayer's Bill of Rights (TABOR) during the November 2nd municipal election.

In an 11-page opinion, Judge Levi dismissed the suit and ruled that Aurora fully complied with TABOR. Citing conflicts with other provisions of the Colorado Constitution and existing case law, Levi ruled that several of the plaintiff's interpretations of TABOR and resulting claims were "...unjust and unreasonable" and "must be avoided."

The suit, filed on November 1st, claimed the election was invalid because of failure to comply with several key election requirements of TABOR (Article X, Section 20 of the Colorado Constitution.)

Deficiencies charged in the suit include: improper consolidation of tax increase and debt questions; failure to include statements of opposition to the Ballot Questions in the official election notice; failure to specify future amounts of tax and rate increases; and other substantive and technical violations. The suit sought repudiation of the two Ballot Questions approved by voters.

The plaintiffs will appeal the ruling to the Court of Appeals, or possibly directly to the Colorado Supreme Court if deemed advisable. The Supreme Court recently agreed to hear an appeal of a similar suit brought against the Boulder Valley School District.

Despite the pending suit, Aurora proceeded with the .25% increase in the city sales tax effective January 1st, but has held off actually spending the funds until now. Voters had approved the tax increase specifically to fund the hiring of additional police officers.

Aurora is waiting for appeals to be exhausted before it issues the \$5 million in bonds approved by voters for completing the construction of the city's jail. The pending lawsuit would have to be disclosed in the bond prospectus, adding a significant cloud of concern to potential investors.

## **Nederland Libertarian Defies INS**

Trygve Bauge came to the United States from Norway in 1980. He is a long-time Nederland resident whose accomplishments include the following:

- ⇒ Founder of the Polar Bear Club and world record ice bather (1hr. and 4 min. in 32° water).
- ⇒ Designer of affordable fire- and earthquake-proof housing.
- ⇒ Developer of a life extension center / retreat and cryonic storage facility.
- ⇒ Author of numerous publications on libertarian issues, life extension, and holistic health practices.
- ⇒ Founder of the Alien Anti-Defamation League and Universal Liberty, a "privately owned international political organization" promoting free trade and travel, along with other libertarian principles.

As of the end of February, he is also a self-described "fugitive from injustice," sought by the Immigration and Naturalization Service for immediate deportation.

Bauge's visa expired in 1987, and he has been battling the INS ever since. In January, the INS ordered him to appear at their office on February 25th, with no more than 44 pounds of luggage, for "voluntary deportation."

Bauge thumbed his nose at the INS, notifying them that he was defying the order and could be found at his mother's residence. When no one had come for him by the beginning of March, he announced he was mailing the INS a map to the place, explaining that "I believe in facing all dangers head on and in the open."

Bauge has appealed to the U.S. Supreme Court for a stay of the deportation order. He has also written the President and various other public officials, and has requested the help of the media, fellow libertarians, and other sympathetic, fairminded individuals. *Colorado Daily* columnist Paul Danish penned a strong defense of Bauge that appeared on March 2.

## IRS Victim Carol Ward on "Geraldo"

Colorado Springs Libertarian Carol Ward will appear on the April 15 "Geraldo" show, sharing with a nationwide audience her story of IRS terrorism and Stalinist bureaucracy run amok. The agency attempted to destroy her family because she made the mistake of provoking an IRS agent.

Ward came to the attention of the CLP, and vice versa, during last year's state convention in Crestone. Her world had just been shattered. With no warning-no correspondence, no request for documents, no examination—agents flashing guns and badges burst into her son's three retail shops and seized them. They also seized the family's bank accounts and put a tax lien on her mother's home. She was, to put it mildly, distraught. She was looking for someone who would listen to her and help end this nightmare.

Someone told Ward she should go to Crestone and tell the Libertarians her story, and she did, concretizing the usual libertarian abstractions about government evils with a moving tale of human tragedy. When "Bumper" Hornberger, in his typically stirring speech, insisted that some of our opponents are not just misguided, but evil, Ward cried out in witness of the truth he spoke: "They are evil! They're not even human! I've looked in their eyes, and they're like shark eyes!" It was quite a moment.

Ward and her son, Tristan, were the victims of a "jeopardy assessment," the most dreaded and rarely used IRS enforcement procedure. This method of collection suspends all the victim's constitutional rights on the grounds that the assets in question may be spirited away before the government can claim them. It is never used against retailers because they can't hide! Besides, shutting down a store ensures that there will be no further revenue from which to collect.

How had this unusual and senseless situation come about? Ward had accompanied her son to an IRS examination of his records, and became upset by the revenue agent's behavior. She accused the agent of unethical behavior, and threatened to report her to her superiors. The agent decided to get even.

The offended agent fabricated a drug dealer profile of Ward, and thus got permission for a jeopardy assessment of \$324,000. For the next several months, the agency fought to cover its institutional backside, knowing full well that Carol and Tristan Ward were the victims of an act of pure vengeance.

Ward fought hard, contacting various elected officials and appearing on talk shows around the country. Sen. Hank Brown's office helped, asking for a full investigation. Chief of staff Bill Brack told her, "The BCCI group was treated better than you."

The levy was finally determined to be wrongful. The IRS declared that Ward owed not \$324,000, but \$4000. With penalties and interest, it came to \$8400. Adding insult to injury, they tacked on the cost of the seizure! That made the total \$12,000, and Ward's lawyer advised her not to fight it.

At first, however, the agency would not accept payment or release the levies until she and Tristan signed a waiver agreeing not to sue the agency or its employees. They refused, and under growing pressure, the IRS finally caved in. It was a rare instance of strong and brave people prevailing against a tyrannical agency that usually destroys all opposition.

Earlier this year, having finally gotten her life back together, Carol Ward paid state and national LP membership dues for herself and her son, and pledged that she would be an active Libertarian for the rest of her life.

Carol Ward's talk show appearances continue. She always urges others to contact her, and has heard many other horror stories as a result. She is an articulate and passionate witness to the horror of a terrorist agency in an increasingly authoritarian government. "This isn't about money," she argues. "It's about power and its misuse. Our country is at war with itself. The parasite is destroying the host."

She will be sharing thoughts like that, you can be sure, with the millions who watch "Geraldo" on April 15.

ERIC KLIEN. Eric Klien moved to Las Vegas on December 31, 1991, and quickly became involved in local politics. He backed Tamara Clark for state Senate in 1992 and, after her election, found evidence that there had been massive election fraud committed against Tamara. After considering the alternatives, he decided to go after the most practical solution — building a new country.

DAVID KOPEL. Dave Kopel is Research Director at the Independence Institute. His book on international gun control, The Samurai, The Mountie, and The Cowboy, was chosen as international criminology book of the year by the American Society of Criminology. He has testified before the United Sates Congress and the Colorado legislature as an expert on guns and crime control.



L. NEIL SMITH. L. Neil Smith is the author of 18 science fiction novels, written with roughly the same intent that motivated George Orwell's 1984 and Aldous Huxley's Brave New World. The difference is that his work is upbeat, often funny, and deals with times and places where people enjoy more freedom and prosperity than we do here and now. A local radio personality, popular convention speaker, NRA "Hunter's Pistol" competitor, and 33 year veteran of the libertarian movement, Neil lives with his wife Cathy and daughter Rylla in Fort Collins, where they can be reached via LEVER ACTION BBS, the cybernetic voice of the Libertarian Second Amendment Caucus.

# A Proposal for Party Growth

by Jeff Orrok

I've devised a plan to give the LP a shot at becoming a major political power. Basically, it is an intentional, directed, long-term strategy for growth. It draws on my past experiences with an evangelistic Christian fellowship and with multi-level marketing ventures. I call this plan The Lifeblood Project.

If you grant me a few assumptions, I will show you how, with The Lifeblood Project, we could become a "major political party" in Colorado by the year 2000. In addition, we'd be cranking out ballot initiatives and running candidates for dozens of local and state offices—hey! maybe even national.

This article provides an overview. I intend to present the plan in more detail at the state convention, and I welcome any and all feedback there or by mail. Write to: The Lifeblood Project, 13674 Parkview Dr., Aurora, CO 80011. Or call 303-393-6855.

#### **Definitions of Terms:**

Activist — For the purpose of this article, "Activist" means one who contracts to fulfill the goals of the Lifeblood Project. More on this later.

Star — One who leads a fundamental change along libertarian ideals. I am aware of only one or two stars—Doug Bruce, who has made one alteration and is preparing to wage the campaign for another, and Penn Pfiffner, who has several attempts to his credit (I am unaware of any successes, although I don't know if I'm up-to-date). It's not easy to be a Star—it takes enormous dedication and resources. Doug Bruce has spent years and hundreds of thousands of dollars. It also takes support—a "Star-friendly" environment, so to speak. Right now, it seems our state generates enough support for just one, and that mostly due to the efforts of Mr. Bruce, TABOR, and CUT. If Mr. Pfiffner is to be a successful Star, there must be a similar amount of support for him.

#### Relationships between Libertarians, Activists, and Stars:

- There at least 1500 registered Libertarians. Let's assume that 1 in 30, or 50 in all, would potentially be committed people who could be approached to be Activists.
- There are 1 or 2 Stars, so the ratio of (potential) Activists to Stars is 25 or 50 to 1.
- I assume that each year, the number of Activists doubles. The most likely way to accomplish this is for each Activist to produce 30 new Libertarians, one of which would become an Activist. As a by-product, the total number of Libertarians would also double. This is the first tricky part. You have to be willing to believe that you can perform a process that will net you 30 people a year.
- I assume that each year, since there are more Activists, more Stars appear (attracted in some mysterious fashion by the growing mass of libertarianism). The idea is that if there are 50 dedicated supporters, a "Star-friendly" environment is generated, so someone who can perform like a Star will naturally gravitate into it. So the relationship would be: each Star has a Star Support Group. If the number of Activists doubles each year, so should the number of Stars.

• In order for the Activists to function cohesively, they need a communication network (phone tree, mailings) and bimonthly meetings. High-tech options (BBS, uucp, voicemail, fax, etc.) would be nice, but must be readily available to all in order to be useful. What is the point of the commnetwork and meetings? In addition to coordinating logistics, it provides a vehicle for the dissemination of working strategies and tactics and a way to express support for our fellow Activists. Every project of whatever kind that I've been on succeeded or failed primarily because of the quality and quantity of communication between the participants. I hope every Activist would believe this and do whatever it takes to ensure enough high-quality communication between Activists and with the Stars.

As I continue to work with these ideas, I expect them to coalesce into a document I'll call the Lifeblood Project Charter. Another document would be a contract for Activists. The idea of a contract is not alien to libertarians, and it is one of the key components of a style of management known as Continuous Improvement (the details of which I will provide upon request). Below is a first crack at what the Lifeblood Activist contract would contain.

I represent that I am a person of my word and that I understand and believe in the intentions of the Lifeblood Project as presented in The Lifeblood Project Charter, the impact it will have on my life, and the resultant impact it will have for the Libertarian Party.

I promise to maintain my values, schedule my time, and budget my money in ways that allow me to honor the following promises.

I promise to produce 30 new registered Libertarians each year\* (\*each year = every 365-day period from the date of signing through the end of the year 2000). I promise to spend enough time (approx 5%) and money (at least 1%) to accomplish this.

I promise to produce 1 new Lifeblood Activist each year\*. I promise to spend enough time and money (another 1%?) to accomplish this.

I promise to stay in regular communication with other Lifeblood Activists, diligently performing my part of the phone tree, mailings, etc., and attending the bi-monthly meetings. I promise to provide and avail myself of an "Activist-friendly" support environment.

I promise to contribute to a Star Support Group. I promise to spend enough time and money to help accomplish the Star's goal. Examples:

- For a petition: 1,250 signatures (assumes 50 Activists), plus \$100 for the campaign treasury, plus 16 hrs/month as a campaign volunteer.
- For legislation/court case: research time, lobbying time, calls/letters.

# A Libertarian's Guide to Talk Radio

Talk radio—is it "the electronic town hall meeting of the 1990's" or "the great cesspool of misinformation"? Certainly, talk radio is an influential force in American politics. Denver is one of the nation's leading talk radio cities, with five major (and several minor) stations dedicated exclusively to talk radio programming. Front Range listeners are blessed with a cornucopia of offerings, including many with libertarian leanings. (Some of these programs also can be heard in southern and western Colorado on these and other stations.)

Here's a roundup of the major daytime (Mon.-Fri.) sociopolitical talk shows. We'll cover nighttime, and perhaps the insomniacs', shows next month. Drop me a line c/o the CLiPboard if you challenge (or agree) with my assessments.

#### The Rush Limbaugh Program

Any discussion of talk radio must begin with the self-anointed "Godzilla of Talk Radio," Rush Limbaugh. With the number one rated radio program in history, two of the best selling books in history, and the largest circulation non-financial newsletter in history, Rush has singlehandedly changed the radio industry as well as American politics. After struggling for years as a rock music DJ and local talk host, Rush made it big with a move to New York in 1988. The program is syndicated to an unprecedented 636 American radio stations, Armed Forces Radio, and even international short wave.

How has Rush succeeded so wildly? Basically, he tells it like he sees it, espousing his generally conservative Republican views via rambling, bombastic, sarcastic diatribes. He's unabashedly pro-free market, pro-limited government, pro-life, and venomously anti-Clinton (both Bill and Hill).

The show also features some of the best political satire ever produced. Yes, ever. The biting musical and commercial parodies are highly entertaining and 100% effective. A recurring series of Beatles' ripoffs featuring a Bill Clinton sound-alike is hilarious and not to be missed!!

The only drawback to the show is Rush's size XXXXL ego, which detracts from the flow. Many listeners must plead to their radios "Shuttup, Rush, and take another phone call!!"

If you can't tune in the radio show, Limbaugh also stars in his own half-hour syndicated TV show, which airs in Denver on KWGN Channel 2 weeknights from 11:00-11:30 p.m.

Even if you don't like Buchanan's politics, the show features exclusive interviews with the nation's top news makers and pundits discussing the breaking news. A recent show featured a very favorable discussion of the Fully Informed Jury Association (FIJA) with National Director Don Doig.
