Paul petitioning becomes urgent

There's only about one month left to obtain more than 4,000 valid signatures on ballot access petitions for Ron Paul, the Libertarian Party presidential nominee for 1988.

Recognizing the urgency in the state that is the birthplace of the Libertarian Party, the national Ballot Access Committee has assigned 12 trained petitioners to Colorado to quicken the pace of Paul petitioning. These dozen campaign workers need places to stay while in various regions of Colorado — contact the Colorado Libertarian Party headquarters in Denver if you can help.

Local petitioning coordinator Bill Fargo reported at the last CLP board meeting that only about 1,000 signatures had been obtained by early June. A total of 5,000 valid signatures of registered electors is needed

by August 2nd to place Ron Paul's name on the Colorado general ballot in November.

Petitioners earn 50 cents per signature for obtaining Ron Paul signatures. If you want to start circulating a petition in your area, contact Fargo at the CLP headquarters.

Newly elected CLP Chairman Mary Lind says it will be an "embarrassment" to Colorado Libertarians if Ron Paul's name does not appear on the state ballot this November. We already know who the Demopublicans are going to put on the ballot — George Bush, a drug-running spook, and Michael Dukakis, the hand-picked man of the Kennedy clan — so the urgency to place Ron Paul's name on the ballot should become even more pressing. Bill Robinson is the Coloradans for Paul coordinator.

Heid challenges 'Peppermint Patty'

Daredevil parachutist, novelist and former(?) Republican Robin Heid is challenging Congresswoman Pat "Peppermint Patty" Schroeder (D-Denver) for her First Congressional District seat in Congress.

Heid is maintaining his registration as Republican, but has joined the Colorado and national Libertarian parties and has gained approval as the CLP nominee for Schroeder's seat. Asked if he had experienced any hassles from the office of Secretary of State Natalie Myers concerning his registration status, Heid replied, "Not yet."

Having already gained the attention of the Denver media by jumping off of a downtown skyscraper last September to promote his novel, "Sport Death: A Computer Age

Odyssey" (he goes to trial for the second time on charges of trespassing and reckless endangerment on July 21; the first trial ended in a hung jury), Heid says his notoriety will help him defeat Schroeder.

"I seriously think I have an opportunity to win...if certain things fall into place," Heid commented over the telephone. "I think I represent a wild card that will change all the equations."

His campaign, Heid says, calls for a referendum on the drug war. He has drafted a 27th Amendment to the U.S. Constitution which will end the prohibition against psychoactive drugs. Heid says he'll use his enthusiasm for parachuting to gain media attention and to promote his campaign.

Greetings!

I'm quite pleased that Ron (Bain) has granted me the opportunity to keep in touch with you each month through the **CLIPboard**. Lots of exciting things are happening in the Libertarian Party!

First, on an urgent note: Get active in petitioning for Ron Paul. We're horribly behind schedule with less than one thousand signatures as of the June Board meeting. We need to get 5,000 signatures to the Secretary of State's office by the first week of August; this translates to 7,500 to 10,000 signatures total to be assured of receiving enough valid ones. What an embarrassment it would be to us all if Ron Paul could not even get ballot access here in the birthplace of the Libertarian Party. We cannot afford to "let the other guy do it."

Get petitions from Bill Fargo (call him at the party office) and set a goal for yourself — hit the post office or the street on your lunch hour, for example, and nail down at least 20 signatures a day. Do it after work, at local public meetings, at fairs, rodeos, or anywhere. It's not hard — just do it! 'Nuff said.

I'm pleased to say we have a fantastic group of candidates to put up against the Demopublican party this fall. After speaking with all of them, I'm very optimistic about our chances for capturing a good percentage of the vote and getting more Libertarians in office. Our adversaries are listening like never before, and the battered voters are ripe for change. Do your part and either run for office or help someone who is.

I'm looking forward to going to non-Denver, Colorado, to activate more affiliates. Active outreach is a primary goal of your Board in this election year. Each of us will be traveling to various areas in the state to personally get the ball rolling. Contact us for information on starting your own group or hosting a local cocktail party.

Statement of Principles of the Libertarian Party

We, the members of the Libertarian Party, challenge the cult of the omnipotent state and defend the rights of the individual.

We hold that all individuals have the right to exercise sole dominion over their own lives, and have the right to live in whatever manner they choose, so long as they do not forcibly interfere with the equal right of others to live in whatever manner they choose.

Governments throughout history have regularly operated on the opposite principle, that the State has the right to dispose of the lives of individuals and the fruits of their labor. Even within the United States, all political parties other than our own grant to government the right to regulate the lives of individuals and seize the fruits of their labor without their consent.

We, on the contrary, deny the right of any government to do these things, and hold that where governments exist, they must not violate the rights of any individual: namely, (1) the right to life — accordingly we support prohibition of the initiation of physical force against others; (2) the right to liberty of speech and action — accordingly we oppose all attempts by government to abridge the freedom of speech and press, as well as government censorship in any form; and (3) the right to property — accordingly we oppose government interference with private property, such as confiscation, nationalization, and eminent domain, and support the prohibition of robbery, trespass, fraud, and misrepresentation.

Since governments, when instituted, must not violate individual rights, we oppose all interference by government in the areas of voluntary and contractual relations among individuals. People should not be forced to sacrifice their lives and property for the benefit of others. They should be left free by government to deal with one another as free traders; and the resultant economic system, the only one compatible with the protection of individual rights, is the free market.

How To Say "NO" To ALL Proposed Tax Increases

PROPERTY OWNERSHIP. Property taxes have destroyed YOUR right to own property. With property taxes you can never fully own anything. Government siezes your property if you don't pay your annual **RENT**. All you are doing when you purchase property, is paying for the privilege of renting from the government.

CENTS vs. PER CENTS. Taxes are generally levied as **PER CENTS**, not cents. You only have 100% of every dollar. Every tax increase takes a greater percentage of your one dollar. You keep less of the whole. Government takes more. If there were **NO TAX INCREASES**, Government would still get more whenever the wealth of the community as a whole increased. There would be more dollars to take the same percentage from.

NUMBERS GAME. When you purchase something from your favorite shoe store, sports shop, restaurant, or supply shop, you do so without having to know all of the numbers involved in managing each particular business. You decide if the product being offered is at a price you are willing to pay. Politicians love to play **NUMBERS GAMES**. You don't have to play. Just say "no."

AVERAGES. One numbers game is called **AVERAGES**. Politicians especially enjoy this game. It's played nationwide. Every one and every program below the average can cry for increased funding. As those below the average then rise above the average, a new and higher average results. You've got it! A never ending spiral onward and upward slices deeper and deeper into **YOUR** dollar.

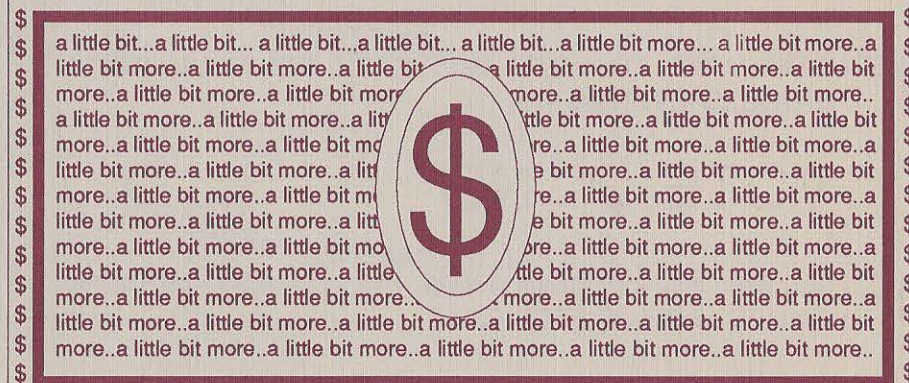
EMERGENCIES. This is probably the most successful of political games. Just continue to say "no." Tell them to find better fiscal managers. Tell them to calm down. Tell them they will survive. "An emergency on your part, does not constitute a panic on my part."

SALARIES. "Our people deserve higher salaries." "We're worth more." Do you deserve a higher salary? Are you worth more? Are you able to **DEMAND** the salary you feel you are worth? Do you rob your neighbor because you deserve a higher salary?

THE BEST. "We want the best." Do you want the best for your home and family? Can you always afford the best? Or do you have to budget and sometimes "make do?"

NEEDS PLEA. "This program is obviously needed. How could you possibly turn us down?" Good fiscal managers set priorities. Top priorities receive available funding. Lower priorities are cut. Of course, it is a good political scam to publicize cutting top priorities. The cutting of lower priorities would not receive as much sympathy.

The **LITTLE BIT** Game. Here is something you can play called "The **LITTLE BIT** Game." Take a black magic marker. Black out one "little bit" from your one dollar. Now black out another "little bit." How about another "little bit?" How about "a little bit more?" Keep going until your little bits don't seem like "a little bit" any more. Is too much of your dollar being blacked out by **TAXES** compounded in "little bits?"



Each government program only taxes you "a little bit." Each new form of taxation only robs from you "a little bit." Each tax increase is just "a little bit more." **YOUR DOLLAR** is getting smaller and smaller. Perhaps this process should be reversed.

GOOD CAUSE HOAX. This is a good "guilt trip" game. Supporting a good cause **DOES NOT** mean supporting increased Government taking of **YOUR** dollar.

YES TO GOAL. NO TO MEANS. Most individuals are well intentioned, compassionate and concerned. Voluntary, peaceful, neighborly solutions are available to those who seek them.

OLD MacDONALD REVISED. Uncle Sam he had a tax. Ee ei ee ei oh. And to this tax he added more. Ee ei ee ei oh. With a little cent here and a little cent there. Here a cent, there a cent, every where another cent....

IF: you don't want even more property TAKEN from you,

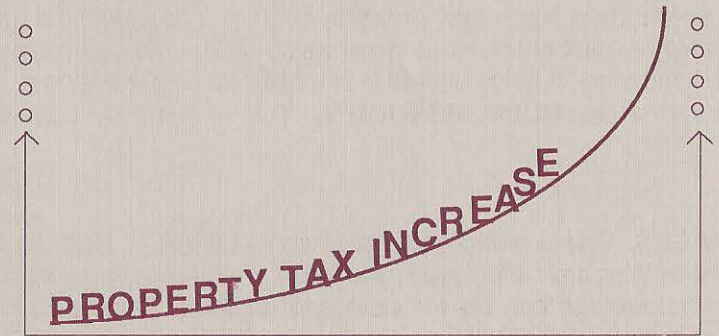

New CLP Board meets

The newly elected CLP Board's June meeting began on time, immediately prior to the Cocktail Party at Victoria Mason's, with all members present except for Communications Chairman Ron Bain, who appointed Bill Fargo as his representative at the meeting.

Finance Chairman David Aitken reported that he had negotiated a reduction of \$20 per month in the office rent. Aitken also reported that approximately \$300 in membership contributions was raised at the state convention, held in Ft. Collins over Memorial Day weekend. Presently, the CLP treasury contains \$800 and all bills are current.

Membership Chairman Jon Baraga reported that he's coordinating a speaker's workshop with Craig Green. He will also advertise in future **CLIPboards** for speakers to conduct outreach efforts. Baraga will also be contacting groups in Colorado Springs and Fort Collins to form county affiliates.

Campaigns Chairman David Daniels reported that Jeff Kelly had dropped out of the Fourth Congressional District (Greeley) race, but that Jim Phelps had announced his candidacy in the Sixth Congressional District. Phelps' candidacy was unanimously approved by the board.

Bain telephoned in a report, saying he needed input from each of the board members to put in the **CLIPboard**, such as officers' reports, photographs, editorials and newspaper articles about Libertarian candidates or ideas from all over the state.

Party Chairman Mary Lind reported that the CLP had maintained its official status as a political organization in Colorado by submitting the names of the new Board on June 8 to the Secretary of State's office. However, Lind reported, next year's submission of Board names must be made no later than May 1, or the CLP will lose all standing with the Secretary of State's office as an official political organization.

The Board discussed creative fundraising methods, noting that an standing offer has been made to provide matching funds for a worthwhile project. The Board decided the first such worthwhile project will be the acquisition of a computer for the party office.

The meeting was adjourned to the Cocktail Party, which was attended by CLP candidates Robin Heid and Dan Nibbelink.

Hamburger booth reports moderate success

The CLP Hamburger Booth at the recent Denver People's Fair sold almost 500 hamburgers and raised \$196 for the party. Charles Stogsdill organized and ran the booth, earning the Board's thanks for doing an excellent job.

Stogsdill was assisted by several volunteers, who showed up for several hours to cook and serve the burgers. They also deserve a round of applause: Victoria Mason, Stanley M. Aitken reports his campaign, which involves mostly door-to-door walking of the district, is moving along nicely. As of June 15, he had completed walking three precincts and was working on the fourth. He reports reception seems to be favorable.

One person indicated she was about ready to change her vote to Libertarian, Aitken said, while another said he would for Aitken again.

Aitken is offering voters something unusual in the political arena: a performance guarantee! The guarantee includes a promise to follow three provisions: 1) not to vote for a bill which increases taxes or fees; 2) or one that contains a net increase in spending; and, 3) or one that reduces basic rights to life, liberty and property as stated by the Colorado Constitution. His guarantee also contains a promise to donate \$500 to charity each time any of the three provisions is violated.
