## Speakers Set for Bill of Rights Rally

The Denver LP's annual Citizens' Rally to Restore the Bill of Rights will be held on Saturday, December 11, on the west steps of the State Capitol between 1:00 and 3:30 pm.

Featured speakers as of this writing include Colorado ACLU President James Joy, CO Ass't. Attorney General Paul Farley, Boulder journalist and former City Councilman Paul Danish, and the man whose lawsuit struck down Denver's "assault weapon" ban, Independence Institute Fellow David Kopel.

Other speakers will be provided by the organizations participating in the rally. As of this date, those organizations include the American Civil Liberties Union, the Freedom From Religion Foundation, the Colorado Trial Lawyer's Association, Jews for the Preservation of Firearms Ownership,

the Pro-Second Amendment Congress, the Firearms Coalition of Colorado, the Fully Informed Jury Association, the National Organization for the Reform of Marijuana Laws, the Colorado Hemp Initiative, the Independence Institute, and the Colorado Libertarian Party.

Before they would agree to ratify the Constitution and form a stronger Federation, the 13 original states insisted on a Bill of Rights to protect the individual liberties of all citizens and to prevent the Federal government from becoming as oppressive as the British government from which they had just broken away.

## Aurora Sued Over Elections

Four Aurora citizen activists, including myself, have filed suit against the City of Aurora for violating the Taxpayer's Bill of Rights (TABOR) during the November 2nd municipal election. The suit claims the election was unconstitutional and illegal because it did not comply with several requirements of TABOR, and seeks invalidation of the two ballot questions approved by voters.

Six of eight tax and bond questions on the ballot were soundly rejected by the voters, by a 62% to 38% average margin, and are essentially moot. Only Question A, authorizing a .25% increase in the city sales tax to fund hiring of additional police officers, and Question G, authorizing issuance of \$7.5 million in bonds to finance completion of several fire and public safety improvements, were passed and are at issue.

Deficiencies charged in the suit include: improper consolidation of tax increase and debt questions; failure to include statements of opposition to the ballot questions in the official election notice; failure to specify future amounts of tax and rate increases; and other substantive and technical violations.

### Denver Courts Respond to FIJA!

At the beginning of September, I reported for jury duty, sat through the instructional video, and was part of the pool for a trial. During the voir dire process, I was able to explain the fully informed jury concept to the courtroom. The judge seemed amused and bemused. The two attorneys argued as to what to do with me. Finally, in a compromise, the judge dismissed me and another person that the defense would not have wanted.

The following week, David Bryant, with help from Ed Hoskins and Tod Wasserman, began distributing the Fully Informed Jury Association's "True or False" brochure outside the Denver City and County building on Monday mornings, targeting those reporting for jury duty. After three or four weeks, David temporarily shelved the project due to lack of time.

In mid-November, Jan Duncan reported for jury duty. The video is now being supplemented with new verbal instructions. A staff person holds up the FIJA brochure and says, "If someone gave you one of these, throw it away. Don't pay any attention to what it says." Could they pique people's curiosity any better? The judge to whom Jan explained FIJA treated her with cold hostility. It seems that just a few hours of FIJA activism have already created quite a response down at the courthouse!

### What is the ERA?

The Election Reform Amendment has four main features:

1. It requires voter approval of politicians' pay raises if they exceed the inflation rate.
2. It encourages small individual campaign contributions with a tax credit and limits contributions from PACs, corporations, and unions.
3. It prohibits government from trying to influence the outcome of elections at taxpayer expense.
4. It restores the people's petition rights as guaranteed by the Colorado Constitution.

Doug Bruce put it this way: "Voter turnout is often low. People feel they have no real choice and it doesn't matter who gets elected. Why? Unfortunately, the deck is stacked against ordinary citizens. To make the system responsive, we must change the rules of the game. The Election Reform Amendment has just that goal: to make democracy work by making government more accountable to us."

## Affiliate News

### — Aspen —

Tom Peckham has challenged the Aspen city council to make good on its claims of being pro-environment by switching to the use of hemp paper.

### — Aurora —

Aurora Libertarians met on November 16th to elect new officers for 1994, including Jeff Orrock as president, David Bryant as treasurer, and Larry Hoffenberg as secretary.

Some members of the group are still following up on recent electoral events. Larry Hoffenberg is one of four plaintiffs in a suit against the city of Aurora (see story on page 1). Dave Bishop, after being treated inappropriately by postal employees while petitioning for the Election Reform Amendment, is following up on a complaint he has registered with the Post Office.

The group plans to work on building membership now, with a mass mailing and notices in several local newspapers.

### — Boulder —

The BCLP got a lot of press in November. A group formed by Chuck Wright, Citizens for Accountable Schools, worked to defeat the school tax increases on the ballot, and Vern Bickel (Colorado Union of Taxpayers) took on millions of dollars worth of proposed new taxes all over the county. Boulder voters rejected one of two school taxes, but passed the other, as well as the open space tax.

Wright and Bickel are now plaintiffs in a suit seeking to void the school district bond election because Amendment 1 procedures were not properly followed. This suit is holding up the issuance of similar bonds all over the state.

November's outreach meeting featured a video alleging a BATF cover-up about the Waco incident; although the video was depressing, the turnout was not. Seventy-five (!) attendees helped make this the largest outreach meeting yet for the BCLP.

Plans for the future include work on zoning reform and FIJA.

### — Denver —

Scheduled speaker John Voss, of the National Commodity and Barter Association, was unable to make the November Denver LP meeting, and will be rescheduled for a future date. The group filled the time with a variety of wide-ranging discussions and a greater than usual amount of party business, including:

- Voting to donate \$100 to the TABOR Committee in support of the Election Reform Amendment.
- Planning for the December Bill of Rights Rally. See story on page 1.
- Discussing the desirability of libertarian social activities. The group decided a party on the evening of the BOR rally would be a good idea, but plans are still incomplete. Call Richard at (303) 871-8824 for information or to help.

David Segal took part in a gun rights debate at Bear Creek school, along with David Kopel. Our side creamed the opposition, he said.

The event elicited favorable comments from Al Knight in the Denver Post.

David Aitken was on KNUS radio's Bob Heckler show, discussing a wide variety of LP platform issues. Those who heard the show agreed that Aitken did well, was treated with respect by Heckler, and got several supportive calls.

The December 7 (Pearl Harbor Day) meeting will feature Linda Thompson's chilling video, *Waco: the Big Lie*. This is must viewing, one of the most important pieces of visual history since the Zapruder film, and much less ambiguous.

### — Ft. Collins FREEDOM NOW —

### — Fremont County —

Fremont County Libertarians fought several tax increase proposals and placed their own ballot question repealing a 2% tax on food. Although the voters did not repeal the food tax, they did reject the tourism tax, a county center, and a measure exempting the county from Amendment One. Plans are already underway to begin petitioning again for the repeal of the food tax next year.

Two Libertarian Cañon City Council candidates were defeated, primarily because of their position on the food tax issue.

Fremont County Libertarians have been enthusiastically collecting signatures for Doug Bruce's Election Reform Amendment; an estimated 1000 signatures were collected from the county. Libertarians in El Paso county have been circulating ERA as well.

Fremont County is joining Teller, El Paso, and Pueblo county libertarians in forming a regional alliance for furthering their ballot initiative efforts in the future.

### — Jefferson County —

JeffCo Libertarians, meeting under the name "The Jefferson Forum," have begun a newsletter of the same name. For more information about the newsletter, contact Tom Goonan, (303) 989-3774, PO Box 150264, Lakewood, CO 80215.

The group continues to present an outstanding speaker series. In November, David Kopel addressed "Gun Control Laws: Effects on Crime and Freedom." In short, the Bill of Rights is one of the conditions upon which the Federal government is permitted to exist, and, in the form of the first ten amendments to the U.S. Constitution, it became the supreme law of the land on December 15, 1791.

While the Constitution and its Bill of Rights have never been strictly obeyed by the Federal Government, they have never, in time of peace, been as grossly violated and widely ignored as they are today. That is why this year's Citizen's Rally to Restore the Bill of Rights is especially important.

This has not been a good year for freedom.

1993 opened with an armed BATF attack on law-abiding American citizens in Waco, Texas. It is about to close with the 1993 Crime Bill, which contains numerous provisions that suspend or completely ignore the Constitution and the Bill of Rights. That Crime Bill now appears virtually certain to pass this session of Congress.

If you want to prevent the establishment of a police state, the time to act is now. Your presence at the December 11 rally is vital, so show up in force and bring every friend and acquaintance you can. If we let the bastards know we're angry now, we may be able to avoid a great deal of serious unpleasantness later. See you at the rally!

## To the Editor:

Since you reported my conviction, perhaps your readers would be interested in the rest of the story. The charge was failure to instantly repair an empty four-plex I had bought a few days earlier for \$4,000. A politically appointed, tax-paid Denver judge suppressed my defense from the jury. That is, he threatened to jail me if I told the jury what really happened.

All repairs were done before trial, at a cost to me of \$25,000, but they took over five months and the city had ordered "repairs" (never specified) done in five days! The judge ruled that impossibility was no defense! In fact, he instructed the jury there *was* no defense; if I didn't obey all government orders (no matter how vague or silly), I was guilty. He also hid from the jury that the prosecutor agreed to more time for the repairs and then filed extra charges before the time expired (a setup). Etc., etc.

The fine was \$2,446, plus 150 hours on a chain gang pulling weeds and painting over graffiti or 28 days in jail. I am a former prosecutor and have never been arrested or convicted of anything in my life. The average sentence for this charge is about \$200, often suspended, and no forced labor or jail. The prior owner owned it for 80 days after the city notified him of the same crumbling stucco and loose bricks. He was never charged. No repairs were required of him. But then, he did not write the Taxpayer's Bill of Rights, did he?

Although it will cost thousands of dollars, I will appeal. I am uncomfortable with asking people for money. But people who want to defeat one goal of this kangaroo court can collect signatures for the Election Reform Amendment. The fact is, apart from retaliation, the government tied me up in court to

In its response to the suit, the City of Aurora denied virtually all claims made against it and challenged the constitutionality of TABOR on several grounds.

The plaintiffs maintain that through TABOR (last year's Amendment One), the citizens have imposed specific constraints on how governments do business. They may not like it, but municipal governments are bound by the Colorado Constitution. If governments don't comply, they should be held accountable to the citizens for their actions. TABOR author Douglas Bruce summed it up best: "Government isn't entitled to ANYTHING except what the citizens give it."

The Aurora suit is currently pending in Arapahoe County District Court. Other suits challenging election results over alleged violations of TABOR are also pending in Adams County, Arvada and Boulder.

discredit and derail our petition drive, which fights political campaign corruption and protects our First Amendment right to petition, now under constant assault by power-hungry politicians.

By the time this is published, Natalie Meyer may already have declared the 52,000 ERA signatures we turned in insufficient. We then have a 14 day "cure period" to gather enough additional signatures to get on the ballot. Patriots who will stand up for freedom can call (719) 550-0010 or (303) 869-6306, or write to TABOR, Box 26018, Colorado Springs, CO 80936. Anyone can fill a petition (96 signatures) in about six hours in a public place. I'm not asking for your sympathy. A 20-second signature on someone else's petition is not enough, either. I want to see concrete, meaningful proof of your abiding commitment to America. Freedom is not free.

When political machine leader Boss Tweed was confronted with a long list of his corrupt activities, he replied, "Yeah? What are you going to do about it?" As one trying to clean up politics, I also ask those disgusted with this latest act of governmental abuse, "What are YOU going to do about it?"

## Governor's Race Challenge

I am developing a variety of ongoing fundraising projects to pay administrative costs of the state organization and provide increased support for the local organizations. These will be introduced as I get my/our act together. However, I believe that the Libertarian Party needs to make some waves and create awareness to kick off our fundraising efforts.

Therefore, I proposed to the State Board that we make a serious run in the Governor's race in 1994. The only way to become a real political party in Colorado, and avoid having to petition onto the ballot, is to obtain 10% of the vote in a gubernatorial race. I sense that we don't believe we have a chance to achieve this. **I don't think that's right.** I think we can do it with a **qualified candidate, a strategic plan, and money.**

Dave Aitken, State Chair, suggested a program to determine if our members and sympathizers have the desire to go for it. That's the challenge. The State Board believes that raising \$10,000 from our own ranks by January 31, 1994 would encourage potential candidates to come forward. I know it would energize me. I propose our goal should be to raise \$100,000 to be committed primarily to electronic media; but we could make a good showing with even less. **Dave Aitken spent about \$800 as a stand-in candidate in the last election and received 18,930 votes, a 10 to 1 ratio of votes to registered Libertarians. Think about it.**

Accordingly, the Board is establishing a Governor's race escrow account, and soliciting contributions. These will be returned if we do not reach the \$10,000. Our Treasurer, Cooper Jager, has volunteered to administer the account and establish procedures for installment payments. We need 100 people to contribute \$100 each and we're there. Obviously, lesser amounts are also encouraged. We already have nearly \$2,000 pledged from members of the Board and several others that I have contacted.

I have also received commitments from individuals to conduct a telephone pledge campaign, so we will be calling you.

As to the balance of the \$100,000, I believe we can secure funds through celebrity-attended dinners and dances, PACs, and other traditional sources. For example, Barry Goldwater and Dick Lamm have been suggested as celebrity headliners. I believe health organization and NRA PACs would support us.

Just as important as the fundraising is the candidate. I encourage you to help recruit potential candidates for the nomination at the April 1994 convention. They need to be issue-oriented and have a "Strategic Plan" for governing Colorado. I'm a notorious slow starter and will close for now, but look forward to working with you to meet the challenge and shake up the system. As a footnote, I empathize with those who believe local elections are perhaps more important than statewide elections, and do not want this effort to distract from the work at the local level. In fact, I believe the publicity to the party from a Governor's campaign will dramatically assist in our local efforts. Dissenting opinions are invited.

## Denver Local Gun Control Activities

There are two kinds of gun control through legislation. The first is to take all guns away from all citizens. The second is to punish persons misusing guns. This latter method is more nearly enforceable and more cost effective. It does not punish the law-abiding for the sins of the lawless, who have no intentions of abiding by the codified rules, ordinances, statutes, etc.

This idea is apparently lost on Denver's City Council. Although the use of center file rifles in crime is down in Denver, Washington, DC, New Jersey, and nationally; Cathy Reynolds, future mayoral candidate, plans to reintroduce the semi-auto ban that was found unconstitutional in county court. That ordinance is before the state Supreme Court. Her intent seems to be to put another ban on the books. There is little doubt it will come any closer to passing constitutional muster. It will, however, "send a message" as she is so fond of saying. In the sham hearing before City Council that led to the passage of the initial ban, she said, "It sends a message that we don't want these kinds of people in Denver."

Council's newest member, Joyce Foster, lost little time before drafting an ordinance that makes previous attempts to disarm the

citizenry pale. Under her proposal, a person wishing to buy a gun would take a list of guns already owned to the police chief, state make and caliber of gun they wished to purchase, justify their need for it, have their picture and fingerprints taken, and undergo

a background check during the waiting period. No study has been done to determine if any of these invasive measures have been successful in other jurisdictions where they have been tried. I doubt Mrs. Foster knows that for less paper work one could get a machine-gun, if only one could secure approval of one's local chief law enforcement official.

Councilwoman Allegra "Happy" Haynes, at a meeting of the Colorado Social Legislation Committee, bemoaned that "there are thousands" of gun dealers in Denver who sell guns to children. Yet Dorothy Nepa of Zoning found there were only one hundred and eighty-eight FFLs in the city.

The CSLC presented a plaque to state Senator Regis Groff for his efforts to abolish the federal Constitution's Second Amendment and increase state-wide gun prohibitions.

Also at this meeting of the CSLC were General Felix Sparks and District Attorney A. William Ritter, Jr. Sparks repeated the Handgun Control, Inc. lie that the militia in the Second Amendment is the National Guard. He also said that half of childhood deaths due to firearms were simply because the handgun was there. He didn't mention that accidental deaths per capita have been declining since the early 1900s when records were first kept. Ritter said General Sparks had pretty well summed up the role of handguns in juvenile violence. He then said that he and other DAs had "lobbied" for the passage of the juvenile handgun possession ban in the special session. Upon

hearing this absurd allegation, I slapped the table, coughed and cleared my throat. "Isn't it just like a politician to attempt to take credit for what his opponents worked three years to pass?" Ritter changed his statement to "supported".

Private investigators of Denver filed suit against the Chief of Police for his failure to issue concealed carry permits, contrary to state statute. The court granted Denver's motion to dismiss. The private eyes have appealed. A zoning inspector told me there are three carry permits in Denver, all issued to arson investigators. He speculated that they would soon be brought under the law enforcement umbrella, providing them with automatic carry permission. Just think, that way Denver could issue no carry permits.

Denver's "daffy" City Council passed a gun shop zoning ordinance that would allow shops only in the most established retail areas. It might more honestly have been titled "Gart Bros. Economic Protection Act." Since roughly seven percent of guns used in crimes come from retail purchases, don't look for a crime decrease due to this "feel good" measure.

Capitol Hill United Ministries has printed a green button that says "I don't carry a gun." It is reportedly the brainchild of the Rev. Paul Kottke of Warren United Methodist Church. Is this an advance "turn the other cheek" self-defense maneuver?

Colfax on the Hill Business Improvement District's Chairman Margot Hartmann, had something of the same kind in mind when instituting an unarmed security patrol between 11:00 am and 7:00 pm. Mrs. Hartmann explained that by being unarmed, the guards would de-escalate the level of violence on Colfax. She said, "The police have guns." By using the politician's enthymeme, she avoided completing her syllogism, with the minor premise "Citizens don't", and conclusion, "Therefore, we're safer with an unarmed patrol." Criticism of such an argument would have been too easy.

Police states aren't safer for anyone except the elite. Armed citizens are the keepers of security and the defenders of liberty.
