# PRESIDENT



ROGER LEA MacBRIDE, Charlottesville, Virginia
Announced February 15, 1975
Born in 1929, Roger MacBride received an A.B. from Princeton
and a J.D. from Harvard Law. After practicing in New York
for several years, he opened a law firm in Brattleboro, Vermont. While in Vermont MacBride served in the state legislature and was an unsuccessful candidate for the Republican
gubernatorial nomination in 1964. He moved to Virginia in
1968 where he served as a presidential elector, bolting the

Republican Party in 1972 to vote for the Libertarian Party candidates. MacBride is the author of two books and editor

"Little House On The Prairie." In the past two years he has crisscrossed the country, speaking to innumerable libertarian groups.

"The LP is indeed the party of principle and owing both to prodigious efforts by its members and to fortuitous events, it has an opportunity to make an enormous impact...in any event a strong showing will ensure that a good part of the ongoing dialogue in intellectual and political circles of the United States during the decade to follow will center about our ideas. Onrushing events have brought the prospective end of what is left of our free society and free economy into distant view; only the victory of efforts such as ours promise that that end will never come."



GUY W. RIGGS, Poughkeepsie, New York Announced May 15, 1975

Born in 1923 and raised in the Southwest, Guy Riggs joined the Navy in 1942 and participated in three battles in World War II in the Mediterrean theatre. He was appointed to the U.S. Naval Academy in 1944 and, after graduating in 1948, he had fours years duty as a commissioned officer, part of it in Asia when the Chinese Communists were coming into power. Riggs left the Navy in 1952 and became an IBM employee. His political activity started in 1964 when he campaigned for Barry Goldwater. In 1972 he ran for New York State Assembly as the first announced libertarian candidate in the country.

Having attracted other libertarians in the Poughkeepsie area, he founded the Mid-Hudson Libertarian Club. Riggs was an FLP Assembly candidate again in 1974.

"I want to change the game from the warlike terminology and attitude infesting current politics. Only the terminology of peace is appropriate. Selling the concept of the minimal state aggressively is all that's necessary...We will never have a free market until the honorable practices of that market are brought into politics. If I become your candidate, there will be many times you'll be asked, 'Who is Guy Riggs,' and you'll be able to give an answer which will finally put America on its proper political base: 'He's the man we've hired to be our Salesman of Liberty.'"



KAY HARROFF, Cleveland, Ohio Announced June 7, 1975

Born in 1930 Kay Harroff became active in Republican politics in the early 1950s, read Ayn Rand's "Atlas Shrugged" in 1960, and in 1962 founded the Cleveland Draft Goldwater Committee. After Goldwater's defeat she left the Republican Party to concentrate on her business activities. She heard about the Libertarian Party in 1972 and was founding Chairman of the Ohio LP in 1972. As Ohio Chairman again in 1973, Harroff handled the 1973 National Convention in Cleveland, where she was elected to the Executive Committee for Region 5. In 1974 she ran for the U.S. Senate in Ohio, receiving 76,822 votes.

She was recently elected Ohio Chairman once again and in May 1975 was elected to a vacant At-Large seat on the Executive Committee.

"It is my deep belief that our basic ideals must be stated simply and repeatedly until they are understood by the American people, and before any great number of them will first accept and then support permanent political and social change... It should be for libertarians to lead and take the offensive; it should be for all others to react and remain on the defensive. If nominated, it is my intention to wage this kind of campaign - not only because it proved to be the most productive last year, but because it is the only position I personally can defend consistently, securely, honestly and proudly."

# VICE PRESIDENT



JIM TROTTER, Santa Barbara, California
A former libertarian SDS member and anti-war activist, Jim
Trotter became an economic libertarian in 1970. For the
last two years he has been selling gold and silver coins and
giving seminars on hard money investment. Trotter is a member of both the Santa Barbara Libertarian Party and the
Peace and Freedom Party, as well as the Society for Individual Liberty and the National Rifle Association.



TONIE NATHAN, Eugene, Oregon
Tonie Nathan has been a music publisher, insurance agent, interior decorator and television & radio producer. She has a B.A. in journalism and is a free-lance broadcaster and columnist. A former liberal Democrat, in 1972 she was the LP candidate for Vice President and became the first woman to receive an electoral college vote. She is the founder and president pro tem of ALF, the Association of Libertarian Feminists.

# **OFFICERS**



EDWARD H. CRANE, III, CHAIRMAN

is an Investment Counselor in San Francisco. He has a B.S. in finance from UC Berkeley and an M.B.A. in finance and investments from USC. While at Berkeley he was active in various conservative political action organizations and was a precinct captain for Goldwater in 1964. He later became disillusioned with what he viewed as the inconsistencies of political conservatism and joined the fledgling libertarian movement, attending the Party's organizing convention in Denver 1972. As Vice Chairman of the Libertarian Party of California for two years, Ed travelled extensively on behalf of the LP, speaking to campus, business and community groups,

as well as delivering over a dozen television and radio editorials for the LP. He was elected LP National Chairman at the 1974 Dallas Convention.



ANDREA MILLEN, VICE CHAIRWOMAN

is currently Production Manager on John Doswell's production of the Campus Studies Institute film, "The Incredible Bread Machine." She is also Secretary and member of the Board of Adlib Communications, Inc. Andrea joined the Free Libertarian Party of New York at its organizing meeting in early 1972 and became a State Committeeperson-At-Large soon after. She was Vice Chairperson of the FLP 1972-1973, Chairperson 1973-1974, and an At-Large Committeeperson 1974-1975. At the 1974 Dallas Convention she served on the Platform Committee and was elected LP National Vice Chairwoman at that Convention.



GREGORY J. CLARK, SECRETARY

attended the University of Detroit and Oakland University, Rochester, Mich. and is currently employed as Secretary—Treasurer and Manager of Rare Coins of Michigan, Inc., a firm which trades coins and precious metals. Greg was active in the Republican Party from 1964 to 1971, holding various leadership positions in both Teenage and College Republicans. He resigned all GOP connections in 1971 when wage and price controls were imposed. In spring 1972 he joined the LP, serving as a member of the State Central Committee of the LP of Mich. continuously since its founding and as Chairman during 1973-1974. Greg was appointed as National Secretary

of the LP by the Executive Committee in May 1975 to fill the unexpired term of Bill Westmiller.



JOHN KRAFT, TREASURER

is a salesman for Central Steel Wire Company. He is a graduate of Wabash College with a major in economics and a minor in history. John served in the Navy from 1966 to 1970, and in addition to politics, he has an interest in sailing. John was elected LP Treasurer at the 1974 Dallas Convention.

# MEMBERS-AT-LARGE



ROBERT H. MEIER, CALIFORNIA

Recently appointed National Director of the Libertarian Party, he has been active in LP activities since 1972. Previous to his appointment he was National Fundraising Chairman. He is Executive Director (in absentia) of the Economic Civil Liberties Association as well as creating and now serving on the board of directors of the Economic Education and Research Forum. Bob is the publisher of The Libertarian Scholar and was the special editor of the 1974 financial issue of Reason. Recently he served as co-chairman of the 1975 Conference on International Liquidity and Monetary Reform held in New

SUSAN F. NOLAN, COLORADO

was a founding member of the LP in 1971 and served as temporary secretary 1971-72, becoming National LP Chairman from 1972-74. She was active in Young Republicans and YAF through 1970 and caucused at the 1967 YAF convention to plan the creation of a new libertarian organization. Susan holds an A.S. in Foreign Trade.

D. FRANK ROBINSON, OKLAHOMA

is a journalist/auditor and editorial columnist for Oklahoma City World. At the 1972 Denver Convention he was chairman of the Constitution, Bylaws & Rules Committee and served on that Committee again in 1974. Currently state Treasurer, Frank was the first Chairman of the LP of Oklahoma. He was director of research for Mickey Edwards' 1974 congressional campaign. Frank is author of the "Secret Voucher Plan" for campaign finance reform, the "Oklahoma Plan" for ballot recognition, the "LINC '76" strategy and the national LP membership registration plan for convention representation. Frank has been a member of the National Executive Committee since 1972.

FRAN YOUNGSTEIN, NEW YORK

has a B.S. in mathematics and has worked for IBM since 1964, currently as Regional Education Support Representative. She is also Treasurer and member of the board of Adlib Communications, Inc. A former liberal Democrat, Fran joined the FLP in May 1972. She was founder and chairperson of Libertarian Abortion Action Group and was a Member-At-Large of the FLP State Committee 1973-75. As the FLP candidate for Mayor of New York City in 1973, Fran almost outpolled all other minor party candidates combined. She attended the 1973 Cleveland Convention and was a member of the Credentials Committee at the 1974 Dallas Convention, where she was elected to the Execomm. Fran is a member of the Constitution, Bylaws & Rules Committee of this Convention.

KAY HARROFF, OHIO (see bio page 8)

JAMES U. BLANCHARD, III, LOUISIANA

became interested in libertarianism after reading the works of Ayn Rand in 1961. After graduating from Louisiana State University Jim taught history for 3 years, but his interest in economics, and especially monetary theory, led him to found the National Committee to Legalize Gold (recently renamed National Committee for Monetary Reform) in 1971. As director of NCLG (now NCMR), Jim planned and organized the two largest monetary conferences ever held, 750 attendees in January 1974, and over 1000 in March of this year. In addition to his duties as Director of NCMR and Editor of Gold Newsletter, Jim owns his own investment company. He was elected to fill an Execomm vacancy in May 1975.

EDWARD E. CLARK, CALIFORNIA

received his A.B. from Dartmouth in 1952 and his J.D. from Harvard Law in 1957. He now practices law in Los Angeles. Ed was the founder and first Chairperson of the Free Libertarian Party of New York in 1972 and was Chairperson of the California Libertarian Party from 1973 to 1975. Chairman of the Platform Committee at the 1974 Dallas Convention, Ed holds that position again this year. He is the author of one published legal article and two unpublished novels.

DAVID F. NOLAN, COLORADO

was one of the 88 libertarians who caucused at the 1967 YAF convention in Pittsburgh to plan the creation of a new libertarian organization. He was a founding member of the Society for Rational Individualism in 1968, Massachusetts SIL representative in 1969. Principle founder of the Libertarian Party in 1971, Dave served as temporary LP Chairman, 1971-72, member of the national LP Execomm and editor of LP News, 1972-74, and Execomm member, 1974-75. A member of this year's Credentials Committee, Dave served on the Constitution, Bylaws and Rules Committee for the 1974 Dallas Convention. Dave's 1971 article on "Classifying and Analyzing Politico-Economic Systems," introduced the two-axis Libersign emblem.

# REGIONAL REPRESENTATIVES

PATRICIA A. ARTZ, WASHINGTON (REGION 1)

came to the Libertarian Party from eight years of Objectivist and NBI studies. She organized the Hospers/Nathan banquet in Seattle in October 1972 and presided at the formal founding of the LP of Washington State in May of 1973. A delegate to the 1974 Dallas Convention, Pat was elected from Region 1 to the Execomm, where she has served on the Publications Committee. A member of the Platform Committee for this Convention, she is also Recording Secretary. Prior political activities were directed to the preservation of rights in private property and feminist issues. She is Treasurer pro tem of A.L.F. and has a long-range interest in revolutionizing the field of education.

LYNN KINSKY, CALIFORNIA (REGION 1)

has been active in the libertarian movement for almost ten years. She is currently an editor of Reason Magazine, and has been a contributor to Reason, Libertarian Forum, Libertarian Review, and "The Libertarian Alternative." She was a charter member of both the national and California LPs, and is chairperson of the Santa Barbara LP. Lynn was a candidate for Santa Barbara School Board early this year. She is a member of the Association of Libertarian Feminists, Peace and Freedom Party and ACLU. A graduate student in sociology at UCSB, Lynn, who has a B.S. in chemistry, is specializing in the areas of political sociology and social change.

WILLIAM V. SUSEL, CALIFORNIA (REGION 1)

is a self-employed contract engineer. He holds a B.S. in Chemical Engineering from the University of Dayton and credits from the graduate school of business at the University of Nevada. Never before active in politics, Bill was the first California State Chairman (pro tem) in 1972, served on the Platform Committee at the 1972 Denver Convention, and managed John Hospers' presidential campaign in 1972. Bill was a member of the 1974 Platform Committee in Dallas, where he was elected to the Execomm from his region. He was the LPC candidate for Lt. Governor in 1974.

ERIC A. WESTLING, COLORADO (REGION 2) (no bio available)

PORTER DAVIS, OKLAHOMA (REGION 3)

is a business consultant and systems analyst with a B.B.A. in Finance and Accounting and an M.B.A. in Organizational Behavior, and two years of graduate study in Sociology... Porter attended the 1973 Cleveland Convention and was a delegate to the 1974 Dallas Convention, where his Region elected him to the Execomm. He is the new Chairperson of the LP of Oklahoma.

WILLIAM HOWELL, TEXAS (REGION 3)

is Vice Chairman of the Texas LP and former Chairman of the Dallas County LP. Bill is Chairman of the Constitution, Bylaws & Rules Committee for this Convention, and was a member of that Committee at the 1974 Dallas Convention.

WINSTON L. DUKE, ILLINOIS (REGION 4)

has been active in the Illinois LP from its inception. He attended the first LP National Convention in Denver and has been active on the Execomm since that time. He characterizes his philosophical/political orientation as "a strong Randian leaning with a current preference for the Nozick scenario." Winston has a B.S. in Physics, an M.S. in Nuclear Engineering and an M.B.A. from Harvard. In the fall he will enter law school in Chicago to begin work toward his J.D. In 1970 he was campaign manager and administrative assistant to Congressman James M. Collins of Texas. Winston has, since 1971, held various administrative and engineering positions with Commonwealth Edison Company.

MARTIN D. JAHN, KENTUCKY (REGION 5)

has been active in the LP on a state and local level since 1972. He attended the 1973 Cleveland and 1974 Dallas Conventions. In Kentucky he was the Party's first Vice Chairman, and later an interim Chairman, before assuming his current position on the national Execomm. A graduate of Johns Hopkins University, Marty has been involved in insurance investigations for most of his work life. He and his wife, Bobbi, both Black Belts in Korean Karate, own and operate a Karate School in Cincinnati, Ohio.

BRIAN DONERLY, FLORIDA (REGION 6)

travelled what he terms "the conventional right-wing route to libertarianism: Goldwater campaign in 1964, YAF, Ayn Rand, and such." Active in the LP since 1972, Brian served as an elector for Hospers/Nathan in Florida. He has been on the LP of Florida's Executive Committee since its formation in 1973, currently as LPF Secretary. His campaign for the Gainesville City Commission, in which he garnered a mountainous 2.8 percent of the vote, was the LPF's first electoral effort. Currently a law student at the University of Florida, Gainesville, Brian served on the Platform Committee at the 1974 Dallas Convention, where he was elected to represent his region on the Execomm.

JOHN HOSPERS is a professor in the Philosophy Department at the Univ. of Southern California, Los Angeles. He has previously taught at the University of Minnesota and the City University of New York. Dr. Hospers was born in a Dutch-speaking free-enterprise enclave in Iowa, and received his PhD in Philosophy from Columbia University in NYC.

In 1971 Dr. Hospers' Libertarianism: a Political Philosophy Whose Time Has Come was published, helping lay the groundwork for the Libertarian Party. He is also the author of two popular textbooks, Introduction to Philosophical Analysis and Human Conduct: an Introduction to the Problems of Ethics, as well as Meaning and Truth in the Arts and

the forthcoming book, A Manual of Libertarian Thought. A prolific writer, he has edited several anthologies, authored over fifty philosophical articles, and is editor-in-chief of an international philosophical magazine, The Personalist.

In 1972 Dr. Hospers became the Libertarian Party's first candidate for President of the United States, receiving one electoral vote. In 1974 he was the LP of California's gubernatorial candidate, and received several thousand write-in votes. He was a member of the platform committee at the 1972 and 1974 National Conventions, and has addressed a dozen other state conventions during and since the 1972 campaign.

MURRAY N. ROTHBARD is a professor of Economics at the Polytechnic Institute of New York. Born and raised in New York City, he received his PhD in Economics from Columbia University.

A noted Austrian economist, Dr. Rothbard's published works include Man, Economy & State; America's Great Depression; Power and Market; What Has Government Done to Our Money; The Panic of 1819; Egalitarianism as a Revolt Against Nature, and other Essays; and For A New Liberty. The first of his four-volume history of colonial America, Conceived In Liberty, was published last spring. His articles have appeared in professional journals and maga-

zines of opinion, including <u>National Review</u>, <u>Ramparts</u>, <u>Reason</u> and <u>The New</u> York Times.

He is editor of the monthly <u>Libertarian Forum</u> and was formerly editor of <u>Left and Right</u>. He is an Associate of the University Seminar on the <u>History of Legal and Political Thought at Columbia University and a former member of the Council of the Conference on Peace Research in History</u>.

Dr. Rothbard is Chairman of the Board of Economic Advisors for the Libertarian Party, and is a member of the FLP and of the 1975 Convention Platform Committee.

As a libertarian activist, he has appeared on TV and radio and has spoken to college political science classes. He has worked in the aerospace industry and as a CPA. Currently pursuing graduate studies in economics at VPI in Blacksburg, Virginia, Charlie plans to teach economics and business administration at the college level.

#### JOANNE CHERNOW, PENNSYLVANIA

is an art director in York, Pa. She attended the 1973 Cleveland, and was a delegate to the 1974 Dallas Convention. JoAnne's responsibilities in the Pennsylvania LP have included membership on the Judicial Committee, Constitution, Bylaws & Rules, as well as editing the state newsletter and coordinating publicity for their 1974 state convention. A charter member of the Central Pennsylvania Region, she served as Chairperson in 1975. JoAnne was recently elected Pennsylvania LP Chair for 1975-76.

#### JOE COBB, ILLINOIS

received his degree in economics from the University of Chicago in 1966, where he served as an Editor of the New Individualist Review. holds a first-degree Black Belt in Korean Karate. She has a B.S. in Biology and Chemistry, an M.S. in Microbiology and Biochemistry, as well as pursuing graduate studies in Business at Xavior University. Bobbi is employed as Manager of Marketing Communication, Products Division, Cincinnati Milacron Company. She was a charter member of the LP of Kentucky, served on their Executive Committee 1973-74, was Vice Chairman 1974-75, and is the 1975-76 Chairman. She also edited the state newsletter from 1973-1975. Bobbi attended the 1973 Cleveland Convention and was chairman of the Ky. delegation to the 1974 Dallas Convention, a position she holds again at this Convention.

#### RICHARD K. KENNEY, MASSACHUSETTS

was a member of the Ayn Rand Society at Harvard, from which he received an A.B. with a combined major in psychology, anthropology and sociology. He founded and chaired the Greater Boston chapter of the Society for Rational Individualism in 1968, and has been a member of SIL since 1969. Rich joined the Mass. LP in 1972 and was Chairman 1973-74. He is a member of the LP of Canada and the LP of Washington State (where he now resides), as well as a life member of the Massachusetts LP. Since 1974 he has been a member of the Libertarian Dialectic. For the last five years Rich has worked as a private security guard, a job which allows considerable time for reading from his 7000-volume library.

#### JEREMY MILLET, LOUISIANA

was first Chairman of the LP of Louisiana and is current Chairman. Jerry ran for U.S. House of Representatives (7th District, La.) in 1974 as the first LP candidate in the state and received 11% of the vote against an incumbent Democrat. He received his PhD from the University of Texas and is an associate professor in political science at the University of Southwestern La. He has had articles and reviews in Rampart Journal, SIL News, and Southwestern Social Science Quarterly. He is currently trying to find a publisher for a new book on libertarianism. Jerry was a member of the Constitution, Bylaws and Rules Committee at the 1974 Dallas Convention.

VIRGINIA SHIELDS WALKER, NEW YORK

received an M.A. from St. John's University and PhD work at New York University. # LP CONVENTION T

The first convention of the Libertarian Party. Quite an event. There were 89 delegates, average age of 31 (as was frequently noted, the same average age as the delegates to the first Continental Congress) from 23 states. Not the most distinguished group of people ever to gather under one roof, but those who were there will testify that there probably was never a group more dedicated. All elements of the libertarian spectrum were represented and what began as cautious skepticism ended as a unified celebration of birth of the second libertarian revolution in America: the Libertarian Party.

Highlights: First-ballot nominations of Dr. John Hospers for President and Ms. Tonie Nathan for Vice President (also establishing the LP tradition of not "making it unanimous").... Hours of debate on the Statement of Principles submitted by a committee. Ultimately adopting Hospers' version -- unanimously.... Discovering that understanding the principles of libertarianism was much easier than applying them to a party platform.... No foreign policy plank in the 1972 convention.... Sue Nolan elected National Chairman (sic).

# **CLEVELAND 1973**

The first "off year" convention (no official party business takes place) was attended by 200 libertarians from all across the nation. Increasing sense of confidence in the viability and permanence of the Libertarian Party. Seminars were held on campaign issues, use of the media, fundraising and organizing state LPs. Featured banquet speakers were Tonie Nathan, the first woman in history to receive an electoral vote and Roger MacBride, the man who cast that vote. They were followed by some twenty other speakers including Dave Nolan, Willis Stone, Kay Harroff, Sam Konkin, Andrea Millen, Ed Crane, Ed Clark and Karl Bray.

Highlights: "Frantic" Fran Youngstein and her entourage from the Big Apple winning the hearts (and dollars) of other delegates as the FLP introduced their unique approach to politics for the rest of the nation... Kay Harroff pinning a carnation on Roger MacBride.... Tape recordings of messages to the delegates from Rothbard and Hospers.... Poolside luau featuring bad classical music.

# DALLAS 1974

This was the one people are still talking about. The attitude was no longer "can we?" but "when will we?" Well over 300 people attended the four day, exhausting convention in sweltering Dallas. Most of the convention was devoted to prolonged platform debate which usually lasted well into the night and on one occasion until 8:00 a.m. Major platform hurdles eventually overcome included ones on taxation, abortion and national defense. Subtle amendments to the Statement of Principles made that document more acceptable to the entire LP spectrum. The spirited race for National Chairman in which Ed Crane of California defeated Eric Royce of Virginia was an intriguing backdrop to the platform debate.

Highlights: The first serious national media coverage of an LP convention....

Jerry Tuccille's outdoor multi-media extravaganza that wowed the delegates and raised over \$5000 for Jerry's gubernatorial bid.... Jean Preece's dance....

Adlib's pictorial history of the libertarian movement.... Speeches by Tuccille, Roger MacBride (keynote), John Hospers and libertarian Democrat Woody Jenkins..... One ballot election of the seven at-large ExeComm posts.... Jean Preece's dance.... Checking out of the Ramada Inn.

# BACKGROUND 72

In July 1971 David and Susan Nolan, Pipp Boyls, Hue Futch and Dave Nelson metin the Nolan's Westminster, Colorado home to plan the formation of a new political party, one which would be a vehicle for those who believe in the inviolability of both civil and economic liberty for all individuals.

Realizing it was too late to make a real impact in 1972, but determining that a presidential campaign was the only way to get the new party organized, they met throughout the summer and fall, each writing to libertarians around the country with whom they had had some contact. By November they had attracted 63 members and on December 11, 1971, by vote of the temporary executive committee, the Libertarian Party was born. The first press conference in January 1972 resulted in worldwide coverage, with clippings from as far away as Germany and Australia.

By June 1972 membership had grown to 900. 89 delegates from 23 states attended the first Libertarian Party Convention in Denver to adopt a Constitution & Bylaws, and a Platform.

As the LP's 1972 Presidential candidate, the delegates chose Dr. John Hospers, professor of Philosophy at the University of Southern California, the man whose Statement of Principles draft had been accepted by the Convention. Tonie Nathan, a Eugene, Oregon television producer, was nominated as the Vice Presidential candidate. Both Hospers and Nathan won first ballot victories over their competition.

The first National Executive Committee decided to allocate a "war chest" to the campaign: \$500. The total final budget for the 1972 campaign was \$6000. With this money Hospers and Nathan crisscrossed the country, speaking to over 5000 people personally and to several million over radio and television. 100,000 pieces of libertarian literature were distributed nationally, and another 100,000 by state and local parties for the dozen other locally endorsed candidates.

Due to the late start and restrictive state ballot laws Hospers/Nathan appeared on only two state ballots, Washington and Colorado, and were certified legal write-in candidates in California. In these three states the LP ticket collected 3,628 votes. Although miniscule in terms of the total electorate, the vote total indicated the viability of the Libertarian Party. Of 39 minor parties in the United States, the LP had made it to number 6 in its first year.

Though the campaign was over election day, the big result came six weeks later on December 18th when Roger Lea MacBride cast an electoral vote for the Libertarian Party candidates, giving the infant party a footnote in history and making Ms. Nathan the first woman ever to receive an electoral vote. By the end of 1972, the membership of the Libertarian Party had grown to 2000.

At the time of this 1975 presidential nominating Convention, the LP has 46 affiliated state organizations and is well on its way to making the libertarian philosophy a major force in American Politics.



# Did You Know ...

- That forced association is the necessary precondition to the development of mental illness?
- That altruism is best understood not as an ethical doctrine but as a psychological disorder? That its acceptance is never due to logical persuasion, but rather to a desire to avoid conflict with one's forced associates?
- That public education necessarily impairs the cognitive abilities of all those who are subjected to it? That most unfulfilled intellectual goals are due to procrastination, fear of revealing mistakes, and the impulse to intellectual haste? That these attributes are in turn due to years of forced confinement in the institutions of public education?
- That cognitive impairments can be overcome, if you know how to go about it?
- That argumentation, though widely condemned, is the basis of the development of one's ability to reason?
- That the Soviets tried to produce chess masters by teaching chess in the schools, and discovered that mastery could not be taught? That this truth is valid in all fields of intellectual endeavor, not merely in chess?
- That the forces which have debased the dollar and brought about rampant domestic inflation do not lead merely to economic collapse, but to nuclear war?
- That the Soviet Union has recently massed sixty divisions on the Chinese border? That the number of Russian tanks in Central Europe has been increased from 14,000 to 20,000—giving the Warsaw Pact forces a better than 3-to-1 advantage over NATO? That such massing of forces is grossly disproportionate to what the Soviets would require if they were intended, as they say, for defensive purposes?
- That the Soviet SS-9 missile delivers a payload which is many times larger than would be needed to destroy even the world's largest city—that its only conceivable purpose is to destroy hardened U.S. missile silos? That there is no need to destroy our silos if they are empty—and that if they are not empty, the Soviets are attacking first?
- That the Soviet "siege mentality" which our liberals urge us to cure by unilaterally disarming is in fact not due to external pressure exerted on the Soviet Union, but rather to the GULAG system—the secret police, the torture chambers, the death camps, and the non-objective law—which ensures that only paranolac madmen can ever reach the top of the Soviet administrative hierarchy?
- That it is impossible to control a foreign nation without the capability to send troops across its borders, and that this means the Birch Society's idea of a single, global conspiracy cannot be correct? That the idea that the CFR controls the Soviet Union via an unseen watchdog agency leads to a well-known type of logical fallacy? That each such unseen watch-

dog requires yet another watchdog to watch it, and so on, ad infinitum?

- That "democracy or dictatorship" is a false dichotomy? That there exist numerous electoral systems which are superior to "one man-one vote"? That a system whereby you vote with your tax receipt would automatically prevent the currently popular practice of heaping taxes on the productive minority-since under such a system "heaping taxes" means "heaping votes"?
- That DDT, much maligned and banned by the EPA, is probably history's greatest saver of human life?
- That human waste amounting to millions of tons per year is winding up in the oceans rather than being recycled back to the farm and grazing lands from which it originated? That this vast process is ruining the land and, as a consequence, is steadily eroding the nutritional quality of the food you eat! That the root cause of this problem is the fact that rivers and oceans are "public domain"—i.e., are not privately owned?
- That the Sahara, the world's largest desert, is man made? That nomadic overgrazing denudes the land of vegetation, that sunlight on the resulting bare earth generates a perpetual thermat which spreads at higher altitudes and keeps rainclouds pushed away? - That mercury pollution is largely a myth and that oceanic mer cury levels were higher a thousand years ago than they are today?



Because no one should coerce anyone regarding abortions, we are hopeful that medical technology can offer help thru the discovery of implant techniques so that the unwanted fetus may be removed and placed in a willing host mother.

#### PARENTS' LIB

To respond to our children's needs, to personally oversee their well-being, we, who assume responsibility for children, demand the freedom that must go with it. This includes the prerogative of assuming all responsibilities alone as well as with the unregulated aid of others in all matters...including defense and protection, private arbitration, education and schools. Furthermore, to increase alternatives and thereby, the quality available of educational standards, goals and systems we support the immediate institution of pure and simple voucher systems and the eventual repeal of governments' coercive control and coerced support of the means of education.

Like a contractual obligation, the responsibility of child rearing is asked for with due consideration before commitment of the duration of childhood, time, patience, monetary obligations, and skills required. Therefore, we find that each father and mother holds both prerogatives to commit and not to commit herself/himself to the nurturing of the unplanned offspring. It is our hope that human beings will be wise in the use of contraceptives should they not plan or want a child. It is the hope of benevolent people everywhere that if a person decides not to care for her/his child, they will take every measure of action to search and find a capable responsive person who will welcome that child.

The first resolution will state: RESOLVED - THE PRESIDENTIAL AND VICE PRESIDENTIAL NOMINEES OF THE LIBERTARIAN PARTY WILL MAKE EVERY EFFORT TO SECURE NOMINATION FOR THE SAME OFFICES BY THE REPUBLICAN PARTY. THEY WILL COMPETE IN ALL REPUBLICAN PRESIDENTIAL PRIMARIES AND APPEAR BEFORE ALL REPUBLICAN DELEGATE SELECTION CONVENTIONS. Of course, the LRA does not expect that the LP candidates will actually obtain the GOP nominations. We firmly believe that the attempt is nonetheless worthwhile.

Libertarianism would receive much more publicity than it has ever received before, resulting in millions of voters being exposed to our principles. Additionally, as proportional division of delegates is required by many state election laws, our candidates would be sure to win some delegates to the Republican National Convention. We would thus be treated to the thrilling spectacle of watching them nominated at next year's RNC, live on network TV. (A similiar effort by Conservatives at the RNC of 1960 - nominating Barry Goldwater for President - served as a springboard for

RESOLVED - IN THE EVENT THAT A CONSERVATIVE THIRD PARTY IS ESTABLISHED IN 1976, THE EXECUTIVE COMMITTEE OF THE LIBERTARIAN PARTY
WILL DETERMINE IF IT IS POSSIBLE TO CONSTRUCT A LIBERTARIAN-CONSERVATIVE FUSION TICKET. IF SUCH IS FOUND TO BE THE CASE, THE
FUSION TICKET WILL BE SUBSTITUTED FOR THE LP'S ORIGINAL SLATE.
The LRA believes that the formation of a Conservative third party
is probable. The thrust of this party could be either pure Conservative, Conservative-Wallacite or Libertarian-Conservative. In
the latter eventuality the construction of a Fusion ticket should
certainly be considered.

The passage of this resolution would actually increase the chances that any Conservative third party would have a Libertarian-Conservative thrust. For the Conservatives would be put on notice that an additional political force - the Libertarian Party - would be allied with them if a Fusion ticket could be constructed.

If the LRA's two resolutions are to have a chance of passing each of you who agrees with one or both of them must help in every way possible. If you are a delegate please vote for them. If you are not a delegate please tell your delegates that you are in favor of their passage.

In the area of crime, the candidate noted, "Shifting investigative officers from the area of 'nonvictim crimes' to that of real crimes would be a wise invest.

The transportation mess could be improved, he said, by revok-ing the monopoly privileges of the Muni and taxicab systems.

"If private taxicabs, buses and jitneys were allowed to operate on a freely competitive basis, on a freely competitive basis, people would not have to depend so much on private automo-biles," he said. "Traffic congestion and pollution would be re-duced; and all this without costing the taxpayers one cent."

Cunningham and his wife Carol, 30, have lived in the city five years. He spent 14 years with the US Coast Guard as an engineer whose duties inch ecological investigations of oil

He said he advocates shifting police attention away from monvictim crimes. "Let's get the police out of the bordellos and back on the best," he said.

Cunningham criticized the "monopoly privileges of the Muni and tancab systems," preferring private companies to operate on a freely competitive basis, and called the crefts pay formula system for some

city workers a "mockery."

He advocates contracting for crafts services directly from the private sector, which he said would reduce the municipal payroll.

A new "fire service demand charge" levied against each building for the demand that building actually places on the city's fire department would motivate the owner to install private fire protection devices, he said.

"Many buildings in San Francisco are exempt from property taxes which shift fire protection costs to other property owners," he said, stressing that his demand charge would be separate from the property

Cunningham's wife, Carol, is co-founder of the Golden Gate chapter of the Society of Women Engineers. They live in the Mission Dutrict.

# STATEMENT OF PRINCIPLES

We, the members of the Libertarian Party, challenge the cult of the omnipotent state and defend the rights of the individual.

We hold that all individuals have the right to exercise sole dominion over their own lives, and have the right to live in whatever manner they choose, so long as they do not forcibly interfere with the equal right of others to live in whatever manner they choose.

Governments throughout history have regularly operated on the opposite principle, that the State has the right to dispose of the lives of individuals and the fruits of their labor. Even within the United States, all political parties other than our own grant to government the right to regulate the lives of individuals and seize the fruits of their labor without their consent.

We, on the contrary, deny the right of any government to do these things, and hold that where governments exist, they must not violate the rights of any individual: namely, (1) the right to life - accordingly we support prohibition of the initiation of physical force against others; (2) the right to liberty of speech and action - accordingly we oppose all attempts by government to abridge the freedom of speech and press, as well as government censorship in any form; and (3) the right to property - accordingly we oppose all government interference with private property; such as confiscation, nationalization, and eminent domain, and support the prohibition of robbery, trespass, fraud, and misrepresentation.

Since governments, when instituted, must not violate individual rights, we oppose all interference by government in the areas of voluntary and contractual relations among individuals. People should not be forced to sacrifice their lives and property for the benefit of others. They should be left free by government to deal with one another as free traders; and the resultant economic system, the only one compatible with the protection of individual rights, is the free market.
