 - b) How to format URL for initials
 - c) Redirects for different names for same individual
 - d) How to handle missing candidates and primaries with more than one candidate
 - e) Using footnotes for citations

B. Finding and preserving more local newsletters

 - a) Mr. Dehn found San Mateo newsletters (~2/3 of series ca 1991-1996 not available; 1996-2000 as a web version, appears different format than print version; 2000+ web and print are presumably same)
