Cynical Thoughts on the Democratic Process

Congratulations. We have survived another electoral expression of the will of the people. Let us forget for a moment that representative democracy is a sacred cow immune from the scrutiny we reserve for rational processes and take a look at this charade from beginning to end.

First, we have to start with the assumption that it is proper for politicians to force their ideas on everyone else, having been given a mandate of the popular majority. But is it a majority?

Starting with 100% of the populace we must deduct 25% to 30% who are not old enough to vote by law, although they are considered old enough to obey the law.

Another 35% just don't vote. Either they don't believe the political process accomplishes anything worthwhile, don't like the choice of candidates, or are too spaced out to care. Not voting is considered just cause for losing one's right to complain about some transgression against individual rights inflicted by the agents of mob rule, by those who do vote.

The remaining 35% to 40% of us naive enough to vote usually begin the process at the party primary. Sometimes we might like a candidate better in another party but the law requires that he win without our vote. After the primary, assuming two candidates and bare majorities in each party race for simplicity, half the people have lost their candidate. So now 17% of the population are going to vote for their choice in the general election.

The winner of the general election probably isn't going to get more than 60% of the aforementioned 17%. That is 10%. Does that mean that 10% IS TOTALLY satisfied with the outcome? Hardly.

Even a candidate's fervent supporters are not going to agree with him on all the issues he takes stands on. Usually voters end up voting against someone instead of for someone. Furthermore, the greater the number of issues a candidate takes stands on the greater the level of disagreement among his supporters will be. So a half-hearted 10% converts to a 5% level of approval from the people bound by all the laws this politician will help enact.

If certain other assumptions are not made this 5% political approval figure will evaporate further. These are that the politician has been honest about his true views and is competent enough to implement them. Some people may not think these last assumptions are reasonable. I can't imagine why.

(NOTE: Similar end results have been found in gambling casinos and lemming migrations.)

It also sets up a commission (noncompensated) to do a one-year study of the agricultural, economic and tax benefits of a free market in marijuana.
