24 LIBERTARIAN CANDIDATES SET FOR NOVEMBER 5TH SCC ELECTIONS!

24 Libertarian candidates running for both partisan and nonpartisan offices will be on Santa Clara County ballots for 2002. There will be 16 federal and state candidates and 8 candidates for local office., Federal candidates are Andrew Carver, Jeff Landauer, and Dennis Umphress for U.S. Congress. Local candidate for a large state district is Elizabeth Brierly for Board of Equalization #1. Seven Local Libertarian are running for partisan offices, with one of them, Carle Hylkema, already a sure winner due to insufficient candidates for office to hold a ballot contest (see second article on this page).

LPC Will Have A **Majority Of Seats** On A Public Board In California For **First Time**

This December, members of the Libertarian Party will have voting control of the Guadalupe-Coyote Resource Conservation District Board of Directors, a publicly elected body.

Currently, registered Libertarians Gilbert Carroll and Board President Gary Molle serve on the 5 member board.

After the coming election on Nov. 5th, Carle Hylkema, also a

STEWART & CO. POLL PUBLIC AT BIG MT. VIEW FESTIVAL

In September the OPH boothing local events, led by Local Organizing Chair Laura Stewart, continued. Two events - the Mountain View

Art and Wine Festival on Sept. 7th and 8th, and Foothill Electronics Swap Meet on Sept. 14th - had enough volunteers to be activated. Using mostly the internet and some phone contact, Stewart has created a very efficient means of communication with, and coordination of, volunteers, and she has been a dynamo at arranging to get booths at various public events around the county.

At the beginning of September she wrote on the LPSCC eboard "Please go to http://www.sc.ca.lp.org/lpsc-volunteer-oph.html whether to volunteer, or to see our current status. We are approved for Cupertino Oktoberfest the weekend of October 12 & 13, we expect approval for De Anza Flea Market Saturday October 5, and we will be at Foothill College Electronics Swap Meet (which doesn't have an approval process, Ray Strong will heroically be there at 5:30 AM to secure us a space) on Saturday September 14.

We are committed to this weekend (Mountain View) and next weekend (Foothill), even though we don't have quite enough volunteers for either event. And after September 14, our presence at all other events will be contingent upon getting enough volunteers. She continued by describing how our members can participate or just learn what's going on: "Visit the OPH web site at http://www.sc.ca.lp.org/lpsc-volunteer-oph.html to volunteer for a shift, or just to see the current status of which events are approved. Note that except for this weekend and next (Foothill Electronics Swap Meet), which we will do regardless of whether we get enough volunteers, our presence at all other events is *subject* to us getting enough volunteers. Of course, the shifts shown are not written in stone...if you have a different slot of time available, please let me know! You can also call me to volunteer or get more information: 650-938-1697."

Your reporter visited our OPH booth at the Mt. View festival on Sunday afternoon, wearing out a lot of shoe leather searching for it at first. The traffic was very heavy. There may have been well over 10,000 people present. I walked up and down Castro among the throngs, from start to finish about 5 blocks, inquiring at the information booth half way along and learning that the non profit booth areas were located at both ends of the festival. Our booth was no where to be seen at either end! Then I noticed after returning to the north end - where I started, that there appeared to be a couple of structures on an unpaved street extending back behind the three non profits on the main drag - Republican Party, Jehova's

Witnesses, and a candidate for city council. I managed to find a narrow path between the three booths and lo and behold there in back of them was the OPH booth with Laura, Ed Allison, and Tony Le (Cathi Brown also had been there but was away during my brief visit) standing there and no traffic at all except a very occasional person coming through to or from their car on the adjacent streets. While I took some of the accompanying photos, several of the few passers through accepted offers to take the OPH quiz and have their initialed color dot placed on the Self Government Chart. While the light traffic depressed the hoped for numbers of quiz takers, there appeared to be a distinct benefit - when our LP reps were conversing with prospects there was quietude and no visual distractions.

Randy Overbeck, who had manned the booth on Saturday, was later asked how he found the situation, replying "The traffic was very low on Saturday as well. The main problem was location. We were off the track of the 1000's of people who were visiting the Festival and even if you looked down the dirt path between the buildings there was a tree and several vendors that blocked the view to be able to see us and the other 12 or so groups there. I asked one of the folks from the Jehova's Witness what time he got there as he had a corner spot that everyone walking by could see (although it was about 5-7 feet away from the main path) and he said 7:00am. Personally I think the only worthwhile option in the future for at Mountain View would be either to arrive early or even to purchase a booth if possible. We would literally get 100's of times the traffic from a purchased booth. (Of course that would require a lot more volunteers but it could be a great opportunity to grow the local base of members)."

No reporter was there, but Stewart reports that the Foothill Swap Meet on the 14th was not a very well attended event. Undoubtedly OPH Program Manager Laura Stewart and the other participants learned from this second month in the OPH boothing event series, and future site arrangements, as well as prospect solicitation methods and interaction, will improve with practice as the months go by.

SEPTEMBER EXCOM MEETING

MEETINGS

Internal business meetings of the local party

7 September 2002

Attendance: All members but Membership Chair; no guests.

The meeting was at the usual place - the Rosegarden Library conference room in San Jose.

Tropicana status report: Dennis Umphress reported on activities relating to "redevelopment" in San Jose, specifically relating to the Tropicana shopping center. Umphress reported on a protest in San Jose in response to a raid on the medical marijuana co-op in Santa Cruz. There were only a few participants at this location but quite a bit of media interest.

Press releases: There was a discussion of better coordination of press releases. Joe Dehn requested that other Excom members have a chance to see them and comment before release.

BALLOT ARGUMENTS: Umphress reported that rebuttals for Measures G, H, I, and J had been submitted. It was noted

that we have been able to work with Silicon Valley Taxpayers Association on such arguments.

Umphress reported that he has been appointed to the oversight committee for the Measure G bond passed in March.

Excom members discussing business at Rose Garden Library

There was discussion of an attempt by East Side Union High School District to change the text of their measure after it was already on the ballot.

OPH BOOTHS: Stewart reported on the booth effort at the Mountain View Art and Wine Festival this weekend. She made a new flyer for handing out at these events and is updating the list of upcoming events on the web site. There was discussion of a table at an upcoming Mac OS conference. There was discussion of how to encourage more volunteers.

CELL PHONE: Hinkle suggested we get a party cell phone and forward the published number to it; this would allow various volunteers to take on the job of answering calls as well as making a phone available for use in activities like petition drives. There was discussion of this and alternative approaches, specifically using a "unified messaging service" for handling incoming calls and other options for providing cell phones for party activities. Hugdahl moved to appoint a committee consisting of Brown, Hinkle, and Hugdahl to come back with a proposal dealing with these issues. The motion passed with no objection.

VOLUNTEER FORM: Strong noted that there is a new volunteer form on the web site. He said that Bill White was willing to help automate processing of volunteer and inquiry data.

LEGAL CONTINGENCY FUND: Strong reported that we didn't end up spending anything on the Measure J issues. There was discussion of setting up a contingency fund to deal with future issues, topics including: defining it as being for quick actions only with any needed followup to be handled by other organizations, working out rules for how funds would be allocated, the relationship of this to publicity, and doing fundraising for it now when we don't have a current emergency. Strong said he was appointing himself, Laursen, and Collier as a committee to develop this idea.

SPEAKER MEETING

Brown said she would be at the upcoming speaker meeting.

Umphress reported that he had attended a recent meeting of the Democratic central committee.

OCTOBER CENTRAL COMMITTEE MEETING

Collier reported that the meeting will be held 10 October at the Fish Market restaurant on Blossom Hill Road. Umphress noted that this will be an opportunity to endorse candidates.

SEPTEMBER SPEAKERS MEETING

Vice Chair Cathi Brown reports that just 4 people attended and no visitors were attract by the constant sign up in Coco's lobby. What does the reader think - would you turn out for an announced speaker?

COPELAND SPITTING INCIDENT DRAWS COPIOUS "LIBERTARIAN" MENTIONS IN SANTA CLARA COUNTY

The LPSCC has LPC gubernatorial candidate Gary Copeland to thank for letting many county voters hear for the first time that there is a Libertarian Party. After supercilious LPC Excom members voted to cancel Copeland's endorsement because of a spitting incident with an L.A. talk show host who forced him off the air and dissed him as he was leaving, the condemned act attracted numerous mentions of Copeland along with "Libertarian". And later the party's endorsement withdrawal attracted still more and helped to save face. - apparently somewhat of a bad-cop/good-cop publicity pattern or maybe more akin to "man bites dog"?.

On Sept. 13th, Joe Dehn reported "Looks like editors everywhere liked that AP story. A two-paragraph version of it was in the Palo Alto Daily News today, on page 3. It was also heard on KCBS radio today (SF Bay Area all-news station)." And later that day San Mateo LP Chair Jack Hickey said "It also hit page 19A of the Murky News. They at least provided Gary's rationale for the unfortunate incident." And on Sept. 15th, Hickey reported "Gary Copeland made Channel 7 (ABC) morning news. Great picture! I'll vote for him."

UMPHRESS GETS LP GREAT COVERAGE

Discussed In Metroactive Column Titled "Reefer Madness"

In a move that proves the ancient grunge proverb, "Just because you're paranoid doesn't mean that they're not after you," the federal Drug Enforcement Administration descended upon Santa Cruz's model medical pot farm in a pre-Sept. 11 surprise raid that slaps the face of Cali's voter-approved 1996 ballot measure, Prop. 215 allowing for the use of medical pot. Last week's harvest-season bust decimated the annual supply of the club, affecting mostly people diagnosed with terminal, multipain and multisymptom illnesses like cancer and AIDS, who make up about 80 percent of the membership-based organization Wo/Men's Alliance for Medical Marijuana (WAMM). (See MetroNews story, page 8.) Representing an alternate take, DEA agents arrested 130 huge pot plants approaching full bloom, farm executive director VALERIE CORRAL and her partner, MICHAEL. The next day, a small but critical mass of protesters took

their "DEA Go Away" and other pro-pot-prescription signs to One First Street in downtown SJ to present their opinions in front of the building that houses local drug enforcement officials. The protest was thrown by the pro-medic-pot grassroots Safe Access Now campaign and organized by DENNIS UMPHRESS, a Libertarian candidate running for the San Jose congressional seat held by Dem ZOE LOFGREN. While it's hard to take a Libertarian seriously when he or she talks about tweaking laws--since the party is supposedly about getting rid of government--Umphress made an effective (though perhaps a wee bit off topic) point when he railed against the huge sentences that cause some pot possessors to stay in prison longer than some rapists and murderers.

Asked about the Humanists, Hiram said it's a national organization that tends to have sophisticated people who are often Unitarian or nonreligious and look for humans to solve their own problems without looking to a higher power. He believes many are naturally libertarian in their thinking and would be good prospects to recruit into the LP. He said he believes there may be another Humanist group in San Jose. registered Libertarian, will become the third Libertarian on the 5 person board after she is sworn in the first week of December. She won her race because after the filing period for the November 2002 election closed in August, only 2 candidates had filed for the three positions that were up for election.

Therefore, Ms. Hylkema won by default. Board member James Clark-Moore, a non-Libertarian, was reelected. The GCRCD Board of Directors has the option of asking the Santa Clara County Board of Supervisors to appoint someone to fill the remaining board position.

Ms. Hylkema was recruited as part of a statewide project to run Libertarians for local, nonpartisan offices. By running for and winning these offices, the LPC hopes to develop a group of elected officials who will later be able to run for higher level offices such as County Supervisor and State Assembly.

The Guadalupe-Coyote Resource Conservation District includes most of the mountainous land in Santa Clara County.

The current OPH booths at community events are definitely a good start. But alone they are far from enough to be the mainstay growth process for attaining the registration numbers our party needs to get Libertarians elected to real power positions - positions reserved for partisan elections - in a winner take all political system. Not only are they limited to the specific dates of community events, but they display no poster ads nor hand out literature asking for LP registrations to those who don't happen to stop to take the quiz , and thus don't influence passers-by who are in the aforementioned 17%, like the COAP program would.
