* ----- State Board Members ----- *

There are currently no declared candidates for the State party board of directors. If no one is elected to these positions at the State Convention, the formal operations of the party will have to cease. Your participation is urgently needed. The positions are Chair, Communications (media contact, education), Finance (fundraising, bookkeeping), Campaigns, and Membership (membership drives, affiliate organizations). The new board's major responsibilities will be preparation for the 1988 general elections, including support of the presidential race.

* ----- Amendment 4 Revisited ----- *

The CLP joined a coalition of Amendment 4 supporters to hold a large press conference in the State Capitol press room on April 15th to protest the 22 percent increase in personal state income taxes and the overall 17 percent increase in taxes expected in 1987. The coalition, composed of Colorado Union of Taxpayers, CLP, Association of Colorado Taxpayers, Colorado Conservative Union, and Coloradans for Free Enterprise, announced its intention to put Amendment 4 back on the 1988 ballot. This initiative would require voter approval of any new tax or tax increase.

* ----- Don't Like the new Seat Belt Law? ----- *

The Freedom First in Colorado PAC is planning to put an initiative on the 1988 general election ballot to repeal the new seat belt law. Both Massachusetts and Nebraska have already repealed their seat belt laws through the same process. Call Cliff Rhead at 420-3096 for details. We will need petitioners to get 70,000 signatures.

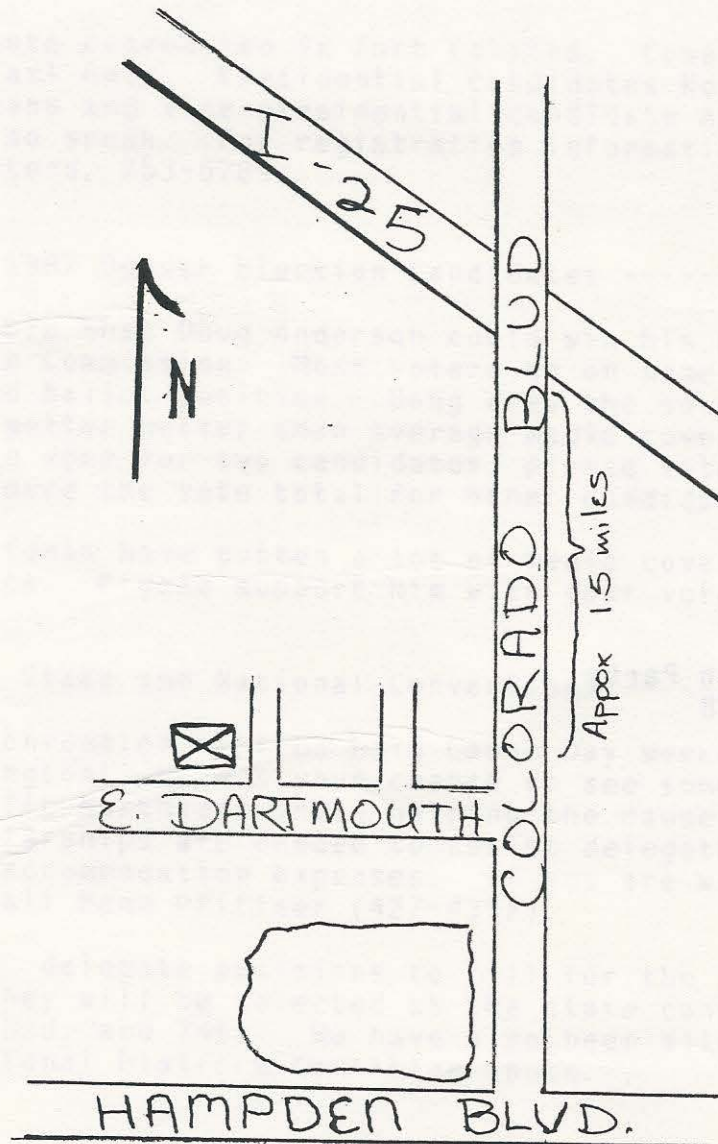
