### SUNNYVALE GROUP FIGHTING RDA EMINENT DOMAIN ASKS LPSCC EXCOM FOR HELP

The highlight of the our February LPSCC Excom meeting on Feb. 1 at the Rosegarden Library meeting room was a visit by leaders of the Sunnyvale group "Friends of Sunnyvale" asking for help in their petition drive to put a charter amendment on the ballot that would prohibit the Redevelopment Agency from using eminent domain to force private owners off their property to sell it to other private parties (usually developers or major

After approval of the January meeting minutes and an officer report by Treasurer Jon Hugdahl that he'd received an unsigned \$700 check from the LPC in partial payment of the amount the LPC is in arrears due to missed payments by the national LP, and discussion about creating a new resolution concerning the Iraq issue

#### Libertarians are looking for a state to take over

Plans are under way for an invasion of New Hampshire. Or Wyoming. Or maybe Delaware, Montana or Alaska. Sparsely populated and independent in spirit, they're all attractive targets for a bloodless coup.

Within the next several years, according to the plan, 20,000 Libertarians would move to a single state and begin infiltrating. They'd get jobs, join civic groups, get elected and take a hatchet to taxes and laws. In this utopia called the Free State Project, schools would be severed from the state, gun-control laws abolished, drugs legalized, health and social services privatized, most federal aid rejected. Government's only job would be to protect against `force and fraud.`The libertarian movement has existed for decades and produced leading intellectuals and Nobel Prize winners, but despite all that it hasn't had much influence on a national level," said Free State Project founder Jason Sorens. `I think it's time we concentrate our resources in a place where we have a shot at actually winning.'

A Libertarian since his teenage years in Houston, Sorens, 26, floated his idea in a July 2001 article in the online journal Libertarian Enterprise. Libertarians around the country began pledging to move -- 2,600 of them so far. Once the figure reaches 5,000, participants vote on their state of choice from a list of 10, selected because they have fewer than 1.5 million residents (easier to sway elections), a promising job market, a culture deemed `pro-liberty' and low reliance on federal aid.

Once 20,000 have signed on -- Sorens expects this by about 2005 -- the migration begins. By 2010, Sorens said, the group should be ready to start influencing policy, first as ``foot soldiers'' to the Libertarians already living in the state and then by running for local and state office. The next goal is to gain control of the state legislature.

You members have elected me to be responsible for party publicity as your Publicity Chair. Now I ask you members to help me do the job by supporting what I believe will be a very cost effective way to get our message to the public · a FREEDOM WAGON. The FREEDOM WAGON · a box truck with a potent message like the one pictured · could be a tangible means of bringing our message to thousands of "small I" libertarians · polls say it's 1 of 6 members of the public · who presently don't know that the Libertarian Party represents their beliefs.



Where and how would they see it? There are positions along busy surface roads all over the county at which such a messaged truck could be parked by volunteers living nearby. And by lining up 52 volunteers living near such visible high traffic locations, each would need to put the truck at a select spot for just one week, and pass it to the next volunteer for the following week. If the truck must be moved a few blocks daily (or maybe bi-daily) to conform to city ordinances, truck-home/home-truck transportation could be by means of a light bike or motor-

#### LIEBERMAN GETS RENT CONTROL DEBATE ON AGENDA

As reported in the January issue of the SCL, LPSCC member Scott Lieberman is now Chair of the San Jose Advisory Commission on Rents. He says this position has enabled him to set up a debate on the pros and cons of rent control. He said, "I was able to set some of the agenda for our retreat. The debate between pro-rent control and anti-rent control experts was my idea. The debate, from 12:30pm to 2pm, on March 1 is open to the public. If you want to see what one appointed Libertarian can accomplish, you are welcome to attend the debate."

The debate, was scheduled to take place at Hayes Conference Center, 200 Edenvale Avenue, San Jose after a morning meeting session between Edward Stringham, Department of Economics and Janet Smith-Heimer, Managing Principal, Bay Area Economics. As it occurs in March the event will be reported in next month's issue of the SCL. Hopefully it will cause the negatives associated with distortion of free markets to become clear to more people.

motorists driving through would see little sky except directly ahead and overhead, the plan has been nicknamed by opponents, "Mathilda Canyon". Hirsch, who has a business in downtown Sunnyvale that would be displaced or eliminated by the development said the city had a "stakeholder" meeting and came up with a high density plan, but that two thirds of the "stakeholders weren't residents, but were developers. The density is comparable to that of one of the World Trade Center towers in density. His group has two members who are architects who have proposed a plan that would be less dense and more people friendly in terms of open space and amenities, but the city wouldn't consider them. So the F of S has submitted 3 separate charter initiatives that if passed by the electorate would:

- 1. Make private-to-private eminent domain transfer illegal without voter approval.
- 2. Require that no RDA plan be adopted without voter approval.
- 3. Require voter approval of any building over 46 feet high.

Jon Hugdahl, and other Excom members said they didn't think the third initiative is something we could support, but that the first two are very consistent with our resolution opposing eminent domain to transfer property from one private party to another that was prompted by the Tropicana fight in San Jose.

The discussion then went to how many petition signatures were needed and before what date. When Hirsch and Johnson said they'd been gathering signatures for 4 months

and still needed about 4 thousand signatures within a month, your reporter said that we probably couldn't make much of a dent in that size of requirement in such a short time, but that this initiative would be ideal for our COAP program if we could gather signatures over a 6 month period. I asked if it would be possible to recycle the project if they were unable to get enough signatures on the present program, but undoubtedly because they didn't want to contemplate the possibility of failure of the present drive, they weren't willing to give that any thought. Wanting to do the best we could for them, Zander Collier and Mike Laursen offered to help by phoning Libertarians to ask them to help gather signatures.

I'll get it started and develop the method of use and make a video to train volunteers, and will call as many of the 5000 registered Libertarians in Santa Clara County as necessary to line up the 52 weekly Freedom Wagon custodians. But not unless some of you folks say you like the idea, some say you'll help me find the most visible sites at which to park it, some will volunteer to be custodian for a week, and some say you're willing to donate toward it's cost · (which I estimate should average about \$250 per month for purchase amortization, insurance, maintenance and gas).

Not only can the Freedom Wagon provide an inexpensive mobile billboard for advertising, but it will be versatile enough to allow quick and easy vinyl-wrap sign changes, store fixtures and handout literature to eliminate our present \$75/mo storage rental, act as a bus for outreach events, give us a highly visible presence in parades, use speakers blaring our message in selected districts during election season

We Libertarians sat in on just the late afternoon of the all day convention. The first speaker we heard was an elderly lady who had started a minimal sized preschool in her home in Walnut Creek in the early 50's that had mushroomed despite competition from public schools. She told how parents were willing to continue to pay for their children's schooling with her when they entered first grade, causing a natural progressive growth into a substantial private school that continues to this day, carried on by her daughter. She was very knowledgeable about dealing with state laws that regulate private schools, and advised attendees how to influence and lobby legislators on programs that pay for disadvantaged children to attend private schools.

Chris Cardiff, former head of CHN, and presently a home school lobbyist, described what practical steps can be taken now to withstand the attacks on home schoolers by the California teachers unions and the office of the state Superintendent of Schools. He said that fortunately they are occupied with staving off voucher advocates and government "challenger" schools, etc., to concentrate on harassing home schoolers. To put further pressure on the dreaded California Teachers Association (CTA) he advocated pushing "Paycheck Protection" a strange sounding term which turned out to mean protecting teachers against paying for union political activities against their will.

Dr. Alan Bonsteel, who heads school voucher advocacy organization, California Parents for Educational Choice, also said emphatically that the best opportunity to counter the CTA is to push for a Paycheck Protection law which would mandate allowing teachers to withhold their dues used by the union for political donations and support.

In the late afternoon, there was a Q and A session, during which Allen Rice invited locals to attend the San Jose Union School District's Measure F Citizens Bond Oversight Committee

on which he serves and help hold the school board to what the bond proposal promised to do. Toward the end of the Q & A session, host Robert Arne took the mic, turned to our 3-man Libertarian contingent, thanked us for attending, and asked for our comments. Your reporter said he hadn't heard the word "freedom" used when speakers and audience discussed how to persuade the public to support home and private schooling as good public policy. As a Libertarian, I said, I see their cause and the problems they face as a "freedom issue", and suggested they could engender more sympathy from the citizenry by describing it that way. Zander Collier told how he'd become active in the Libertarian Party and that he'd propose putting paycheck protection for teachers union members into the California Libertarian Party's Program when he would be serving on the program committee at the upcoming state convention in two weeks.



Dennis Umphress Gets Bray Award

"The first Karl J. Bray Memorial Award for Activism was presented at our 1980 state convention, and it has been the Libertarian Party of California's premier activist award ever since. Karl Bray was a charismatic libertarian leader and tax rebel who died of cancer in 1978. He was one of the founders of the National LP, and he served as an early member of the Libertarian National Committee. A year after Karl's death, one of his good friends and admirers, past LPC state chair Bruce Lagasse, established this award in his honor. The award is designed to honor effort "above and beyond the call of duty" during the previous year. It is designed to recognize the unsung hero . . . the activist working in the shadows, rarely -- if ever -- in the limelight . . . who, because of his or her self-initiated actions, significantly advanced the goals of the Libertarian Party of California during the past year. Recipients must be chosen unanimously, and therefore the award is not made every year; however, because the award is not competitive in nature, but rather is based on individual merit, some years have seen multiple recipients as you can tell from looking at the list of past recipients on your table.

I'm pleased to announce that this year we do have a recipient.

This year's recipient must have tremendous energy, because all of the people supporting his nomination were amazed at the variety of tasks he was able to perform.

He served as campaign chair for his county party -- recruiting and supporting candidates for both partisan and nonpartisan office.

He was active in the mailing to collect signatures for partisan candidates, and he organized several candidate workshops -- providing candidates with practice for appearing at public candidate forums.

He kept a watch on the various measures being placed on the ballot by local municipalities and school districts, providing timely warning and assistance in composing and delivering ballot arguments.

He also participated heavily in the party's Operation Politically Homeless program and in the petitioning for signatures for a local ballot measure.

He organized the Northern California Libertarian group for cooperation and coordination of LP activities in Northern California and managed several Yahoo groups for the state and county parties.

He also found time to run a low budget but active campaign for congress, and as a candidate he gave speeches, appeared on the radio, and at candidate forums. He carried his candidacy to a new level by appearing with and joining groups like the local taxpayers association and working tirelessly against the use of eminent domain in his city and against the enforcement of federal marijuana laws in conflict with California's medical marijuana law.

All of those who write in support of his nomination pointed out that in every issue of the regional newsletter during 2002, there was some mention of this person's activity. In the words of his nominator, "he did the work of at least three normal Libertarian activists" during 2002.

And a seconder had this to say about him: "He never lets his feathers get ruffled. He is an excellent example to all of us diehard, vehement Libertarians in how to convey our message in an inclusive way -- inclusive of those who want the same results we do, but who have vastly different ideas of how to achieve those goals."

So it is with GREAT pleasure that I present the Karl J. Bray Memorial Award for Activism for the year 2002 to an outstanding activist from Santa Clara County . . . Dennis Umphress.

# IRAQ LIBERATION WILL BE A STEP TOWARD WORLD PEACE

The idea that if we maintain an isolationist foreign policy then the rest of the world will leave us alone is wrong. Muslims hate the United States because we are the greatest country on earth and in all history, not for what we've done. For example, Israel's neighbors did not simultaneously and instantly attack Israel from all sides the day that Israel declared independence (and repeatedly thereafter as opportunity permitted) because of any Israeli foreign policy. Israel is subject to constant attacks because it is non-Islam. Many followers of Islam are at war with all non-Islamic people. They wage their war as opportunity permits.



On whether or not to invade Iraq, let me first say that we never finished the Gulf War and that we're still fighting it. The peace treaty with Iraq contained the provisions that 1) Iraq would eliminate its stockpile of Weapons of Mass Destruction (WMD's) and allow inspectors to verify compliance, and 2) the establishment

of a no-fly zone to protect local rebellions from Iraqi air attacks. Iraq kicked out the inspectors and has continued to hide and produce WMD's and Iraq constantly commits hostile actions upon coalition aircraft patrolling the no-fly zones.

It is so clearly and overwhelmingly in our interest to finish the Gulf War that I believe that people who argue that it's against our interest are not being intellectually honest. Rather, they are rationalizing to cover up an irrational pacifist bent. First, beating the Iraqi military a second time will be even easier than it was the first time. Second, a democratic Iraq will be an enormous benefit in the fight against terrorism, the weakening of Iraq's theocratic neighbors, and will pave the way for the democracy in other Muslim states in the region. Why are democracies important to

us? Because, as the adjoining box score shows, democracies don't war with other democracies.

A democratic Iraq will probably cause an even stronger "brain drain" from the neighboring theocracies than already exists between the Middle East and the West — similar to how so many people have left the Peoples Republic of China for Taiwan and Hong Kong. Intelligent, freedom loving entrepreneurs and artists leave China, and books, movies, and the ideals of capitalism and democracy filter back, in effect Westernizing the Communist behemoth. A democratic Iraq located in the center of the Middle East could, over the years, grow to dominate the entire region culturally and be as great an ally in the war on terror as Germany was in the cold war.

The arguments against toppling Saddam Hussein are usually either that there is no immediate threat or that there is no particular reason to attack Iraq as opposed to other evil regimes throughout the world. To the first objection, Iraq is our enemy whether we like it or not. If we don't act now, the potential situation is that Iraq will get stronger, and pose a bigger threat in the future. Are we going to wait around until the threat is immediate? To adopt the policy of "Be nice to Saddam and maybe he'll be nice to us" is to come from a position of weakness and fear. And lunacy.

Why is Saddam trying so hard to get WMD's? It's not to use against his neighbors because he's learned that in a post-cold war world the West will not tolerate wars of aggression. It's not to use against his own people. He has plenty of bullets and torturing chambers to use against his own people. It can only be to blackmail the west. I assume he seeks to get to the point of MAD (mutually assured destruction), where he has powerful enough weapons that he can act with immunity on the conventional battlefield.


We have a great opportunity to take a big step towards world peace, liberate the oppressed, and help secure our citizens from terrorism. Liberating Iraq is an act that will safeguard democracies in the short term and is a crucial step towards bringing about world peace in the long term. We should seize this opportunity while it presents itself.

Because our members ALL pledge to shun initiation of force, getting all Libertarians to agree against initiating a war should be a slam dunk. Right? But what if it's defense? Or not initiation but continuation because of a

broken condition to eliminate mass weapons signed by the loser of the initial encounter in exchange for the winner not continuing the initial hostilities? And what if America has declared war against terrorists hostile to it, and the aforesaid loser refuses to cooperate in apprehending anti-American terrorists, and is likely to arm with mass weapons, terrorists seeking to kill Americans? If the these what-ifs are true, especially the latter, then it's difficult for Libertarians to make a nice clean decision on Iraq. We believe in non initiation, but we also believe in defense against threats. And we believe in enforcing agreements. This difficulty apparently has created an opinion schism among our members of approximately 60% anti-disarm and 40% pro-disarm Saddam Hussein by force.

Among local leaders there is also a second question; should the LPSCC take an official position on Iraq? I think it shouldn't. I believe that like abortion, where it's impossible to get a super majority to agree on what is a "life", it appears impossible to get substantial agreement on whether or not an Iraq war is needed for defense. Maybe with detailed military intelligence information, Bush does, but we Libertarians who don't want an official position feel we don't know enough to be sure.

On the other hand, our Chair Ray Strong, feeling that the public expects a political party to have a position on such a major issue, wants to compose a resolution about Iraq that our Excom could approve. I guess if it's ambiguous it could get approval and would make for better PR than having no opinion. But I wouldn't know how to write it. As we go to press the UN "Resolutionary War" has ended, and the start of a shooting war is just hours away and the outcome may significantly alter some members' pro -war opinions if it goes terribly. But a quick minimal loss victory probably won't change any anti-war members' opinions. They see it as not only non-Libertarian initiation of force with danger of large losses and damage, but also as non-Libertarian foreign meddling - not defense, which will further inflame Muslims around the world, and cause major tax expenditures for years to come. The latter two objections would not be resolved by a quick easy victory.

In this issue's opinion pages are two members' opinions on opposite sides of the Iraq war issue. One pro by Jeff Landauer on the preceding page, and the other con by Zander Collier which follows on this page.

Zander's opinion is in the form of an anti Iraq war resolution submitted by him for an Excom vote on 1/17/03 that would empower him to deliver a speech representing the LPSCC at a peace rally in San Francisco in January. (It passed at the time with the asterisked whereas's removed - although not in time for the speech. But it's no longer operative after being subsequently rescinded under a motion by Zander at our Feb. Excom meeting, in order to clear the way for a more euphemistic resolution on the subject. But it clearly was, and possibly may still be Zander's opinion for LP-internal consideration.)

"Whereas, The Libertarian Party rejects the initiation of force in all matters: personal, economic, social, and political,

Whereas, the current administration in the White House has repeatedly stated that there is proof of duplicity on the part of the Iraqi Government - and failed to deliver said proof to the American People,

Whereas, the current administration has repeatedly stated that there is proof of a link between Al Qaeda, the September 11th Terrorist Attacks, and the Iraqi Government - and failed to deliver said proof,

(\*)Whereas, human beings are vulnerable to Goebbels' Maxim: "Tell a lie often enough from a position of power and it becomes accepted truth.",

Whereas, the War on Terrorism was the declaration of one George W. Bush, and NOT the declaration of the United States Congress as is duly prescribed by The Constitution,

Whereas, the American public has been bombarded with a propaganda campaign to scare it into giving up its rights and civil liberties guaranteed by The Constitution,

(\*)Whereas, this same propaganda campaign has also been designed to incite the American Public to warmongering rather than to a genuine civil discourse on building a safer and more respectful world community,

Whereas, the safety and stability of the world community is just as threatened by an inconsistent and capricious United States foreign policy as it is by tin pot dictators and despots,

And Whereas old politicians' decisions are young soldiers' deaths,

Be it resolved that we, the Libertarian Party of Santa Clara County do hereby condemn the unilateral initiation of force by the United States against any sovereign nation and its people."
