## Northern California Activists Meet

On Sunday, June 28, a group of Northern California libertarian activists met in the State headquarters office at 5332 College Avenue in Oakland. The purpose of the meeting, as announced by hosts Northern California Vice Chairs Martin Buerger (California Libertarian Council) and Carolyn Judd Felton (Libertarian Party of California), was "to develop a Northern California spirit of cooperation and a coherent program of activities for the coming months." Fruitful discussions were held on strengthening local organizations, finding candidates for 1982 partisan races, and fundraising.

Announced year end goals for Northern California include (1) completion of precinct analysis to identify target precincts for 1982 races, (2) identification of at least 80 percent of our 1982 candidates, (3) development of a statewide slate, (4) setting of goals and budget for 1982, and (5) development of a schedule of training sessions for candidates and campaign managers.

Subsequent meetings are planned including one scheduled for the end of September.

# Is Sennholz's "Age of Inflation" Upon Us?

"Our generation is pursuing 'free lunch' money with greater fervor than ever before. For the first time in the history of the world, inflation is engulfing the whole globe. The only difference between the various countries is the rate of inflation at which governments depreciate their currencies. Some are inflating at single-digit rates which makes their currencies relatively 'strong.' Others are inflating at double and triple-digit rates, which makes for 'weaker' currencies. And all are making international payments in stronger currencies, especially United States dollars, which are depreciating at even faster rates. Like a herd of stampeding cattle approaching a gully, the world is rushing toward monetary collapse."

The preceding was excerpted from *Age of Inflation*, written by Hans F. Sennholz, a noted free-market writer and student of laissez-faire, Austrian economics. I have read Mr. Sennholz's book and completely agree with his viewpoint. We are most definitely going to have another depression, probably much worse than the Great Depression of the 1930s because of the larger degree of government intrusion in the economy. The only question I have is whether or not our government will "hyperinflate" or mass-produce the money supply. The political consequences of stopping the current inflation we are experiencing are

very harsh and stopping an inflationary spiral at this late stage is unprecedented in history, which tends to make me believe that we are headed for hyper-inflation similar to the one Germany went through in 1920-1923 in which the German Mark was devalued to *one-billionth* of its previous value and became virtually worthless.

What can you do to prepare for this hyper-inflation/depression scenario? First, convince yourself that it really is possible.... Read your local newspaper, read books about the subject (see suggested reading list below), talk to other individuals who are free-market oriented, improve your health and diet (stress is going to be one of our biggest problems), and finally, use your newly

gained knowledge to improve your family's and your friends' chances of getting through the difficult years ahead because we will need intelligent, libertarian people to lead the way after government has lost its ability to lead. The failure of governments throughout history has led to totalitarian dictators ruling their respective countries by force rather than wisdom. Hitler, Mussolini, and Stalin are prime examples.

To quote Hans Sennholz once more, "To disrupt a highly developed division-of-labor economy such as ours must have dire consequences. You can reduce the speed of a donkey cart witout much loss of distance traveled, but if you slow the forward thrust of a jet plane you'll lose many miles in a matter of minutes. When the American economy slows down and our standard of living falls substantially, the psychological and sociological effects could be disastrous. In the demoralizing atmosphere of the transfer state, millions of Americans have grown accustomed to free government services and benefits. They are demanding the maximum of welfare from the community, giving little or nothing in return. Labor unions are making insatiable wage demands for a minimum of productivity. How will the American people take to depression and deterioration with shrinking wages and benefits?

"The reaction may be militant and violent. Guided by doctrines of conflict and convinced of their inalienable rights of government care and egalitarian redistribution, they may insist on their rights. After all, our transfer politicians, parties, and intellectuals have

for forty years convinced them of the social justice of their claims. Are these now to be abrogated in the face of economic adversity? Moreover, their collective organizations wield the necessary political power to extract their due share from the body politic. But if this body should fail to yield the expected benefits, will the millions of beneficiaries peacefully suffer the welfare cuts? Will the labor unions peacefully consent to wage cuts? If they do not, our redistributive society may be torn asunder by civil conflict and strife. Business establishments may be looted, our cities burned, and law and order may give way to violent disorder. Since the first redistributive measure, several decades ago, this has been the ultimate destination of the Redistributive State.

"Finally, economic and social deterioration of such major magnitude strengthens the call for law and order. When society can no longer cooperate voluntarily and peacefully, the raw power of the State will be used to enforce some measure of cooperation. Vast emergency power will be thrust on the President, who will be expected to restore civil order. For this grim task the most ruthless politician is likely to rise to the top [Teddy Kennedy?], surrounded by the most ruthless advisors and lieutenants. They will eagerly crush all dissent and bring peace to the society so bent on strife and self-destruction. They'll bring the peace that is totally inimical to individual enterprise and personal freedom."

Not a very pleasant scenario, but hard to refute. Please do your homework and do what you can to make America once again free.

### Forum

The following letters by local libertarians appeared in recent issues of the San Jose Mercury-News.

#### Tax burden is borne by individuals

The UPI article, featured on your front page of June 6, under the headline "Big oil firms" U.S. income tax for 1979 averaged 12.4 percent," requires much more explanation than the factually correct but nonetheless misleading article provides.

The above headline implies that oil companies are not paying their fair share of taxes and the article itself states that their average U.S. tax rate was about the same as a wage earner making \$15,000-\$20,000 annually. The point that I wish to make is not whether oil companies are being taxed fairly, but that there is no such thing as a tax on business, fair or otherwise.

All taxes on business are part of the cost of doing business, and a business which does not recover all its costs as part of its prices is not going to stay in business very long. Thus, an overt tax on business is a hidden tax—a favorite of politicians—on the ultimate consumer. A business is merely an involuntary tax collector and it matters not whether it is taxed at a 12.4 percent rate or whatever because the tax is paid, knowingly ur unknowingly, by the customers of that business.

An indication of the tax burden borne by the taxpayers—mostly wage earners—can be gleaned from the fact that every single dollar of taxes is paid by roughly 100 million working Americans. This means that every wage earner pays more than \$6,000 per year in federal taxes alone instead of the \$2,500 or thereabouts which shows up on his Form 1040.

Universal standard may have a nice ring to it, but it flies in the face of reality. In reality, different standards are appropriate for different people in different situations. People should have the right to choose.

Of course, banks may not want to lend money for some structures, insurance companies may not want to insure them, and land owners might put protective covenants on their own property. That's their business. These are natural controls, not repressive edicts.

In case it hasn't crossed your regulation-infatuated minds, safety and quality are relative terms. Something can always be made safer or more luxurious at some cost, excluding consumers along the way. Likewise, extra care and some improvising can be substituted for a given margin of quality and safety until we get to things that are necessarily unsafe.

In addition to the building code reforms you denounce, there are many other building innovations and creative improvisations that would make housing affordable to even the below-average wage earner. Why don't you pick up some of those homesteading-type magazines and see how low-income people make do when no one's foot is on their throat?

How smug it is for you to declare which amenities of housing you think are necessities when so many cannot even obtain the basics in housing.

One statement in your editorial, though, perfectly highlights your inability to take positions based on how the real world works. "Concern for safe, durable homes clearly must come before questions of cost and social inconvenience." So now we're supposed to have concern for the home's well being.

You see, when I took economics, there was this thing called supply and demand that made sure there was more of whatever people wanted to buy. And if someone messed with it, people started doing without. I seem to remember costs were very important in this process.

Why should the house dictate that buyers must have a \$34,000-plus income? People's income should be allowed to determine the type of housing that's built.

So here 95 percent of the new housing market sits; costed out and socially inconvenienced and to you that's too bad.

Owning your own home of some kind is a large part of the American Dream. It is not a privilege to be ladled out by government planners to ensure an exclusive landed gentry.
