# What is Obama ashamed of?

WASHINGTON – On March 11 America's third largest party asked why President Obama enacted the \$490 billion FY09 omnibus spending and its over 8,500 earmarks behind closed doors, and despite campaign promises to end earmark abuse.

"President Obama's decision to hide from the media while signing this bill isn't just a violation of his promise of transparency, it's an attempt to avoid questions about breaking another promise to end earmark abuse," said Libertarian National Committee Communications Director Donny Ferguson.

"He promised to end earmarks. He promised transparency. He promised fiscal responsibility. He didn't mean a word of it. More and more Americans realize his crippling taxes and crushing debt are prescriptions for prolonged economic suffering. Now he has to hide behind closed doors to sign his pork-stuffed plan to explode wasteful spending," said Ferguson.

Libertarians support an economic renewal plan centered on tax and regulatory relief for employers, preserving the 2001 and 2003 tax cuts that blunted previous recessions and greatly simplifying the tax code for employers and taxpayers. Polls such as Rasmussen show voters prefer the Libertarian approach over the Republican and Democrat plans to increase government spending.

### Sundwall to debate Republican, Democrat

TROY, N.Y. -- Eric Sundwall, the Libertarian nominee for U.S. House in the March 31 special election to replace New York Senator Kirsten Gillibrand, will debate Republican nominee State Assembly Minority Leader Jim Tedisco and Democrat nominee Scott Murphy.

"We're very happy to be included in the process. Obviously, it will depend on whether or not we are challenged for our petition signatures. If the democratic process is allowed to play out, we expect to offer the voters a distinct voice and choice," said Sundwall.

The forum, sponsored by the League of Women Voters, will take place at the Holiday Inn Express in Latham, N.Y. at 7 p.m. and will be moderated by WROW's Sherman Baldwin.

The forum gives Sundwall an opportunity to share Libertarian policies with not only the voters of the 20th congressional district, but to a national audience as well with the election attracting attention from observers around the country.

### Still time to file for office in N.J., Va.

RICHMOND, VA & TRENTON, N.J. — In New Jersey and Virginia, it's always an election year. Unlike other states, they hold state legislative elections in odd-numbered years, and there is still time to file.

Libertarians hoping to run for Virginia's House of Delegates have until June 9 to turn in the required form and 125 valid signatures from registered voters in the district. No State Senate seats are up for election in 2009.

Libertarians looking to run for New Jersey's General Assembly or Senate must turn in 100 signatures by June 2.

### Sundwall collects 7,000 signatures

**SCHENECTADY, N.Y.** - Libertarian Eric Sundwall has more than twice the signatures needed to get on the ballot, his campaign told *The Schenectady Gazette* March 6.

"To finish a petition drive is a good feeling," Sundwall told the *Gazette's* Lee Coleman. "It's the first time I have been home at this time [in the evening] in two weeks."

Sundwall, an information technology consultant and chairman of the state Libertarian Party, submitted more than 7,000 signatures to election officials March 9.

John Norris, a spokesman for Sundwall, said Sundwall has more than enough valid signatures to qualify for the March 31 special U.S. House election to replace newly confirmed New York Senator Kirsten Gillibrand in the 20th House District.

"The only issue is how many GOP attorneys will attack us this time," Norris said. Sundwall ran for Congress in 2006 against Kirsten Gillibrand and then-incumbent John Sweeney, but was prevented from getting on the ballot after election lawyers from the Republican Party scoured his list for errors.

Sundwall needs 3,500 valid signatures to qualify for the ballot. He hopes submitting 7,000 will overcome expected legal obstacles thrown up by opponents.

## White House: Focus on Limbaugh was 'counterproductive'

WASHINGTON -- The White House on Wednesday admitted that their public comments about conservative radio personality Rush Limbaugh and cable news personalities in recent days has been "counterproductive."

White House press secretary Robert Gibbs said that he has been guilty of "feeding" a public debate about the Obama administration's economic agenda that both the president and his top officials, as well as Mr. Gibbs himself, have been dismissive of.

Both President Obama and Mr. Gibbs on Wednesday derided what they have come regularly to refer to as "cable chatter."

"I certainly criticize it, and I even occasionally watch it," Mr. Gibb said. "I certainly believe that feeding it, undoubtedly, I'll plead guilty to counterproductivity."...

...The Libertarian Party also criticized the White House for their focus on Mr. Limbaugh, who has said he wants Mr. Obama's economic policies to fail.

"With polls showing more and more Americans oppose his agenda, Barack Obama needs a distraction. He gets it by having his operatives pick a fight with a colorful radio personality," said Libertarian National Committee Spokesman Donny Ferguson.
