


This summer, Libertarians

Michael Badnarik, LP Presidential candidate, has maintained that here in America, the whole country is a free speech zone. On Aug. 31, during the Republican Party convention, Badnarik debated his Green Party counterpart, David Cobb, right there in New York; the debate was covered by C-SPAN.


The Free Emergence

One of the most inspirational speakers was LPC's Judge Jim Gray, who spoke on general freedom and Libertarian issues. My other favorite speaker was Vernice Kuglin, the courageous FedEx pilot who defeated the IRS and so-called "Justice" Department in a criminal trial. She won because she was well prepared by her attorney, Larry Becraft, and she was able to ask the question, "Where is the Law making me Liable?" Evidently the IRS witnesses could not or would not answer that simple question. I have been asking that question myself for over ten years and I have not received an answer either!

In my opinion, the Income Tax is a hot issue for us as Libertarians. Our platform calls for its abolition, but most of our candidates are not as knowledgeable as they could be on this issue. I would be happy to share my knowledge on this subject.

I have been a non-filer for 29 years, and I am still walking around on the right side of the Graybar Hotel. Most people know that there is something wrong with the Income Tax but are too frightened or knowledge-poor to

I don't mean emotionally or mentally, although I suspect that even these have happened. Usually it's just a matter of him or her finally having to make a choice between activism and living. That's a shame. After all, what's activism if you don't get to live the benefits?

Which raises the killer question: When do we get the libertarian society we envision? There appear to be two unhappy answers.

First: No time soon! Most cannot agree that we will get anyone elected to partisan office within the next election (or decade or century). It may seem I'm exaggerating, but just ask someone, "When?" and see if you don't get the dull, blank look I've been seeing.

Second: We don't really see it at all! Not that we can't imagine it, but that we spend so much time

looking at what's wrong, we forget to keep our eye on the goal. It's easy to understand. Who can smile and speak from a warm and fuzzy place about how wonderful our society will be with real education occurring in our children, without snapping off into a snit about government-con-

trolled indoctrination centers? Why, just this election cycle alone, those very abominations are trying to suck away another \$885 million of ours (plus interest!), just in Santa Clara County alone, to pay for various boondongles which still won't fulfill our children's needs.

hile presenting a report on my activities to the Executive Committee of the local LP of Santa Clara County, it dawned on me how significant is the amount of time, money, and energy which a number of dedicated people put into publishing our newsletter each month.

As Chair of the Newsletter Committee, I thought it appropriate to document that process, and to say a word or two of thanks to the many people that make this enterprise a success.

The lion's share of the responsibility for Santa Clara Mark Hinkle



Libertarian goes to our editor extraordinaire: Elizabeth C. Brierly. Not only does Elizabeth serve as editor of our newsletter, but she's also the one responsible for obtaining articles, photos, and announcements from our candidates and activists, and failing that, covering events herself and writing much of the material. And she manages to squeeze all this in, while simultaneously serving as editor of California Freedom. Amazing!

Once the newsletter is laid out, nearly ready to print, Elizabeth sends it to me to proofread. If any corrections are needed, they're quickly updated and then it's off to the printer, Internet style.

Elizabeth creates a PDF document (thanks to Mike Laursen of Adobe for the software) and

transmits it via FTP ("file transfer protocol," for you non-nerds among us) to Jascha Lee, who lives in Santa Cruz County. Once it's in his hands, Jascha prints the newsletter; downloads the latest updates to the membership database; prints address labels; prepares the post office paperwork; and then delivers the entire package to VTF Services in Mountain

VTF Services is a nonprofit firm which in Dec., 2003 was the second to be named Mountain View's "business of the month" for its service to its city. The nonprofit, which receives no additional funding from the government, began as Veterans' Task Force in 1968. Its vocational program gave disabled veterans new skills and a new purpose, and now offers job opportunities to "anybody who has trouble getting and keeping jobs," explains Susan Hamilton, executive director. We libertarians sure like to see and reward this type of private enterprise/charity instead of those relying on yet another government (a.k.a. taxpayer) handout. VTF provides all kinds of manual services, such as assembling gift baskets for pet owners and cleaning machine parts for an aerospace company. But for LPSCC, they assemble our newsletter and prepare it for the post office (ZIP code order, etc.).

Hiram and Arden Pierce, who live in Palo Alto, collect the assembled newsletters from VTF and

Whew!

The problem is, too many of us are too angry-secretly, if not overtly-about the way things are. We look around our perfectionist selves at a world that shoves rules and laws upon us by the ton while the very people imposing those rules and laws too often ignore them in their own lives.

For example, we staffed a booth at the Mountain View Art & Wine Festival this year. Adjacent to us on Saturday were the two factions of the MegaParty. Both violated the major rules: stay in your designated area, and no funds shall be solicited for any purpose whatsoever. We, meanwhile, the truly good and moral people that we are, refused to break the rules.

I wondered: Is this what moves a person to become a Libertarian? Do we so respect people and laws that our only recourse to aggression and law-breaking is to remove enough of those laws so we can breathe again? Because we obey where others don't, and so we must remove laws that others simply ignore?

I wondered: Is this why so many Libertarians are in such a bad mood? Is trying to live an ethical life, as perfectly righteous a life as possible, bad for one's emotional and mental health in a world where the law-givers are also the worst law-breakers?

I wondered: Is this bad mood, inarticulate and possibly only subliminal, the reason we eat our own young? Can it be that we unthinkingly direct our frustration at only the handy target of our own kind, they being the only ones we can challenge against inadequate performance?

Are we ourselves the only ones any of us still expect to do the right thing? So that when we see ourselves not being perfectly perfect, we turn on each other?

We don't have any serious enemies "out there" yet. A few liars who misrepresent us, certainly, but they could not get away with that if we didn't always look so bloodied from infighting and factionalism.

But it's not as bad is it could be. Locally, it's a lot better. We've been finding better ways to cooperate, and we're communicating at a higher level than usual.

So if the real reason you stopped being so active was that you tired of criticism and back-biting, I implore you to call me. Give me a chance to help you talk it out, and to protect you from it recurring.

We're in this mess together. And we're not getting out of it by each of us in turn "doing a John Galt" (dropping out, à la Atlas Shrugged). We're going to change the world only through a concerted effort. That means, playing together with the cooperation and precision of a symphony.

I know it's possible. All each of us has to do is accept a part, take a little coordinating direction, and seek joy in a job done well enough.

We can do this. Ask me for my help. It's what the Chair is for.
