Reforming health care!

Which is it going to be, "the Clinton Plan", the "Cooper Plan", or one of the Congressional clones of them? Make no mistake about it, health care is in a crisis, so we are going to get stuck with something. Too bad we cannot get major media attention for the "Libertarian Plan". (My own boiler-plate free version)

Unlike the centralized state shell games of who's going to pay for business as usual, the Libertarian Plan focuses on <u>alternatives</u> to the priest-like professional, public and private.

Alternative Providers of Present Care-It is assumed that medical doctors are the best source of what we get now. This is not necessarily so. The arduous process of becoming an MD, including the superfluous undergraduate degree, is designed more for exclusivity than excellence

The Office of Technology Assessment concluded that nurse practitioners make more accurate diagnoses than physicians. Physician assistants have to work under MDs even though they do the work. Usually pharmacists can write a better prescription than your doctor - and at one time they did. Instrument salesmen have surreptitiously rushed in and saved lives when surgeons bungled operations. You get the idea? It's the specific training and experience, not simply being anointed by the AMA, that results in quality, consumer driven medical care. It is patients who should evaluate someone's medical qualifications.

Alternatives to Established Methods and Orthodoxys At the time the allotropes were given monopoly authority by the state to exclude alternative healing philosophies, they were still practicing blood-letting. Yet they have been largely successful in brainwashing the public in believing all other schools of thought are "snake-oil". Sometimes MDs are allowed to branch out into some of these areas. A few of us aren't too sure it's all snake oil, especially those who remember that before 1980 the gatekeeper for cancer research, the American Cancer Society, believed diet played no significant role in cancer.

Homeopathy, Osteopathy, Acupuncture and many immune stimulating systems are not entirely promoted by quacks. They are however, competitive schools of thought that will stand or fall on their merits. Sometimes it is just a "miracle" substance that is kept from consideration by individuals. The theocracy of professionals has no interest in treating patients as customers.

The FSA, ANA, insurance companies, drug companies with lucrative patents to defend, privileged research institutes, pompous, greedy MDs, and the hospital "temples" that ties them all together make up a cabal which cannot be challenged piecemeal by individuals. (Health con't from page 1) cannot be challenged piecemeal by individuals. There are economies of scale in researching alternatives, negotiating and contracting, along with actually providing the care for yourself.

Alternatives to Institutional Contexts - The solution to the above is to change from the hyper-individualistic model. The ideal situation would be for intentional communities to simply hire their doctors and nurses directly. Intentional communities could cooperate in building their own clinics. They could also make sure their caregivers have similar philosophies as to alternative methods. An association of communities could effectively lobby for changes

So there is my Libertarian Plan to replace the Clinton Plan. It is based on elimination of privileges and active cooperation as opposed to trusting in the omnipotence of government.

The Meaning of Life by Lloyd Licher

Part of understanding human life and its meaning involves knowing human nature as well as we can and seeing how it operates in the societies that have developed. We have become a very interdependent people, with a division of labor that has essentially eliminated the self-sufficient person, one who produces all of his own food and makes his own clothes and shelter. As such we "need" each other in many life supporting ways, hence we act, out of self-interest, so as to enhance these relationships, and thus our lives. Practical moralities result, such as the Golden Rule: do not do to others what you would not have them do to you Having total respect for the property (life and its derivatives) of others has the effect of minimizing conflict and maximizing the well-being of everyone. No faith in a mystical being or obedience to a set of rules because some authority figure commands it is needed. Instead there is reliance on the self as an autonomous, rational being with keen senses capable of perceiving reality, and a mind that can integrate that knowledge to understand how to act to best realize the happiness and well-being of that self.

As an interdependent species, man has developed what is termed the marketplace, the total of all daily economic transactions. In the marketplace each person voluntarily trades with others, to their mutual satisfaction, each benefiting from the transaction, whether it be time for money, money for things or service, or perhaps for some intangible psychic gain. Value is subjective and can be determined for each individual only by that individual. With the development of tools and machines and the division of labor people are able to produce more than they consume and use up, hence there is a constantly expanding total of wealth created, resulting in higher living standards for everyone. Another facet of human nature is involved here because the amount of effort people put into production is affected by the degree of control they have over what they produce. Unfortunately, a social institution known as political government has developed to the point where it taxes away 30% or more of what people produce. Although nearly all of individual's lives are governed by themselves very peacefully and productively through other, voluntary social institutions. such as the family, businesses and associations, coercive political governments were allowed to become entrenched until now they have arrogated to themselves virtual monopolies on certain functions of societal life. These functions include systems of so-called justice and protection, schools, roads, mail delivery, and fire fighting. Most people have been brainwashed in tax-supported public schools into believing that these are sacred cows, such that only political government can provide them. Thinking people can see, however, that all of them could be more efficiently provided by the marketplace on a voluntary, user-fee basis, as has been demonstrated for many of the functions. In recent decades agents of political government have gone far beyond providing "essential" functions to set up huge social security" and welfare programs, redistribution of wealth schemes that train recipients to be perpetually indolent, killing their incentive to be self-reliant producers, and severely affecting the incentive of producers to exert themselves beyond that necessary for their own basic needs.
