Membership Grows Three Months in a Row; Monthly Pledge Up; Staff Hired

After nearly twelve months of a steady and scary membership decline that bottomed out in October at 14,170, dues-paying membership has now grown three months in a row. In January, it was 15,059.

While President Obama and the U.S. Congress certainly did their share to drive people towards the Libertarian Party, I think some of the improvements we've made at LP headquarters have made a significant difference.

We've worked to make our membership renewal mailings more inspiring. And as minor as it may sound to some, we re-designed the reply form to make it easier to fill out. (Don't you hate it when there's not enough room to comfortably write your address or your credit card number?)

I've found that it is really hard for organizations like ours to make progress toward their goals if they don't pay attention to getting a thousand details correct. Details are a priority for me.

We recently sent out an emergency fundraising appeal from Chairman William Redpath. We were down from six to four full-time staff members.

Enough people responded that we felt comfortable making Kyle Hartz a full-time employee. Kyle was a volunteer intern for the 2009 fall semester and graduated in December.

With the added staff, I'm expecting to be able to provide more assistance to the candidates we have been encouraging to run for office. We're

working on website templates to help candidates get a presence online.

Additionally, we put Kyle to work phoning people to sign up for monthly pledges or send in credit card updates. He often makes calls in the evening when it's easier to reach people. While our office is on the East Coast, many of our supporters are on the West Coast, and Kyle has been willing to work past 10 PM Eastern Time (which corresponds to 7 PM Pacific Time).

Results have been strong. For January we reached \$26,969 in monthly pledge revenue.

The table below shows our recent results.

With some of our basic operations improved, I'm hoping to spend a little more time putting useful tools into the hands of our activists.

I recently put together an offer to buy huge bulk quantities of bumper stickers and distribute them at cost. I expected to get orders for maybe ten or twenty thousand stickers. At the time of writing, Libertarians have ordered over 65,000 bumper stickers!

I'm delighted so many people are willing to help build the Libertarian brand when we make it easier for them.

Next I'm hoping to get a good flyer into the hands of activists that they can bring to events, particularly the massive Tea Party protests, to recruit more people to the Libertarian Party.

More Libertarians = More Freedom and Less Government.

I want to send a huge THANK YOU out to my supporters and congratulate Senator Brown on his new role in the U.S. Senate. Senator Brown ran a very aggressive campaign and was able to get the support and funds needed to pull a huge upset in Massachusetts. May he represent the people well.

Tea Party supporters turned their back on our campaign, despite my personal commitments in the past to numerous local events. Fellow Libertarians sent email after email asking me to drop out and support Brown. Members of the Independent party requested that we throw our support to Scott Brown. The negative email campaign from Tea Parties and Brown supporters from across the country impacted us greatly and we did not have the staff to compete against it. For those who are not aware, my unpaid campaign staff consisted of part-timers with limited campaign experience, and faced with unmanageable task of coordinating campaign efforts across the state.

Here is my promise to you: I will do what needs to be done in Washington. I will go down there and file legislation to cut spending, hack jobs, useless departments and anything I find that is wasteful. I will fight lobbyists, cut my own salary and work to bring the Washington aristocracy back to earth. I will work to eliminate the FED, end any wars and ensure equal rights for all. I want to do this. And, I want your help.

Our biggest lesson learned is support and backing are essential. I will not run a losing campaign again. I need you to take an active role in mobilizing resources across the state while raising funds to pay for staff and advertising amongst other campaign costs. We can do this together. I will keep this site up, spread my own word, join organizations and sacrifice my own time. I ask of you, what are you willing to sacrifice for your country, your state, and your liberties?

If you want me to run again, I leave it up to you. Find me events, spread the word, and find a way to assist in funding my next campaign. When elected I will work harder for you and your wallet than anyone in government today. If you want me to run again we need to start today. Spread the word, get more people to join the site and keep the energy flowing. Let us together continue what we started and bring back a government of and for the people.

Coleman's Proposal is about Self-Defense

The government that governs least, governs best. Take Libertarian City-County Councillor Ed Coleman's proposal to end the ban on firearms in city parks for example. Coleman's timely proposal addresses a glaring problem with our city's current laws. As it stands now, you have the right to defend your life from an armed assailant on the street, in a

supermarket, in a department store, a state park, a federal park, just about everywhere except a city park. Are Indy's public parks such utopian safe zones that you don't need to worry about protecting yourself there? What makes a city park safer than a state or federal park where you are allowed the right to defend your life?

Let's be clear: this proposal is not about "gun rights". It's about the most fundamental of human rights; the right to self defense.

Coleman's proposal would finally allow law-abiding citizens to exercise their natural right to self-defense while on the grounds of a city park, rather than having to give up their safety at the park entrance. How does a firearm ban deter an armed criminal who is intent on breaking the law anyway? By the time they are caught (if they are caught) and the additional gun charge is tacked on to their sentence, they have already shattered the lives of their victims and their victims' families. While our law enforcement officers are fine men and women who risk their lives every day to protect us, they simply cannot be everywhere at once. We owe it to them, and to each other, to keep ourselves from becoming victims in the first place.
