Libertarians Lay Solid Foundation for Future

More than one percent of the voters in the 1980 presidential election were convinced that their votes were best cast as an investment toward a libertarian future. Fighting an establishment pretender to independence and a shamefully misestimated "close" race between the two major contenders, the Libertarian Party slate of Ed Clark and David Koch garnered an unofficial 878,674 out of 84,458,379 votes cast. The final total for Clark will probably be short of the hoped for one million votes; but the accomplishments of the Clark campaign only begin with our new record vote total for a Libertarian candidate.

Ballot status in all 50 states plus the District of Columbia, a network television advertising campaign exposing millions of viewers to libertarian ideas for the first time, and a new level of libertarian activity all over the country are all attributable to the efforts of the Clark campaign. The media will not be interested in the "losers" of the presidential race; but everywhere people are asking, "How did the Libertarians do?" The answer is that they achieved their goals of Libertarian Party growth and establishment both nationally and locally.

Now the average voter knows there is such a thing as a Libertarian Party. Since John Anderson collected the protest vote, we can be fairly sure that one percent of the voters actually under-

stand enough about us to vote for libertarian ideas and ideals. Most of our accomplishments are not as measurable as votes: they will only show up in future elections. But even our national and local vote totals give some indication of trends of interest.

In California Clark got 146,780 or 1.7 percent of the 8,422,589 votes tallied so far. In Alaska, it was 14,495 or 12.0 percent of 120,868. In New York the 0.9 percent of the 5,937,843 total was 51,141 which, if it had been a gubernatorial race, would have qualified the Free Libertarian Party for the New York ballot, eliminating the costly petition drives there. Wyoming produced 4,694 or 2.7 percent for Clark. Colorado, birthplace of the Libertarian Party, gave Ed 25,628 or 2.2 percent. And in Massachusetts Ed's 21,170 or 0.8 percent was more than twice the difference between Carter and Reagan.

Locally, Libertarian candidates added to the Clark-Koch base with votes ranging from David Bergland's 2.5 percent for US Senate to Bill Evers' 7.6 percent for US Congress. In the only close race in the area, Dante DeAmicis with 4.8 percent, more than doubled the difference between Pegram and Cortese. A table of Santa Clara County ballot races appears on page 2

November 20 County Meeting Will Feature Election Analysis

The November meeting of the Libertarian Council will be devoted to discussing and analyzing the election results. Candidates and campaign managers will tell about their activities of the past few months and the results at the polls. This will be an informal election recap—please come bringing your insights and experiences.

The meeting will be held at another new location—the Santa Clara Service Center at 1555 Berger Dr., San Jose. This meeting room has a big advantage over last month's room—it won't cost us anything. The room is in the same building as the Registrar of Voter's Office (see map). Walk in the front door and go the first room on the left. The meeting will start at 8:00 p.m. Thursday, Building #2, Santa Clara Service Center. It may be a little hard to find the first time, leave early to allow time for being lost.

Bill Evers Outpolls Democratic Candidate in San Mateo County

Bill Evers, Libertarian challenger to Rep. Paul N. "Pete" McCloskey, outpolled the Democratic candidate, Kirsten Olsen, in San Mateo County 5,975 votes (15%) to 5,489 (13%). Overall in the 12th Congressional District, Evers polled 14,834 (8%), McCloskey, 139,737 (72%), Olsen, 36,163 (19%), and Peace and Freedom candidate Adele Fumino, 4,162 (2%).

Evers's eight percent, together with Libertarian Dan Mahaffey's eight percent in California's 40th Congressional District (Orange County), were the highest third party percentages for federal office in California.

Evers campaign staffers pointed out that Evers polled nine times Libertarian registration in the district (and eighteen times registration in San Mateo County). Mahaffey polled three times the Libertarian registration in his area, which is a stronghold of Libertarian sentiment.

"I think we've shown," Evers said, "that the potential is there in the Midpeninsula area for a new coalition of people who want to roll back bureaucracy and ensure security for their personal liberties."

"People are tired," Evers added, "of the poor choices which the Democratic and Republican parties have consistently offered."

Evers praised the work of his campaign manager, Robert Costello, and all the volunteers who helped him meet the voters in recent months and pledged to run again in 1982.

You may not realize that he has been campaign manager for Bill White, Dante DeAmicis, and myself, as well as general office manager for our headquarters in South San Jose. For the last two weeks, Mark has taken leave of absence from his job, without pay, in order to put in 26-hour days on our campaigns.

The campaign manager gets all the blame for things that go wrong. I think it's time for Mark to also get some credit for pulling together all those individual efforts that brought us our successes. So, thank you, Mark.

Speaking of pulling things together, Clark-for-President County Coordinator June Genis also put in a lot of time during the day at our South County headquarters. Using vacation time from work she came in every Wednesday during the summer to organize the office and arrange for candidate appearances. Thanks, June, for staying on top of things.

All of our candidates' efforts would have been much less useful, if not wasted, without the support of our regular office workers and our precinct workers. Among so many deserving special mention are four of the officers of the Libertarian Council who regularly fulfill their duties and do every other job that comes up—Karen Huffman (membership chair), Lory DeAmicis (secretary), Dante DeAmicis (publicity chair), and Jerry Gray (treasurer). Thanks to all of you for being there.

Finally, in my estimation, our best investment in this campaign has been our telephone (268-6800). It has made us available as candidates and kept the troops together and in touch, through thick and thin. But that instrument is only as good and valuable as the responsible people who have answered it. Without the kind of full-time coverage it has received, we would have been relegated to the status of minor fringe party by many inquiring souls, including news reporters and registrars of voters. Thanks to all of you who covered the phones, especially Anna Pierce and Gloria Rotunno (of Jean Graphics).

As I hope most of you know by now, Gloria and I are expecting the birth of our first child soon after the election. What Gloria has done for this campaign and for the Libertarian Party goes way beyond the call of duty. From my biased point of view I've seen her as the mainstay and cornerstone of the local libertarian movement. She may not print it, because, among her many preoccupations is that of editor of this newsletter. But I want her to know that I appreciate what she has done and acknowledge her contribution to my life, to our goals, and to Liberty.

The people I've discussed (and you who read this) are the real winners of this campaign. Thank you very much, each of you. Now let's get back to work.

Libertarians Establish Credibility

For myself and for all those who worked with me, Campaign '80 was a success. It was so because we reached all of the goals we set for ourselves. Those goals were to: 1) have as many people as possible hear about and come to believe in Libertarian principles, 2) get those people to express this belief by voting for me and other Libertarian candidates and 3) have fun doing so. As a yardstick of success, we sought to get 5 percent of the total votes cast.

In fact, I received 6.1 percent of the total. In other words, 13,160 individuals who live in District 11 wanted a Libertarian to be their representative in the State Senate. This demonstrates to me that the Libertarian Party has been accepted by voters as a legitimate and attractive alternative to the Establishment parties.

This was brought home to me on a personal level. The day after the election, many people commented to me that they were impressed, surprisedly so, by my vote total and stated, quite proudly, that they had voted for me. I think they were saying that before the election, they didn't think I was for real. Now they were convinced I was. Libertarians had gained their respect.

That new-found respect represents the opportunity we've been seeking. People and perhaps the media will now be listening to what we have to say with earnest. In the next two years, we must continue to carefully articulate Libertarian principles and their application to current problems.

I wish to thank all of those who helped make my campaign a success: Cary Kunz, campaign manager; Tom Retson, treasurer; Ray Strong who provided leadership and direction to an otherwise rag-tag group of political rookies; long time activists Mark Hinkle, Jim Wurm, Russ Fridley, Dante and Lory DeAmicis, June Genis, Karen Huffman and Peter Van Sant for their moral support; Gloria Rotunno for preparing my brochures and ads; John David Webster for taping my radio ad; and volunteers and contributors Ken Watkins, Rich Tilley, Sam Milam, Dennis Townsend, Carol and Al Oglesbee, Carol and Herb Mallicoat, Perr Cardestram, Tony Reese, Bill McDonough, Jim Mokri and Patty Solomon.

I have a great deal of respect and admiration for those who were involved in Campaign '80. These people made a long term commitment and stuck to it, even though there were few rewards along the way. It was gratifying for me to share in their excitement and satisfaction on election night when the Libertarian Party came of age.

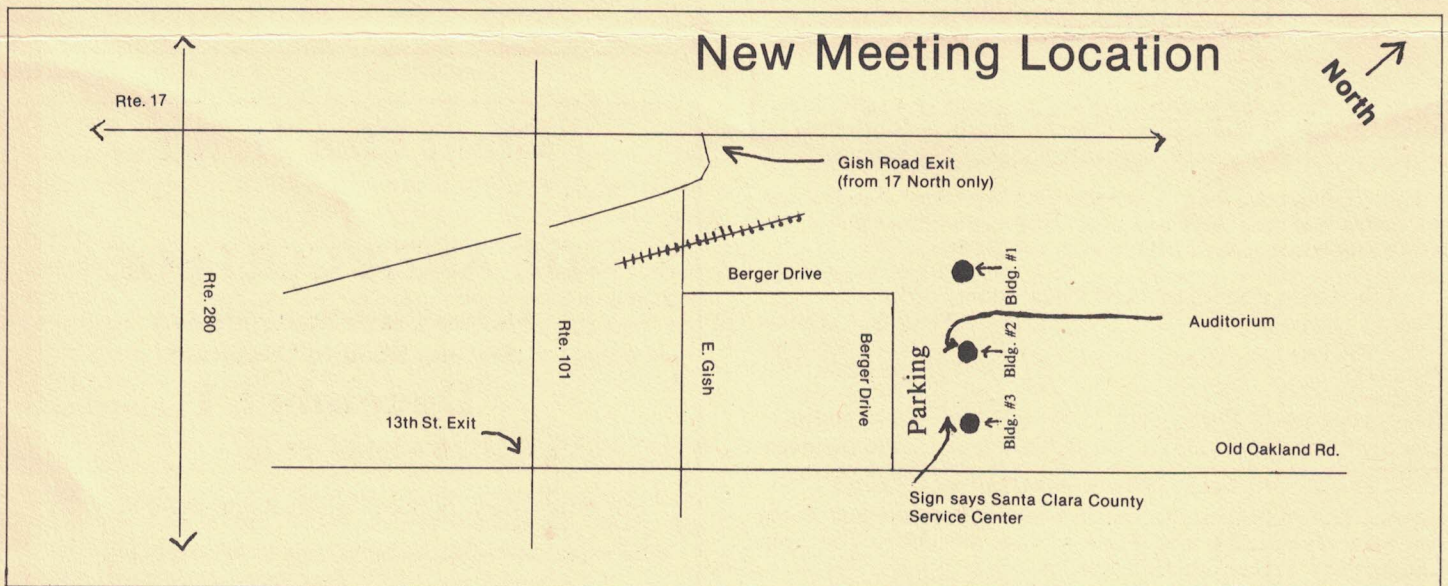
