# CLC, LPC to Eye Merger

Mary Gingell Elected LPC Chair

In a move partly overshadowing the election of Santa Clara County's Mary Gingell as chair, the Libertarian Party of California voted at its August convention to establish a committee to consider merging with the California Libertarian Council.

Strictly speaking the organizations would not merge, but as Eric Garris pointed out in his successful campaign for Northern Vice-Chair of the LPC, recent events have raised the question of the necessity of a separate CLC. In particular, a recent Supreme Court decision would apparently allow a political party to endorse candidates in that party's primary, despite California law to the contrary.

The major obstacle before the committee is probably the question of dues. The Garris proposal is to appoint automatically anyone to the appropriate central committees who pays dues and signs the non-aggression oath. Appointed members would be fully equal to members elected at the June primary by registered Libertarians.

Bill White is the only Santa Clara County member of the nineperson committee. The committee will report to both the CLC and LPC Executive Committees at their November meetings in

Hollywood. Ideally, final action can be taken at the CLC convention in Oakland in February.

In other action at the LPC convention, the party voted to adopt the CLC platform without change. The only changes in rules and by-laws were minor. Santa Clara County members elected to LPC positions were Ray Strong (Judicial Committee) and Mark Hinkle, Bill White, Scott Olmsted, and Karen Huffman (at-large Executive Committee). Jeff Smith replaces Huffman as the Santa Clara County representative to the Executive Committee.

The CLC Executive Committee met on Sunday, August 15, following a successful breakfast at the Taylor Street head-quarters. Most of the meeting involved routine financial business, but the committee did discuss the November ballot propositions. The following positions were taken: For 7 and 12, No Position on 6 and 10, and Against the eleven other propositions. Further details will appear in future issues of this newsletter.

In addition to Gingell and Garris, the newly elected LPC officers are Jack Dean, Southern Vice-Chair, Carolyn Treynor, Secretary, and Tom Jacobsen, Treasurer. At-large Executive Committee representatives from outside Santa Clara County are Lyn Sapowsky, Martin Buerger, Carolyn Felton, Mark Pickens, John Hamilton, David Bergland, Sharon Ayres, John Vernon, Mike Hall, Melinda Pillsbury-Foster, and Sally Foster. Joining Bill White on the merger committee are Eric Garris, Mary Gingell, Carolyn Felton, Hank James, Dennis Schlumpf, Mike Hall, Mike Anzis, and Jack Dean.

# Zoning and Land Use Regulation: 20th Century Feudalism

The problem with the *public interest* approach is that land and its resources are allocated and developed on a sporadic and wasteful manner. Political influence causes a shortage of buildable land and subsequent housing crisis. The controls severely cripple the market, causing high rents and prices. In reaction, more regulation is applied in the form of rent control, inclusionary zoning, subsidies and other manipulation. Rents and prices, in turn, escalate again.

This vicious cycle of interference eliminates all but the most costly ownership and rental opportunities, forever barring the poor from better housing.

Blaming the private sector for the housing shortage caused by its own interference, government has entered the housing market itself. After a decade of urban renewal projects, over 3 million homes have been destroyed in order to build 2 million—the replacement housing citadels of crime and squalor. In the 1950's, one out of three families owned their home. Now less than one in 20 are fortunate enough to afford today's regulated housing.

## THE ENVIRONMENT: PUBLIC WASTE AND DESTRUCTION

The environment suffers equally under the hand of the state. Regulatory agencies are not concerned with efficiency and retention of long term value, but rather with politics and empire building. Our fragile environment is entrusted to a government which we know to be always wasteful and often corrupt.

Environmental problems should be seen as matters of property rights. Clarification of rights and responsibilities, rather than public regulation is necessary to resolve conflicts of land use while preserving individual liberties.

When land is privately owned, sovereign control exists. Total control of the owner is limited, however, by the boundaries which mark his property. No owner has control or authority over property other than his own. Private ownership is complete within the boundaries and nonexistent beyond.

If we truly wish to clean up our environment, we must demand full restoration of property rights. Politicians and the judiciary must realize that social interests are best served by owner's rights and strict liability. With strict accountability no industry could afford to degrade our environment as is being done today. If property rights were strictly interpreted, the smallest amount of silt, herbicide, smoke, noise or radiation across a boundary would constitute *trespass*. In today's regulated society, these trespasses are negotiated by political process to "allowable limits," thereby compromising the rights of all property owners.

#### A LIBERTARIAN APPROACH

A number of libertarian approaches include the following:

- 1. Allow complete *laissez faire* in the housing market, and put an end to all building codes. Instead, replace state regulation by private warranty systems or insurance. Result—abundant and affordable housing for all, a diversity of styles and construction methods including experimental energy-efficient dwellings.
- 2. End government zoning and planning schemes. They are tools of vast destruction. Instead, allow voluntary covenants among willing neighbors. Also, the courts must clarify and enforce trespass and nuisance laws.
- 3. Eliminate government power of eminent domain. This law of state seizure causes untold loss and misery to many thousands of victims.
- 4. End environmental regulation, a system of public waste and destruction, and return to private conservation with clear and enforceable property rights.

5. Abolish state ownership of land. As much as 85 percent or more of some U.S. states are owned by the government. Public or common ownership is nonownership. When land belongs to all there is no specific responsibility to conserve. Any resource held in common, whether it be air, streams or forests, can be wasted and misused by any and all.

#### CONCLUSION

While it may be emotionally satisfying to believe that the land and its resources are the common heritage of mankind, this approach leads to degradation of the environment. As in all central planning schemes, human rights are violated on a massive scale while an elite core of bureaucrats make all decisions regarding growth, population density and movement, allocation of resources, and aesthetics. Control of the *land* becomes control of the *people*. In the interest of human rights, libertarians would restore property rights.

### Santa Clara County Fair 1982

This was the 8th consecutive year that the Santa Clara County Libertarians have had a booth at the Santa Clara County Fair. This year's booth cost us \$696.00, including \$425.00 for space rental, \$75.00 for liability insurance, \$20.00 for staff admission tickets, and \$176.00 for a Position Tester. The Political Position Tester was purchased jointly with the San Mateo County Libertarian Council and was a demonstration model obtained at a discount. Unfortunately, it did not arrive until six days after the fair started so it was not well utilized. It will be on display at Libertarian Headquarters throughout the year. Come and find out your political position and then leave any suggestions you have for clearer, more concise questions with Karen Huffman.

Donations totaling \$5.50 were received at the booth. Our staff registered 58 people into the Libertarian Party. (Last year's donations were over \$20.00 and LP registrations totaled about 110.) No one has tried to keep track of how many pieces of literature are handed out at the fair booth, but it was down this year partially because we were out of some of our Position Papers for most of the fair. Two people have joined the CLC in the 10 days since the end of the fair when this was written. This is an excellent response as we usually expect 3 or 4 new memberships within two or three months following the fair. Staffing the fair booth was much more difficult than usual this year because many of our major local activists were unavailable because they were staffing the Libertarian Party of California Convention that was held in San Jose the last weekend of the fair. A total of 85 persons were phoned (including nonmembers and members from other counties) and asked if they would be willing to help staff the fair booth. A total of 47 persons helped to staff, fund, set up, or take down the booth.

As the Fair Booth Coordinator, I would like to thank all of the persons who helped to make the fair booth a success. (The number of times that the person was a staffer includes help with set-up or tear-down of the booth.) **My special thanks** goes to those persons among the following who helped staff the booth because we were short-handed, even though they dislike the fair booth, and another special thanks goes to all the reluctant novice staffers.
