Doug Bruce Addresses Denver LP

Douglas Bruce, author of the pathbreaking tax limitation initiative, Amendment 1, and of the Election Reform Amendment, on the ballot this fall as Amendment 12, proved once again that he has many fans in the metro Denver libertarian community. At least 45 people attended a June 1 meeting of the Denver LP, rescheduled especially for Bruce's appearance.

Bruce warned the crowd to focus their political efforts, rather than charging off in too many directions at once. He argued persuasively for making Amendment 12 the top priority on the freedom agenda. Excerpts from his address, selected and transcribed by Larry Hoffenberg, appear on page 4.

Bruce was accompanied by the indefatigable treasurer and metro Denver contact for the TABOR Committee, Clyde Harkins. They asked for volunteers and contributions to help with the Amendment 12 campaign. A number of people committed to do volunteer work, which Harkins described as more

valuable than money at this time. Contributions totalled over \$1000.

Also attending the meeting were Dennis Polhill and Rick Grice of the Consumer Protection Referendum (CPR) Committee. Grice served as warm-up speaker for Bruce. He briefly described the CPR and solicited support and signatures for the effort, for which petitions had just become available (see story in June *CLiPboard* and related item on page 5).

LP Booth Popular at P-Fair

As in previous years, the Denver LP's booth at the People's Fair June 4 and 5 proved popular with fairgoers, justifying its status as a leading libertarian outreach effort in the state.

A thousand people took copies of the US Constitution, exhausting the supply by early Sunday afternoon. Each copy contained a copy of the World's Smallest Political Quiz, with the LPC address and phone number on the back.

Fairgoers also picked up hundreds of copies of *Liberty Today*, the national LP outreach tabloid, and various pamphlets. The expanded selection of bumper stickers sold well, and more importantly, the display drew many people to the booth and invariably evoked amusement and positive comments.

The booth took in about \$330 in contributions and sales, and collected about 60 cards requesting more information or asking to be placed on the mailing list. Booth workers also solicited signatures for the Term Limits initiative and CPR, collecting well over 100 for each.

From the Editor

I'm excited and concerned.

I'm excited because Dave Aitkin's decision to run for Governor promises to give each of us at least one Libertarian option on the ballot. Please help us achieve this modest goal.

I'm excited because Judd Ptak is planning an intelligent, well-organized campaign in State Senate District 13. The potential in this race is great. The incumbent, Sally Hopper, is one of the most liberal "tax and spend" Republicans in the legislature, and is vulnerable to a strong, principled attack from a Libertarian direction. Judd's goals are ambitious, but achievable, and he has thought out fall-back options if things don't go as planned. He deserves your strong support.

I'm concerned because the opposition to Amendment 12 is really pulling out all the stops. Balance Colorado (a bunch of bond dealers) has begun a smear campaign against the measure. A group formed by the Municipal League and the state chamber of commerce is planning to spend \$850,000 to defeat #12. Two other "election reform" petitions, both frauds, are being circulated in an attempt to give voters an "alternative solution" to Doug Bruce's. One of these would void #12 even if it passed!

And of course, there are the two stinkers referred by the legislature. You've no doubt heard of Amendment A, which would allow opponents, through court delay, to effectively kill virtually any petition. Amendment B, put on the ballot in the last days of the session, would bar petitioner comments from Amendment 1 election notices.

Please consider this a call to arms. Contact the TABOR Committee, and do what you can to help. Contact the LPC office and help petition Aitken onto the ballot. Contact the Boulder LP and offer some time and money to the Ptak campaign. Freedom isn't free. You can make a difference.

Affiliate News

— Aspen Liberty Coalition —

Aspen libertarians have several opportunities this summer to spread the message. Some will help Jon Baraga with his Hemp Initiative booth in the first week of July; then they will have a booth of their own at the Carbondale Mountain Fair on the third weekend of July. In August, Chris Patterson will be putting together the Liberty Coalition's annual Hemp Rally. Tom Peckham says the group's summer events are a lot of fun, and he hopes Libertarians from all over the state will once again show up to help with the work and to party with them. Several people will also travel to western Wyoming over the Fourth of July weekend to set up a libertarian camp at the Rainbow Family gathering, which Peckham describes as an annual "summer camp for adult hippies," many of whom have libertarian leanings.

— Aurora —

The June meeting featured Jack Woehr, a Democrat running for Dan Schaeffer's seat in the US House of Representatives. Woehr agrees with Libertarians that the War on Drugs should be ended, but disagrees with us on other issues, such as health care; he supports the Clinton plan.

— Boulder County —

At Boulder's June outreach meeting, David Kopel of the Independence Institute spoke on behalf of Democrat Paul Danish and his campaign for state representative. Kopel said he believed that if a pro-second amendment candidate like Danish could win the Democratic primary in a place as stereotypically left-wing as Boulder, it would send an important message to other candidates about the wisdom of supporting the right to bear arms. Danish also addressed the group, and several people offered their support individually, although the county party is technically unable to endorse a Democratic candidate.

The outreach booth at the Boulder Creek Fest was a success, bringing in the names of fifty new prospects, many of whom seemed pretty enthusiastic. The group will be continuing its outreach efforts this summer by running an "Operation Politically Homeless" booth on the Pearl Street mall.

— Denver County —

Denver's June meeting was the last at the Village Inn, which is being torn down for new retail development.

Beginning in July, Denver LP is meeting on the **second Tuesday** of the month, instead of the first. The new meeting place is the Palace Chinese Restaurant at 6265 E. Evans (just west of Monaco, on the north side next to McDonald's).

The private room that we will be using seats up to about 40 (a larger room is available, should we need it). The room has a small stage, sound system, and video monitor available for our use.

The Palace offers outstanding food at moderate prices (the ownership is the same as the long-acclaimed Imperial), and everyone should give it a try on July 12. Plan to arrive between 6:30 p.m. and the start of the meeting at 7 p.m. in order to get your meal order placed expeditiously.

Scheduled speaker for July is Rick Grice, who will describe what happened to the Consumer Protection Referendum and what the CPR Committee intends to do about it.

— Jefferson County —

At the Jeffco group's June business meeting, Sandra Johnson was selected as the new chair. The group also elected Dick Reseigh as vice-chair, Gary Sandritter as treasurer, Cliff Rhead as secretary, and Tom Goonan as parliamentarian.

This month's Jefferson Forum, on July 20, will feature a panel discussion on local issues and suggested solutions. Editors Fred Brown of the *Denver Post*, Tony Messenger of the *Courier*, and Ben Miller of the *Jefferson Sentinel*, along with Jack Woehr, Democratic candidate for 6th Congressional district, will address the question, "What should citizens be most concerned about, and why?"

— Southern Colorado Libertarian Party —

Libertarians in Fremont County are sponsoring a debate between Doug Bruce and City and County attorneys on July 8. They are aiming at significant newspaper and television coverage of the event.

Phil Freytag met with the Florence city council's Government Committee in hopes of convincing them to support the state's resolution in favor of the 10th Amendment and state sovereignty.

A True Friend of Liberty: Douglas Bruce in His Own Words

On June 1, the Denver LP proudly hosted a very special guest speaker, Douglas Bruce. Author of 1992's Taxpayer's Bill of Rights (Amendment 1), Bruce is also principal author of this year's Election Reform Amendment (Amendment 12). Bruce spoke for 1½ hours, piquing the interest and enthusiasm of the 45 or so attendees. A highly abridged version (due to space limitations) of his remarks follows. So grab your favorite beverage, relax, and enjoy a sampling of Doug Bruce at his best.

My name is John Galt. My name is Spartacus. My name is everyman who cares about liberty.

Amendment 1 was a firecracker; Amendment 12 is a hydrogen bomb. This is going to revolutionize Colorado politics. Amendment 12 will give us the direct control to do what we need to do.

Amendment 12 is not ideological. It is not about the end result; it is about the process. It's about protecting the process for everybody: for my friends and for my opponents; for people on both sides of Libertarian issues; any issue.

The Collectivists are in control of the government right now. They don't need to petition. All they need to do is call up the fascists in the legislature and say "pass another bill, require another badge, increase another fee, impose some more regulations." They can get their way without having to stand out in front of King Soopers.

Amendment 12 gives us the chance to counterbalance the Collectivists. I believe there are enough of us, as lazy and disorganized and apathetic as most citizens are. I believe that we'll get issues on the ballot that respond to people's frustrations about why government is not working. We can accomplish the reasonable portion of our freedom agenda.

Amendment 12 isn't about economics, or cuts in services, or growth formulas. There is no math on this test. This is not about money, but about morality. It's a simple matter of right vs. wrong. And people are going to understand why we need Amendment 12 in those terms.

Referendum A, which the politicians have already put on the ballot, is in my opinion, the single worst ballot issue I have ever seen in any state, anywhere, anytime. It's the legislature's response to our having voted "the wrong way" on Amendments 1, 2, 6, and 8. They say we just don't understand, so therefore we're not capable of voting on petitions that are, in their opinion, too complicated for our poor feeble minds to understand. So they're going to protect us from ourselves. This is the single greatest threat to your liberty that you'll probably see in your lifetime.

Fortunately, I think the politicians have made a big blunder. Instead of saying that protecting the right to petition is the delusion of some paranoid from Colorado Springs who happens to have a personality conflict Natalie Myer, people are going to see on the ballot that the government really is trying to take control and seize power over our constitutional rights. So they're going to help us make our case for the passage of Amendment 12 and protect our right to petition.

President Kennedy once said "those who make peaceful evolution impossible make violent revolution inevitable." The right to petition is a safety valve against government abuse. That's what it's there for.

I'm fond of saying 1% of the people make things happen, 4% of the people watch things happen, and 95% of the people ask "What happened?" I'm trying to motivate you to cross the line and become one of the 1%. Or, in our case, the 1/100 of 1% that basically committed a coup d'etat against the political establishment in 1992. The people in this room could control this election if you really made it a priority higher than TV, or other petition drives, or free activity or other things that you're doing.

Of the many benefits of Amendment 1, the one that I'm proud of the most is that I convinced people that naive dreamers, if they focus on one issue and don't run after 27 different daydreams, really can beat the system. And maybe that's the wrong term. We didn't beat the system. We reminded the politicians that *we are the system*.

The number one argument against Amendment 12, as it was with Amendment 1, is "trust representative government." It's a polite way of saying "bend over and assume the position." Let the politicians do whatever they want, and if you don't like them, your only recourse is to recycle them. That is not what freedom is about.

The first thing we have to do is rebut this blind faith that people have been raised with from childhood, in government schools, that the government is always right; the government knows what it is doing; we have to trust the government. *Why?* Why do we have to trust them? They keep screwing up over and over again.

The average audience doesn't know the first five words of the First Amendment: "Congress shall make no law..." Doesn't that sound like a limit on representative government? Isn't that what a constitution is about? Isn't that what keeps people free? Trust in representative government doesn't work. The citizens are being taken to the cleaners. The politicians have forgotten who's in charge. They've forgotten who they're working for. And that's what we're trying to change.

With Amendment 12, for the first time, to my knowledge, in American history, government officials and employees will be *personally liable* for violating the Constitution.

I want you to make a real commitment to restore our republic, defend our democracy, protect our political freedom, clean up politics, and stand up for America. Help us pass Amendment 12. Thank you.

Aitken Enters Governor's Race

State Chairman David Aitken has announced that he is running for Governor, and that Robert Martin of Clifton has agreed to be his running mate. Martin ran for Mesa county commissioner several years ago, receiving 5 percent of the vote.

The Aitken/Martin campaign has two primary objectives: first, to give voters throughout Colorado the opportunity to vote Libertarian; second, to ensure that the party maintains its status as a qualified political organization (which allows citizens to register as Libertarians). Aitken said that Judd Ptak's campaign for State Senate District 13 would also qualify the party, but "it's a lot easier to get 1000 signatures statewide than in a single state senate district."

"The single most important thing that party members can do at this time", said Aitken, "is to collect signatures to put both the Aitken/Martin ticket and Judd Ptak on the ballot. Every other campaign task is wasted effort unless petitioning is successfully completed." Petitioning started June 21st and ends August 2nd. Petitions must be received by July 29th in the LP office. Conservancies You Can Trust

Many of us value wilderness and wildlife and recognize that private property rights are essential to protecting wild areas. Some of us want to support conservation organizations that put their money where their mouth is instead of making Faustian bargains with politicians. Recently, I criticized the Nature Conservancy for abandoning its principles of private ownership, and several folks asked me for a list of conservancies that are kosher. There are so many I wouldn't know where to begin. But here's how you can get a list of 500 such conservancies and land trusts.

The Land Trusts Exchange publishes a National Directory of Local and Regional Land Conservation Organizations for about \$5. They also publish a journal (they'll send you a free sample) and other books.

The Supreme Court has upheld the Colorado Municipal League's challenge of the Consumer Protection Referendum, agreeing that the title contained "misleading slogans and catch phrases." The ruling voids all signatures gathered to date, and the CPR Committee is expected to wait until next year to continue the campaign. Spokesman Rick Grice is expected to discuss the situation at the July meeting of the Denver LP.

Gun Rights Rallies Planned

Planning is well under way for the next gun rights rally, scheduled for Sunday, Sept. 25, at the State Capitol. The rally will be officially sponsored by the Liberty Alliance, not the LP, since it is intended to give candidates from all parties an opportunity to show their support for the 2nd Amendment. If the necessary funds can be raised, organizers plan to advertise the rally throughout the state, and hope to double or triple the April rally's turnout of 1000+.
