LPC ExCom Notes

The state Executive Committee met in Sacramento on June 12th. Aside from a few items that were covered quickly, the entire time was devoted to trimming the budget, occasioned by the fact that membership renewals have been lagging far behind projections.

Since expenses were kept down as well, there was no likelihood of going broke, but there also was no chance of repaying the regions their back dues without a significant surplus of revenues over expenses.

Since the contract services (newspaper, 800 number, and database) are the largest expense items, they were the main areas of investigation. Others were also reviewed, and the budget was reduced from \$101,125 to \$64,700.

Naturally, there was a lot of pain in making such large cuts. The main hit was to Liberty Bell, the LPC newspaper, which is being changed to bimonthly publication and reduced press runs. A call for bids to provide the state publication is being made and a new contract will be awarded after evaluating them. (The request for bids has been sent to all local chairs and the current editor.)

Database accounting is being changed to apply charges to the areas that incur them rather than lumping all expenses into "database". Database costs and services are recorded separately as well, and all contracted services will be closely tracked eventually.

Many areas, including 800 number services, had their budgets reduced to reflect current and projected activity. Fund-raising projections were cut in half, but we look to surpass those pessimistic numbers.

Even with all the cuts, the 1992 back dues will not be paid by the end of the year, but it looks like a significant portion will. (The first payment went out in

Williamson Evers was appointed National Platform Committee rep, Ed Moss was appointed National Credentials Committee rep, and Sharon Ayers was ratified as NatCom Second Alternate.

Reports were given for the Audit Committee (headed by Eric Lund) and the Multi-Party Unity Committee (Ed Moss plus George O'Brien and Brian Schar). The joint effort on NOTA is essentially dead. Proportional representation is moving forward, with some concerns. Libertarians may spearhead an "Alternative Parties" booth at the Los Angeles County Fair.

San Diego is using a membership form that has no pledge but notes that people who use it cannot vote in LPC affairs. They have also missed three ExCom meetings, thus forfeiting their right to a seat. Region 62 was given the seat, effective next meeting: Sunday, September 19 at the Long Beach LP office, 9:00 AM.

Change

Many have fallen by the edge of the sword: but not so many as have fallen by the tongue. —Ecclesiasticus 28:18, The Apocrypha

Changes in the meanings of words can happen suddenly. One day gay apparel was something you donned at Christmas time. The next day you wondered if maybe it was a dress on a transvestite. Sudden changes in meaning might cause embarrassment for the incautious, but the greater danger lurks when changes in meaning accumulate slowly. When words don't mean what they meant 50 years ago, the potential for harm can be sinister. See for yourself:

1941: Fascism was defined as "any system of government in which property is privately owned, but all industry and business is regulated by a strong national government."

In 1941, this probably didn't seem like a description of the USA.

Thorndike Century Senior Dictionary

1955: Fascism was "a centralized system of government which

exercises absolute control over industry, and which advocates strong national policies, regulates all news and suppresses opposition."

Webster's New School and Office Dictionary

The addition of key words (i.e. absolute control) and selected ideas (i.e. regulates all news) prevented people from perceiving the definition as a description of the USA.

1961: Fascism was "Any program for setting up a centralized autocratic national regime with severely nationalistic policies, exercising regimentation of industry, commerce, and finance, rigid censorship, and forcible suppression of opposition."

Webster's New Collegiate Dictionary

By 1961, fascism wasn't anything that was actually happening. It was only a program for setting it up. This rendered the idea safely remote. In any case, words like *autocratic* and *censorship* kept it from being perceived as applicable to the USA.

1965: Fascism was "a political philosophy, movement, or regime that exalts nation and race and stands for a centralized autocratic government headed by a dictatorial leader, severe economic and social regimentation, and forcible suppression of opposition."

Webster's Seventh New Collegiate Dictionary

This definition is even more remote. Fascism wasn't even a program any more, but only a philosophy or possibly a movement. The word *regime* was generally applied to foreign autocratic governments which practiced forcible suppression of opposition. LBJ was a Good Ol' Boy.

1973: Fascism was "a political philosophy, movement, or regime (as that of the Fascisti) that exalts nation and race above the individual and that stands for a centralized autocratic government headed by a dictatorial leader, severe economic and social regimentation, and forcible suppression of opposition."

This definition more carefully identified a fascist regime, the Fascisti, which was safely remote from the USA in both time and place. Also, it was no longer fascist to exalt nation or race. To exalt nation or race above the individual was fascist.

Webster's New Collegiate Dictionary

1987: Fascism was "a political philosophy, movement, or regime (as that of the Fascisti) that exalts nation and often race above the individual and that stands for a centralized autocratic government headed by a dictatorial leader, severe economic and social regimentation, and forcible suppression of opposition."

After 1987, fascists didn't <u>always</u> exalt race above the individual, they just <u>often</u> did. I suppose that way selected racists could avoid being fascists.

Webster's Ninth New Collegiate Dictionary

1992: Last year, fascism was "A system of government marked by

centralization of authority under a dictator, stringent socioeconomic controls, suppression of the opposition through terror and censorship, and typically a policy of belligerent nationalism and racism."

The American Heritage Dictionary of the English Language

It's no longer fascist to have a centralized autocratic government headed by a <u>dictatorial leader</u>. Now, there must be an actual <u>dictator</u>. To exalt nation or race above the individual doesn't denote fascism. Only <u>belligerent</u> nationalism or racism indicates fascism. Finally, it's no longer fascist to employ forcible suppression of opposition. Suppression must be by the use of terror and censorship in order for a state to be fascist.

Erosion


It wasn't bad enough yet when I lost the option of sending my daughter to the store to buy some paint for me. I still had way too much freedom. Recently, I lost a little more.

The San Jose Municipal Code, Chapter 6.74, Title 6, now requires sellers to lock their spray paint. That means that when I interrupt my project (because the codes won't allow me to send my daughter for paint), get cleaned up, and go to the store myself, I can no longer browse the shelves to decide what paint to buy. I must find an attendant (a challenge in itself) and read the labels while he stands behind me tapping his toe.

The requirement (supposedly) is intended to prevent graffiti. So was the requirement that said my daughter couldn't buy paint for me. That one didn't work and neither will this one. 1. Any statute, whatever it's advertised purpose, will ultimately restrict the behavior of people who didn't cause the problem.

2. When paint is outlawed, only outlaws will have paint.





The resolution for peace by the Coalition for National Drug Policy Change as signed at the Hoover Institute is on the reverse of this page. It is our way to bring the drug war to an end. Libertarians have a significant part to play in pressuring Congress and the President into calling the requested Commission.

The Outreach potential for Libertarians is enormous as public sentiment **HAS** shifted support away from the war on drugs. There are significant parallels here with the end of alcohol prohibition in this effort. That is where Libertarians can play key

The objective is to have friends, neighbors, relatives and their friends, neighbors and relatives to sign and send the resolution **once** a month to the President, two Senators and one Congressperson. This will create wave after wave of resolutions flowing into the Capitol and give the needed courage to call the requested commission. These resolutions will create doses of courage, give them enough.

To aid our efforts we have created our "END THE DRUG WAR" SAVE OUR CHILDREN stamps after the successful Alcohol Repeal Stamps of the 1930's. We want these stamps to be used under your return address and on the back as a seal. They will soften public attitudes towards the war on drugs by making the connection between ending the drug war and the saving of our children.

If just 1/20 (5%) Libertarians were to 'work at this' resolution, we would end this drug war against Americans. What we need to do is to be part of the building of this

Coalition as individuals and groups circulating the chain resolution.

To the "purist", this is working with the 'enemy'. I agree. However, when the ship is sinking, as ours is, such distinctions are meaningless in the face of survival. These 'aversions' must be set aside and a commonality, working for peace in America, found.

RESOLUTION "FOR PEACE"

by THE
COALITION for NATIONAL DRUG POLICY CHANGE
(Signed at the Hoover Institute)

WHEREAS, the overall situation regarding the use of drugs in our society and the crime and misery that accompanies it has continued to deteriorate for several decades; and

WHEREAS, our society continues to attempt, at enormous financial cost and loss of civil liberties, to resolve drug problems through the criminal justice system, with the accompanying increases of prisons and numbers of inmates; and

WHEREAS, the huge untaxed revenues generated by the illicit drug trade are undermining legitimate governments world-wide; and

WHEREAS, the present system has spawned a cycle of hostility by the incarceration of disproportionate numbers of African-Americans, Hispanics, and other minority groups; and

WHEREAS, the number of people who have contracted AIDS, hepatitis, and other diseases from contaminated hypodermic needles is epidemic under our present system; and

WHEREAS, in our society's zeal to pursue our criminal approach, legitimate medical uses for the relief of pain and suffering of patients have been suppressed.

THEREFORE BE IT RESOLVED, that our society must recognize drug use and abuse as the medical and social problems that they are and that they must be treated with medical and social solutions; and

FURTHER, BE IT RESOLVED, that an objective commission be immediately empowered by the President and by Congress to recommend revisions of the drug laws of these United States in order to reduce the harm our present policies are causing.
