Government Succeeds by Failing

New Orleans it I New Orleans, it became crystal clear that the Category 4 hurricane was more than just a natural disaster. It had become a human disaster of epic proportions.

New Orleans survived the hurricane, but not the government's emergency relief efforts, which points to a standard principle about government: the bigger the failure, the bigger the payoff for the bureaucracy. Because of the debacle, the Bush administration will reward FEMA & other state agencies with hundreds of billions of dollars to fix what it broke. Government has indeed succeeded by failing.

But how successful was Katrina's disaster? Consider the evidence.

The first hint of trouble occurred the morning after, when Red Cross and other private relief agencies tried to rush in with supply trucks. The La. governor's office of Homeland Security blocked them because the relief supplies would act as a magnet and attract more evacuees to the already overcrowded Superdome—even though officials had told residents to gather there, well before the storm had made landfall. Ironically, at this moment, the mayor of New Orleans, Ray Nagin, pleaded across national air waves for more supplies for trapped citizens.

Failing to expect the unexpected, various government agencies erroneously thought that enough buses would be supplied to take everyone out in short order. Instead, the refugees in the Superdome & Convention Center were abandoned for 5 days.

With reports of disorder, rape, & violence running amok inside the Superdome, National Guard men were stationed outside to prevent hurricane refugees from leaving. In fact, a number of citizens tried to escape. They were chased down & dragged back into what one witness called "a hell hole."

In stark contrast, those in the French Quarter had no government troops to protect them, yet order reigned. Feeling abandoned, citizens in this above-sea-level neighborhood did not wait for rescue. Without outside assistance, they organized & divided up chores. Some did the washing down at the river, others stayed behind to prevent looting. A number of bars, including Johnny White's Sports Bar, remained open day & night. These little command posts handed out water, food, & medical services—a far cry from the squalor at government-sponsored emergency shelters.

Even Wal-Mart provided relief days before FEMA got into the act. Years ago, the company had set up its own emergency operations center to prepare for national disasters. With Katrina, they arranged for trucks to resupply their stores

The purpose of the Party is to proclaim and implement the Statement of Principles of the national Libertarian Party by engaging in electoral, political, and informational activities within the County of Santa Clara in the State of California.

3 Allen Hacker proposed the following change to the Constitution, to remove an overlap in tenures in the Judicial Committee during the Annual Meeting:

Existing:

Article IV - Organization, Section 4. Judicial Committee, sentence 2

The Judicial Committee shall take office immediately upon the close of the Annual Meeting and serve thereafter until the <u>election of new Committee members</u>.

Change it to read:

The Judicial Committee shall take office immediately upon the close of the Annual Meeting and serve thereafter until the <u>final adjournment of</u> the next Annual Meeting.

Article IV – Organization, Section 3. Executive Committee

& gave out tons of merchandise: chain saws, boots, clothing, water, and ice. As one stunned shopper remarked, "I still haven't managed to get through to FEMA. It's hard to say, but you get more justice at Wal–Mart."

Meanwhile, in Atlanta, some 600 to 1,400 firefighters sat on their hands waiting to be deployed to La. or Miss. as emergency workers. Many whispered, "What are we doing here?" as they sat in the hotel conference room attending classes on equal opportunity & customer service. Eventually, the firefighters discovered that FEMA authorities planned to have them pass out pamphlets. Many of these firefighters were paramedics, haz—mat and search—and—rescue certi-

fied. Some were so upset that they took off their FEMA-issued shirts & refused to represent the agency, frustrated that people were still trapped in homes & dying along the Gulf Coast while FEMA discussed sexual harassment. Trying to restore order, one official jumped atop a chair & shouted, "You are now employees of FEMA, & you will follow orders & do what you're told!"

Some officials argued that they lacked the planning skills & preparedness for such a disaster. But according to Time magazine, a well-funded simulation of a hurricane over New

Orleans was performed in 2004. "Hundreds of regional & federal officials met in Baton Rouge for an elaborate simulation exercise. The fictional 'Hurricane Pam' left the city under 10 ft. of water & looked a lot like Katrina."

The skills, resources, & preparation were there for the government relief efforts. But government often seems to be more interested in protecting its own self—interest. Some have called for FEMA to be contracted out to a private relief agency. One thing is for sure: a private contract would have a far different definition of "success."
