Analysis and Recommendations on the June Primary Ballot Measures

This article is a combination of descriptive excerpts and paraphrases from an article by Les Antman in the March-April issue of Caliber together with comment from the editors of SANTA CLARA LIBERTARIAN. At the end of each section we summarize the recommendations of the executive committee of the California Libertarian Council, Les Antman, and your editors. Missing propositions were not deemed important enough for inclusion (we ran out of space).

Proposition 1. New Prison Construction Bond Act: Authorizing \$495 million in new bonds to be paid for out of tax revenue, this proposition would punish victims again by making them pay more for the housing and feeding of criminals. All sources recommend a **No** vote.

Proposition 2. President of Senate: This proposition repeals the constitutional provision that the Lieutenant Governor is President of the Senate. Antman recommends **Yes**; the CLC and your editors take no position.

Proposition 3. *Taxation:* This proposition provides property tax reduction for victims of eminent domain. All sources recommend a **yes** vote.

Proposition 4. Bail: This amendment to the constitution would extend the criteria for denying bail from those charged with capital crimes with a strong presumption of guilt to those charged with felony acts of violence where there is "substantial likelihood the person's release would result in great bodily harm to other." Libertarians advocate speedy trials and restitution for victims, including those wrongfully imprisoned. Antman argues that this amendment tends to move us in the opposite direction. The CLC and Antman both recommend a **no** vote. Though we hate to see repetitive perpetrators of rape and armed robbery released on bail, we must reluctantly agree that the proposition provides insufficient objective standards and no restitution for the wrongly confined; so we also recommend a **no** vote.

Propositions 5 and 6. Gift and Inheritance Taxes: These propositions are identical in intent to replace existing gift and inheritance taxes with a state "pickup" estate tax equal to the maximum federal tax credit. All sources strongly urge repeal of the "death tax" and recommend a **yes** vote on both propositions.

Proposition 7. *Income Tax Indexing:* This proposition would bind percentage changes in income tax brackets to the full percentage change in the Consumer Price Index. It's a small change in the right direction. All sources recommend a **yes** vote.

Proposition 8. Criminal Justice: This proposition, called the Gann Initiative, contains provisions too numerous and varied to list. According to Antman, the most libertarian of its provisions is for restitution by the criminal to the victim; its least libertarian provisions include one declaring that students have "the inalienable right to attend campuses which are safe, secure, and continued on page 2

LIBERTARIAN PARTY PRIMARY BALLOTS ARE GRAY!


Registered Libertarians in Santa Clara County will be allowed to use voting machines for the first time. The Santa Clara County Registrar has arranged for all minor party voters and the non-partisan voters to share one Vote-O-Matic machine at each polling place. The voting booths will have instructions on how to fix the ballot-holder to vote only for the party the person is affiliated with.

In 1980 many Libertarian Party (LP) voters were deprived of their right to vote for LP candidates because they did not know their rights and some poll workers are woefully ignorant of correct procedures for third parties. The most common errors are trying to give LP voters a nonpartisan ballot (light pink) or an American Independent ballot (lavender) or telling them they can only vote for propositions and nonpartisan candidates. Do not accept any color of ballot except the light gray one assigned to the LP. It has already happened this year to an absentee voter—do not let this happen to you!

If you wish to confirm that you are registered in the LP you can call the Taylor Street Headquarters at 408/CRY-FREE from noon to 6 p.m. on Monday through Friday. (The Registrar of Voters will only give this information if you write to them or if you go to their office, whereas we can give you this information by phone in a short amount of time.) On Election Day the 408/CRY-FREE phone will be answered by a live person from 8:00 a.m. until midnight or later. If you have any problems voting please let us know. Although it is almost impossible to get through to the Registrar of Voters on Election Day any urgent problems should be phoned to them at 408/299-2161.

The LP will have observers at ballot-counting headquarters on election night. They will be phoning in election results to CLC Headquarters as soon as possible after they come off the computers.

peaceful," one allowing presentation in criminal cases of illegally obtained evidence, and one providing even less objective standards for denial of bail than Proposition 4. Appealing to conservatives and libertarians, it is unfortunately likely that the proposition's worst features will be the only ones to survive a test in the courts and implementation by the legislature. All sources recommend a **no** vote in spite of the provision for restitution.

Proposition 9. *Peripheral Canal:* Libertarians firmly oppose this further dislocation of the economy. According to Antman, it will increase the general costs of water and electricity while the real benefits will go to large agricultural interests in Kern County. All sources recommend a **no** vote.

Propositions 10, 11, and 12. Reapportionment: We oppose these blatant attempts to provide incumbent politicians with increased job security. All sources recommend **no** votes on all three propositions.

Nonpartisan Races in Santa Clara County

We cannot recommend any of the candidates for nonpartisan office as explicitly libertarian, though some come close. In the absence of libertarian candidates, we remind our readers to vote against incumbents.



Two Libertarians Battle for Lieutenant Governor Spot

In the only contested primary race for Libertarian voters in Santa Clara County, John Vernon and B.J. Wagener are both running for our nomination for Lieutenant Governor. The CLC con-

vention endorsed John Vernon in February. In this issue we reprint excerpts from statements and biographical material submitted by both candidates.




JOHN VERNON LT. GOVERNOR

John Vernon is a restaurant consultant and caterer who is known in catering circles as "The Omelette King." He lives in Los Angeles and he is a member of Toastmasters International, the National Rifle Association, and the Aircraft Owners & Pilots Association.

"As Libertarian candidate for Lt. Governor, I offer my services in the interest of promoting the philosophy of government which says that each individual is the rightful sovereign of his or her own life and affairs. Thus, if elected, I will endeavor as President of the California Senate to assist in the introduction of bills which will reduce taxation, relieve regulation of business and implement a hands-off policy with regard to the private lives of individuals. Our aim is to build a society in which every individual can fulfill his or her maximum potential through the possession of maximum individual freedom and the exercise of personal responsibility.

"Crime is one of the most important issues on the minds of urban Californians. I advocate the encouragement of the voluntary Neighborhood Watch as the most effective means of preventing crime in our neighborhoods and on our streets. Traditional politicians have yet to come up with a 'program' which can take the place of individual responsibility. I also propose a Private Police Tax Credit as a means of enabling many people not now able to do so to obtain more satisfactory police protection from private security agencies operating in the free market."



B.J. WAGENER LT. GOVERNOR

B.J. Wagener is a self-employed real estate investor/consultant. he lives in Los Angeles where he is scoutmaster for an inner-city troop. He has been married fourteen years and is the father of two sons.

"As a candidate for State Senate (1st Dist. Wisc.) in 1970 and 1974, and Assembly (4th) and Congress (8th Dist.) in 1972, I have vastly more experience in campaigning and debating than my worthy primary opponent. I also ran for Board of Trustees for L.A. C.C. in 1977, and for the 26th Congr. Dist. of Calif. as the LP nominee in 1980 with a full-time campaign office in my district. Experience! There is no substitute.

"I alone am willing to uphold the absolute inviolability of property rights regardless of whether one 'creates,' buys with honest money, uses or chooses to not use a given piece of property, real or personal. This is a fundamental concept in libertarian thinking. My opponent made clear at the CLC convention that he did not quite believe that. It is a very important issue. So much so that Dr. Nathaniel Branden, a leading writer philosopher and formerly close associate to Ayn Rand, broke his long-standing policy of *not* endorsing candidates of any party, and has endorsed me in his letter of April 20, 1982, 'on the grounds of his general support of the Libertarian platform and more particularly because of his stand on the inviolability of property rights.'
