Once again, it has been an honor to serve the Libertarian Party and the cause of freedom. Since I was hired, the Libertarian Party has accomplished the following:

- 1. The Libertarian Party has presented a libertarian message, differentiating us from conservatives and liberals.
- 2. Monthly pledge recurring revenue increased from \$20,854 to \$33,092.
- 3. The cash reserve or "money in the bank" has been at record levels.
- 4. Over 800 LP candidates ran in the November 2010 elections, up from around 600 in 2006 and 2008.
- 5. Total votes cast for Libertarians increased from 12,573,194 in 2008 to 14,754,525 in 2010.
- 6. We posted, what some say, was the first accurate nationwide list of elected Libertarians on LP.org.

7. Facebook fans grew from 11,770 to 184.705.

8. A negative is that the number of "active donors" dropped from 14,977 to 13,981.

I do hope to increase the membership or "active donors" between now and the end of the year.



#### LPRI On Pension Reform

Like most political and civic organizations in our state, the Libertarian Party of Rhode Island (LPRI) has been taking an active role in the state and municipal pension crisis that threatens to become THE biggest issue in Rhode Island history. The potential impacts of this crisis are staggering. It has been reported in the media that potential total unfunded pension liabilities currently approach close to \$10 Billion. The LPRI has been participating in the on-going State House hearings on this issue as well as many other forums and events that have been held throughout the state. We intend to stay focused on this issue and will work to ensure that the rights of all state citizens, including workers and taxpayers, are respected throughout the process to achieve a viable solution to this critical problem.

Based on publicly available information, the LPRI believes that much of the current crisis is due to the inability of our big-government state bureaucrats to properly manage the funds entrusted to them by workers and taxpayers. Years of irresponsible spending via unsustainable benefits and failure to properly fund the various pension accounts have gotten us to the precarious position that we are in now. # Founder of Fairfax pot club joins push for state ballot initiative

Marin Independent Journal, October 17, 2011

The founder and director of the Marin Alliance for Medical Marijuana in Fairfax is joining a Libertarian Party-backed effort to place an initiative on the November 2012 ballot that would require marijuana to be regulated like wine....

Key proponents of the ballot measure include retired Superior Court judge **Jim Gray**, a former Republican who ran against Democratic Sen. Barbara Boxer as a Libertarian Party candidate in 2004; **Steve Kubby**, a Libertarian Party activist and cancer survivor who played a leading role in passage of Proposition 215, which made medical marijuana legal under California law in 1996; and **Steve Collett**, who is running as a Libertarian Party candidate for Congress in California's 36th district based in Los Angeles.

In a press release, Gray said the federal crackdown "is tantamount to a government bailout for criminal gangs and violent drug cartels."

# Reality TV star running for governor

America's favorite survivor star **Rupert Boneham** has thrown his hat, or shall we say tiedye shirt, into the ring for governor.

The 47-year-old Washington Township resident—who received \$1 million after winning TV's "Survivor: America's Tribal Council" in 2004 and used most of the money to establish Rupert's Kids to help at-risk teens—announced today he would seek the nomination for governor on the 2012 ticket of the Libertarian Party of Indiana....

The next step would be an official endorsement from the Indiana State Libertarian

Convention, where about 200 delegates will vote April 14, 2012, said **Tim Maguire**, political director of the Libertarian Party of Marion County. Assuming Boneham gets a nomination, he would be on the ballot in November 2012, for the 2013-2016 term of office.

# Three vie for Kentucky treasurer, an office one wants to eliminate

...The third candidate is Libertarian **Ken Moellman**, an information technology specialist who is campaigning on a platform to eliminate the treasurer's office....

As former chairman of Kentucky's Libertarian Party, he was trying to find candidates and realized he was qualified to run for treasurer and even more qualified to get rid of the post.

"This is an administrative job, and it's impractical," he said. "I'm up here saying, here's the unnecessary spending; the reality is that the average taxpayer would never know the difference."

# Travis voters to decide on \$82.1 million for land, park facilities

Travis County voters will decide on \$82.1 million in bond projects to improve parks and greenways, preserve natural spaces and buy land for parks, including proposals to acquire vast swaths of land in the eastern and western ends of the county....

Opposition has emerged from the Travis County Libertarian Party, which says the bond propositions run counter to the Libertarian principle of "less government, more freedom," according to a news release Monday.
