Mr. Redpath asked that we consider a bonus for Andy Jacobs for his work in North Dakota but was told that it cannot be heard this evening as notice was not given, but it could be moved immediately on the LNC Business List.

EXECUTIVE SESSION

Secretary Harlos moved to go into Executive Session with the rest of the LNC present as well as members of the Ballot Access Committee for purposes of discussing political strategy regarding ballot access regarding confidentiality and related potential or potential related litigation issues.
