New Business

Dr. Glogowski spoke about sharing membership information between the political party and the corporation. His concern was sharing with the appropriate points of contact.

The chair appointed Fred Cole to act as liaison with the communications director of the LPNY.

Dr. Glogowski moved that the ISC request the LPNY corporation begin the process of creating a separate website for the ISC and the LPNY. Seconded by Dr. Becker. The motion failed 2-12-1.

Dr. Glogowski move that the list of candidates to be considered for nomination to be voted on be distributed at least three hours before the meeting and that the rules and officers of ICOs to be considered by made available at least 24 hours before they are to be voted to charter. Seconded by Mr. Arcati.

Ms. Dordal moved to divide the motion. Seconded by Mr. Coburn. Motion passed by a majority vote of the quorum present.

Moved that the list of candidates to be considered for nomination to be voted on be distributed at least three hours before the meeting.

The motion failed 5-8-1.

Moved that the rules and officers of ICOs to be considered by made available at least 24 hours before they are to be voted to charter. Motion failed by a majority vote of the quorum present.

Mr. Cole moved that Veronica Diver, Cody Anderson, Phil Vecchio, and Fred Cole be authorized to by this body to form ICO in Albany, Columbia, Rensselaer, and Schenectady Counties, respectively. Seconded by Mr. Coburn. The motion passed unanimously.

Ms. Dordal moved to name herself and Mr. Potwora to serve as liaisons to interface with the LPNY on the issue of websites. Seconded by Alyse. The motion passed unanimously. LPNY Liaison special committee.
