Privatization key to prison

There were 300,000 prisoners in federal and state facilities in 1977. Ten years later the Williams prison population had nearly doubled. This crowding prompts callous judges and parole boards to turn criminals loose to prey on the law-abiding public. Long sentences are handed out just to placate the public and a few years later parole boards free the criminal. In some cities, criminals are sentenced, then told to go home and wait until there is room in jail.

Privatization can alleviate the prison facility crisis according to Prof. Samuel Brakel of the Northern Illinois University Law School in a paper titled "Privatization and Corrections," published by the Reason Foundation, Santa Monica, Calif. Brakel says, "The federal government should develop contract guidelines addressing tax payer, prisoner, private provider, and public agency con-cerns." There are already some 25 to 30 facilities, under private management, totaling about 3,000 beds. And there are preliminary contract awards to private companies for 2,500 beds in yet-to-be constructed facilities.

While private prison facilities play only a minuscule role today, they must assume a more important role as public facilities become more bogged down in the mire. Despite the biggest construction push in the history of corrections over the last 10 years, the U.S. Sentencing Commission estimates there will be



tion over the next decade.

The construction of a maximum security prison costs the public sector an average of \$58,000 per bed. Medium security and minimum security construction costs are \$46.000 and \$26,000 per bed respectively. On top of that, it takes about two-and-a-half years to build a prison.

Brakel's report shows that the private sector holds out promise for better prisons at a lower cost. For example, the Corrections Corporation of America (CCA) has developed an impressive record. Three years ago, CCA built a 350-bed minimum security facility in Houston for the detention of illegal aliens. It was completed in the space o six months at a cost of \$14,000 per bed. This compares quite favorably to the Immigration and Naturalization Service (INS) average of two-and-one-half years at \$26,000 per bed.

Private prison management has had similar success in saving tax dollars in Hamilton County, Tenn., and Weaversville, Pa. At least 10 states have enacted enabling legislation specifically authorizing private-sector provision of

prison facilities. The only real question is whether prison privatization

Sales tax isn't the answer

Everyone is fed up with rising property taxes. Nobody doubts that property owners need relief. South Carolina has one of the highest total tax burdens of any state in the south.

South Carolinians would obviously benefit from lower property taxes. However, politicians often take a good idea and turn it into bad legislation. The local option sales tax bill is a good example.

If cities and counties are allowed to impose sales taxes on their citizens, the economy of the state will suffer. Property taxes are deductible on federal income tax forms, but sales taxes are not deductible. Therefore, if any property tax revenues are replaced by sales tax revenues, South Carolinians will be forced to pay more in federal income taxes. This will leave less money in South Carolina and more money in Washington. Does anybody seriously believe that this would help South



The taxpayers' concern is that prison costs be minimized at no cost to humane prisoner treatment. The evidence from our brief experionce with modern privately managed facilities suggests that these concerns are met.

The thornier issue has to do with the civil servants and bureaucrats who manage federal and state prisons. High positions in the prison system are political plums handed out to favorites. Privatization means fewer political plums to dole out. Public employee unions aren't wild about privatization. Politicians easily caved in to their demand for higher wages, more fringe benefits, and easier working conditions because the higher costs are passed on to the taxpayers. Since privately managed prisons will have a profit bottom line, unions will encounter more resistance.

It's time we give prisen privatization a chance. Our lives may depend on it.





Private sector does public jobs cheaper

It delights me for an editorial to read, "The taxpayer ought to be considered one of the legitimate priorities" (The State, Jan. 4). Taxes are higher in Columbia than in any other major Southern city except Atlanta, according to U.S. News and World Report (Jan.

Legislators and state executives need to remember that before they got to the public trough they had to go out and compete to win money to live on. They need to ask why private and church schools are educating children on half the expenses with virtually no dropouts, no functional illiteracy problems and no giant bureaucracy. They need to know how other states have improved their schools by allowing their parents a voucher to transfer to another school, public or not, if they think it is in the child's interest. They need to know that a variety of other government functions, from fire departments to computer services, have been turned over to private competitors at far less cost to the taxpayers.

But most of all, they need to remember that taxpayers don't have other people's money to spend and have better things to do with their money.

Knowing that you will probably refuse to print any sagreements with your prejudices, I am making copies is send to others. Let us start with the death penalty.

First, the largest number to be executed by a death penalty in the US this century has been from conscription. During most war years of the last 40, a larger percentage of those conscripted died as a result than the percentage of those convicted of murder, rape, or any other capital

The abolition of the death penalty in Great Britain has led the law enforcers, especially in Northern Ireland, to kill in the process of arresting. This is also true in some of the US States which have abolished the death

In Japan the substitution of cruel, inhuman jailing for the death penalty is hardly an improvement.

If an abolition of the death penalty is wanted, the courts must be given the right to impose the old life sentence for imprisonment for life without furlough, pardon or probation so that the murderer can be prevented from murdering anyone (except a fellow-murderer in the same prison) for life. In the old law, except for a few cases where it was proved that someone else had committed the murder, murderers were paroled only if they were so weak in old age as to be unable to defend themselves. Of course, there have always been cases of pardons being bought by bribery, which is why S. C. no longer allows this to the governor except for those who have completed parole. In a death sentence, it is almost certain that there is someone of the jury who knows that a "so-called" life sentence will be for a maximum of 25 years or whatever, probably allowing the person to murder in public again.

Also, it fails to mention that only one state, Utah, allows the convicted murderer a choice of a death sentence or life imprisonment without eligibility for parole, and in one of the few such cases there the mass murdered chose execution. In other states the convicted murderer has great difficulty in committing suicide, but it has often happened.

Now let's go to Amnesty Intl., which is not the whole truth. It has refused cases of cruel inhuman & degrading treatment in cases, like Mamuata in South Africa who led a murder squad against other blacks or Stephens of Vanuatu who resisted arrest in a case in which his son was murdered by the govt.

It has refused to take on many unfair cases, like that of Rep. George Hansen was convicted of omitting some financial acts of his wife to the Fed. Election Comm., which told him they were not required, and which most of the other House members also did. On his 2nd unfiar trial, he was sent back to prison, with an attempt to infect him with AIDS, for making a talk in a church. Likewise, although it supports those convicted of refusing to be drafted in other countries, it has refused to take the cases in the US, most recently Paul Jacob & Kevin Gillian, both of whom received scandalously unfair trial.

Why it refuses to take cases of political prisoners in the US or Great Britain, as their USA director, Lyons, pointed out to them in the 1960s, is unknown.

What is holding up abolition of the death penalty in the US, where most of the States reinforced it when the Supreme Court threw out death penalties is that the court has no other way to keep a murderer off the street permanently. Because there are so many murders in the US, no one can keep up with all. Bundy (white) in FLA is trying to delay the death penalty by confessing murder in other crimes he has not been tried for. He thinks that by forcing all the trials and appeals for every serial murder, he can delay death indefinitely.

for 18 years of the 18th century by the Czarina Yelizaveta, what she substituted was torture (the knout!) and cruel, inhuman punishment. In the USSR they declared

that they had abolished the death penalty by announcing "10 years without correspondence" as the penalty in the 1920s. Even Stalin quit using that lie.

The reason that a court will try for a death penalty in cases of mentally retarded or insane murderers is the obvious knowledge that if released they will probably murder again, so that letting such a person out is executing a death sentence on some one in the public as a future murder victim. In one Texas case the court wanted to indict the state parole board as accessories to murder. In the Lee case in Florence, SC the insane murderer had gotten out of the state asylum on a previous conviction of attempted murder, by escaping without the asylum notifying the sheriff. This time he did rape and murder. If the court knew that they could keep such a person in security permanently, they would not try for a death sentence.

Now what causes the death sentence is the court's conviction that there is no way to rehabilitate this murderer. For example, in family murders, they think that no one will be stupid enough to marry the man who killed his wife, as no one else is really in danger.

But the most flagrant misleading statement is that those who committ murder are predominately male. Female murders are uncommon, and largely of members of the family. In a NY case of murder of some 8 adopted children, no one else was in danger, if they could keep the murderess from adopting any more.

That those selected for the death sentence are predominately poor, is that those who commit murder. despite TV publicity, are also. Rich murderers just get far more publicity.

The same can be seen in bank robberies; those who use a gun and kill in robbing a bank are almost exclusively poor. (Those who are not poor rob banks by embezzlement.)

Death sentences for murder are disproportionally blacks, because in the states with active death penalties, except Florida, have a population which is disproportionately black, and a murder act which is disproportionally black by far. Florida, curiously, has executed more whites.

That the victims were nearly always white is also an interesting curiosity, because there is one case pending in this county of a black who admits killing 4 young white females, one of whom was his wife. But interracial murders are also disproportionally blacks killing whites. Whites killing blacks, excluding police officers & prison guards, are rare; there have been exactly 2 in S. C. in the 80s, and one of those was a convicted murderer hired by a Sicilian to kill the black who had murdered his parents, and who had escaped the death penalty by faking mental retardation.

The cases of whites killing whites, or blacks killing blacks contain many lesser offenses, such as claims of temporary insanity in marital cases. The first temporary insanity defense in S. C. to succeed was a policeman (the only one killed in the city's first 100 years) who was caught in bed of another man's wife. If he had lived, she would have claimed rape and he would have faced a capital sentence. Likewise a 16 year old black shot and killed by police when he refused to drop a knife with which he was threatening to kill someone. The NAACP was very upset with the police officer; she was black.

I enclose a copy of Otto Scott's article on reverse racism, something that is a serious problem in the Amnesty Intl. USA, which is why, although I was the first AI member in the South, I got AI to transfer me to another group, because of some of its prejudices.

It would be superfluous for me to mention fat it happened in Los Angeles.

Any story this strange could only happen in L.A., which is to Oddity what Politicians are to Felonies. (And before any L.A.-baiters let their smiles get excessively broad smiles on their faces, I should perhaps make it clear that we're talking about the L.A. which is the most startlingly beautiful city in the country, & most exciting, & the most important, and: The Future of Us All.)

On a Spring day in a couple of high schools in West. L.A., some subversives took control of the schools' public-address systems in a way that the announcer used to say "We are taking control of your television set" at the beginning of "The Outer Limits" TV series of the 60s. The song was Pink Floyd's ANOTHER BRICK IN THE WALL.

These are its friendly lyrics: "We don't need no education..... We don't need no thought-control..... No dark sarcasm in the classroom..... Teacher, leave them kids alone...."

Then the chorus: "Hey! Teacher! Leave them kids alone! All in all, its' just a brick in the wall..... All in all, you're just another brick in the

That verse/chorus combination is sung in its entirity twice: First there's a seminormal-sounding version (intense, but recognizably-human) by Pink Floyd; then there's an overpowering version sung by 100 carefullychosen junior-high students. What they were "carefully-chosen" for was a voice quality which could be described as rasping, or shreiking, ot threatening or chilling or better yet, all of those. While P.F.'s version reached a level of great voicetension, the kid-chorus's version left mere "tension" far behind impressively and reached for something like Enraged Dementia If there are any schoolchildren on Neptune, this is the way they must sound — on a bad day, when they've all just flunked out and their allowances have been cut off.

That blood-curdling Neptunian Choir understandably drew a certain amount of attention from prison officials (as I understand it, they refer to themselves as "school administrators"), and an investigation was quickly begun, one designed to uncover how the audio-vandals had managed to splice-their-way into the P.A. systems and delive their anti-school-indoctrination

Consider:

(A) Along with the police, the school-system comprises the core of the state, for without the ability to thoroughly indoctrinate each oncoming generation (in state-worship), all regimes would be disastrously weakened; AN-OTHER BRICK IN THE WALL might have chosen any part of the state to attack - but it chose the right part.

(B) The first two lines of the verse are blunt in equating "education" and "thoughtcontrol"; true education doesn't always have to be thought-control, of course, but state education necessarily is, for by defination any state-run system must teach the legitimacy/ desirability of the state.

(C) The "dark sarcasm" line alludes to more than just narrowly-defined sarcasm, & is meant to refer to the general-air-of-superiority affected by all government-teachers-over-alltheir-kid-prisoners; most kids recognize intuitively that they're mentally/intellectually "pushed around" by the custodians-in-schools, and that's a leading reason why students tend to (accurately) see the public schools as prisons.

(D) If the teacher-leave-them-kids- alone line make those teachers sound like childmolesters, that's entirely appropriate, for that's just what they are, as long as they work for the government: Although they may avoid the message. The struggle of the Libertarian Party is nothing less than the struggle for freedom. And party politics is the most efficient way to educate, inspire, and recruit for that cause.

It's true that, in the decade or two that the Libertarians have been on the ballot, no great inroads have yet been made into the system. It's also true that, as a philosophy, Libertarianism has not enjoyed huge popular support. But there have been a few triumphs lately which more than justify our continued efforts.

Two weeks before this election, I was on a cross-country road trip, which gave me the opportunity to sample many of the local and regional newspapers as I kept up-to-date on the campaigns. Several things surprised me, and also delighted me.

I counted no fewer than twelve articles about Libertarian presidential candidate Ron Paul in the short span of two weeks, and not only in small town papers, but in major publications such as the Chicago Sun Times, the St. Louis Dispatch, the Los Angeles Times, and the Wall Street Journal.

I saw coverage of Dr. Paul escalate from 4:00 a.m. cable-TV filler spots to popular daytime news and interview shows.

And the most impressive recognition, I thought, was in Los Angeles, where the state ballot initiatives guide provided not only Republican and Democratic viewpoints, but, you guessed it, the Libertarian view as well.

In 1992, the two major parties will face enormous chalenges. The Democratic party is being torn apart by its own factions, and is suffering a tremendous loss of membership; they are bracing for the nomination of a left-winger like Jesse Jackson. The Republican borrow and spend practices, plus new revelations about the Iran hostage crisis, will blow up in their faces before the next election.

Voters are beginning to reject the polarization of the two parties, because the parties have grown out of step with the American ideals of freedom, opportunity, and reward. One of the few points on which all the polls agree is that more than two-thirds of the voters wished they had someone else to vote for!

No, we probably won't win in 1992; but if we dedicate ourselves to increasing our national exposure, we have a real chance to keep the movement toward statism in check. Victory at the polls will come in time.

The United States had a two-party system in 1860 also, but bad odds didn't stop Abraham Lincoln and the then-third-party Republicans from lighting for their beliefs. And they won.

The founding fathers of this nation didn't surrender when their troops were hopelessly outnumbered by the British; to abandon the party because the waters are rough is not only cowardly, it is a disservice to ourselves and to our children.

Bush Wants To Keep No-Tax-Boost Pledge

President Bush, at a January 27 news conference, stated that he would like his campaign promise not to raise taxes to be a four-year pledge. He also reaffirmed his support for reducing the tax rate on capital gains. During his campaign, Bush advocated lowering the tax rate to 15 percent. He disagreed with arguments that a capital gains rate reduction would worsen the federal deficit.

Citing estimates that a lower tax rate on capital gains could bring in more than \$4 billion in additional revenue, the President maintained that reducing the capital gains tax rate could not only result in higher revenue but could also create additional jobs. He did, however, acknowledge that there might not be sufficient congressional support for such a reduction.







Politicians must disavow 'racial charlatans'

Lee Atwater, chairman of the Re-blican National Committee, publican National Committee, George Bush, and Ronald Reagan were the first to disavow him as a member of the GOP. Later on, other Republican and Democrat stalwarts

you won't hear asked at press con-ferences: "Mr. Bush (or Mr. Atwa-ter), since you repudiated Duke's political victory, won by his campaigning against race being used as a criteria in hiring and college ad-mittance, does that mean you're in favor of race as a determinant for jobs and college admittance?

What do you suppose would be the response to the question? I pre-dict they'd rephrase the question, or at best give a convoluted answer, but not a clear yes or no.

George may honestly think that race is an immoral criteria for deciding who gets a job or is admitted to college. But his political advisers may feel that a forthright statement against racial quotas may thwart the GOP's efforts to become "Amer-

ica's new majority party."

If the president and his men, as well as other politicians, share Duke's stated position against racial quotas, isn't it dishonest or lacking in courage not to say so? And

doesn't it smack of political deviousness to be against racial quotas to curry favor with blacks while criticizing Duke?

Libertarians take low blows for high ideals

No doubt about it: Libertarians are an oft-misunderstood species, as Arkansas traveler Paul Jacob knows full well.

Ten years ago, when you said you were with the Libertarian Party, they'd ask, 'Are you all Communists?' " the 28year-old Little Rock native said wryly.

"Now they say, 'Are you LaRouchees?' ... the 'bogey-man' has changed a whole lot, but we haven't," said Jacob. the man who served as national ballot coordinator for America's largest third party last fall.

Libertarians are, in fact, neither Communists nor followers of recently convicted felon Lyndon LaRouche.

Instead, they like to think of themselves as a group of rugged individualists who banded together to form their own party in 1971. Last year, 431,499 Americans voted for Libertarian presidential candidate Ron Paul of Texas, a former GOP congressman who decided that the big parties were two peas in an overgoverned pod.

"I think Libertarianism, as a philosophy, kind of speaks to the individualist and the pioneer in us," Jacob told The

Commercial Appeal in a recent interview.

'It's very free-market-oriented. We put a lot of faith in individual initiative, innovation and coming up with new ideas.

Trouble is, voting Libertarian is a new idea that has not caught on very fast. Ed Clark, the party's presidential nominee in 1980, polled almost a million votes. But the Libertarian total sagged to 231,000 four years later, perhaps partly because Ronald Reagan picked up (or stole) many of their themes

Ron Paul almost doubled that total in 1988, but the party still won less than one of every 200 votes cast.

Arkansas native Jacob wants to help remedy that. He became the Libertarian Party's national ballot drive coordin-

ator last fall, succeeding in getting the party on 47 state ballots.

It seems that Americans just aren't used to voting for thirdparty candidates. Even worse, minor parties tend to be seen as minor parties tend to be seen as a collection of kooks, crooks or both. A man who attempted to run his dog for president in 1984 didn't help the image much elevel ther. Jacob noted.

"He causes us a lot of prob-lems." Jacob continued, "because (most) people think about

politics when it gets close to an election, and if LaRouche is the person . . . they hear about most, then if you have a new idea or a new party, they just naturally associate you."

Still, the Libertarian Party has had more success than almost any other modern "minor" party. Jacob says it boasts elected or appointed officials in 22 states.

What Libertarians stand for may sound attractive to many.

David Bergland, the party's presidential candidate in 1984. said the party wants to "substantially reduce the size and intrusiveness of government and cut all taxes.

"Let peaceful, honest people decide for themselves what to eat, drink, read or smoke and how to dress, medicate themselves, or make love, without fear of criminal penalties," Bergiand added.

In foreign affairs, "The U.S. government should defend Americans and their property in America and let the U.S. taxpayers off the hook for the defense bill of wealthy countries like Germany (and) Japan."

Not everyone will agree. But so far, Jacob mourns, the main problem has been getting the

message out.

The media tend to concentrate almost exclusively on Republicans and Democrats, and some Americans think the two-party system is almost part of the Constitution.
