



### Ron Paul meets northwest Libertarians

Texan front runner grilled by delegates at Tacoma barbecue by Tom Tanaka

Ron Paul, former Republican Congressman of Texas, was in the northwest to persuade local delegates to support his bid for the presidential nomination at the Libertarian National Convention in Seattle this September.

Paul arrived from the Idaho LP convention in Boise to attend a barbecue in Tacoma on June 27. He spoke before a gathering of 65 people to stress that 1988 was an opportunity the LP couldn't miss. Paul believes that the American people are disgusted with the Democrats and Republicans both and would gladly hang their hats on the Libertarian peg if the choice is given to them. Paul urged renewed efforts at fundraising and motivation to this end.

After a hearty meal of barbecued chicken and salmon, delegates from Oregon and Washington met with Paul for an amicable grilling of the candidate on his campaign stands.

Paul said his campaign, which has raised over \$200,000 so far, would stress economic issues, and that by speaking to those issues he would be speaking "to the belly." He believes that employment and financial security are basic concerns of Americans. Accordingly he will stress sound money, abolition of taxes and reductions in government spending.

On foreign policy he advocates a noninterventionist U.S. stance with an end to military subsidies to American allies. Paul stressed that credit subsidies to the Soviet Union must cease immediately. He believes that defense should be limited to the protection of America and advocates the closing of all overseas American military bases. Paul supports a move toward unilateral free trade as well.

Paul is known for his controversial stand against abortion, his only point of disagreement with the Libertarian Platform, a point which probably prevents him from being an automatic shoo-in over Russell Means. Paul holds that life must be assumed to begin at conception and does not see any contradiction in this belief with the libertarian philosophy.

Apparently radical anti-abortion advocates don't feel satisfied with his positions on this issue either. Paul believes that abortion laws should be handled on the state level and he is opposed to restrictions against "morning after" pills which would induce abortions. He acknowledges difficulty in handling extenuating cases such as teenage pregnancies. He believes that penalties for abortions should be weighed against the particular circumstances under which it was performed.

Paul stated that support has been high for his campaign among his newsletter subscribers and former constituents. He pledged to support local ballot access efforts where feasible and to cooperate with state and local campaigns.

Attendance at the barbecue was the highest for a state LP event since the Freedom Conference held in April 1985. 125 people attended that event.

Before returning to Texas Paul met with Washington State Senator Jack Metcalf (R). Metcalf is spearheading a drive to challenge in U.S. Supreme Court the Federal Reserve's authority to issue debt money. Metcalf's bill (SB 5444) will appear on the ballot this November for voter approval. Paul is chairman of The Committee to abolish the Fed.

Paul was also interviewed on KING radio by Dennis Nettles on a 30 minute program. He took questions from listeners by phone and plugged the upcoming national convention as an important historic event.

## Here at last!

### Historic occasion for Libertarian Party to take place in Seattle.

Most of you have been following the progress or participating in efforts to bring the Libertarian Presidential Nominating Convention to Seattle's Sheraton Hotel. We are now on the home stretch.

Concerns still exist about the expected attendance. The reason is the lowered delegate count due to changes in the Libertarian national bylaws and reduced membership when the tallies were made. Some efforts are being made to organize a move to increase the delegate count as the first order of business so that alternates may be seated. There is doubt that some states will send any delegation at all. Larger states such as California are attempting to fill the positions of those states.

Other than that enthusiasm for the convention seems to be spreading in movement media sources. The convention has been advertised in Reason, Nomos, American Libertarian, LP News, and various newletters. A 12 page promotional tabloid was mailed to lists of over 35,000 names.

Larry Reed from the Center for the Study of Market Alternatives will be added to the speakers' roster. He will speak on the Polish solidarity movement. He will be accompanied by a Polish student and libertarian.

A babysitting and childcare service will be available on the convention site in one of the hotel rooms.

Norma Jean Almodovar may not appear as a speaker. The California Supreme Court has refused to hear her appeal of a blatantly unfair and unjust 3 year minimum sentence for pandering designed to silence and punish her for writing a book exposing police corruption.

Tom Robbins, a Washington state author, will be unable to attend. The appearance of Doctor Demento is uncertain at this time.

The Carribbean Super Stars, a steel drum band, has been signed to provide live music on the Puget Sound Cruise. Individual ticket prices will be \$40 and includes a dinner.

Other ticket prices are speakers: \$7.50 per event, Presidential Banquet; \$60, Breakfast events (4); \$30, LP Birthday Soiree; \$20, Movie series; \$15, Self-Government Advocates series; \$75, All speakers excluding SGA series; \$100, Bumbershoot tickets; \$14, Notebooks; \$7.50.

Tickets to breakfast and banquet functions are in limited supply. Advance reservations are suggested.

### Liquor tax opposed

Costco Wholesale is fighting against a regulation enacted by the Washington State Liquor Board requiring a minimum 10% markup on the retail sale of beer and wine. Costco is a member organization that offers goods at wholesale prices.

Northwest Libertarian

Costco president Jim Sinegal stated in an editorial in the member newspaper Costco Connection that his company would not comply with the regulation and would challenge it in federal court.

Sinegal writes: "We believe the State has provided ample proof that it does not do well in the business arena. One need only look at the condition of the Washington State Liquor Stores as evidence that they are out of their element. The private sector could make that business profitable and lower prices in the process. Incidentally, the State excluded its own liquor stores from compliance with the regulation. How's that for unfair competition?"

## Other candidates toss hats in

The LP News has described the upcoming convention as The Battle in Seattle.

Last month this newsletter reported on three individuals who are seeking the Libertarian nomination for president. Those three are Carol Newman (who has reportedly just dropped out), Jim Libertarian Burns, who proposes spending all campaign resources in Vermont and Nevada for a maximum media blitz, and Harry Glenn, a retired welder and self-described constitutionalist. Since then the Northwest Libertarian has learned of two others.

Jim Lewis was the Libertarian vice presidential candidate in 1984. He is a book binding company representative and constitutional tax resister. He is the author of Liberty Reclaimed. He can be reached at 2 Neponset Ave., Old Saybrook, CT 06475 (203) 388-2046.

Edward W. Roth is a self-employed cabinet maker who "wants to make sure his kids have a country." He can be reached at PO Box 9053, Downers Grove, IL 60515 (312) 969-2314.

These five contenders are not likely to be a threat to either Ron Paul or Russell Means who are campaigning diligently and have extensive support from within and without the party.

In the Libertarian Party the vice presidential candidate is elected by the convention delegates, rather than chosen by the presidential candidate. Presently Andre Marrou, former LP Alaska legislator, is focusing his efforts on obtaining this nomination along with Ron Holland. Marrou can be considered the sole front runner at this time.

# Simplified ballot access laws soughts

HR 2320, the unsuccessful bill to ease ballot access restrictions, has reemerged as HR 1582. This bill would set uniform ballot standards for elections to all federal offices. Currently each state makes its own laws concerning access to the printed ballot for non-Democrat/Republican political parties. In many states the requirements are so stiff that opposition parties are virtually barred from the electoral process.

HR 1582 would set a maximum of 1,000 petition signatures to qualify a third party candidate for federal office in any state. By contrast some states require as much as 80,000 signatures.

Richard Winger reports in Ballot Access News that HR 1582 has acquired 21 co-sponsors. This is much better than HR 2320 was able to do in the last legislative session. Winger reminds us of the days of truly free elections in this country: "...in the 19th century, there were absolutely no restrictions on who could be on the ballot, since there were no government printed ballots. Voters could make their own ballots, but most ballots were prepared by political parties. Voter turnout usually exceeded 80% of the eligible voters, sometimes over 85%. ...when both major parties shut out entire segments of the population, new parties arose suddenly and in considerable strength."
