I think it should be made clear to LP National in very certain terms that Jilletta Jarvis was (and currently is) STILL CHAIR of the LPNH and insomuch when she registered the party name with the state (on/around June 5th) she de facto **did so acting as current/active chair for the organization for which she was dutifully elected**.

To be clear: Jilletta has not resigned (and she still has not resigned) when performing this official function. although I am no lawyer, I feel this timing is critical from a legal standpoint—as she cannot perform this duty for a "competing organization" while active in the current party's leadership and executive committee.

I also would like to mention that she NEVER once suggested to the EC (which I am a part of) the need to renew/file with the state as she attested in her video interview. If this was stated it would have been recorded in the official EC Minutes, which were dutifully kept by our former Secretary (recently resigned on June 10). Jilletta has all these minutes, but has locked the rest of the EC out of Google Drive so we cannot access them (or any of our other party documentation, minutes, or files)!!

If she had this conversation with our Treasurer (cc'ed) she must have had this conversation in private and i will not speak to that. But the idea that this task "was not done" as a pretense for disaffiliation and creating a new organization is beyond frustrating to say the least. She was (and technically still is) responsible for this task in her official capacity as chair—even if she did delegate the responsibility to someone else as she claims.
