FILING DEADLINES FOR CANDIDATES ANNOUNCED

As of January 26, The S.C. Election county). (file with SCLP Exec Com) considered for nomination. Commission has informed us that the filing deadlines for candidates (for the 1996 elections) will be:

March 16 (noon)-March 30 (noon) for county candidates, State Senate & House districts within one county (file with county chair)

April 16 (noon)-April 30 (noon) for U.S.Congress & Senate, state wide offices and State House & Senate districts (more than one

(Note: As in previous years, legal challenges to district lines may postpone these dates, but, based on the information we have now, these are the dates to plan for.)

County candidates are nominated at the county conventions in March, U.S. and state candidates (including State House & Senate) at the state convention. in May. But, all candidates must have first filed with the appropriate party official during the filing time periods or they can not be noon Feb. 15 to receive instructions.

If you wish to be a candidate, you should contact your county chair or Exec Com rep immediately.

By State law, all county clubs wishing to nominate candidates must run a 5x7 ad 2 weeks prior to March 16, and fulfill other legal requirements. If you need instructions on how to do this and did not attend the Feb. Exec Com workshop, or, if you are in an unorganized county and want to be a candidate, contact M.L. Seymour (803-593-6876) by



Blue Laws: An Unnecessary Government Intrusion

Most counties in South Carolina still have Sunday closing laws, also known as "blue laws". Of course, Libertarians are against these laws, and have urged their repeal for vears.

One important question has been lost in the debate about blue laws: Where in the Bible or in Christian doctrine does it say that we should arrest those persons who choose to do business on the Sabbath? The answer is: nowhere. Jesus never asked his followers to throw non-believers into jail! That

amount of force is as un-Christian as have to waste their time arresting one can get.

Many persons observe the Sabbath on Saturday, but these persons have not asked anyone to force stores to close on Saturday.

I personally often have to work on Sundays. I try to attend church on most of the other Sundays. However, that is my decision. My religious practices are not affected by someone choosing to use force for any other purpose. shop while I am in church.

Law enforcement officials have enough difficulty catching violent criminals. They should not peaceful, honest citizens who aren't hurting anybody.

As a Libertarian, I have long opposed the blue laws and any other laws that impose particular lifestyles. The government should be limited to its proper function: protecting each person's right to life, liberty, and property. There is no religious or moral basis for the government to

LEGISLATIVE WATCH: Initiative & Referendum

Many states allow their citizens to introduce legislation by petition. (initiative) The proposed legislation is then put on the ballot for a vote (referendum).

In S.C., although initiative by citizen petition is available on the county level (except in tax matters), it introduced Jan.23,1996.) is not available on the state level.

Several bills were introduced last

year in the S.C. Legislature with different versions of initiative and referendum (S.57, 192, 465; H.3077, 3045). This year, a version has been introduced which would allow citizens to petition for the repeal of laws, as well as the passage of laws. (H.4470,
