Problem: The proposal as passed might not currently include a delaying proviso. Since this proposal changes delegate eligibility, I do not think it should go into effect midconvention.

Solution: Add a delaying proviso to the proposal as passed.

Benefits: This eliminates the possibility that any delegate could become ineligible midconvention.
