Bill would require cigaret firms to pay medical expenses of certain smokers

Legislation to require cigaret manufacturers to pay the medical expenses of long-time smokers who die of lung cancer or emphysema has been introduced

The sponsor, State Sen. Bob Kustra (R, Des Plaines), said the legislation was patterned after the strict liability imposed on taverns and liquor stores for alcohol-related accidents caused by their patrons.

The bill's intent is to shift the burden of the costs of cigaret smoking from the general taxpaying population to those who cause these diseases - the cigaret manufacturers," he said. The proposal also would allow the Illinois Dept. of Public Aid to recover medical expenses for welfare recipients who die of lung cancer or emphysema. Kustra said the state annually paid more than \$10 million in hospital bills for these patients.

Ambitious Chinese saw that the time was ripe for domination of the world by guncarrying ships. They pulled their high technology together and built dozens of large sailing junks with multiple masts, steered by sternpost rudders, navigated by magnetic compasses, and armed with guns. In A.D. 1405 a powerful fleet set off to impress the barbarians, and a succession of expeditions overawed half the known world, gathering treasure from as far away as Mecca and Africa. Had that naval policy persisted, this book would be written in Chinese. Officials and accountants persuaded the emperor after less than thirty years to put a stop to it, and eventually they destroyed even the records of the voyages. It was bureaucracy's most breathtaking accomplishment.

Free individuals Know Base

Gary Hart's call for "a new patriotism" and mandatory national service for young people simply underlines what all the left wing politics is—the politics of slavery.

Sen. Hart apparently thinks that our young people aren't wise enough or worthy enough to decide for themselves how to run their own lives. He would take them from their homes and let a bunch of bureaucrats decide how these teen-agers would spend their time. Just because these youngsters were born when they were, for some reason they owe the government control over their lives.

WELL, IF A PERSON truly wants to provide a service for the government, or anyone, he certainly should be allowed to voluntarily do so. But what right does the government have to tell our teen-agers, "Either you will serve us or we'll put you in jail?" This is the most inhumane attitude a "compassionate" man like Sen. Hart could have.

Hart's type of "compassion" is the same kind of compassion of Lyndon Johnson, the president who forced young men to fight and die in Vietnam. Hart claims to oppose military intervention, but if elected, you can bet your boots he'll use his flocks of young slaves for military intervention somewhere abroad.

This policy of compulsory national service is the kind of program we would expect from Adolf Hitler or Josef Stalin—not from the nation founded by George Washington and Thomas Jefferson.

AMERICA WAS FOUNDED by persons who believed that the individual knows what is best for himself. These "selfish" individuals fostered the strongest, most prosperous nation in human history.

OO WE NEED ORGANIZED LIBERTARIAN STUDENTS?

Have you ever stopped to consider the importance of the libertarian student movement? If you have never given thought to this question in the past, perhaps you should now. The future of the libertarian movement may depend upon your answer.

A recent article in a major Midwest daily newspaper made note of a growing phenomena that should provide us all cause for concern. The article made note of the fact that there are now more than 80 conservative newspapers published on college campuses around the country. These periodicals are not published by adults, but rather by conservative students who are receiving substantial funding from adult sponsors. In one case cited, upwards of \$10,000 was being provided conservative students to publish a campus newspaper.

The right is not the only group organizing on campuses. The left has long recognized the importance of students and youth as a group. Virtually every left wing sect devotes resources to publishing an outreach newspaper. Using their own publications, conservatives and leftists, student and adult alike, are moving to attract young people.

And we libertarians? Two times in recent years the NatCom of the Libertarian Party (LP) has considered forming a youth group, but decided in the end against it. Though the reasons were varied, for young libertarians like myself the result was the same: We had no organization to back us up on campus

Now somebody has taken positive action to address our movement's lack of a youth group. Founded in 1982, the Libertarian Student Network (LSN) has recently embarked on an ambitious program to fight the left and the right for the hearts and minds of our nations young people. Through its outreach newspaper, YOUNG LIBERTARIAN, the LSN is moving to attract students to the libertarian cause. And meeting with success. During the last month the LSN has nearly doubled in size, and all indications point to a 25-campus network by this fall. Clearly the LSN is doing good things, positive things, on behalf of our movement, and activists such as myself.

How long the LSN will be able to carry the libertarian banner is another question altogether. One point is without dispute: Without adult support the LSN cannot long continue to publish YOUNG LIBERTARIAN for distribution to students. The LSN needs your support to succeed. How much support? You may be surprised at learning how little is needed to publish YOUNG LIBERTARIAN. \$3, ØØØ, a mere pittance compared to what the left and the right spend, will allow the LSN to publish YOUNG LIBERTARIAN on a quarterly basis. \$5,000 will allow the LSN to increase its frequency of publication and distribute hundreds of copies of Murray Rothbard's "For A New Liberty" into the hands of interested students.

I am sure you will agree this is not a large amount of money when one considers the benefits our movement will accrue from such a group. Many LP leaders graduated to their current positions from student organizations. If our movement is to survive and grow there will have to be others in the future.

Now that you have had time to consider my original question there are three things you can do. One, you can subscribe to YOUNG LIBERTARIAN. At \$5 a year it is one of the best bargains around. Two, you can make a one-time donation or pledge a specified amount every issue. One former student libertarian, now a member of the work force, pledged \$1,000 to the LSN recently, reducing to \$2,000 the amount needed to publish YOUNG LIBERTARIAN quarterly. Finally, you can tell young libertarians in your area about the LSN, and have them tie into the campus network.

We face an uphill battle when we take on the statists. Building an effective student group will make that battle easier for us all.

Ravenel raps Senate for exception to rule



THERE SHOULD BE GOLD & SILVER STOCK IN YOUR FUTURE By Robert J Chapman, Investors International Securities, 32123 Lindero Canyon Rd. #300, Westlake Village, California 91361.

Gold's value is a reflection of other events. the mirror of international tensions and a barometer of fear. It registers in dollar terms the anxiety level of world events. Gold is money, the only real money there is. It has no price. It measures the direction of all other prices. It would seem to me, looking at the direction in which international governments are headed, that a level of stability, both political and economic, is some way off.

Protection of one's assets is the individual's first line of defense when faced with the inflationdeflation syndrome created by our bankers. For the past 23 years I have unchangingly felt that gold and silver stocks have been the best protective device: owning the stocks when inflation and world events prompted it and being short these stocks when the storm subsided.

Historically gold and silver stocks have only had interrupted trading world-wide for several days at a time. On the other hand, governments have over and over again confiscated gold and silver bullion and coins. This is because the bankers and politicians usually use the gold stocks as one of their vehicles to wealth. As an example, in 1933 35 when coins were forcibly collected by our government. Homestake Mining stock went from \$4. to \$400. per

During the 1977-80 period gold stocks outperformed bullion by anywhere from 3 to 40 times. Gold began its bull market in 1968. Since that time the stocks have gone up approximately 40 times more than bullion, not taking into account dividends.

There has always been an open and free market in gold stocks, making them cash-liquid on any trading day. All South African and many U. S., Canadian, Australian gold stocks can be bought and sold on some 40 stock exchanges throughout the world.

Enormous leverage exists in gold and silver stocks without using margin. It costs no more for a mine to produce gold whether gold is \$400. per ounce or \$800. per ounce. The mine has a set cost. which increases with inflation.

Historically South African mines have paid dividends varying for 5% to 30%, depending on the stock. North American mines have paid very small dividends, taking the profits and plowing them back into the companies for further development and growth; two decidedly different concepts of management objectives.

The potential for the future in gold stocks, needless to say, is tied to gold's price. An interesting history shows that only a handful of people throughout the world own either gold or gold stocks, perhaps only 3% to 5% in wealthy countries. If this percentage were to be changed to only 10%, a dramatic change in gold and gold share prices would occur. If the cash-rich OPEC countries or pension and profitsharing plans or insurance companies put just 5% of their assets in gold or gold stocks, the price would explode.

Of all the gold-related investment vehicles, the gold stocks particularly the South Africans, have been purchased by the most astute, sophisticated investors. These are not plungers, but observers of the world economic and political climate; hence, the stocks usually run ahead of bullion on the way up

and the same on the way down. Consequently, if one is to invest in gold stocks, he or she should seek someone out as a broker who has specialized in those stocks for some time.

Our present political situation is disastrous. as usual. Supply-side economics has been abandoned. It was never meant to succeed. How could it with our indestructibel welfare state, budget deficits of \$200 billion, trade deficits of \$175 billion and government intervention in the free market? Then there were those "now you see it; now you don't" tax cuts: increases. Mr. Reagan must have learned those as he sat out WWII on the Culver City lot. Harsh, but true. He has 65 Trilateralists as advisers, more than any previous president.

Rep. Ron Paul said recently at the Duck Financial Conference in Costa Rica that, "Our government is in a state of collapse." He's right, and let me give you some of the reasons.

The Federal Reserve Board, controlled by David Rockefeller's Council of Foreign Relations and his Trilateral Commission in league with other major bankers, is implementing a controlled monetary col-

The F. R. B. has agreed to bail out The \$1.7 billion Euromarket created by the Swiss and British bankers. If this isn't staggering enough, they also, through the Monetary Control Act, will bail out the major world banks' loans of \$1 trillion to the Third World and communist countries. The credits created by the Fed to pay off these debts will cause inflation in excess of 20% in 1986. These factors alone should push gold well into the thousands of dollars per ounce area and silver over \$100 per ounce. Make no mistake; every Third World country and

communist country will default on its debt. Mexico will be followed by Argentina, Brazil, Peru, Colombia, Zaire, Zambia, Tanzania, then Poland, Romania, and Yugoslavia. There are scores of countries that are technically in default right now. It is only a matter of taking them one at a time in order to keep the whole edifice from collapsing. The Monetary Control Act of 1980 that makes all this possible was passed by a 380 to 13 margin. Most of the Congressmen who voted for this bill never read it, and even if they had, most of them would not have understood it. This act is the most inflationary piece of legislation ever passed. It allows the Fed to bail out the world. Not only can the Fed monetize the Eurodollar debt and the debts of other nations, but it can also monetize Municipal Bond debt. Since the enactment of this legislation, it has been used over 70 times for foreign debt purchase. That surprises you doesn't it? They just don't tell you about it. You don't have a need to know. I might add here that the inflation that will be caused by the Monetary Control Act will, in and of itself, stop any deflationary aspirations the world economy might have over the next 10 years. The deflationists are dead wrong. They do not understand the conspiracy. This is a battle of psychopolitical warfare, the result of which is economic warfare. Some day they will be right, but not now. We are not to the cracking point as yet. If you follow the deflationary theorists you will miss an enormous opportunity to protect your assets and perhaps to make a cushion of additional profits to keep yourself financially afloat for the future.



Can you believe the Omnibus Banking Bill was passed by a voice vote, that is the votes were not recorded, at 10:30 at night? Just as the Federal Reserve Act was in 1913, late at night just before Christmas. This bill allows the government insuring agencies. FDIC and FSLIC, to bail out any company which controls or contemplates controlling a bank or savings & loan. Guess who supplies the cash? You are right - the Fed. This means in times of emergency the Fed has the power to force mergers and takeovers of other financial institutions. This will allow the major Trilateralist-CFR banks such as Citibank, Chase Manhattan, Manufacturers Hanover, etc. to pick up all the small banks and savings & loans in the country for 25¢ on the dollar, under the guise of a financial emergency which they in fact created themselves. The first instance of this being used was in the forced merger of a major San Francisco savings & loan into Citibank. In effect this bill will cause the demise of banking as we know it in America. Several major institutions will control all banking. It will also cause an end to the underground economy. It will make it impossible to function, thereby controlling all of our financial lives. With this, it will control us totally. George economically for almost 3 years. The American Orwell was right. His timing was just off a little. This is also going to allow these megabanks to form Bank Service Corporations, which will vastly expand their non-banking activity into insurance, mortgage banking, commercial data processing, real estate and owning stock brokerage houses; all of which they have heretofore been prohibited from doing. Of these two pieces of legislation, I do not know which is worse. Simply put: we have been had again.

And if the aforementioned bills were not enough, they were topped by the passage 3 years earlier of the International Emergency Economic Powers Act. Essentially this bill allows the President to implement foreign exchange controls over all foreign exchange transactions, assets and property. As I returned by plane from the Duck Conference lately, I was really surprised to see many signs telling you to declare anything that could be of monetary value over \$5000. No signs were seen telling you that you could bring in only \$300. worth of foreign goods. The big push is to let you know that your government is watching you and your money. This act was enacted to allow our government to find and control all your assets.

I should add here that the above 3 pieces of legislation will be very instrumental in a number of ways in causing gold particularly and silver to go to historic highs. All the bills are highly inflationary and may not be totally implemented for some time. The only solution now is partial expansion of banking activities by the majors and partial money control. This phase should end in 1986-7 to be followed by a new phase into the early 1990s for further implementations. This means another bull market in gold will follow the one we are currently in. The exception to this projection would be if we could stop these criminals in their tracks. Only time will tell.

Forecasting is a dangerous game where the experts are right only one-third of the time; and here I have attempted to take you into the early 1990s. I guess the U. S. government made a terrible mistake by training me in counter@intelligence. Be as it may, I have seen so many poor projections from conservative letter writers and, of course, the planned failure projections of people like Wharton Econometrics, Chase Econometrics, Data Resources and U. MONTREAL (AP) — Loyal followers of the Rhinoceros Party, deciding their satirical movement should not outlive its founder, put more than two decades of zany political theater to rest Tuesday in not-very-solemn

Inventive Rhino campaign pro-mises — to repeal the law of gravity, pay off Canada's public debt with an American Express card and national-ize bockey star Guy Lafleur — were remarkably successful in attracting attention and even votes from

But party leaders said they had decided years ago that the party should be buried with its inventor, Jacques Ferron, a physician, ac-

claimed novelist and promoter of independence for Quebec who died a

independence for queese who died a week ago at age 64.

"He taught us the power of positive absurdity in the face of absolute idlocies," said Charlie McKenzie, the Rhino party president. "He taught us that we could best become a free

unation by acting as a free people."

Upstairs at a seedy Montreal bar called "Les Fourounes Electrique," or "The Electric Fanny," McKenzie told a crowd of reporters that after Ferron's death, the party would be "following in his footsteps, foundering with our founder."
With a straight face, the 42-year-

old freelance journalist insisted that many Rhino campaign planks had

entered the political mainstream over the years.

over the years.
"We were the only political party
to promise rock videos, 24 hours a
day, seven days a week," McKenzie
sald. "Today, that is a reality."
He said party members were

He said party members were burying the institution "not with our heads bowed low, but our horns held high, mindful that — after 22 years in the muddled trenches of front-line politics — we have preserved our dignity and avoided the ultimate humiliation of being elected to public

office."

But the Rhinos came close, running second in two of Canada's 282 parliamentary districts in the 1980 election to the intense dismay of the

Conservatives, who came in third. The Rhinos gained official status as a recognized party, including guaran-teed free television time during campaigns to get the message

Ferron, one of French Canada's most honored writers, created the party in 1983. At first it participated only in Quebec's provincial politics, but then it spread nationwide.

in October 1970, Ferron became the intermediary between authorities and terrorists of the Front de Liberation du Quebec who had kidnapped and murdered a govern-ment official, arranging their sur-

Since 1979, the party's nominal

leader has been Cornelius I, A rhinoceros born in Granby, Quebec, now living in the San Diego Zoo. "For good and faithful service, Cornelius I is named Leader-in-Exile and delegated to service in perpetuity."
