Lynda Kay, our Executive Director's top notch assistant, has a bookkeeping background and is busy getting this done as I write this. This is both bad and good news. The bad news is that the party has gotten too big to handle the finances solely with a volunteer treasurer. Of course, it also happens to be the good news.

We are very fortunate to have an Executive Committee that understands the importance of being solvent and growing the party. I'm proud to write that most everyone on the committee has agreed to help with fund raising to get us over our financial hump. I would like to acknowledge our new Treasurer, Lori Adasiewicz, who has already brought in a \$5,000 check from a donor in the Sacramento area. Good Job, Lori! I hope to report similar successes from the rest of the Executive Committee in my next report.

Our questionnaire project is going well. A draft is going out to hundreds of Libertarians so that we can perfect it and then send it out to the membership-at-large. Your answers will affect the future direction of our party.

Since becoming your chair, I have gotten offers of free computer programming assistance from David Maloney, the chair of San Francisco, and Glenn Dickey, a member in Alameda County. The dedication to our movement that these two have makes me very optimistic about the future.

There are a few more individuals I'd like to thank. Irv Rubin, Al Carlan, Audrey Carlan, Bruce Dovner, Kate O'Brien, Paul Blumstein, Erich Miller and Rodger Rosie are all working very hard with Rabbi Reuven Mermelstein on our first Yom HaShoah project at the North Valley Jewish Community Center in Los Angeles. Yom HaShoah, the Holocaust Remembrance Day, provides an opportunity for us to reach out to a community whose relatives have suffered from one of the more horrific examples of modern government tyranny. It is also an opportunity to bring out our message of how important it is that we preserve the Second Amendment to prevent this sort of genocide in the future. If you'd like to attend this event, it will be held on April 19th at 7:00 PM.

There's plenty more to do. If you have any skill or resource that you even remotely think could be helpful, please drop me an e-mail and let me know. I'll do my best to take advantage of your help.





Ros has kept a busy schedule the past month, including:

- Attending the Steve Kubby sentencing on March 2 in Auburn. “The cheer that went up in the courtroom when the judge lowered Steve’s convictions to misdemeanors was overwhelming!” Ros recalled. “And when the judge went on to say that Steve would be allowed to use medical marijuana, I knew that the justice system in California had finally turned a corner in securing the rights of suffering patients.”
- Attending an Electoral Reform Conference at Stanford on March 3. The conference was co-sponsored by the California Instant Runoff Voting Coalition and the Center for Voting and Democracy. “Seeing so many individuals from all over the political spectrum get together and support the implementation of Instant Runoff Voting only shows how much voters are fed up with the current system and want a change. Fortunately IRV will benefit the Libertarian Party and Libertarian candidates — and I look forward to working with this coalition to help make it happen!”



## YES, WE NEED TOASTMASTERS

If you set a goal for yourself of becoming the Libertarian Party's most persuasive and influential speaker — a dynamic individual who captures the hearts and minds of both Libertarians and non-Libertarians alike — what would be your first step towards achieving such a lofty goal?

Undoubtedly, the vast majority of Libertarians have more immediate goals ahead of them. Some Libertarians may want to be Chair of their local region. Some activists may want to be more comfortable when speaking to the media. Some Libertarians may be striving to improve their own image before representing the party as a candidate.

Regardless of what our individual goals may be as Libertarians, the first step is something we all have in common. The first step is to join Toastmasters.



Many Libertarians already recognize the benefits of becoming a member of Toastmasters. Founded in 1924 by Dr. Ralph C. Smedley, Toastmasters has grown from a small group of men in a YMCA basement to a worldwide organization with more than 175,000 members. Since its inception, Toastmasters has helped people become better public speakers, better listeners and better leaders. Toastmasters, like Libertarianism, helps to change peoples' lives in very powerful and meaningful ways.

For Libertarians, becoming a member of Toastmasters is a wonderful experience because it is a very Libertarian organization. Participation in Toastmasters — unlike participation in Social Security — is completely voluntary. Toastmasters is financially independent because it is supported by its own dues-paying members. Friendly competition is an element of every Toastmasters meeting not just because it's fun, but because the organization is grounded in an understanding of what motivates and inspires people to achieve their personal best.

As political activists determined to improve ourselves and share our message, can we afford to stay home when our local Toastmasters club is meeting? When we miss our local Toastmasters club meeting, we miss a lot. We miss opportunities to meet other leaders in our communities. We miss opportunities for many people to meet the first Libertarian they've ever known. We miss opportunities to talk to bright, educated and open-minded people.

## GETTING GOOD PRESS QUOTES

Many candidates, including myself, have been misquoted by the press. Here are some ideas to help minimize errors.

- When you are being interviewed by the press, make sure that you pause after you answer so that the reporter has enough time to write down what you said.
- If you really want to emphasize something, say it slowly so that the reporter can write it down accurately and POLITELY ask him to read back what he wrote so that you can hear what it sounds like in order to correct and clarify.
- It's also helpful if you can provide the press with your prewritten statements.

The easier you make it on them, the more likely you'll look favorably in print. Remember, you will probably only be given a one or two sentence quote in the article. So make it count.

## KUBBY FORBIDDEN FROM GOING BEFORE SUPREME COURT



March 28, 2001. Former Libertarian gubernatorial candidate Steve Kubby should be going before the United States Supreme Court today, but Placer County has forbidden him from leaving the state. Kubby is one of 14 patients whose medical records have been submitted as examples of patients who cannot live without medical marijuana.

“It is frustrating that after all my work for ten years on behalf of medical marijuana, I am being denied this historic opportunity to join my fellow patients and friends at the Supreme Court hearing today,” said Kubby.

Kubby played a key role in the passage of Prop. 215, but was arrested when he publicly asserted his voter-approved right as a medical marijuana patient to cultivate his own medicine. Both Kubby and his wife were raided, arrested and charged with 19 criminal counts. All marijuana charges were later dismissed, but Kubby was convicted of misdemeanor possession of a psychoactive mushroom stem and some tiny peyote cactus buttons. Kubby was forbidden from leaving the state and sentenced to 120 days of house arrest with electronic monitoring and three years of formal probation.

In a recent letter to Placer County officials, Kubby said he is publicly refusing to serve a single day of probation or pay a dollar in fines, “because of my profound belief that the threat of jail is being held over my head to coerce me into ‘voluntary compliance’ with a criminal justice system that is broken.”

## WRITE-IN CANDIDATES RIGHTS

Legal briefs are being submitted in the State Court of Appeals, in *Edelstein v Fado*, A93007. The issue is whether San Francisco permits write-in candidates to file a declaration of write-in candidacy in city run-off elections.

## DON'T LET CALIFORNIA KEEP YOUR DOUGH!

There is a super easy-to-use free web site listing unclaimed funds held by the State of California. The front page is at <http://www.sco.ca.gov> but you can go straight to the inquiry page at <https://scoweb.sco.ca.gov/scoucp/inquiry/index.html> if you want to get straight down to searching.

I found six different sums of money belonging to people I know, and it took only a few minutes of looking. With a rare name you can just type in a last name, but with a name like mine you have to say ‘Schmidt’ and ‘Chris’ to narrow it down some. Shorter names match longer, so ‘Chr’ matches Chris, Christopher, Christine, etc. You can also use cities to narrow or widen your search. E.g. I tried all the Schmidts in Redwood City, in case they got my first name wrong. (I found one that way for someone else.)

The only bug is that if you examine a listing in detail, you have to re-search from scratch to look at the other listings – a minor inconvenience, but you’ll use your “back” button a lot. There is a clearing house for unclaimed property in other states at <http://www.unclaimed.org/> It helps you find the other states’ web sites that do things similar to the California site.

### POLITICS AS USUAL

#### TAXING FIGURES

Senators, Representatives and their employees are more likely than other federal employees not to file tax returns or to have unresolved debts to IRS or owe back taxes, an Internal Revenue Service report showed. The noncompliance rate for the House of Representatives and its staff was 5%; Senate and its staff was 4.4%; federal employees and retirees was 3%. IRS employees have a low non-compliance rate of 1.7% but they can be dismissed immediately for non-compliance. (For all Americans, the noncompliance rate was 5.7%.)

#### BRAVO BATTLE!

Uruguayan President Jorge Batlle has become the first head of state in the region, and one of the few anywhere, to call for the decriminalization of illicit drugs. Batlle, a blunt free-market reformer, questions the costs and effectiveness of a drug war whose primary theater of battle is Latin America. "During the past 30 years this has grown, grown, grown, and grown, every day more problems, every day more violence, every day more militarization," the 73-year-old president told a radio audience. "This has not gotten people off drugs. And what's more, if you remove the economic incentive, (the drug business) loses strength, it loses size, it loses people who participate."

#### HOME YIELDS HOT INFORMATION

Thermal scan of a home led police to the discovery of marijuana. Danny Lee Kylo (Florence, Oregon homeowner) contends that his Fourth Amendment rights were violated because the officers did not obtain a search warrant to scan his house with the thermal imager. "If the government is free to use technology to look inside our homes, there really won't be anything left of the right to privacy," said Dave Fidanque, executive director of the Oregon Chapter of the American Civil Liberties Union.

#### PORK IS ALIVE AND WELL

Cash for pet projects could set a record. Some porky items: sunflower research in North Dakota, mapping chicken genes in Michigan, \$1.25 million to repair a church in the Aleutian Islands, \$176,000 for the Reindeer Herders' Association, \$4.6 million to help restore a downtown section of Wheeling WV. Tom Schatz, president of Citizens Against Government Waste, an organization dedicated to eliminating pork, said that Congress is likely to break the record, \$17.7 billion, set last year.

The Zoning Commission in New Milford, Connecticut has banned a family from holding prayer meetings in their home. Robert and Mary Murphy were told to immediately stop holding weekly prayer meetings and Bible studies in their single-family home. The Murphys had been conducting the meetings – which were attended by two dozen or fewer people — since 1995. But the Zoning Commission threatened to take legal action against the Murphys if the meetings did not stop.

## VICTORY IN FULLERTON

The Libertarian Party has just become the fourth largest political party in Fullerton. The Libertarian Party has gained 75 registered voters from 409 to 484 while the Reform Party lost 51 registered voters falling from 493 to 442. This is according to *Fullerton At A Glance* newsletter printed by Fullerton City Hall.

Of the seven political parties recognized by the state of California, the Libertarian Party is one of the three listed as organizations by the Fullerton Chamber of Commerce. When I volunteered to become the Acting leader of the Libertarian Party in Fullerton; the Libertarian Party became the only political party with active leadership in the community. The Libertarian Party now trails the third place American Independent Party by 630 registered voters 1,114 to 484. Since the American Independent Party is not listed as an organization by the Fullerton Chamber of Commerce and has no active leadership in the community this gap of 630 is expected to narrow.

I was very pleased to hear that the City Council Watch Program of Orange County has been re-named the California Council Watch Program. I was even more pleased to hear that I had been named the first Chairman in charge of its state-wide expansion. I did not ask for this great honor, but I gladly accepted.



## LIGHTFOOT ATTENDS FORUM AT CAL POLY POMONA


On March 5, 2001, I attended a forum titled "The Body Politic" at Cal Poly Pomona. Melinda Pillsbury-Foster of Santa Barbara joined me as the two Libertarians on the panel. Representing the Republicans were Martha J. House and Dr. Barbara Stone; Democrats were Eileen Ansari and Helen Daugherty; and Greens were Walter Sheasby and Julianne Spillman.

The panel was most notable for its apparent agreement and congeniality. Few, if any, direct attacks on another's viewpoint were made. It appears to me the political landscape is leveling out - at least as far as the spoken word is concerned. Democrats sound like middle-of-the-road Republicans, while Republicans sound like middle-of-the-road Democrats. Libertarians were equated with the conservative element in the Republican Party. Greens were characterized as the 'real' Democrats by Dr. Stone. Those present agreed on most issues and even the generalities of solutions. There was very little focus on specifics so as to illustrate our differences.

Since 1964 when Barry Goldwater shocked a nation by expressing conservative views, the Body Politic has indeed shifted. Today there is little if any admitted or discernible difference from one political party to the next. This is especially apparent when we gather in panels and forums to explain our positions on issues.


