HOW TO INTRODUCE LIBERTARIANISM TO YOUR FRIENDS WITHOUT APPEARING TO BE A FOOL

As a novice libertarian in 1981, how was I to know how difficult it is for people to see the logic of our ways?

So in January of that year I invited 8 friends and aquaintances over to a 2.5 hour "INTRODUCTION TO LIBERTARIANISM".

This philosophy made so much sense to me that I knew if I just "splained it good" I could have a whole bunch of converts in one evening. In fact, I was doubly sure of myself because my whole sales career had been in explaining new and bold concepts for computer and insurance companies.

I got my comeuppance. Nobody rushed to join the party. While none of their objections shook my belief in the free market, correspondingly, none of my responses were so convincing that the audience gained the confidence I have in the market.

FIRST BREAKTHROUGH

Every month or two I would invite a new crew to hear my introduction, and I modified it each time to overcome the inadequacies of the prior month. A major breakthough was caused by a minister who belligerently/jokingly proclaimed early in one meeting: "You are not going to convince me to be a libertarian!!"

It was one of those rare times when the right response occurred to me at the right time: "I am not trying to convince you to become a libertarian...I'm trying to find out if you already are one." We all laughed, and the meeting proceeded smoothly. (By the way, he scored 100% on the libertarian quiz I gave later that night, and he stayed an extra hour to help me improve the presentation.)

PURPOSE CLARIFIED

So after a lot of trial and error, I finally decided which objectives are suitable for this session, and I share them with the audience in the early minutes of the evening:

- 1. If your political philosophy is already libertarian, but you don't use that word to describe it, my objective is to help you discover there are a lot of people who agree with you: libertarians.
- If your political philosophy is not libertarian, my objective is to pique your curiosity enough that you want to learn more.

These objectives are worthwhile, obtainable and measurable. They are measurable because at the end of the evening I offer to sell a bit of literature. If they are willing to invest a dollar to learn more, I have met my objective.

Of course, the person who

Of course, the person who finds he already is a slibertarian is encouraged to re-register and join the party on the spot!

In the first year I recruited the audience myself. I invited people I knew and even some I didn't know; I asked if they had time for some fun...specifically, an introduction to libertarianism.

Almost half say yes, and I log the name & phone number on a prospect list. Then 7-10 days before the event I phone & confirm that it is on their schedule. And then the day before or the very day I call again to remind them and make sure they have the address & directions.

Now other libertarians invite their friends too, so it is easier.

FORMAT, TIMING, & FACILITY

We do the introduction in the home of a doctor whose living room comfortably seats 15. Because of his "M.D." and nice location, the invitee feels a sense of security.

We ask people to arrive at 7:15pm, tell them we will start at 7:30 and finish at 9:45. And we do adjourn on time. We use nametags. The chairs are arranged in a circle, about 3 fewer than I expect. (If all come we bring more chairs; if we are short some people, which is the norm, we don't have empty chairs staring at us all night.)

I do the evening in a sit down mode without a podium or table.

CONTENT

After much trial and error, the best approach I have found is the 5 P's presentation:


PURPOSE
POLITICAL POSITION
PRINCIPLES
POLITICS
PRACTICALITIES

PURPOSE...I use the Tonie Nathan approach: "We libertarians have the same purposes as Republicans and Democrats; ie, we would like to live in a world where children are fed and educated, people can walk in the cities without fear of attack, roads are paved and drivers obey the traffic lights and other rules of the road, etc.

"While we want the same things, the difference is that libertarians do not believe in forcing others to pay for what we want."

This "Purpose" section takes just 2-3 minutes, but anyone who thinks we aspire to chaos starts to have his fears alleviated.

POLITICAL POSITION...I draw the left/right political spectrum on a small blackboard and ask the audience to volunteer names of leftwing and right-wing politicians, groups or philosophies. I write each one in its approximate location and after 8-10 have been mentioned I ask the rhetorical question "Just what is being measured on the left-right scale?" Of course there is no answer, because unlike baby scales, yard sticks and barometers (which have real numbers and measure something), the leftright scale is a nonsensical myth. It measures nothing. Next I present the Nolan model.



The "Political Position" section takes about 15 minutes to present. By its completion, the prospects have a pretty good fix that libertarians are not conservatives, not liberals, and certainly not communists.

PRINCIPLE... In introducing an individual to our political philosophy, I find it helpful to first discover if the person already agrees with us on major items of principle. Only if there is agreement on certain principles does it make sense to get into the difficult practical issues. To find out if a person's political philosophy is congruent with ours, these questions probe:

- 1. Belief in right and wrong.
- 2. Belief in private property. 3. Belief in respecting rights
- of others.
- Belief that "might" does not make "right".
- Unwillingness to compromise principles.

These are the questions:

- 1. Are murder and slavery wrong?
- Do you "own" any property (eg., wristwatch, shirt, home, cat-tle ranch) in the sense that if someone were to take it from you by force (eg, extortion, robbery, arson), their action robbery, arson), would be "wrong"?
- Do you advocate the initiation of physical force in order to achieve your business, social or political goals?
- When individuals form a government, does "wrong" become "right" if the majority agrees to it?
- 5. If you became convinced that a society based on force (eg. communism, socialism or fascism) would produce more goods for everybody (say 18.2% more GNP per capita), would you want to live in that society?

If an individual has answered YES, YES, NO, NO, NO, he certainly agrees with us in principle. The next great task is for the prospective libertarian to try to apply these principles to everyday concerns that all of us have: education, national defense, internal order, medical and other care for the underpriviliged, etc.

It often makes sense to expand on some questions by giving examples. In question 3, you may need to clarify that "initiate force" means that self-defense is OK, and that by "force" we mean physical

When using the questions with a group, you may wish to poll them at each question to verify agreement. If there is a person who disagrees, find it best to simply acknowledge the disagreement but not to try to dissuade. (The most common place for disagreement is Q4; in those cases I simply point out that the person is of the majoritarian persuasion, and that there are many people who share this opinion.)
The "Principles" section takes

20-30 minutes. Avoid answering heaby questions (eg, the origen of natural rights). Simply ask the questioner to defer until break.

BREAK...A 10 minute break gives people a chance to stretch, get a cup of coffee and a piece of cake.

POLITICS...I first point out that the Libertarian Party is one of 51 organizations in the libertarian movement and has no special position of authority or influence.

Next I mention some of the better known forefathers of the movement (Adam Smith, Jefferson, Thoreau, Mencken, R. Taft) and some of the better known quasi libertarian events of our history (American Revolution, anti-slavery movement, anti-Viet Nam war movement).

Finally, I describe the founding of the party in 1971 and the

vote history:

As the last political item, point out that no one knows whether the Libertarian Party will become a mass party and win many elections, or whether it will simply lead the way and the two main parties will coopt our positions and implement our programs. This whole section is quite short, about 10 minutes.

PRACTICALITIES...At this point I open the evening to discuss how the libertarian principles would work when applied to practical issues we are facing today. The audience enjoys asking questions of the "what about the roads?" ilk, and I respond with 2-10 minute answers.

To end this section, I point out that I became comfortable with libertarianism only after I understood the principles are practical and work in the real world.

THE CLOSE

At about 9:40 I begin to close the evening by showing the audience what literature they get for \$1.00. I usually include the Q&A, a couple of LP Position Papers, a reprint or two I like, a membership application and a back issue of Caliber.

Their next step is to read the literature and attend a supperclub or business meeting.

THREE MORE SUGGESTIONS

- 1. Do the introduction your way, not my way; use this write-up as a guide, not as a rulebook.
- 2. If any libertarian activists are coming, ask them in advance to remain silent during the session. 3. Be sure to finish on time.
