#### SCLP CONVENTION

The South Carolina Libertarian Party held its 1982 state convention in Columbia, on April 3.

Steven Kreisman of Spartanburg gave a slide presentation about the principles of the Libertarian Party, and its solutions for current problems.

Drug laws were the topic of a speech given by Professor James Stiver of the University of South Carolina at Columbia. He has been asked by the South Carolina Commission on Alcohol and Drug Abuse to present it as the keynote address at many of the latter's workshops. Some of the organization's officials agree with the Libertarian Party's views regarding drug laws, but they are unable to admit it because they are being paid to uphold the law.

Craig Franklin, Chairman of the Judicial Committee of the National Libertarian Party, came from North Carolina to speak about "Strategies for the 80's." He suggested that Libertarians use the slogan, "Vote Libertarian for an improvement," in response to the GOP's slogan, "Vote Republican, for a change."

Chairman Tom Waldenfels spoke about the April 15th, Tax Protest Day, and handed out information to those planning to participate.

Prior to the business meeting, A.J. Lanigan spoke on the issue of salary and wages not being income (more about this in a subsequent issue).

Three amendments were added to the SCLP's platform. The first one is a Statement of Principles (added to the beginning of the platform):

We hold that every person has a natural right to liberty; that liberty is essential to human happiness, progress, survival, and creativity; that force may only be used in defense of life, liberty, and property; and that the organization of defensive force should be voluntary and limited to the protection of life, liberty, and property.

The second amendment was added as an additional paragraph to the MEDICAL CARE section:

We support the right of everyone to control his or her own body and the right to consent to or to refuse medical treatment. We support the right of women to choose an abortion, and when the mother's life is threatened her right should never be questioned.

The other amendment was added as the second paragraph of the POLLUTION section:

South Carolina and its adjacent waters should not be a dumping ground for nuclear waste. The land area of Aiken and Barnwell counties known as the Savanna River Project should be decontaminated as much as practicable, returned to private ownership (if the original owners can be found, or their heirs, they should be allowed to reclaim their land) and the Federal Reservation status of the area ended.

There were also three resolutions adopted as follows:

NATIONAL DEFENSE - Be it resolved that: We believe that military defense should be organized voluntarily and that the military establishment must be reduced to a minimal size to secure peace, liberty, and the separation

#### SCLP CANDIDATES

State Treasurer: Tom Waldenfels is 27 years old. He has lived in South Carolina for the past 17 years. After graduating from Wake Forrest University in 1976, he worked as a radio station program director and music director. He has also worked as an investment broker, and more recently as a retirement consultant, helping working people set up flexible personal and small corporate pension plans.

As past chairman of the SCLP and candidate for Congress from the 4th District in 1980, he feels that his biggest contribution, given his pension background, can be made as State Treasurer because the person in this position is responsible for the state employee pension plan.

In his campaign he will recommend that the staff and salaries of the Treasurer's office be cut, that state employee pension contributions be reduced, that no money be lent to the federal government, and that pension funds be lent to South Carolina enterprises, on a lottery basis, at no more than 51% interest. In doing this, the disastrous effects of high interest rates set by the Federal Reserve can be counteracted, and the investment objective can be shifted away from protecting the retirement security of state employees to providing money for productive sectors. This should make state employment less attractive.

Tom hopes to show how improvements can be made along Libertarian lines even in a low profile office, such as treasurer.

House Seat 34: Steven Kreisman is running for the state legislature because he believes that Libertarian principles apply to state government just as much as they apply on the federal level. "Thanks to the Democrats, state

and local government is growing faster in South Carolina than in any other state except Alaska." He aims to reverse this trend. He has called for reducing state spending 30% in 1983, alone, and believes they should continue in subsequent years. This will allow substantial tax cuts in 1983. as a first step towards abolishing the state income tax.

SOUTH CAROLINA LIBERTARIAN

He will launch an intense campaign this fall; not only with the intention of educating voters on Libertarian principles, but also to become South Carolina's first Libertarian state legislator.

House Seat 36: Tom Norman is 34 years old. He is a native South Carolinian, having obtained his formal education (except for one year) in this state. In 1972, he received a Bachelor of Arts degree in Journalism from the University of South Carolina, at Columbia. He attended graduate school there during the 1974-75 school year.

His current occupation is senior analyst/programmer for Multimedia, Inc., in Greenville. He has previously worked as a journalist, broadcaster, instructor, and textile worker.

From 1980, to the present, he has been a member of the State Executive Committee.

House Seat 62: John Harllee was born and raised in Florence. He holds two degrees from the University of South Carolina.

He has more than a dozen years' teaching experience at all levels from elementary school to advanced college courses. For the past 15 years he has been a selfemployed certified public accountant.

In announcing his candidacy, he stated, "I am especially concerned about the educational system and its failures to educate. about the cruel burden of taxes at the state and local level that have grown even faster than federal taxes and faster than almost any other state, the proliferation of useless and harmful state and local governmental agencies, and all the other attacks by the state and local government on the rights and liberties of a free citizenry."

#### TAXES

Now that tax time is here again, there are a few issues I think the American taxpayers should consider:

- 1. How much time did you spend preparing your tax returns? If you had someone prepare them for you, you spent a good bit of time getting your records together. If you prepared them yourself, you spent even more time. This is your time you are giving to the government. You don't do this because you want to, but rather because you have to. Forced labor is generally known by the name of slavery.
- 2. After you have spent all of this time figuring your tax returns, take a few minutes and figure how many weeks or months you spent making that much money. All of that time was spent working for the government, again through no choice of your own. Once again there is a name for this slavery.

#### DAIRY PRICE SUPPORTS

According to your editorial May 10, we have a problem: Federal warehouses are bursting with surplus dairy products. Secretary of Agriculture John R. Block names the cause — overproduction by America's cows. He proposes a solution: People should drink more milk.

I submit that Brock's alleged cause is but a sympton of the true cause, and his solution but an effect of the proper solution.

The true cause of the problem is the existence of the dairy price support program, which encourages farmers to produce more dairy products than the market will bear at the support price. The Agriculture Department, which must buy the surplus, is thus a guaranteed buyer of last resort. (Note that a surplus is what can't be sold at a given price; it can usually be sold at a lower price.)

The true solution to the problem is now obvious: Abolish dairy price supports and let the chips fall where they may. The prices of dairy products will then decline, and people will drink more milk — unless farmers cut production to levels which sustain present prices (an unlikely eventuality). Either way, the warehouses will get no fuller, and the Agriculture Department can try to figure out what to do with what's there already.

Once again, government interference in the market is the cause of an intolerable situation, and removal of that interference is the cure. America's cows, sacred or not, are as innocent as lambs

of civil and military authority. We oppose the slavery of conscription in any form, for any purpose, and at any time, including wartime. We recognize that war is the greatest threat to liberty. Therefore, South Carolina should end all participation

in the Federal Selective Service System; the South Carolina National Guard should be reduced to the minimal size necessary to secure peace in this state; and the South Carolina Veteran's Administration should be abolished.

REAPPORTIONMENT - Whereas, the delays by the state legislature in redistricting were an intentional effort to disenfranchise minor political parties and minority voters, and to protect the special interests of the incumbent officials,

Now therefore, be it resolved that: We condemn the legislators for the time and money that they wasted.

CORRUPTION IN GOVERNMENT
Be it resolved that: We are disgusted by the recent examples of corruption in the state government, especially when it goes unpunished.
