David Hoesly for Lieutenant Governor, an active organizer and able administrator for the Libertarian Party in Rochester. Dave is an engineer.


Delores Grande for Attorney General, an attorney who has previously campaigned for district attorney in Manhattan.

The Comptroller of the State of New York is the chief fiscal officer of the state responsible for auditing the financial transactions and management practices of state agencies, commissions and public authorities; and the financial practices of the 1600 cities, counties, towns and villages, and thousands of special districts in New York State. He is also responsible for the management of the New York State Employees Retirement System and the New York State Policemen and Firemen Retirement Systems, including investment of funds and payment of claims.

With thousands of Democrats and Republicans spending money at every level, shouldn't the State Comptroller be someone other than a Republican or Democrat?

#### INDEPENDENCE REQUIRED

The auditing functions and reporting obligations relating to that function requires independence of such auditor from the decisions and performances being audited. The position of Comptroller of the State of New York requires a truly independent administrator, one without political ties to the spending policies and management practices of the post. The Comptroller should be someone who is an advocate, in philosophy and deed, of the taxpaying public; someone who knows whose money is being spent and how it was obtained.
