1. Call to order

The meeting was called to order by Caryn Ann Harlos at **2:20 pm ET** *ALL TIMES LISTED ARE EASTERN (please adjust accordingly)*

2. Roll Call

4. Determination of Quorum

5. Public Comment

Combined there were an estimated 20-30 guests both in person and online. Starchild commented and congratulated the committee and the report.

6. Meeting Summary

This meeting is the in person meeting of the committee at the National Convention, as required in Rule 5, section 2 of the convention rules of order. Some members, as noted previously, are present in Orlando, FL, while others are participating virtually. The meeting started a little bit late due to technicalities.

The Chair explained where the committee is and that the agenda is a carry over from the un finished items from the 6/30 meeting (See 6/30 **AGENDA** in outline). The secretary displayed the agenda and the report in person and online. The Chair also announced, if time allowed, for the committee to take up a new amendment to plank 1.6 "Parental Rights" by Ensor.

The first item taken up by the committee is the "Gender Autonomy" proposal(PC 9). There was a motion by Harlos to amend the text of the "Gender Autonomy" proposal. There was a motion by Starr to delete this item from the committee report. The Starr motion and Harlos amendment failed. As time remaining for use of the room was low, the Chair asked the committee to take up the Ensor motion. The motion was not heard and the meeting adjourned promptly(see below and note 5).

The next section will detail motions, amendments, vote tallies and all points of orders.

7. Motions and Votes

PC9 Adopted by email ballot on 3/9/20 current text:

Individuals have the sole authority to determine and express their own gender identities. No entity has the power to supersede this individual authority.

Harlos moves to amend PC 9 as follows:

Individuals have the sole authority to determine and express their own gender identities. No entity has the power to supersede this individual authority. The right to determine and express one's own identity does not include any limitation on the freedom of expression of others.

Harlos amendment <u>FAILS 2-14-0</u> at 3:09pm (see vote Tally <u>Ballot 2</u>)

Starr moves to delete proposal PC9 from final committee report

Starr motion <u>FAILS 0-15-1</u> at 3:48pm (see vote Tally <u>Ballot 3</u>)

The Chair asked to hear the proposal by Ensor, Starr asked if it was in order to move for a time extension, the Chair stated it is not in order due to lack of time(see note 5). The Chair called for a vote to hear the Ensor amendment, but there were various POI brought up. One of which was to have the text read out loud, which Ensor did. There were more POI's and before any items pending could be resolved, the meeting adjourned.

The LNC was scheduled to meet in the same room and time could not be extended. Before the meeting adjourned there were LNC members present making preparations to sit down.
