TO WAR TAXES

When we speak of nonpayment of taxes for war, we are not speaking of tokenism holding pack a small fraction of one's tax. We are talking about refusing the whole amount. The federal income tax not only is the chief source of monetary support of the war system, but is the chief link connecting each individual's daily labor with the tremendous buildup for war. A breaking of this link is important both as a stoppage of war supplies and as a real, personal commitment to peace.

To break this link it is necessary for an individual to withdraw totally from the federal taxing of income. This means that we do not pay taxes either directly or through the withholding system, nor turn over the taxes of workers in our employ. Only after settling the withholding matter can people be in command of their own incomes and choose where their money goes. Therefore the Peacemaker position is one of nonpayment of federal taxes, including excise taxes such as telephone tax.

such a manner as to owe nothing.







Holding Blacks to Housing Quota Can Aid Integration

By Michael Meyers

A federally subsidized housing project in Brooklyn, N.Y., opened more than a decade ago with a plan to maintain a racially integrated community by imposing a quota on the number of nonwhite occupants. Sociologists contend that once a residential housing project reaches a certain percentage of nonwhites-a "tipping point"-whites begin to look elsewhere.

This week the 6,000-unit Starrett City complex was the focus of a federal court hearing, the latest bout in a continuing controversy, as the Justice Department sought to have the middle-income development's current quota plan barred. Report by NAACP contends How about 'racism' permeates library

The Public Library and Information Center is "permeated with racism" and has "a plantation mentality," Maxine Smith charged yesterday in an appearance before the library board.

She urged that blacks be given more positions of authority and that "harassment and retaliation"

against employees stop.

Mrs. Smith, executive secretary of the Memphis NAACP, read a brief report which she said was based on observations and complaints from library employees.

She was accompanied by Richard Fields, NAACP

legal redress chairman.

Mrs. Smith used a chart to support the NAACP claim that the upper levels of management of the system are top-heavy with whites, "although there are qualified blacks who could hold many of the positions.

At five professional levels, she said, there are 57

white employees but only 11 blacks.

Henry Evans, library board chairman, asked Fields for more specifics, saying, "We can't respond to generalities.

Fields demurred at first, saying some library

employees feared for their jobs.

Then he agreed "to go back to the complainants, assuring them there'll be no definite identification."

Evans asked the board to get library staff replies to the NAACP complaints, which included:

 Discrimination in promotional opportunity and a reluctance to promote blacks.

Lack of confidence in supervisory personnel

and low morale among employees.

Few blacks at professional levels and no black

department heads at the Main Library.

The report said punitive actions are taken against employees for filing grievances and that employees are sometimes embarrassed by supervisors who "yell, slam doors and perform other condescending acts in the presence of patrons.

The report recommended that supervisors "be held accountable for actions in hiring, promo-

tions and equitable treatment.'

It also said that use of the current evaluation form be suspended until it is rewritten because it "is difficult to interpret, results in discrimination, and does not lend itself to objectivity.

Noting that there are no black professionals at suburban libraries, it urged that librarians be as-

signed without regard to race.

It's Time to Drop

Draft Registration

WASHINGTON - Jimmy Carter has been out of office for more than six years, but his legacy lives on. Gillam Kerley of Madison, Wis., has become the latest young man to be convicted for failing to register for the draft. And Mr. Kerley's sentence - a hree-year prison term with a mandatory year before parole and a \$10,000 fine - is the harshest yet.

This punishment is grossly disproportionate to the "crime" of publicly refusing to fill out a one page form. #is sentence also highlights the Reagan Administration's scattershot enforcement policy. Though at least 450,000 young men annually commit the same crime as Mr. Kerley, fewer than two dozen have been prosecuted.

Mr. Carter proposed draft registration in early 1980 after the Soviet invasion of Afghanistan. Under the plan, 18 year old men must register for the draft, although they will not actually be drafted unless Congress approves conscription. While the official justification was to increase emergency readiness, the program's real purpose - which proved ineffective - was to show toughness in the face of Soviet aggression.

During the 1980 Presidential campaign, Mr. Reagan criticized the Carter program, arguing that registration "destroys the very values that our society is committed to defending." Once in office, however, he accepted the sign-up as his own, citing national security concerns. But the President was embarrassed when his manpower task force's report on registration was leaked to the press. The study showed not only that a postmobilization sign-up could bring in men almost as quickly as the current program, but also that the Pentagon's training camps would be filled to overflowing with volunteers and other military personnel even without peacetime registration.

In fact, Mr. Reagan maintained the program for the same reason that Mr. Carter created it - to demonstrate national resolve, this time after the Polish military's crackdown on Solidarity. Unfortunately, though, registration had no more impact on events in Poland than in Afghanistan.

Today, with prosecutions continuing, a program that was supposed to help free Polish Solidarity members has instead been used to jail young Americans. And a system intended to accelerate mobilization in the event of war has made both the defense establishment and the public complacent about a future conflict.

President Reagan should simply drop registration and end the persecution of vocal nonregistrants. But Pentagon planners like the illusion of security that the peacetime sign-up provides. Thus, a registration analogue of the All-Volunteer Force is needed, something that provides a sure source of emergency manpower but is consistent with America's tradition of individual liberty.

Consider a reserve volunteer force, a pool of untrained volunteers who would be subject to immediate callup in a mobilization. Using the most pessimistic Pentagon estimates, 130,000 men would be needed for sufficient untrained manpower in the first two months after mobilization.

Reserve volunteers would sign up for a set term, during which they would enter the military only during a national emergency. Members would receive a modest financial stipend and would be invited to become part of the "military family" through involvement with the active forces, reserves and service associations.

Reserve volunteers would provide a better source of emergency manpower than does the current system. Members would automatically report when called up; because of exemption claims, Selective Service would have to issue 600,000 draft notices to assure 100,000 inductions.

Are there at least 130,000 young men ready to serve? Today's young people are patriotic; qualified recruits are flocking to the active duty forces. Moreover, draft registrations soared after the bombing of the Marine barracks in Lebanon and the Grenada invasion.

With some Democrats calling for a return to a peacetime draft, there would be no better way for the Administration to demonstrate its commitment to the volunteer military than to abolish registration. Let's raise America's entire armed forces in a manner consistent with our principles of freedom, which the military is sworn to uphold.



A Kennesaw College professor apologized Thursday for writing that Nazis and Ku Klux Klansmen deserved to have their "point of view" included in a national teaching curriculum about the Holocaust.

Christine Price, a newly hired political science instructor at the Cobb County college, was chosen last year by the U.S. Department of Education to critique the "Facing History" curriculum, which is used in public secondary schools nationally to sensitize teachers and students about the Holocaust.

The New York Daily News reported Sunday that Ms. Price wrote that the curriculum gives no "evidence of balance or objectivity."

At the time she wrote the critique, Ms. Price was a faculty member at Troy State University in Alabama.

A Kennesaw College spokeswoman said Thursday she did not think Ms. Price's controversial critique would affect her status at the college.

Department of Education officials Tuesday barred Ms. Price from participating in any other curriculum critiques.

Although she apologized in a written statement after the News report, Ms. Price also questioned the accuracy of Sunday's News

"I believe the quote attributed to me is incorrect. I will say, categorically, I am not a Nazi or Ku Klux Klan sympathizer, and if the quote used by the New York Daily News has anyone concerned about that, I am sorry.'

In a written statement issued Thursday at Kennesaw College, Ms. Price said she could not comment further because Department of Education reviews are conducted in confidentiality.

Ms. Price told the New York newspaper this week that she believes federal officials owe her an apology for having let her identity

become known publicly.
"I was told that this was all going to be totally anonymous, and that I was writing this for internal use," she told the News in a telephone interview. "I was trying to do a public service."



overnment employees do it differently. When football face. players (and most other private-sector union members) are upset with pay and working conditions, their final resort is to go on strike that is, to withhold their presumably valuable services. When public emwages and hours, their most effective ploy is to give us more of their

'services' than we can handle. Thus Orange County building inspectors are currently engaged in Hart. "working to code" — or going by the book. That means that instead of random inspections of houses in a tract. they'll inspect every single one of them - very carefully. Instead of giving a courtesy inspection of another adjoining house as long as they're out there, they'll wait until they have a formal request. They'll do it all laboriously, just the way the book says they're supposed to.

The hope is that doing it slowly will put enough financial pressure on developers that they'll complain to the supervisors and the inspectors will get their raises. It might work.

Years ago, when I lived in Virginia, the Fairfax County police wanted a raise and the supervisors didn't want to give them one. So the police started enforcing the law with exquisite care - handing out tickets for the most minor and inconsequential infractions, doubling, tripling, or quadrupling their normal quotas. Since the victims of this operation were ordinary citizens rather than developers who need approval from supervisors for future projects, they weren't the least bit shy about complaining. The supervisors got the message and the police got their raises.

Now this is all a little sleazy, but it gives us some important lessons about how over-regulated this sociery has become. There are so many laws on the books that if all of them were really enforced as effectively as they theoretically should be, society would be tied up in knots and virtually unable to function.

Regime Mounts Military Attacks on Civilians, Tortures Prisoners and Forces Resettlement

A Report on the Testimony of Nicaraguan Refugees concerning Conditions in Their Country and the Reasons for Their Flight, was published recently by the *Puebla Institute*.

It notes that by early 1987 over 300,000 Nicaraguans, or about 10% of the total Nicaraguan population had left their country since 1979. Seven main reasons are given why they left, they are:

- 1. Restrictions on freedom of religion and conscience.
- 2. Sandinista military attacks against civilians.
- 3. Arbitrary arrest and detention.
- 4. Torture and ill treatment in detention.
- 5. Military draft evasion.
- 6. Economic hardship and reprisals.
- 7. Forcible resettlement.

In addition, refugees active in Protestant and Catholic evangelistic movements described the following harassment and discrimination:

- 1. Prohibitions on preaching, evangelizing, or attending prayer meetings;
- 2. Detention on the basis of religious affiliation;
- 3. Pressure on prisoners in detention to give up religious beliefs, including belief in the existence of God;
- 4. Discrimination by the government in dispersals of food and medicine rations or in education opportunities because of religious beliefs;
- 5. Coercion or intimidation to join Sandinista organizations or to incorporate into religious instruction Sandinista ideology that religious activists believed conflicted with their faith;
- 6. Pressure, including threats of further detention, to spy on other members of the congregation;
- 7. Denial of conscientious objector status to religious pacifists.

In Honduras alone by the end of 1986 there were 24,195 registered and an estimated 30,000 to 100,000 unregistered Nicaraguan refugees.

The problems these people face are enormous and the future bleak. In order to help, be it very limited, JTTCW sponsored three days of medical clinics during the month of January 1987. With the help of American and Honduran doctors, over 400 patients living in the refugee camp of "Los Guasimos" near Jacaleapa, Honduras, were seen. But the clinic or any other clinic was not allowed right in the camp. It was necessary to use a school building in Jacaleapa. Many simply had to be turned away as time ran out. More of the clinics, which are suppported by donations, are planned for the future.



Video store owner

A Cayce video store owner has asked a panel of three federal judges to declare the state's new obscenity law unconstitutional.

Tony Denning, owner of the Video Movie Center at 829 Knox Abbott Drive, filed a motion in U.S. District Court in Columbia late yesterday seeking an injunction against the law, which takes effect today.

"This thing has really scared the dickens out of most of our clerks," Denning said.

The motion seeks a temporary and permanent injunction against state Attorney General Travis Medlock from enforcing the statute, which makes it a felony to exhibit or disseminate to persons younger than 18 materials that "depict sexually explicit nudity or sexual activity."

It also says anyone older than 18 who knowingly hires or uses anyone younger than 18 to produce or distribute obscene material is subject to prosecution. The law carries penalties of up to three years in prison, a \$10,000 fine, or both

The motion seeks a hearing on the constitutionality of the law, described as "vague and ambigu- Should Die Before I Wake. ous" and an infringement on the rights to free speech and free trade and commerce.

The hearing has not been scheduled, a court clerk said.

The law is a "danger" to video store owners because it requires them to judge the content and nature of video tapes for sale or rent without being given sufficient guidelines for determining whether they are obscene, the motion says.

The law, passed June 10, also forces video store owners to discriminate against its customers "by groups and personal taste" without sufficient guidelines on obscene materials.

Denning said his store has about 4,000 club members, about 80 percent of whom have rented an X-rated movie at one time or another.

The motion says the law also discriminates among movies, videotapes and books and is vague and ambiguous because violations are considered misdemeanors in some sections and felonies in

"I believe the Constitution guarantees me the right to do this," Denning said about the injunction. "This is a censorship issue. It's not morality it's censorship.'

Denning said his employees, none of whom is younger than 18, feel threatened by the new law.

He said the controversy surrounding the new law is giving video stores a bad name,







Windy City Seeks School Options

A column by Neal R. Pierce in the January 17 Los Angeles Times reports that Chicago might become the site of a bold experiment in educational alternatives.

Chicago's schools have averaged a major teachers' strike every other year for the last 16 years. They rank near the bottom nationally in student test scores. An entrenched bureaucracy thwarts all hope of reform. So it is that a coalition of white ethnics, blacks, and Latinos have joined to form CURE: Chicagoans United to Reform Education.

And a stiff "cure" it is, too. Under their plan, the central bureaucracy would be reduced from its current 3,000 to about 200. Their only jobs would be to distribute state money to the schools on a per-student basis, negotiate with teachers' unions, and supervise test scores, so the various local schools' success or failure could be evaluated. The control the central office once wielded would shift to the local schools, especially to the parents of children in those schools.

Each local school would be governed by a council of teachers, parents and community representatives. They would be empowered to set curricula, and hire and fire teachers and a principal. Parents unhappy with their neighborhood school would be free to transfer their children to any other school in the district. Unsuccessful schools would be closed.

An unusual political environment gives the coalition hope of overcoming the city forces-that-be. The racial diversity of the coalition makes the organization less prone to attack.

County reviews limits on number in household

The county is about to place a ceiling on the number of people that can stay under one roof.



Executive Order 11110, June 4, 1963, signed by President Kennedy, further amended E.O. 10289 of Sept. 19, 195i, gave authority to the president to issue the currency. He ordered the issue of US Notes in the amount of \$4,292,893,815. In November, 1963 he was shot and killed in Dallas, Texas. The next day the E.O. was rescinded by President Lyndon Johnson.



THE ASSASSINATION THAT WILL NOT DIE

Representative Henry Gonzalez of Texas periodically makes significant and powerful speeches before the House I always listen to him when I come upon him on C-SPAN during the day.

Today, 3-21-88, I caught part of a speech of his, and an astounding bit of history was revealed.

Henry Gonzalez was on Air Force One with President John Kennedy on the trip to Texas. Gonzalez had been vocal in his opposition to U.S. advisors stationed in Vietnam.

As Kennedy rose to leave the compartment, he turned to Gonzalez and said, "By the way, I've issued orders to pull all our military and their equipment from Vietnam, beginning this December." (I'm paraphras-This is a dynamite bit of history ing what Gonzalez said in his speech which I have on tape, but I'm too lazy to play it and transcribe it word for word.).

A few hours later, in Dallas, Kennedy was assassinated. He had issued those pull-out orders days before, and told many of his plan in the months and weeks previous to the decision and official order.

His vice president, Lyndon Johnson, reversed those orders and used the Tonkin."incident" to vastly expand the American presence in Vietnam. Johnson's policy change was stunning and to my mind, now, very suspicious. To be blunt, I suspect John Kennedy was killed to stop that withdrawal and to put in the presidency a man whom the killers'bosses knew would expand the war, because he was their creature.

They wanted the billions upon billions of war profits the Vietnam war would bring. They milked it as long as they could, before the American public finally forced them to stop it.

There may have been larger, geopolitical, factors in the decision to assassinate Kennedy, as well as the huge money at stake, as well as a Catholic factor (to save the hundreds of thousands of Vietnamese Catholics who were forced south from the Communist North Vietnam after the partition, and to reclaim the north for them).

There is in man a natural desire for laws and freedom from laws, a need for authority and a need to defy authority; a desire to impose order and conformity, and a desire to oppose order and to be nonconformist. How do you strike a balance? Or, more realistically, how do you structure society to allow for the safe expression of all aspects of man's nature?


Banking on voter unhappiness

Indeed, the Libertarians say that the growth of non-participation in national elections is directly linked to the belief by citizens that neither party offers leadership that is philosophically capable of resolving the nation's problems.

And that, they say, will lead voters to the Libertarian Party.

"I'm convinced if people hear our message and look at it with an open mind, they're going to be for it," Paul said in an interview this week in Palo Alto between Bay Area campaign appearances.

That message is cutting government back to the minimum — providing police, a monetary system, national security limited to America's borders, and little else.

"It's a message of non-aggression, a commitment to never aggressing against another individual," Paul said, adding that that fundamental philosophy puts the Libertarians one step ahead of the Democrats and Republicans.

"The others don't have one," he

The combination of voter dissatisfaction and Libertarian philosophy should be enough to move the party into a genuine third-party status this year, Paul said, with enough of the total national vote to claim an influence on the presidential election.

Careful to note that he plans to win, Paul acknowledged that a "reasonable" result would be getting 7 percent of the vote nationally, with much larger support in pockets around the country, the same as independent presidential candidate John Anderson in 1980.

Paul, 52, a physician near Houston, was philosophically a libertarian during his seven years in Congress, although he served that entire time as a registered Republican.

"If I had run as a Libertarian, I may not have won," said Paul, who retired from Congress in 1984.

Even as a Republican, he had a tough time holding his congressional seat, winning re-election once by 703 votes.

Some of that political difficulty was due to his libertarian voting pattern, which put him at odds frequently with members of both political parties. It even saw him vote against federal funds for a hospital in his congressional district.

"We began going in a different direction then, to much bigger interventionism. We want to get back to the individual," Paul said.

A bigger, wealthier America, he said, "is no reason to give up on the American dream."



OLITICIANS IN PRINT

Libertarianism is a political philosophy based upon a simple yet profound observation: that people own their own lives. Because of this, Libertarians believe that people should be free to use their lives and property as they wish, as long as they don't interfere violently with the lives and property of others.

Before the imposition of the income tax in 1913, the United States had an active economy, a strong national defense, balanced budgets, and international respect. Our loss of freedom is not unique. In medieval England, William the Conqueror ordered officials to list everything of value in England. Not fooled by William's motives, citizens dubbed this list the "Doomsday Book" because they knew the next step would be confiscation. It's worse in America. We're fitted with thumbscrews and forced to make out our own Doomsday list every April 15. And it better be correct!

Even when we give up our rights meekly, the IRS, like the Mafia, is prone to make examples of selected victims for enforcement purposes. Americans are also troubled about an unconstitutional foreign policy. Where is it written in the Constitution that politicians in Washington may install or unseat foreign dictators? The same place it is written that the feds can control our economy or suppress our liberties. Nowhere.

As a former Air Force flight surgeon, I saw the medical results of Vietnam. The lust for a foreign war in the Persian Gulf is not only sickening--given the record of almost continuous U.S. intervention on behalf of big oil and the big banks--it also subverts our remaining freedoms. Nothing enlarges the government like war. As Libertarian Randolph Bourne put it during World War I: "War is the health of the state."

Too many body bags of 18-year-old boys have come home to sobbing parents. Thank goodness the non-interventionism of the American people--denounced as "isolationism" by the pundits--has

kept Washington from actually starting a full-scale war. Yet.

In 1988, as in 1776, the only answer is the policy of the Founding Fathers--a real defense for America with no foreign intervention, no entangling alliances, and no overseas meddling.

Adams, Jefferson, and Washington told us again and again: we cannot have a limited, republican government at home with an unlimited, imperial government overseas. The Founders knew that foreign intervention destroyed freedom in ancient Greece and Rome, and they knew the same thing would happen here if we ever embarked on such a course.

Tax oppression, foreign fiddling...and I haven't even mentioned deficits and spending, monetary manipulations, spying on our personal and financial lives, machine-gun equipped federal drug agents bursting into innocent homes, and all the other atrocities typical of Washington in 1988.

Everywhere I go, in cities and small towns, in all 50 states, I find the people ready for serious change. They're aching for leadership to reestablish the liberty our forefathers fought and died for.

That's why I've dedicated 100% of my time to this effort. I January, I closed my medical practice to campaign full-time. And the response has been great. On a recent trip to Colorado Springs, both tv stations, both newspapers, and two radio stations covered my visit. And that was a typical response.

What an opportunity this is. As someone with $14\ {
m years}$ of political experience, I can tell you: THIS IS THE YEAR.

Does that mean I believe I can win? It would take a miracle for me to get a majority of electoral votes. This time. But I can win a whole lot of popular votes, and a victory for our ideas. I can make such an impact for liberty that 1992 and 1996 will be very different stories.

Please, won't you help me make a difference?

Without you, I can't keep getting our ideas out: curbing the vicious dogs of the IRS; quashing the Federal Reserve; advancing the free market and the gold standard; bringing the boys home; undermining the special interests; and protecting our personal and financial liberties.

I don't accept federal funds, of course. Those campaigns that do have a welfare mentality. But I make sure that each dollar received is spent with ten times the efficiency of the major party candidates.

Help me make history. Help me make $\underline{\text{big}}$ news on election eve. Help me make a White House official's nightmare come true

They know this could be 1856 all over again--the year the new Republican Party became a national force. Four years later, it took the White House.


The key to Republican victory then was their opposition to slavery. This moral issue galvanized the American people. And it can again.
