Money By Mail

LPC direct mail fundraising campaign is huge success

ibertarians may not think too highly of the U.S. Postal Service, but when it comes to fundraising, the mail has proven to be an excellent tool.

The LPC's direct mail fundraising program has been a rousing success, generating more money for the party than any other similar program in its history and helping to double its revenue to an unprecedented \$170,000 in 1997.

LPC Chair Mark Hinkle decided to launch the program after the Unified Membership Plan was adopted this year. "I knew our \$25 basic membership fee was going to be split three ways [between the national, state and local parties], with the LPC getting the short straw," he said. "So fundraising became critical."

To assist him, Hinkle turned to an old pro: Michael Cloud, arguably the LP's most successful fundraiser. It's Cloud's "plans and progress" style that graces the party's monthly fundraising letters.

"We tell the members what we've



done and what we're doing," he explains. "Then we tell them what we'd

like to do, and why their contributions are so important. After all, their donations are the LPC's budget."

The direct mail program brought in almost \$17,000 in its first two months, unheard of in a post-election year. "We've had more (continued on page 5)

Banquets Raise Big Bucks

Harry Browne and Michael Cloud generate over \$26,000 in donations for the Libertarian Party of California

hristmas came early this year for the Libertarian Party of California. On December 5-7, it hosted three fundraising banquets in San Francisco, Los Angeles and San Diego — and raised \$26,284.00 in donations.

"I'm thrilled," said LPC Chair Mark Hinkle, announcing that the funds had enabled the party to meet its goal of generating \$150,000 in revenue in 1997.

Special guest speaker at the banquets was best-selling author and 1996 Libertarian presidential candidate Harry Browne. (see article on page 8) Fundraising honors were conducted by Michael Cloud, one of the party's most entertaining and liveliest speakers. Afterward, Browne chatted with the crowd and autographed copies of his recently repub-

lished book, *How I Found Freedom in an Unfree World*.

"What a pleasure it was to speak to and meet so many impressive Libertarians," said Browne, who attended with his wife, Pamela. "We had a (continued page 5)

Putting Things in Proportion

I congratulate Ron Paul [see Ron Paul Introduces Bills to Help Third Parties, last issue] and hope both of his bills make it to the floor. But it is important not to ignore the other efforts in the works that will help the Libertarian effort. Specifically, the LP should endorse and support Rep. Cynthia McKinney's (D-Ga) Voter's Choice Act, which would free the states to choose their own systems for electing representatives and — and this is most important — allow them to use methods of Proportional Representation. The Illinois LP recently endorsed Proportional Representation. The LPC should endorse PR now and advocate for a national party endorsement at the coming convention. Milking Californians

It's a fact: Lowfat milk costs \$1.55 per gallon more in Los Angeles than in Phoenix! And

Sharon Ayres appointed to key fundraising position

The Libertarian Party of California is pleased to announce that it has appointed veteran Libertarian activist Sharon Ayres to serve as its Finance Chair.

As part of her efforts to meet the revenue goals set by the LPC Chair and Executive Committee, Ayres intends to coordinate the party's efforts to produce monthly fundraising letters. She also intends to work to increase the number of members participating in the LPC monthly pledge program, establish a major donor fundraising program, and launch a telemarketing fundraising effort.

A former Vice Chair of the National LP, Ayres currently serves as an At-

Large Member of the LNC. She also managed Harry Browne's 1996 presidential campaign.

"I supported [LP presidential candidate] Roger MacBride in 1976," she said, "and joined the party in 1979. I realized its success is the only way that dramatically smaller government can be achieved in my lifetime. The Republicans and Democrats are just two sides of the same big government coin."

Ayres has been married to longtime Libertarian Party activist, presidential candidate and author David Bergland since 1984. A Registered Nurse, she also received a B.A. in history. She has two grown sons.

California Libertarian Re-elected

Activist wins second term

ark Dierolf, a Libertarian Party member from Salinas, won a second term on the Hartnell Community College Governing Board on November 4.

A 34-year-old insurance salesman, Dierolf bested three opponents to win 49.9% of the vote.

Hartnell College has 7,000 students. Its Governing Board has seven members.

Dierolf campaigned on his record of improving the college without raising taxes. He notes that other nearby school districts have attempted to pass bonds for building repairs and maintenance. Hartnell not only didn't propose a bond or tax increase, but even reopened a satellite campus within the existing budget.

As the sole Libertarian on the Board, Dierolf notes there is "only so much you can do." He believes that if he had not been on the Board, however, that the other trustees would have put a tax increase on the ballot. While his colleagues aren't too receptive to his ideas, the staff members are, and make proposals to the Board accordingly. When other Board members have advocated higher taxes, the staff has not listened to them.

Dierolf believes the public is on his side. He has told his colleagues that he would lead the fight against any bond measures or tax increases. Without this opposition, they would have made attempts to do both. Instead, the district has been obtaining grants from private foundations and help from local businesses to support their programs. The Board has voted to obtain grants from other levels of government as well, but Dierolf has opposed them.

The Chair gave an oral report on the status of various projects. He announced the appointment of Sharon Ayres as Finance Chair, and outlined his ideas about establishing an office and hiring employees. The vice chairs provided written reports on their activities, highlights including the reactivation of several regions in the North and plans for candidate training meetings in the South.

The Committee accepted a proposal from Perry Martin to renew his contract as editor of *LPC Monthly* for another year on the same terms except that he will no

longer be responsible for labeling and mailing; he presented a report showing that another contractor could be hired to do these tasks in such a way that the additional cost would be made up by savings in postage.

Dick Rider presented a proposal for a new telephone affinity program. The proposal was referred to the Operations Committee for review.

Current financial statements were reviewed, and a budget for 1998 adopted. The new budget calls for more than \$350,000 in gross revenue, with net revenue and expenses of almost \$200,000. It includes hiring two employees during the year, as well as significant amounts for membership recruitment and a project to survey existing members to help focus marketing and volunteer activities.

There was discussion of current special election campaigns and plans for 1998. Ted Brown reported on candidates signed up so far. Other topics included implications of the blan- (continued on page 4)

From The Chair:

A Very Good Year

his is my tenth column as LPC Chair and my last for 1997. Overall, it's been a very good year. As before, let's remember that we have had three main goals this year:



- 1. Increase our dues paying membership to 5,000
- 2. Raise \$150,000 in revenues
- 3. Hire at least one paid employee working in an office

I'd like to report that we've achieved all three goals, but I can't — yet. Here's an update...

Goal #1: STILL IN PROGRESS.

I've just received word that the first joint national/California LP membership recruitment letter, sent to 25,000 registered Libertarians, reached mailboxes on December 6th. Perry Willis, architect of this project, believes that most responses

will come before Christmas, and then trickle in as we enter 1998.

So, unfortunately, we won't know if we've reached

our year-end membership goal until the last minute — too late to report here. And, if we don't reach our goal by December 31st, we'll continue until we do. Thanks to your generous donations, we've mailed more membership recruitment letters than ever in our party's history. In addition, the LPC Excom has approved a budget for next year that doubles the funds allocated for building membership this year. We are serious about that goal — and we will achieve it.

Traditionally, Christmas is a time of giving and sharing. How about getting into the spirit of the season by sponsoring a membership in the Libertarian Party for

that interested family member or friend? Truly, that is a gift that will keep on giving — by helping us reach our ultimate goal: political freedom in our lifetimes.

Goal #2: ACCOMPLISHED!

Because of the highly successful Harry Browne fundraising dinners this month, we met and exceeded our goal of raising \$150,000 in revenue by this year's end. A special thanks to Pamela and Harry Browne for helping the LPC. Thanks also to Michael Cloud and Laura McFadden, the events' fundraiser and organizer respectively, for their fine work. We're lucky to have them on our team. Most of all, thanks to all of you who attended the dinners and gave so generously!

Goal #3: VERY CLOSE!

enue in 1997. Next year, we

expect to double it again."

With luck, I'll be able to make an offer to one of the candidates I've interviewed for the clerical position soon. Meanwhile, the lease of the Santa Clara party's office is due in March 1998. That's when we expect to move into a larger space and commence regular office hours. I hope to sign the new lease at the LPC convention

in February, 1998. With your help, I will also sign a letter offering a job to our new Executive Director at that time.

And now a further peek into 1998...

The LPC Excom recently passed a budget for next year that includes not one, but *two* employees. It also includes a full-time office. *And* we're planning an extensive survey of our membership. *And* we plan to send our Executive Director to testify before the state legislature. *And*, of course, we'll be continuing our support of Party building at the local level with additional training seminars and other types of educational material.

We doubled our 1996 revenue in 1997. Next year, we expect to double it again. Our 1998 budget is based on raising \$303,565 in gross revenues, not counting the projected gross revenues of \$71,800 from the LPC Convention this February. Last February, if someone told me that I'd propose and that the LPC Excom would pass such an ambitious budget, I'd have said they were nuts. But you made it possible! To be honest, the level of your support has astonished me. Next year, I'm counting on it big time. So please, help us continue to help you!

ket primary and contested primary situations and possible ways to deal with them.

The date for the nominating convention for statewide offices was set to be February 16 so it can be held as part of the regular state convention. The Committee decided that the regional caucuses for nomination of district candidates should be held during January, with results to be reported to the Secretary by February 5.

The Committee endorsed the "Free the People" initiative to eliminate the state income tax. Also endorsed, but only "in concept" since final wording was not yet available, was the "Safe Communities Act of 1998"; a subcommittee was established to explore how the LPC could provide polling data in support of this initiative.

The Bylaws Committee for the 1998 convention was selected, consisting of Joe Dehn, Linda Grau, Jon Petersen, Terry Savage, and Bob Weber. Ted Brown was selected as coordinator of the Platform Committee.

Joe Dehn is Region 43 Representative to the LPC Executive Committee. This article has been condensed from his summary distributed to activists via e-mail. "I want to raise so much money that [LPC Treasurer] Eric Fine gets hernias from lifting it!" said Cloud, adding that


the monies will be put back into more efforts to build the party and its membership.

Harry Browne:

"Political Freedom Soon, Personal Freedom Now"



n December 5-7, former LP presidential candidate Harry Browne addressed Libertarians at three fundraising banquets in three California cities—San Francisco, Los Angeles and San Diego. Following are some highlights from his speech...

Harry Browne: I think most Libertarians don't realize how close we are to real political freedom in this country. I also think most Libertarians don't realize how much personal freedom can be obtained right now. And I think most of us don't fully appreciate how the two are linked.

The desire for freedom requires no justification. Wanting to be free is the most natural thing in the world — and it can be lost in many different ways.

Most people think freedom is the absence of government coercion. That's political freedom. Personal freedom is immunity from social pressures — all the things you and others do that keep you from living the kind of life you want. Many people seek political freedom while allowing all kinds of other people — family, friends, business associates — to tell them how to live. I wrote *How I Found Freedom In An Unfree World* to show that, while we wait for political freedom, there are many, many things we can do to increase our personal freedom.

If you are not as free as you'd like to be, it's probably because of two reasons...

The first is that you have accepted



assumptions about life that just aren't true — falsehoods you've heard so often and from so many angles that you believe them without question. I call them *traps*.

The most basic is *The Identity Trap:* attempting to be something other than what you are. It's so easy, when someone asks you a question, to think "How can I answer in a respectable way?" rather than saying what you really think. But you subjugate yourself in the process.

The second reason people are not as free as they might be is that they don't see all their alternatives. There are two types of alternatives - direct and indirect. A direct alternative is when you choose something without receiving help from someone else. For example, when you want toothpaste, you go to a store, select a brand, and pay for it. An indirect alternative is when you have to persuade other people in order to get what you want. Joining a political party is an indirect alternative. Most people automatically choose indirect alternatives to get what they want and, as a result, spend a lot of time and energy trying to persuade other people, when they have a wide range of direct alternatives available to them.

I explored all this in *How I Found Freedom In An Unfree World*, and I'm proud to say that the book has had a profound effect on many people.

Last week I was on a radio show with a fellow named Carl Wigglesworth. He told me that, in the mid 1970s, after he'd been in radio for years and had a top-rated



show, he was suddenly out of a job. A year went by and he was unable to find another. He spent all his savings, became despondent, and began to think he'd never work in radio again.

Then he read *How I Found Freedom*. Within one week, he not only got an excellent radio job but turned down two others. Carl told me there were many things in the book that hit home with him, but that one simple line saved his life: "No one owes you anything." No one owes you a job, respect, love, or recognition of your talent. There is *nothing* that *anyone* owes you. Whatever we get in this life, we must get for ourselves.

Once you realize that, two things happen: first, a tremendous weight is lifted from your shoulders because you no longer have to try to get from people what you think they owe you. The second thing is that you realize the only way you are going to get something from another person is by discovering what *they* want so that you can provide it in order to get what *you* want in return. In short, you stop trying to change other people, and start trying to see and connect with them.

Carl realized that every radio station he called, he had expected the receptionist to know who he was and to respect him. Once he realized that no one owed him anything, he approached everyone differently — and suddenly the world opened up to him.

Another false assumption is *The Selfishness Trap* — the belief that you

must put others before yourself...

We always hear how wonderful it is that, at Christmas, everyone thinks of others first; and how good it would be if people were like that all year round. The false assumption is that this would be a better world if everyone were always unselfish. When people talk like that I can't help but shudder. Selfishness is the natural state of all life. All living things seek their own interest — and thankfully so. Otherwise, the world would make no sense. Unselfishness serves no purpose unless there is a selfish person willing to accept the act of unselfishness. Not only would it be a worse world if everyone were unselfish, it would be an impossible one. Selfishness provides order. Because people act in their own interest, it is possible to understand them.

So while we are waiting for that great day when the walls of tyranny come tumbling down, we can be looking for ways to free-up our lives right now. And the more we understand personal freedom, the better we will be able to bring about political freedom.

Some people say Libertarians can't compete with the Democrats and Republicans because they're giving away goodies and we're not. That's not true. We are promising people the one thing they want more than anything else: control of their own lives.

I believe almost everyone is a naturalborn libertarian. Who doesn't want to decide how their child is educated or how they can spend the money they make? Who doesn't want to live in a neighborhood free of crime and all the other ill effects of drug prohibition?

Not only are the Republicans and Democrats not offering these things, they can't offer them — because it is against their nature. They're not in Washington to change anything; they are there to take and use power. With the possible exception of Ron Paul, there isn't a single person in Washington who will lift a finger to change the system. They like it just the way it is.

Every political philosophy competing with ours is bankrupt. Liberalism is dead. Conservatism is dead. The major political parties have no coherent philosophies. Their platforms are a grab-bag of positions with no consistency from one issue to the next. Mainstream American politics has devolved into a meaningless game between identical opponents. The field is wide open for someone to walk in and say, "We want to dramatically change your life!"

Some people say we can't win because Americans have chosen security over liberty. Oh really? The only time I can think of during my life when Americans were offered a clear choice between liberty and security was the 1980 election, when Ronald Reagan promised to "get government off our backs." He won by a landslide. Of course, he did nothing about it when he was in office, but that election was a referendum on the issue of liberty versus security — and liberty won hands down!

That was our message last election but few people heard it. How can we jump that hurdle next time?

We have to make sure every American hears our message. We have to be at least as visible as Ross Perot was in 1992. The only way to do that is through advertising. That means we must raise at least \$50 million for the presidential campaign in the year 2000. And the only way to do that is by building a much larger party — at least ten times bigger than it is now. Last election, we raised about \$250 for every one of our members. If we have 200,000 members in the year 2000, we'll raise the \$50 million we need.

I'm very encouraged that we can do it. The national party is much more professional than it was four years ago. The California party is too. Both have their own membership recruiting campaigns. It is *very* possible we'll have those 200,000 members by the year 2000. Then whoever becomes the Libertarian presidential candidate will be operating in a completely different world from any of his predecessors. For one thing, the press will be following him around, instead of us begging for attention.

Now, even if we reach our membership and fundraising goals, I don't believe we'll win the presidency in 2000. But we might get 5-20% of the vote. If that happens, millions of Americans are

going to say, "Oh my God, I wish I'd voted Libertarian! I agreed with them but didn't think they could win. Now I see that they can. Next time, they're going to get my vote!"

I think that would lay the groundwork so that, in the year 2002, we'd elect a lot of Libertarians to Congress. That would lay the groundwork for the election of 2004. By then we'd have a half million members. We could run an all-out campaign and win the Presidency. Now, that wouldn't be the end of it. We probably wouldn't have a majority in Congress. It would be a battle between the President and Congress for two years. If he's smart, the President would tell Americans: "Look, you voted for me so we could cut spending and repeal the income tax. If you want to get the job done, you need to elect a Libertarian Congress."

Then, in 2006, it just might happen. Then, finally, in the year 2007, the income tax would be repealed. Social Security would be taken out of the hands of the politicians. The insane War on Drugs would come to an end. Our cities would become more peaceful then they've been in 30 years. All that could be just 10 years away.

Now that may seem like a fantasy today. But who knew the Berlin Wall would come down before it happened? Who knew the Soviet Union would collapse as rapidly as it did? I believe that the time for freedom to be reborn *here in America* is at hand.

This is not 1965, 1975 or 1985. This is 1997 and America is already transforming. All that is missing is a party that can come before the American people and give them a choice. And the only way that we are going to be able to present them with that choice is by having a party that is large enough to flood this country with our message. That's why, for the next two years, we need to focus our efforts on building the party. That's our launching pad.

I look to 2007 as the year when Americans finally get what they want. And when that happens, we can look back at all the things we did that brought us to that point — and be proud and happy that we did them.
