TAX PROTEST DAY PLANNED FOR APRIL 15

Every year on April 15th the S.C.L.P. holds a tax protest at various post offices throughout the state, and this year is no exception. Along with the fair booth, this is the most important annual community outreach effort. Since April 15th is the time of year when taxpayers are the most angry at the gov-ernment, this is the best time for Libertarians to communicate with South Carolinians about the

harmful effects of taxation.

Despite what the politicians say about tax "cuts", most persons are paying more federal and state taxes now than they were two years ago. Many persons, aware that their taxes are increasing, take a fatalistic attitude and say that high taxes are inevitable. The Libertarian Party must convince these persons that

there is an alternative.

The fact is that high taxes and government "welfare" programs actually INCREASE poverty, which is the exact opposite of the stated aims of the programs. Government "welfare" programs are not the answer to the unemployment problem, for they waste over two thirds of the money they steal from the taxpayers. The answer to the poverty and unemployment problem is for the government to quit destroying jobs. Both the federal and the state governments must get out of the way of businesses and must allow voluntary charities to operate without interference.

1982 ELECTION HIGHLIGHTS

A total of fifteen Libertarian candidates ran for office in South Carolina on November 2, and, while none was elected, there were some

encouraging signs to be found. Over 42,000 South Carolinians voted for at least one Libertarian candidate in November. The three candidates for statewide offices each received over 6 percent of the vote (see table on page 2). They each received over 12 percent of the vote in Aiken County and over 11 percent of the vote in Lexington County. U.S. Congressional candidate Gordon T. Davis received the highest county percentage with his 15 percent the Aiken County vote.

STRATEGY FOR THE FUTURE

In the 1982 elections, Libertarian candidates in South Carolina received over 125,000 votes -- far more than in previous elections. However, many of these votes were obtained simply because there was no Republican opponent to the Democratic candidate. Nationwide, the number of Libertarian votes remained about the same. Why didn't we get more votes, and why didn't we win any major elections?

We have to realize that the vast majority of the voting public (not necessarily the entire public) does not share our libertarian ideology. They believe that the good of society comes before individual freedom. believe that there is nothing wrong with government force-it just has to be applied in the proper manner to build a "strong America."

They view the principles of the American Revolution as being hopelessly out of date, inapplicable to our modern times. Because of this fundamental difference, most people will not vote Libertarian today, even if they happen to agree on certain single issues, like taxes

being too high.

How do we change this situation? How do we change the ideology of 200 million people? First, we must recognize the failure of the quick-fix, opportunistic approach. Winning people's vote to the Libertarian Party without winning their mind to the libertarian philosophy is not going to accomplish anything in the long-run. Therefore, we must avoid campaigns that compromise libertarian principles in order to gain a few more votes. We must not delude ourselves into running candidates where there is no Republican opponent with the hope of picking up Republican votes. Their vote against the Democrats is not a vote for liber-tarianism, and therefore is essentially use-

less towards achieving our goal of freedom.

Instead, we have to recognize that changing the basic ideology of our society is going to take time. However, it is not a hopeless endeavor. Today we nave many hard-core, dedicated libertarian activists. I am convinced that there are many other potential activists that we have not yet reached. It should be the goal of every election campaign to identify these people and get them involved with the Libertarian Party. Each activist, through personal contact with his friends and associates, can them persuade other people to the litertarian philosophy and hopefully turn them into activists. They in turn may be able to persuade others. They in turn may be able to persuade others. This personal "ripple effect," as David Bergland calls it in "Communicating Libertarianism," is the only way the libertarian philosophy will spread in a society dominated by socialists. Election campaigns should supplement, not substitute for, this personal recruiting. Once the libertarian philosophy spreads in this manner, consistent votes for the Libertarian Party will come about by itself, and our goal of a free society will be possible.

As expected, the highest percentages went to candidates with only one opponent. However, John Comer received 12 percent of the vote in a three-way race for York County Council, and Steven Kreisman received 8 percent of the vote in a three-way race for State House District 34.

While Libertarians are disappointed that there were no election victories, many candidates put forth respectable showings if one considers that they ran against candidates who were personally acquainted with a large number of their constituents. Most Libertarian candidates are young and lack ready-made political constituencies to call upon at election time. Building a base of support will take a long time and will involve a lot of hard work. It time to start looking ahead to the next elec-

Several candidates noted that among young voters (under 30), there was a large amount of support for Libertarian candidates. Unfortunately, many young voting-age individuals are not registered to vote. Hopefully, these persons will soon catch on to Libertarian ideas and will find the emergence of the Libertarian Party to be a compelling reason to register.

UTILITY MONOPOLIES

S.C.E. & G. and other electric power companies continue to raise their rates and to waste money, provoking cries of outrage from consumers, but few persons realize why this problem continues. The utility monopolies have no competition, so there is no incentive to be efficient and to keep prices Consumers are the losers in this deal.

Whenever any service has a legal monopoly and customers can't choose between competing alternatives, prices will always be high, and the quality of service will be poor. The best examples of this are the U.S. Postal monopoly, the utilities, and the phone companies, although the case can also be made for the Pentagon, the criminal justice system, and the health care system. These monopolies are created by the government. Competition is against the law. Even if someone can produce electricity less expensively or deliver mail more efficiently, it is against the law for


anyone to offer competing services.

Under the guise of protecting the consumer, the Public Service Commission claims to "regulate" the power companies, but what it actually does is to guarantee a profit. Does anyone really believe that a company with a guaranteed profit will offer consumers anything close to the best possible deal? Imagine how much automobiles would cost if only one auto manufacturer were allowed to sell cars in each state, especially if that

manufacturer were guaranteed a profit!

In Lubbock, Texas, there are two power companies which compete for customers. While the utility market in Lubbock is not entirely free, consumers do have some choice. If a customer doesn't like the service provided by one company, he or she can switch companies. As a result, electric rates are 20 percent lower than in nearby areas, and the quailty of service is better.

Libertarians realize that the answer to the problem of rising utility rates is to free the market. The utilities, along with all other services, must be de-regulated in order to allow consumers to shop around for the best deal.

THE STATE AGAINST BLACKS by Walter E. Williams. A distinguished black economist evaluates minimum wage laws, licensing, union policy, trucking and other regulations as examples of systematic impeding of the advancement of minorities. Sees the government as a major perpetrator of racial exclusion. Views the free market as the destroyer of racial barriers and privilege. (hd. 160p)

FREEDOM FOR ALASKANS by Richard L. (Dick) Randolph. The 1982 Libertarian gubernatorial candidate gives his blueprint for rolling back the State in Alaska. Randolph, the first Libertarian State Legislator in the country, was responsible for repealing his state's income tax. (pb, 108p)

SOCIAL SECURITY: AVERTING THE CRISIS by Peter Ferrera. Shows that social security has been established and maintained by deceit. Includes a detailed presentation on how to get out of the system. (qpb, 160p)

PROGRESS AND PRIVILEGE: America in the Age of Environmentalism by William Tucker. Argues that environmentalists, who like to think of themselves as liberals, have in reality used the movement to protect the status quo at the expense of less-privileged classes. By exposing how they have distorted the issues to serve their own purposes, Tucker reveals why many problems, though serious, are soluable. (hd, 314p)

A NEW BEGINNING by Ed Clark. Presents a basic overview of the libertarian approach to the pressing problems facing our nation. By the 1980 Libertarian Party presidential candidate. (qpb, 135p)

TOMORROW, CAPITALISM by Henri LePage. Already translated into six languages and a besiseller in France and Sweden, this is one of the most controversial books in Europe today. Describes the recent revolution in economics toward the free market. Argues that the science of economics has been reshaped into a coherent, comprehensive approach to the study of human problems. (hd 254p)

FOR A NEW LIBERTY by Murray N. Rothbard. A biting attack on the legitimacy of the State, with numerous criticisms of government intervention. Offers market solutions to many social and economic problems and presents a "revisionist" interpretation of foreign policy and the origins of the cold war. (pb, 325p)

THE OMINOUS PARALLELS: The End of Freedom in America by Leonard Pelkoff. Intro by Ayn Rand. What is required to turn a country into total dictatorship? How did the Nazis accomplish it? Is it happening here? Pelkoff argues that today's dominant ideas are leading America down the road to a Nazi-type dictatorship in the near future. A profoundly disturbing book. (hd, 383p)

ECONOMICS IN ONE LESSON by Henry Hazlitt, Classic primer on the principles of the free market economy and the dangers of government intervention. Discusses minimum wage laws, rent control, tariffs, unions, price fixing, inflation, etc. in an easy-to-understand style. (qpb, 214p)

THE TWELVE YEAR SENTENCE: Radical Views of Compulsory Education, Edited by William Rickenbacker. A major attack on compulsory education from authors who range across the political spectrum. A legal and general bibliography make this an invaluable tool. (hd, 236p)
