## FLP SETS CONVENTION

The first State Convention of the Free Libertarian Party has been set for March 30, 31, April 1, at the Williams Club, 24 East 39th Street, NYC. Agenda and schedule will be forthcoming. The business of the convention will be to adopt a state platform, amend state by-laws, elect party officers and nominate candidates for the 1973 election season.

First drafts of the majority and minority reports from the Platform Committee are available to any member who sends a self-addressed stamped 9 X 12 envelope (16 cents postage) to the FLP office.

The Platform Committee will hold open hearings February 4th at the Williams Club. Members who have submitted alternate planks or full alternate platforms will be heard at that time. Final drafts from the Platform Committee will be available by February 28th to any member sending a self-addressed stamped envelope.

A general meeting of the FLP will be held February 11th at the Williams Club. An introduction to the FLP will begin at 1:30 p.m. for new and prospective members. General business meeting will begin PROMPTLY at 2:00 to discuss the upcoming convention. A guest speaker has been invited to discuss the threat to New York's liberal abortion law.

Immediately after the meeting an office-warming party will be held at the FLP's new offices - 15 West 38th Street, Room 201. Guests are urged to bring an office-warming gift (a shelf or even a bracket, a ruler, pencil sharpener, paper clips, ash tray, etc.)

On February 14th the FLP will sponsor a "We Love Liberty" Valentine's Day party, admission 99 cents, at a place to be announced. These parties have been very successful in the past as fund raising and social events.

**NOTICE: Article IV, Section A of the FLP Bylaws states: "Each FLP member in good standing 30 days prior to any FLP Convention shall be entitled to one vote at said Convention provided such member has registered at least 14 days prior to such Convention. No voting by proxy shall be permitted."**

A list of contenders for party office will be mailed to members early in March so that everyone will have ample opportunity to consider his/her choices for party leadership.

All members and friends of the FLP are urged to become actively involved in the events of the next 2 months leading up to the convention. It is *you* who will determine the goals and direction of the FLP in the coming year.

# THE MOST IMPORTANT LIBERTARIAN ISSUE

Most libertarians are better economists than political analysts. They understand the economic relationships between issues better than they understand the political relationships. The thesis of this article is that, in political terms, most of the economic issues which concern libertarians are placed like a set of dominos behind one key issue, and if that one key issue falls, all of the others will also.

That key issue is the gold standard, and its importance stems from the effect of inflation on the people in our culture. Other things being equal people in our society prefer freedom and would not willingly support economic controls. However, held over from the Middle Ages there is the concept of the "fair" price and the "fair" wage. When prices are stable or changing slowly, this concept is not operative, but in an inflation it leads people to demand that "fair" prices and wages be achieved by legislation — hence price and wage controls. Inflation also leads the country into a balance of payments problem, and the twisting and turning of the nation's leaders to get out of this problem lead them to impose higher tariffs and import quotas and restrictions on people's freedom to take money out of the country. In some countries (such as Japan) balance of payments considerations have led to massive government intervention into the economy on the fascist model with the government encouraging exports with subsidies and direct controls.

These economic controls then lead to further controls. For example, strict limits on the amount of money being taken out of the country cannot be enforced as long as the U.S. has its long open border with Canada. To seriously impose economic controls on America this border would have to be closed, with police stationed along the 3000 mile frontier. As another example, when Nixon imposed his price and wage controls, he made an appeal for all citizens to spy on their neighbors. In short, most of the restrictions on people's freedom in effect today or threatening for the future occur as a normal political response to inflation.

The importance of the gold standard as an issue is that it is the only libertarian way to stop inflation. Once gold is money, the money supply can increase only as fast as gold is taken from the ground. One hundred and forty-five years on the gold standard in this country proved that that is a rate which keeps prices almost exactly stable. Even after the massive social and economic changes of the 19th century the price level was the same when the nation left the gold standard in 1933 as when it adopted the gold standard in 1788.

When libertarians campaign for economic liberty in some other area, such as opposing price and wage controls, they run into public prejudices which require a tremendous amount of education. ("Well something has to be done to fight inflation." "Why, do you know what my grocer is charging?" "That labor union wants a 40% pay increase!") However, a successful campaign to restore the gold standard will make all the other campaigns unnecessary, and in this area the public prejudice (if such it be) is on our side. Once inflation is ended by a gold standard, the *raison d'être* for the other controls disappears.

Probably the greatest era of libertarianism in America was the era surrounding the American Revolution. Yet even these great men resorted to price and wage controls during a period of inflation.

"Early in 1777, the states were asked to make the Continentals, then sunk to half face value, legal tender . . . Price controls and ceilings were also adopted, enforceable by stiff fines and imprisonment."

If these people, who so valued liberty, called for controls during an inflation, then what hope is there for our present generation?

Furthermore, attempts to stop inflation without a gold standard are futile. To hope that the Federal Budget can be balanced or that the money supply can be held to a small annual increase is naivete refuted by long experience in every country in the world. Political pressures are such that, if a government has the paper money power, then it will use it.

Yet such ignorance abounds on this subject that, once when I proposed to a libertarian that he support the gold standard, I received the answer: "I support private money."

What does he think the gold standard is? There has never been any legislation necessary to establish gold as money. Again and again throughout history, when people have had their choice they have selected gold. A perfect example was in this country. After the Revolutionary War inflation the country's economy was in chaos, and the Continental Congress sent Thomas Jefferson out to devise a monetary system for the country. Jefferson reported that people had stopped using the official money and were instead using the Spanish thaller (mispronounced dollar), a gold coin imported from the Spanish colonies. Jefferson proposed that the government ratify the existing situation, and this was done.

To restore the gold standard it is necessary to end two government interventions in the economy. End the prohibition on ownership of gold, and end the legal tender laws (which compel people to accept paper money as a legal tender in payments of debts). Two further measures are desirable. Force the government to restore to the people the gold stolen from them in 1933, and amend the Constitution to divest the government of the power to coin money.

If libertarians were to unite in a determined attempt to restore the gold standard, instead of scattering themselves in many areas, they would find an immediate change in the political climate. In order to mitigate criticism from this direction the Federal Reserve would begin to restrict its issues of paper money. Inflation would slow, and controls would start to come off instead of going on. Libertarians who ignore the corruption of our money system and try to fight other manifestations of statism are fighting the symptoms instead of the disease. It is this, not any inherent statism in the American people, which has been responsible for most of our defeats over the past 40 years.

# THE RIGHT TO BEAR ARMS

The right to keep and bear arms voluntarily (as opposed to being drafted and forced to bear them) is no less fundamental to freedom than any of the more well-known issues like abortion, gold, the draft.

So if you're one of many libertarians who has trouble arguing against gun controls, here's some ammunition to help you see why they are not only wrong in principle, but why they in fact can't work.

It is a goal of all dictatorships to ban all private firearms ownership. Just as you cannot turn a country into a welfare state without first making it illegal to own or trade in gold, you cannot turn a country into a police state without first making it illegal to own guns.

A free country has nothing to lose and everything to gain from an armed populace. The opposite holds true for a repressive state.

The more dictatorial a state becomes, the more reason it has to want to make sure its citizens are defenseless and disarmed. But they can't take away a gun if they don't know where it is.

How do they find that out? Easy. Gun owners tell them by registering their guns according to law. That's where it starts.

But there's one detail. Street hoodlums (as opposed to the government variety) neither bring their guns in for registration, nor request a permit, if that is what's required. They would have to submit to being fingerprinted, which might tend to identify them as felons with records, which would disqualify them from owning one.

The 1968 New York City gun control law required, for the first time, that all shotguns and rifles be registered with the newly created Firearms Control Board along with fingerprints, photographs, and notarized vouchers attesting to the registrant's good character. (Nowhere in the Constitution is "good character" or anything else a pre-condition for the right to own a gun.)

For a \$3 fee, you listed all such guns in your possession (legal pistol purchases were already very tightly controlled under a different set of laws), got yourself fingerprinted and photographed, and found yourself filed away along with thousands of other gun owners who obeyed the law and from whom the people of New York City have nothing to fear. Because it is simply not the registered gun owners who are committing the crimes with guns.

And, yet, when the time comes, they will be the people whose guns will be confiscated.

This is why, when a public figure talks about banning private gun ownership (though such talk is usually only done in private), what he in effect means is that he favors confiscating all *legally*-owned privately owned guns, since these are the only guns whose whereabouts can be known for sure.

A fact largely ignored by legislators at the time of the 1968 law is that in the four year period previous to the law, the number of crimes committed with rifles and shotguns, on which there had been no controls at all, had gone down 10%, while the number committed with pistols, long since very tightly controlled, had gone up 80%. (The percentage of those crimes committed by the City's few pistol permit holders was very close to 0.)

And in the 'power to tax is power to destroy' dept: it is rumored that the \$3 fee for registration will shortly be increased to \$20 per gun per year. By basing gun ownership on ability to pay, this will be discrimination against the poor, because they will be least able to afford to keep their guns, although living in high crime areas, as the poor generally do, they will be the ones who need them most.

As for registration, well, sure cars are registered. But anybody can buy a car — you don't need police permission to own one. And you get it without having to list personal history, or having to get your friends to list their personal history when you use them for references, and without having to get fingerprinted and photographed and have all kinds of personal information stored in police files.

And nobody calls you a car-nut for wanting to own one.

You simply cannot keep guns out of the hands of criminals. All you can do is make them think twice about using them. But gun laws, as they stand today, give street criminals a virtual monopoly in their use and a virtual 100% guarantee that the people they use their guns against will be unarmed.

Between the intrusive paper work of gun registration, the difficulty of qualifying for a pistol permit, and the fact that people with police records are not allowed to own any kind of gun, the situation created is a virtual arms embargo on both sides, with only the good guys honoring it, and only the good guys being penalized when the bad guys violate the laws.

Banning guns will no more stop crime than Prohibition stopped drinking. (Appropos of that, on the eve of Prohibition, there were 15,000 bars in New York. On the eve of Repeal, there were 32,000.)

If, when an armed felon is caught or killed, news coverage included whether or not he was a pistol permit holder, or a repeater or parolee, it would soon become apparent that it is not the few permit holders who are committing the crimes.

In all fairness, it should be noted that there have been cases where the banning of guns from private ownership had reduced violent crime to near zero — Nazi Germany and Fascist Italy, for instance. In these cases (though gun-haters prefer not to use them as showcases) violent crime as we know it here went out of existence.

So did a lot of other things.

Then again, in cities like Tampa and Phoenix, where the Police initiated small arms training courses for interested housewives, the mug-rape rate went down to 0 and stayed there.

# TAX REBELLION REPORT

What is helping the firearms crime rate go up is not the supposed ease with which, as many politicians think, you or I can get a gun, but 1) the knowledge that anybody who commits a crime will probably get away with it, and 2) the fact that police are spending nine-tenths of their time on victimless crimes.

There should be a heavy automatic no-parole jail sentence for any crime committed with a gun. This would make criminals think twice about carrying one, even if they "didn't intend to use it." And it would leave hunters, collectors, target shooters free to own guns without any complicated privacy-violating forms to fill out.

Voluntary registration with minimal paperwork will make it extremely easy for a man or woman to own a gun. And a man or woman who might have a gun is somebody for street hoodlums to steer clear of.

If your Congressman or your Assemblyman is against private gun ownership in the face of a skyrocketing murder rate, ask him why.

And drop in on your local precinct and find out how hard it is to get a pistol permit.

And ask *them* why.

## THE FIGHT IS NOT OVER

The Supreme Court's recent decision on abortions is cause for celebration for all libertarians. The 7 Justices who supported the historic decision are to be applauded - at least with one hand. While we can all rejoice that the State now cannot in any way interfere with abortions in the first three months and the pronouncement of our right to privacy, the Court's decision still leaves abortion regulation to the State in the second 3 months, and allows prohibition by the state in the last 10 weeks.

Pertinent excerpts from the majority opinion: "Some amici argue that the woman's right is absolute and that she is entitled to terminate her pregnancy at whatever time, in whatever way, and for whatever reason she alone chooses. With this we do not agree." "The Court's decision recognizing a right of privacy also acknowledges that some state regulation in areas protected by that right is appropriate." "With respect to the state's important and legitimate interest in the health of the mother..."

If a woman has the "right of personal privacy," she has it. If she has that right sometimes but not other times, then she has no right of personal privacy except by State whim.

The decision to have an abortion properly rests with the pregnant woman, her physician, husband, lover, or whomever else she chooses to consult. The decision to have an abortion must not rest with the State.

After we finish toasting Justices Blackmun, Burger, Douglas, Marshall, Brennan, Stewart and Powell, let us pick up the banner and finish the job in New York State: the repeal of all laws concerning abortion.

There are three major tax resistance organizations around the country. The first of these is War Tax Resistance, mainly concerned with the telephone federal excise tax. Their literature is very informative and shows how easy it is to fight the telephone tax. Anyone interested in obtaining literature from them can write to War Tax Resistance, 339 Lafayette St, NYC 10012.

The second is Tax Rebels of America which is headed by Karl Bray (LP State Chairman for Utah). He has much information on income tax resistance as he is going through litigation with the IRS at present. Karl has written a booklet called *Taxation and Tyranny* which can be obtained for \$1.00. It is well written and easy to understand. He has filed suit against the IRS and three of its agents for invasion of privacy in the amount of \$135,000. He has three attorneys representing him. In the war against the IRS, he has already won one battle. Federal District Judge Willis W. Ritter issued a restraining order against the IRS. The case at present is before the 10th Circuit Court of Appeals in Denver. Anyone interested in writing to Karl Bray can reach him at Box 856, Provo, Utah 84601.

The third organization is the Tax Rebellion Committee of Los Angeles which is headed by John N. Schmitz, Economist (no relation to the John Schmitz who ran for President on the American Party ticket). The Committee has a taped telephone tax message and holds tax dinners every Saturday. They too have commenced a lawsuit against the IRS. The Tax Rebellion Committee, the leading purveyors of income tax resistance information, can be reached by writing to P.O. # FLP RADICAL CAUCUS: WHAT'S IT AFTER?

Not power, that's for sure.

Philosophically, we form the caucus which seeks fealty to consistent, "radical" libertarianism and opposes the compromise of principle and position for such as electoral gain.

Our position on any given issue follows immediately from this: no matter how little you wish the legitimized monopoly of coercion to act, we wish less. Examples are less State "defense" (warfare), taxation, "police" (extortion), foreign alliances, currency manipulations such as inflation, and involuntary servitude (e.g., conscription and welfare).

Since, by our nature, we are concerned with the adherence to libertarianism of those representing libertarians, we are constantly campaigning for reforms in the Party structure to prevent centralization of authority, exercise of arbitrary power in a bureaucratically-protected fiefdom, and access to funds unrestricted as to specific use. Thus we will support moves to give increased control of nominations, electoral campaigns, platforms and stands on issues to local constituency organizations rather than state organizations, and state parties rather than the national party. We will oppose the party's soliciting or accepting moneys which are not earmarked for a specific purchase. Above all, we will oppose empire-builders in the party structure, the creation and maintenance of a Partyarchy.

One position of special importance to all lovers of liberty is the prevention of expulsions, suspensions, non-recognitions and any other euphemisms for purges. We wish the widest possible definition of membership; simultaneously, we demand the narrowest, most rigorous definition of libertarianism.

If you think the Party on Platform and mechanism has none of the above problems, check out the radical caucus' coming convention campaign literature. If you already think that the Party Platforms and mechanisms can be better - freer - then check out the Radical Caucus at its next meeting. (See Club News)
