## Proposal #R

#### **RULE 8. ELECTION OF OFFICERS AND NATIONAL COMMITTEE**

**Problem:** The Party's existing electoral method to elect Party officers of the National Committee is outdated and inefficient. The Libertarian Party platform "support[s] ... election systems that are more representative of the electorate...."

**Solution:** Implement Ranked Choice Voting to elect Party officers of the National Committee.

**Benefits:** Ranked Choice Voting (RCV) is a balloting method that eliminates multiple rounds of voting, facilitates greater voter expression than a single choice ballot, and mitigates the "wasted vote" problem. Using RCV also helps our Party practice what we preach by implementing more competitive and representative electoral methods, familiarizes Party members with the use of such methods, and models the use of such methods to external audiences.

## **Current Wording**

- 1. Nominations for Party officers shall be from the floor. The election shall be conducted in the following manner:
- a. For each office, a majority vote will be necessary for election.b. Each delegation shall tabulate its total vote,
- tabulate its total vote, and the delegation chair shall deliver a written total to the Secretary. When all delegations have submitted their votes, the Secretary shall declare the voting closed.
- c. In cases where no candidate receives a majority, runoff votes will be held, dropping the candidate with the fewest votes after each ballot.

# **Proposed Amendment**

- 1. Nominations for Party officers shall be from the floor. The election shall be conducted in the following manner:
- a. For each office, a majority vote will be necessary for election.
  b. Each delegation shall tabulate its total vote, and the delegation chair shall deliver a written total to the Secretary. When all delegations have submitted their votes, the Secretary shall declare the voting closed.
  c. In cases where no candidate receives a majority, runoff votes
