The meeting was called to order at 7:05 p.m. by William Cody Anderson, Chair.

The Credentials and Nominations Report (Exhibit 1) indicated that there were 66 voting members at the time the meeting was called to order due to the resignation of Kevin Warmhold on September 4, 2021 (Exhibit 2). 42 of 66 Members of the State Committee were present at the time of roll call; Michael Arcati, Jay Carr, Milva Dordal, Robert Greibesland, Gary Popkin, William Schmidt, and Angelo Veltri later entered the meeting.

The Chair issued opening remarks, issuing an update to the ballot access lawsuit, the Libertarian Party's involvement in numerous demonstrations across the state regarding protesting the healthcare mandates, and the court-ordered disregarding of the independent petitioning deadline that allowed incumbent Byron Brown, running as independent for Mayor of Buffalo.

The Chair left the meeting due to technical difficulties. 1st Vice-Chair Anthony D'Orazio took the gavel. He thanked everyone for their hard work around the state. The meeting stood at ease from 7:19 p.m. to 7:23 p.m. William Cody Anderson entered the meeting and took the gavel back from Anthony D'Orazio and resumed his opening remarks.

Motion by William VanHelmond to **adopt the Agenda (Exhibit 3)** was seconded by Anthony D'Orazio and passed without objection.

Motion by Todd Haggerty to **adopt the Special Rules of Order (Exhibit 4)** was seconded by Anthony D'Orazio and passed without objection.

Secretary Andrew Kolstee issued a Credentials and Nominations report (Exhibit 1). The following individuals were submitted to the Secretary to fill vacancies in the State Committee and accepted their nominations. Motion by Andrew Kolstee to enter the following candidates into nomination to fill vacancies on the State Committee passed without objection.

Jonathan H. Gunther, nominated by Gary L. Donoyan to fill a vacancy in Judicial District 10 Fredy Omar Calvache, nominated by Robert J. Glomboski to fill a vacancy in Judicial District 12

The Chair opened the floor to nominations to fill the vacancy in Judicial District 1. No candidates were nominated.

The Chair opened the floor to additional nominations to fill the vacancy in Judicial District 10.

Anthony D'Orazio nominated James Harris and he accepted the nomination.

The Chair opened the floor to additional nominations to fill the vacancy in Judicial District 12. No additional candidates were nominated.

Fredy Calvache spoke on his candidacy.

In the first round of voting for the vacancy in Judicial District 12 on the State Committee, the results were as follows:

Require that the legal age for any adult activity regulated by the state not exceed 18.

Once individuals are considered to have adequate judgment to vote and to serve on a jury or in the military, they should be considered to have sufficient judgment to decide their own purchase and use of alcohol, tobacco, firearms, and other potentially risky activities.

Mark Braiman continued issuing the Platform Committee report.

Motion by Mark Braiman adopt the platform in accordance with the Rules of the Libertarian Party, to include the "Right to Decide" plank that was adopted at the July 18, 2021 Meeting of the State Committee:

WE THE LIBERTARIAN PARTY OF NEW YORK

Recognize that all people, being created equal, are endowed with unalienable rights, among these are the right to life, liberty, property, and the pursuit of happiness. We recognize that if governments must exist at all, their only just purpose is to secure these rights for individuals.

While we defer to the national party on issues of national interest, and we defer to our candidates to offer specific policy proposals, we do so only so far as they do not conflict with the following principles:

The Right to Free Association – Individuals have the right to associate or not associate with one another on the terms of their own choosing, and without interference from third parties. Nor should one lose their individual rights should they choose to band together collectively.

The Right of Free Expression – Individuals have the right to express themselves peacefully in whatever form they choose, even if that expression is seen by some as profane or offensive.

The Right of Conscience – Individuals have the right to live their lives in accordance with their own values and sense of right and wrong, and, except for rare cases of abuse or neglect, the right to raise and educate their children as they see fit.

The Right to Self-Ownership and Personal Autonomy – Individuals have the right to do with their own bodies whatever they please.

The Right to Personal Property – Individuals have the right to their own property, and to keep, to use, and to dispose of that property however they see fit.

The Right to Personal Privacy – Individuals have the right to live free of government intrusion or surveillance into their movements, communications, health, or personal affairs.

The Right to Freedom of Personal Action – Individuals have the right be free to live and do as they please, so long as they respect the rights of others to do the same.

The Right to Decide – Individuals and families have a right to decide for themselves all issues regarding their health, wealth, and safety.

The Purpose of the State is to secure these above rights to all persons, all the time recognizing that it is a servant of the people and never its master.



Special Rules of Order of the Libertarian Party of New York for the State Committee Meeting of September 12, 2021

To be proposed for adoption by the State Committee on September 12, 2021.

Rule 1. **CREDENTIALS.** The Secretary, directly after the opening ceremonies of the business meeting, shall call the roll of the elected members of the State Committee.

Rule 2. **IDENTIFICATION OF VOTING MEMBERS.** To facilitate identification, seating, and voting, members and others shall be required to retain and display upon request the wristbands, voting cards, or other indicia issued by the organizers of the meeting upon registration. Division votes, whether simple or counted, shall be taken by members' standing and display of such voting member indicia. For meetings held by teleconference, voting members shall be identified within the platform or platforms used to conduct the meeting.

Rule 3. **DEBATE.**

- Rule 3.1. No member shall speak in debate on the same question a second time until every other member who wishes to speak had the opportunity to do so.
- Rule 3.2. No member shall speak in debate on the same question more than twice or longer than three (3) minutes in total without permission of the State Committee granted by a two-thirds vote without debate.
- Rule 4. **FILLING OF VACANCIES.** Vacancies on the State Committee shall be done in a manner as described in this Rule and in accordance with the Rules of the Libertarian Party. If there is no candidate to fill a vacancy for a particular district, the Chair may move to the next district or item on the agenda.

Rule 5. ADOPTION AND AMENDMENT OF PARTY RULES.

- Rule 5.1. All proposed amendments of the Party Rules must be submitted in accordance with this Rule and the Rules of the Libertarian Party.
- Rule 5.2. If discussion on an amendment has begun, any recognized speaker may also discuss alternative proposed amendments that deal with the same issues and may use that text to propose a substitution to the current amendment.
- Rule 5.3. If a member of the State Committee proposes more than one amendment, their subsequent proposals shall be taken up only after every other member's first proposed amendment has been considered.
- Rule 5.4. Debate on each amendment shall be limited to ten (10) minutes. Each speaker is limited to one (1) minute at a time. The Chair shall alternately recognize those speakers in favor of and opposed to the amendment.

Rule 6. CANDIDATE SPEECHES.

Rule 6.1. Candidates for Chair shall each be allowed five minutes to speak; candidates for all other Party offices shall each be allowed three (3) minutes to speak. Candidates to fill vacancies on the State Committee shall be allowed one minute to speak. Candidates may cede their time only to other members of the State Committee to speak on their behalf during their allotted time. Speeches will not be allowed for uncontested positions, in which candidates are only running against NOTA.

Rule 6.2. Candidates seeking endorsement for the highest public office shall each be allowed five minutes to speak; candidates seeking endorsement for all other public offices shall each be allowed three minutes to speak; candidates seeking endorsement for any public office shall also each be allowed one nominating speech and one seconding speech of one minute each.

Rule 7. **ENDORSEMENTS OF CANDIDATES.** Endorsements of candidates for public office shall be made in the same manner as elections for Party office, except that endorsements shall require a two-thirds (2/3) majority. Each office shall be filled with one election, even if that office has more than a single position to be filled. Each election shall consist of a series of ballots. In each ballot, voters may vote for as many candidates as there are positions for the office still open or "None of the Above". If None of the Above achieves a majority, a new election shall be held for the open positions still remaining and the candidates who were outpolled by None of the Above shall be ineligible; otherwise, those who achieve the requisite majority shall be recognized as elected, in order of their vote totals and in order of the length of term. The candidate receiving the fewest votes shall be eliminated from succeeding ballots. Ties shall be resolved by a separate ballot.

Rule 8. **PLATFORM.** When discussing the Platform, the previously adopted Platform shall be the base on which amendments, additions, or deletions shall be offered. Such changes to the Platform shall require a vote in accordance with the Rules of the Libertarian Party.

Rule 9. RESOLUTIONS.

Rule 9.1. A resolution offered by an individual member shall be submitted by the maker and the seconder – each of whom shall be a member of the State Committee – and shall be sent by email directly to the Secretary.

Rule 9.2. The Resolutions Subcommittee may convene during the main meeting to consider resolutions. Each member who offers a resolution shall be given an opportunity to explain it to the Resolutions Subcommittee if he so requests.

Rule 9.3. The Resolutions Subcommittee shall review all resolutions in the order they were submitted, and shall amend the text of each resolution to the satisfaction of the member that submitted the resolution, while satisfying formatting requirements, grammar, clarity, etc. The Resolutions Subcommittee shall present a report to the State Committee of all resolutions in the order they deem appropriate.



PROPOSED PLATFORM AMENDMENTS

The Platform Committee proposes the following language to append to the Platform of the Libertarian Party of New York.

Proposal #1. New Platform Plank Proposal A

Motion to adopt the following platform plank:

The Right to Decide - Individuals and families have a right to decide for themselves all issues regarding their health, wealth, and safety.

Proposal #2. New Platform Plank Proposal B

Motion to amend the following platform plank and move to the end of the Platform:

While we defer to the national party on issues of national interest, and we defer to our candidates to offer specific policy proposals, we do so only so far as they do not conflict with the following principles:

We support the Platform of the National Libertarian Party, in addition to the following planks specific to New York State:

Proposal #3. New Platform Plank Proposal C

Motion to adopt the following platform plank:

Eliminate taxation and regulation of cannabis for adults. We support the full legalization of cannabis and hemp products, including cultivation, processing, distribution, sales, possession, and transportation, without introducing any new taxes or licensing requirements.

Proposal #4. New Platform Plank Proposal D

Motion to adopt the following platform plank:

Require that the legal age for any adult activity regulated by the state not exceed 18. Once individuals are considered to have adequate judgment to vote and to serve on a jury or in the military, they should be considered to have sufficient judgment to decide their own purchase and use of alcohol, tobacco, firearms, and other potentially risky activities.

Proposal #5. New Platform Plank Proposal E

Motion to adopt the following platform plank:

Maintain the greatest possible degree of local autonomy during emergencies. Government responses to extended emergencies, including pandemics, should be as localized as possible. One-size-fits-all solutions have little benefit for sparsely populated regions in much of the state.

Proposal #6. New Platform Plank Proposal F

Motion to adopt the following platform plank:

Maintain due process during extended emergencies. Any response to an emergency at the state level must be enacted by the Legislature following extensive committee hearings, not by Executive Orders, and should expire when the emergency declaration expires. The State should be held liable for damages to persons or businesses, that are caused by emergency rules that have not been subject to a deliberative legislative process.

Proposal #7. New Platform Plank Proposal G

Motion to adopt the following platform plank:

Protect personal freedoms during emergencies. We oppose the violation of First Amendment rights of free association and human interaction associated with lockdowns and stay-at-home orders during government-declared emergencies. We respect the diversity of values; people who wish to engage in commerce, worship, and social interaction should be free to individually assume the associated risks of such action. We believe government decrees intended to enforce healthy behavior erase personal responsibility. The continued use of emergency powers to make and enforce such decrees habituates society away from personal responsibility, which will gradually erode our liberties.

Proposal #8. New Platform Plank Proposal H

Motion to adopt the following platform plank:

Increase choices and eliminate barriers in education. We support parents' rights to send their children to any school of their choosing, whether public, private, or charter. We furthermore support eliminating barriers to alternative educational options, such as vocational training and homeschooling.
