#### NATALIE CLARK

Crime is one of Natalie's greatest concerns, and she would work to end the war on drugs, which causes much of the violent crime in our state. Natalie earned her law degree at Marshall-Wythe School of Law at William and Mary University, and an advanced degree at Columbia University. She has twice been the Libertarian candidate for Attorney General and is an attorney and professor of law at Northern Illinois University, DeKalb.

Natalie has been a Libertarian for 20 years. What brought her to the party, she says, was that "I heard a Libertarian speaker who was a politician -- and made sense!"

# JOSEPH SCHREINER

As Secretary of State, Chicagoan Joseph Schreiner would develop measures to safeguard the privacy of individuals -- something he believes is threatened by computerized databases



and information sharing, particularly between governmental agencies. He wants to privatize mass transit in Chicago and Northern Illinois, and end the practice of using driver's license suspension as a penalty for unrelated offenses.

Joseph has been active politically at the local level, working against discrimination and serving as a Cook County election judge, pollwatcher and registrar. He says, "I was active in the Democratic Party, but have abandoned it because it has abandoned any true allegiance to personal liberty."

Joseph has worked for 17 years in the statistical and analytical computer software industry.

# • GOVERNOR • DAVID KELLEY

David Kelley, a native of Rockford and a long-time Libertarian, knows that the other parties' "solutions" to crime -- more taxes, police, prisons and gun control -- have been the same for two decades...and they're just not working.
