Audit Report:

The 800 Telephone Number

Because Dick Rider in San Diego will be running for Office, he will no longer be able to answer the 800 telephone number, therefore, the number must be moved, at a cost of \$700. The Los Angeles County Central Committee has recently obtained office space in West Los Angeles, and has indicated that it would like the 800 number moved to that office. LA is proposing to hire an office manager, Don Meyer. There will be a \$700 charge from the telephone company to move the number. Motion was passed to move the 800 number to the Los Angeles Office.

Libertarian Data Base

The Los Angeles County Central Committee would like to move the data base into their new offices. They propose to hire Don Meyer as office manager, and thereby have the ability to administer the data base. There was some objection from those who thought that "Withease" was doing a satisfactory job. Concern was express as to what type of computer language or software would be use. The matter was deferred until the next meeting, when Los Angeles would present a written proposal. Withease is on a month to month contract.

Notice of new Members to the Nationals

There was concern express that there is to much time lag between when the State gets new members, and when the National find about them. A motion was made to set up a revolving \$500 account with Withease, so that they would automatically forward the names of new members, and their dues, to the National. The motion passed, with two votes against.

Review of expired memberships

A motion was made and passed to review expired memberships on a monthly basis instead of a quarterly basis.

Renewal Forms

A motion was introduced to up grade the renewal forms. Should the wording on the forms change? Expense is a restraint. Pat Wright will research and report back at next meeting.

Fund Raising

The next fund raising letter was discussed. We have 13,000 names in our data base. It costs us approximately \$3 for each new member. There is \$7,000 in the budget for membership drives. There are 52,200 registered libertarians in the state. Suggested that the April Newsletter have an envelope for a fund raiser. Mark Hinkle to report by March 1 on fund raising status. Suggested that a higher bounty be paid for new registrants with good phone numbers.

Style Committee

Style Committee set up to review language and spelling of the recently adopted Platform. Committee members include Mark Hinkle, Jerry Douglas, Jerry Collette, and Gail Lightfoot.

Convention Expense Item

There was a complicated money issue regarding the exchange of money with the Convention organizing committee. I was not able to follow the details. Something about a cost over-run on the printing of the fliers. Half of the cost over-run will come out of anticipated profit of the Convention.
