During World War II, when the Allied Command ordered saturation bombing of Frankfurt, Berlin, and Munich, would you have scrubbed the mission upon receiving intelligence that Allied prisoners of war were being held in those cities? Hitler would have loved to have had a U.S. president around at that time who considered those lives overly precious and called off the bombing.

Middle East disputes, Israel's role in them, and our own bungling foreign policy are not the main issues in the current crisis. What is at issue are the basic principles of international conduct governing the ways that nations negotiate and settle their differences.

The focal point of any discussion of our response should be: What are the best steps to take to reduce the chances of future terrorism? The Bush administration should make it plain that taking hostages, blowing up civilian airliners, and committing other acts of international terrorism are not profitable.

You don't convince terrorists of this by congressional resolution condemning terrorism. Nor do you convince them by being willing, as George Bush has indicated, to consider negotiating with Iran (through a third party) over its frozen assets. This merely proves to terrorists, and the nations that back their activities, that terrorism is profitable and the United States is a wimp nation. At best "success-

ful" negotiations take care of ful" negotiations take care of the immediate problem, such as the release of hostages, but they it possible we have failed to adapout such as about such an archaic curriculum last century — either update their last century — e lay the groundwork for the next airliner bombing and the next hostage taking.

Americans must have the will and resolve to exact a high cost from terrorists and the nations who back them. But what do we hear from Washington? Such exkeeping out people." Such experts ought to be canned. If the tiny nation of Israel can find and arrest Sheik Obeid, and be in and out in an hour, why can't we develop similar intelligence and adeptness?

Instead of all the whining and wringing, we need to use our carrier-based Mediterranean and Indian Ocean naval fleets to send an unambiguous message to both the terrorists, and the nations who back and harbor them, that the principles of international conduct do not include terroristic acts, and heavy military sanctions will be imposed on nations who support terrorists.

President Bush needs to look at President James Madison's foreign policy. Barbary Coast pirates were preying on U.S. and European shipping. The United States and Europe dealt with the pirates by paying tribute and ransom resulting in higher demands. Finally, Madison sent in a naval force headed by Admiral Stephen Decatur. The pirating stopped.





OLYMPIA (AP) - Sen. Jack Metcall demanded and received Friday 383 Susan B. Anthony dollars when he presented his expense check for cashing at the state treasurer's office.

The Langley Republican endorsed the check and added a statement that read "It is hereby officially noted that in cashing this check I will accept only constitutional, lawful money.

Treasurer Robert O'Brien had advance notice of Metcalf's plan so had the Susan B. Anthony dollars available.

Metcalf said he wouldn't accept federal reserve notes because they are unconstitutional.

"Susan B. Anthony dollars are clearly constitutional and federal notes are clearly unconstitutional," he said.

Metcall pointed to a section of the U.S. Constitution that states that Congress shall have the power "to coin money, regulate the value thereof, and of foreign coin and to fix the standards of weights and measures."

It's not the verb "coin" that bothers Metcalf. He said that also means print money.

However, he said the Federal Reserve System prints money without the authority of Congress.

He said the Federal Reserve System, while chartered by Congress, is independent and is supported not by Congress but by member banks.

On the other hand, he said, the Susan B. Anthony dollars were issued by the Treasury Department with the blessings of Congress and so are constitutional.

Barrows said 67 percent of the drug arrests that have been made over the last 10 years have been marijuana busts.

"The first two drafts of the Constitution were written on hemp paper. Now they won't let you burn it," he said.

James Parker of the Ohio Libertarian Party said some public service messages say, "You have the choice to say no to drugs."

"Choice means that you should also have the choice to say yes, Parker said.

"It's your body, your life, your decision ... Why should you allow someone to tell you that you can't take drugs?" he said.

"If both parties are happy, then there's nothing inherently immoral about drug dealing," he said. "The real immorality (comes from) the drug laws and the professional politicians who establish those laws and try to take our freedoms away."

There is a myth that cocaine heroin, mushrooms, whatever, are more evil than alcohol," Gaylor said.

"Drugs in general are probably harmful because they change your brain in some way, but there's no difference between using alcohol and crack," Gaylor said.

Fuller said criminalization of drugs is racist because prohibition traditionally has been used to suppress minorities. The first laws making drugs illegal were designed to prevent Chinese laborers from using opium and to prevent blacks from using marijuana and cocaine, he said.

Legalization also would make drugs cheaper, he said. A gram of cocaine currenty costs about \$100, he said, but a legal gram cost about

Barrows suggested the money generated from a drug tax could be used to build treatment centers across the United States.

But legalization will not result in greater numbers of addicts because most people have a selfpreservation mechanism when it comes to drug use, Barrows said.

If the United States continues to keep drugs illegal, urine tests definitely will be the wave of the future, Fuller said. "The next step is a police state."



According to Newsweek (Sept. probably expel white students 25, 1989), there have been racial incidents at 250 of the nation's colleges since 1986. These ranged from graffiti and jokes to destruction of anti-apartheid shanties and assaults.

Civil rights "experts" blame the recent increase in racial incidents on "the atmosphere of racial intolerance created by the Reagan administration. This reasoning is absurd, particularly when we consider there have been more racial incidents on campuses in Massachusetts, not exactly known as Reagan country, than in the entire South. Moreover, racial incidents have been cropping up at colleges like Oberlin, Columbia, and the University of Pennsylvania, places with long histories of racial tolerance.

Part of the problem results from racial dishonesty of the kind represented in the Newsweek report, wherein the writers failed to report black racism. At one college, a black professor frequently uses "honky" in his classroom when referring to whites. At another, a black professor lectures on the genetic inferiority of whites. Then there was the case or a black student who made virulent anti-Semitic remarks to a Jewish student. No sanctions were taken against the student, but the conservative student newspaper which reported the incident was thrown off campus. Administrators yield to black student demands for segregated housing at some colleges, but would

for making similar demands. At a Midwestern college, its engineering school automatically adds 0.5 to the grade point average of all minority students.

Then there are race-based admittance policies. Black stu-dents score well below the national norm on scholastic achievement tests (SAT). This means in order to achieve what administrators call "cultural diversity" two academic standards

for admittance must be set up one for whites and a lower one for blacks. The tragic result, for many black students, are academic warnings, academic probation, and ultimately dropout or suspension. Worse than this, many black students see themselves as out of place; they're often treated with condescension, and white students who hold stereotypes of black mental incompetence perceive their stereotypes as confirmed.

It does not take much intelligence to see how these and other unevenhanded policies can lead to racial resentment and incidents. But what do college administrators do in the face of racial incidents? You've got it. They prescribe more of (what I consider) the racially insulting

practices that sparked the racial resentment in the first place.

They call for more race-based admittance and faculty hiring policy, anti-racial harassment codes that will no doubt be unevenly and arbitrarily applied, and graduation requirements mandating classes on race, which will be nothing more than forums for moral exhibi-tionism and demagoguery. The result of all this is years from now, we will be wondering how the children of white and black parents, who stood side by side in the civil rights struggle of the '60s, became racists.

Part of the solution to campus racial problems requires an end to the wholesale destruction of black youngsters by government schools. The doors to college, for far too many blacks, are closed before they reach the sixth grade. Improving education at the primary and secondary levels will do far more to ensure higher education opportunities than will racial quotas.

Another part of the solution is to press for principled administrators. College administrators may not appreciate principles of fair play, but they do care about falling enrollments and contributions from alumni and foundations. We should with-draw our children and withhold our money from colleges practicing the new racism.

Free market: no respect for race

F.W. de Klerk has replaced P.W. Botha as chief executive of South Africa. Political pundits aren't sure what to predict, but if South Africa progresses as much under de Klerk's leadership as under that of his predecessor, apartheid should be gone by the turn of the century.

Most people think the battle against apartheid is waged on moral grounds where the stakes are the triumph of good or evil. But, as I found in researching my new book, "South Africa's War Against Capitalism" (Praeger, 1989), the major struggle against apartheid has been waged on economic grounds where the stakes are profits and

What impresses me most about South Africa's history is the thoroughness of its laws codifying race, particularly those in the labor market. The Mines & Works Act of 1911, as amended in 1926, introduced regulations prohibiting employment of nonwhites in various trades - skilled and unskilled. And the Industrial Conciliation Act of 1956 gave the labor minister the power to reserve certain jobs in the clothing, construction, transportation, and other industries for whites only.

South Africa's captains of industry, though white supremacists themselves, fought these laws by: seeking special exemptions to hire nonwhites, outright violation, and underhanded contravention. Sometimes they even employed blacks at night to do "white" work. In 1922, violetions of racial quotas led to South Africa's most violent laoor unrest - the Rand Rebellion. White miners roamed Johannesburg streets, committing arson, bombing murdering and looting. Led by socialists and communists, they paraded, chanting "Workers of the World Fight and Unite for a White South Africa." The government has a use infantry artillery, and aerial bombardment to restore order, leaving whites dead and many more wounded.

Initially, all of this seems strange. Aren't the owners of South African industries white? cial cooperation? I believe it's because the Free Market shows little respect for race. As I ask in my book, "If white businessmen would not hire blacks in certain jobs, why on earth would there be a need for a law prohibiting them?" It turns out: . White workers wanted privilege; they wanted to be paid "civilized" wages. But black workers were willing to work for less. White businessmen, looking at the profit line, saw that racial solidarity exacted a price, and no amount of brotherly appeal by white workers could make the executives ignore profits. But government does respect race, which is why white workers sought to enlist its power - to give them privi-leges unattainable in the open market. That's why

Anarchist squatters in Greece

On May 27th a group of homeless young anarchists occupied an empty building on 34 Asklipiou Street near the center of Athens. The building, empty for the past 10 years, was a mess and was cleaned up by the squatters.

A few days later the owner began proceedings with the courts and the cops to remove the anarchist occupiers. However, with its attention focussed on the June elections in Greece, the occupiers were not immediately evicted by the government.

Then on June 23rd a district attorney and many cops invaded the house, arresting the five comrades who were at the time. They were held, beaten while in custody, and sent charged with "disturbance of the common peace" (this despite--or possibly because of--the fact that all the neighbors in the area were supportive of the anarchists and their clean-up efforts). A trial date was set for November and the judge in the case set the five free till then.

On June 30th 200 anarchists and leftist sympathizers marched around the area of the occupation and promised to begin a new squatter's movement, since in Athens alone there are 200,000 empty apartments, while many remain homeless. The groups involved in all the current occupations are in support of the most recent attempt at 34 Asklipiou which has been locked up by the cops.

The last 15 years have seen more religious freedom cases than at any time since the Revolution. And government interference into church affairs continues to increase, in spite of the religious liberty guarantees of the U.S. Constitution.

new deception whereby you'll be tricked into thinking employers will pay mandated health benefits.

You may ask: "If that's right, Williams, why do labor unions support mandated benefits? Unions have also supported the minimum wage as a means of protecting their members from competition with non-union workers.
