
Davis stated at a meeting of supporters in Columbia.

This will be the first time the S.C.L.P. has run a full-time state-wide campaign. Davis will be traveling throughout the entire state, spending a week at a time in each congressional district and will kick off his campaign at the S.C.L.P. State Convention on August 18.

"In each district, I want to speak to as many church groups as possible and discuss the horrendous government abuse of church schools taking place around the country, and indeed, in South Carolina, and pushing the concept of government non-intervention in church and education. I also want to speak to as many high schools and colleges as I can, as well as service clubs and other local interested groups. The Libertarian Party has some important things to say on the key issues in 1984, and it's time to get the message out."

Mr. Davis has stated that he will push for televised debates between himself and Mr. Thurmond, hopefully to be sponsored by the League of Women Voters or some other non-partisian group, and let the state see the differences between what people perceive as Strom Thurmond and the REAL Mr. Thurmond.

"With your help, I truly believe that we can pull off some surprises in 1984. As I will say often during the next 6 months ... THERE IS NEW HOPE!"

LAWYERS IN OFFICE OPPOSED

COLUMBIA (AP) — Lawyers should not be able to hold public office and those who do should be declared "in open rebellion" against the state Constitution, according to a lawsuit filed by the founder of the citizen's group Freedom Watch and three other citizens.

E. R. Rish of Cayce said he and the other plaintiffs, all residents of Lexington County played "jailhouse lawyer" to write the class-action suit, which was filed July 2, 1984, in Richland County Court of Common Fleas. The plaintiffs say they were filing the suit on behalf of all citizens of the state.

Other plaintiffs are Arthur J. Lanigan, jr., James C. Goodman, and Jan L. Chapman.

The lawsuit contends that lawyers may not serve in the state's legislative or executive branches because they are already officers of the courts and that holding both positions violates the separation-of-powers doctrine of the state Constitution.

TEACHERS OPPOSE SOUND POLICIES

Pike has been running a
quiet but grassroots
campaign against incumbent

In a statement released by the Pike Committee, Ray Pike blasted the State Teacher's Organization for their endorsement of Mr. Smith. "The very ones charged with molding the minds of our young people have taught them some bad lessons by example. First they completely ignored a third candidate in the race. teaching children to be prejudiced. Instead of looking at the candidates" complete platform they have taught children to only use their selfish interest. Bragging about their ninetyseven percent success in '82 they taught children to use sleazy power politics to get what they want. The media failed to report the political background of the leaders of this group which are deeply rooted in the Democrat Party. The President is a long time member and former leader of the Greenville-Spartanburg Democrat Women's Club. suggest that in the future the State Teacher's Union bring all of the candidates together before their entire body. 
BLEVINS PROMISES TO RUN

SOUTH CAROLINA IBERTARIAN PARTY



A PRIMER

WHAT IS THE GOAL OF THE LIBERTARIAN PARTY?

As its name suggests, the goal of the Libertarian Party is LIBERTY - not just for some, but freedom for everyone. The principles which guide the Libertarian Party are the same principles that sparked the American Revolution... that people have natural rights to life, liberty, and property, and that GOVERNMENTMUSTNEVER VIOLATE THESE RIGHTS.

To achieve liberty for everyone, we are becoming a nationwide political party of importance. We are already the third largest and fastest growing political party in America. In 1979, the Libertarian Party gained permanent ballot status in South Carolina and began challenging Republicans and Democrats, winning thousands of votes and presenting Libertarian solutions to present-day problems.

WHAT ARE THE PRINCIPLES OF THE SOUTH CAROLINA LIBERTARIAN PARTY?

First and foremost, we believe in PEOPLE! We believe that individuals and their families - not the government - know best how to solve their own problems and run their own lives. Libertarians recognize that each person has the absolute right of self-ownership over his/her own life, body, speech, action and honestly acquired property. The only proper way for people to deal with each other is by mutual respect for each other's rights of self-ownership. Anything that is peaceful, voluntary and honest violates no right and thus is not a proper subject for government intervention.

The right jto control one's own life and property includes the right to speak and write freely, the right to produce and trade and keep the fruits of one's labor, the right to travel freely, and the right to maintain privacy in matters of personal behavior, to name just a few examples. People should not be forced - by any individual or government - to sacrifice their lives or property for the benifit of others.

Government today seems to be run according to opposite principles. Individuals are treated as the property of the government and are prevented from acting according to their own judgement. Libertarians recognize that government's only proper function is to assist us in defending our right. The only proper laws are those which penalize such conduct as murder, rape, assault, vandalism, theft, arson, trespass and fraud, for such conduct necessarily violates someone's rights.

Libertarianism is the philosophy of the Declaration of Independence and the American Revolution. Most people, most of the time, deal with each other on the libertarian basis of mutual respect and cooperation. Two groups do not: criminals and government. Libertarians challenge the notion that government can rightfully control the rest of us through taxation, regulation, conscription, and penalties imposed upon peaceful, voluntary conduct. Government should be held to the same standard of respect for our rights that the rest of us follow.

WHY WAS THE LIBERTARIAN PARTY FORMED? CAN'T LIBERTARIAN POLICIES BE IMPLEMENTED THROUGH THE DEMOCRATIC AND REPUBLICAN PARTIES?

We believe that there is no longer much difference between the Democrat and Republican parties. Their bipartisan policies have CAUSED most of the problems that South Carolinians face today on both the state and national levels.

Government has simply grown too big and its policies have been disasterous. Inflation, taxation, unemployment and government spending have soared for years. Our government has supported foreign governments (many of them dictatorships) with American lives, materials, and money, while our own personal freedoms have been continuously taken away.

AT NO OTHER TIME IN HISTORY HAS THE AVERAGE CITIZEN BEEN SO TAXED, REGULATED, REGISTERED, LICENSED, NUMBERED, TOLD WHAT TO DO, AND TOLD WHAT NOT TO DO! More and more, elected officials are acting like public masters, rather than the public servants they are supposed to be.

Not only are Democrats and Republicans incapable of making changes - they actually do not want to ! They have both become willing partners with special interest groups of all kinds who seek favors in the halls of government offices.

The Libertarian Party was formed to change this situation. Libertarians seek to end the destructive policies of the Democrats and Republicans - not only because they are inefficient and wasteful, but also as a matter of principle.


We firmly believe that the best society is one in which our rights to life, liberty and property are free both from criminals AND government, that the government which governs LEAST governs BEST.

HOW DOES THE LIBERTARIAN PARTY INTEND TO IMPLEMENT ITS PRINCIPLES?

Libertarians are already at work putting their ideas into practice. In the state of Alaska, Libertarian State Representative Dick Randolph promised tax relief - and delivered it! His efforts on behalf of a statewide income tax repeal initiative pressed the legislature and governor into repealing all of Alaska's personal income taxes!

Libertarians are also leading the opposition to the draft, are involved in efforts to return government-owned land to private individuals, are urging the return to a free-market currency based on gold or silver, are promoting tuition tax credits and other alternatives to the government monopoly of education, and are advocating the decriminalization of victimless crimes such as bingo, paramutual betting, private sexual behavior, and the personal use of drugs. Libertarians feel that it is time once and for all to do away with South Carolina's "Blue Laws".

We believe that South Carolina should be a shining example of liberty, justice, peace, and prosperity for the rest of the nation and the world.





DISCRIMINATORY DRUNK DRIVING LEGISLATION

Robert 'Bob' Madden, congressional candidate in the 3rd District, has opposed the nationwide dringking age of 21. "Whose business is it what an adult wants to breathe or drink, what price he pays for it, or where he gets it?" asked Mr. Madden at a meeting of supporters in Westminister.

Each year 25,000 Americans die in alcohol-related traffic accidents. Of that number some 5000 are between the ages of sixteen and twenty-one.

Madden, who will challenge Democratic incumbent Mr. Butler Derrick, said the proposal to establish a nationwide drinking age infringes on citizens' privacy.

He accused anti-drinking groups of using drunk drivers, especially young drunk drivers, as scapegoats for their cause.

"If raising the drinking age to 21 is justified because it might save one life, why don't we raise the drinking age to 60 and save even more lives. We must realize that drunk driving and not youthful drinking is the true crime here. Prohabition proved that this nation will continue to drink, no matter what the sanctions, and that some people, even those over 21, will drive when they are drunk. As a society we should work toward elinination of the drunk as well as the drunk driver. As a nation we should be leary of politicans who so eaisly revolve around popular issues while sitting on fences."

THOMPSON CAMPAIGNS IN SIXTH

"Your vote is too valuable to waste it on a professional politician," Dr. Hugh Thompson, candidate for Congress in the 6th District told a social club of Darlington businessmen.

"A professional politician relies on party leaders and big-money contributors for the funds to run expensive elections campaigns, and these are the people he or she represents in Congress, not the voters. If you fall for the high pressure ad campaigns, you are wasting your vote, no matter whether your choice wins or not." he said. you vote for someone who will try to represent you, not a lot of special interest groups that give her/him lots of money, you are wasting your vote; win or lose."

"The fact that professional politicians are so beholden to special interest groups for money to run slick election campaigns is one of the main reasons the economy and the government are in such an awful mess," he declared. "They will try to let things get better from now to election day to try to reelect the incumbents, but after November, watch out!"

The Darlington
anesthesiologist declared
that they could tell that he


