Tuniewicz Seeks Region 6 Seat

Plans to focus on local campaigns

The following is a press release received from the Tuniewicz for LNC Committee.

Libertarian Party activist Mark A. Tuniewicz announced he will seek Region the Representative's seat on the Libertarian National Committee, representing New York and New Tuniewicz, England. former Director of Communications for the LP of Connecticut, first registered Libertarian as a Boston College student in 1979. In September of 1995, he moderated the only debate ever held between Harry Browne, Irwin Schiff and Rick Tompkins, the Party's three presidential hopefuls.

Said Tuniewicz: "Now more than ever, our state parties need the support of an active LNC member, one who can facilitate teamwork. If elected, I will focus my efforts on state party building and local campaigning--increasing our political base as the real alternative in American politics. At the same time, I will continue to work to build a broader consensus, fostering an inclusive and educational approach to

national Libertarian politics."

A lifelong resident of the northeast. Tuniewicz served as campaign consultant Connecticut candidates in the last with record-setting elections, "This past year results. Connecticut we fielded the largest number of candidates of any state, and finally have an Libertarian!" elected said Tuniewicz. "I have a vision that sharing strategies targeting our efforts at the state and local level, in a short time we can elect more Libertarians in every state in the region."

Reaction to the announced candidacy was swift and positive. "Without Mark, we wouldn't have stood a chance," noted Stanley Viens, top of the ticket of an 18-person Libertarian slate of candidates in Windham, Connecticut. "He spent many long hours with us. His coaching style kept us together and focused, but his political expertise got us energized and ultimately got results!"

LP of Connecticut Chair Carl Vassar was quick in his endorsement. "No offense to the incumbent, but Mark is the best possible choice for the LNC.

Letter to the Editor

LPNY. Unfortunately for neither joining (membership is more or less static at abysmally low level) nor voting Libertarian [voting for...exactly how many candidates did LPNY actually field in the last (or for that matter any) election?] seems to be effective. Why? Because the voting public doesn't know the LP exists let alone know what the LP stands for and how it benefits them both short and long term. And why doesn't the voting public know what the LP philosophy is? Because WE, collectively the LPNY, haven't told them!

From my observations and conversations, the LPNY, both local and state are very interested in fielding candidates and having the voting public give us their vote. Yet, as an organization, LPNY overlooks giving the voting public a reason to think and understand what the LP philosophy actually is and earn their vote. And until the voting public is exposed to the alternatives that the LP philosophy can bring and has time to mull over and digest the alternative ideas, and understands these ideas and ideals, they will not be convinced, and the result will be no votes for Libertarian candidates--few that they are--on sustainable level. Sure an individual LP candidate in an individual election can win, but the question is did the candidate win because of some unique aspect of the candidate her/himself or that particular election, or because of the public support of the LP, public support in the form of any kind of media coverage? My conclusions are that any LP candidates that do win, win in spite of the LP, not because of the LP. Furthermore, can that win be at all sustained? I think not.

Think for a minute. Somehow Libertarian candidate Bob Schulz gets elected Governor of NY. The State Legislature composed of the current mix of Repubs. Is the Dems and legislature going to go along with the Governor because he's a nice guy? I don't think so. Schulz would have been in solitary isolation, if it's possible to be doubly alone. Where is the Governor's support organization? More importantly, where is the grass roots philosophical support among the voting citizens, so the Governor can take his case to the people? There is none to be reckoned with, not to mention trying to buck the financed Dems and Repubs campaigns to bring their individual point of view to the people. To believe otherwise is to be delusional.

There is no organized grass roots suport among the voting citizens (at least not a difference that makes any difference) because traditionally the LPNY chooses to bypass, or believes it can circumvent or ignore this extremely essential foundation work and go straight for the gold ring prize--the election box. The LPNY apparently has done this

on a fairly regular basis since its inception. The results of this flawed logic are self-evident with the historical results achieved so far in membership over the years and also in the number, breadth and sustainability of candidates fielded and/or elected.

Mind you, I'm talking about LP candidates that are actually placed on the voting ballot on any and all levels of election, not nominated LP "conventions" from local district up through county and into state level and then basically "left out to dry" on their own. As I personally saw occur at a recent Sufflolk Chapter "convention" where a relatively full slate of town and county candidates were "nominated" as if candy were being disseminated among the and all were duly "seconded", and to the best of my knowledge not a nominated candidate received any support whatsoever and none ever made it to the ballot posting. So much about the shortcomings of the Repubs and Dems, and then all these candidates left out to dry. Keep in mind that there was zero political experience among the nominated candidates, no fincacial supportwhich is just as well because there was no support of any kind anyway. If ever there was an exercise in how not to do something or to learn how to fail at the political system try-outs, and as a result support the opposition, this was it!

It must tell and explain to the voting public--Joe and Johanna average public person--what the Libertarian philosophy is and the solutions that this philosophy can bring and how they will benefit, both short and long term and allow them time to mull over and digest these ideas and ideals until they understand and are convinced. The speed of the entire process is dependent on how well the LPNY gets its message out.

The methodology is much the same as marketing any new product in the marketplace. In simple terms, big companies allocate huge sums of money for advertising. saturation until consumer demand becomes selfsustaining. Lacking huge sums for a sustained advertising campaign, the next alternative is to take advantage of inexpensive, constant and consisent exposure, of which cable public access TV is one. There are other methods of exposure also. All are cheap, some are free. Until the average person understands the new product (Libertarianism), sales are going to be few and far between. The results will continue to be as they have been...at best.

Vermont LP Qualifies For 1996 Ballot

■ LP is well ahead of other minor parties in ballot access race

Vermont has become the 29th state to qualify for Libertarian ballot status in 1996. In mid-January the Vermont Secretary of State sent the Vermont LP a letter informing them that they had qualified for minor party status. This will enable them to

run a full slate of candidates in the upcoming elections.

The LP is far ahead of all other minor parties in gaining ballot access. Of the other minor parties, the U.S. Taxpayer's

Party is doing the best and they are on the

ballot in only six states so far. The Natural Law Party is on the ballot in five states. Ross Perot's Reform Party is on the ballot in only two states, but there are 11 other states in dispute.

"For Americans who want to vote for someone other than a Republican or Democrat in 1996, the Libertarian Party is shaping up as their best bet," said LP National Director Perry Willis.

To qualify, the Vermont LP had to hold organizational meetings in at least 10 towns. By

contrast, to qualify as a political party in New York, a party's candidate for Governor must get at least 50,000 votes. The closest that any LPNY Gubernatorial candidate has come to achieving this goal was Gary Johnson in 1990 who garnered almost 25,000 votes. In 1980, Ed Clark, the LP candidate for president, received over 52,000 votes in New York. In 1992, Norma

for

Segal, the LP candidate for U.S. Senator received over 108,000 votes. However, vote totals for president and U.S. Senator don't qualify a party for ballot status.

The other states in which the LP has already

qualified for ballot status in 1996 are: Alabama, Alaska, Arizona, California, Delaware, Georgia, Hawaii, Idaho, Illinois, Indiana, Kansas, Maryland, Massachusetts, Michigan, Mississippi, Missouri, Montana, Nevada, New Hampshire, New Mexico, North Dakota, Oregon, South Carolina, South Dakota, Texas, Utah, Wisconsin and Wyoming.

Four other states are very near completion: Colorado, Nebraska Oklahoma and West Virginia.
