Atheists challenge constitution in Arkansas

LITTLE ROCK, Ark. (UPI) -The American Atheists organization founded by Madalyn Murray O'Hair filed suit Tuesday challenging a requirement in the Arkansas constitution that all officeholders and court witnesses believe in God.

Naming Gov. Frank White and President Reagan among the defendants, the suit asked that all federal funds to Arkansas be stopped because they are being used to run agencies and departments "founded on patently void and illegal religious discrimination.'

"Even if the concept of God could be clearly defined, a state could not inquire into the beliefs of its citizens in that regard," the suit said. "Freedom to believe as well as not believe in 'God' is absolute."

Article 19, Section 1 of the Arkansas Constitution states: "No person who denies the being of God shall hold any office in the civil depart-ments of this state nor be competent to testify as a witness in any court."

Only Arkansas, Texas, Mississippi and South Carolina still require public officials to believe in God and only Arkansas requires it of witnesses in court, Mrs. O'Hair said. Arkansas also was the last state to arrest anyone for claiming to be an atheist, jailing a Hot Springs man in 1920, she said.

American Atheists, based in Austin, Texas, won a suit in North Carolina to remove a religious requirement from the constitution and has a case pending against the state of Texas.

Man sentenced on tax charge

CHARLESTON - A former Charleston Baseball Club Inc. president, Raymond G. Blomquist, has been sentenced to six months in prison in connection with failing to file federal

quarterly employment tax returns.
According to U.S. Attorney Henry Dargan
McMaster, Blomquist, 50, was charged in April 1976 with failing to file the returns for the second and third quarters of 1973 while he was club

An investigation by the Internal Revenue Service revealed total taxes of more than \$20,000 that were neither reported nor paid.

Blue laws under fire in House

COLUMBIA (AP) - Despite Bible thumping and religious professions by several state representatives, the House tentatively approved a measure Wednes-day to repeal many of the state's blue

Lawmakers voted 62-36 in favor of the bill, which allows more than three employees to work in grocery stores, permits athletic events, entertainment events, arts and crafts shows and funerals on Sundays.

The bill also allows the sale of educational supplies, cameras, film, flash bulbs, batteries, baby supplies, hosiery and undergarments, all of which are currently banned for Sunday sales.

Rep. Lloyd Hendricks, chief sponsor of the bill, said the measure would allow athletic events like the Heritage Golf Tournament and other professional sporting events on Sundays if promoters obtain local permits.

The measure marks the first time since 1962 that the blue laws have been weakened. The laws, which ban specified activities and the sale of certain items on Sundays, date back to 1691 when South Carolina was under British rule.

Denunciations

The bill drew strong religious denunciations by several members, including Rep. Rick Rigdon, R-Greenville.

"What we are going today is wrong — it's against Scripture," Rigdon said. "We are in violation of the word of God and we are going to live to regret it."

But Rep. Bob Sheheen, D-Kershaw, disagreed.

"I am as strong a Christian as anyone in this body," Sheheen said, "but I don't think we should sell the blue laws to the citizens on that basis. They haven't been upheld in the courts on that basis.'

Sheheen said lawmakers not only represent Christians but also people of other faiths who observe the sabbath on days other than Sunday.

Rep. William Branton Jr., D-Dorchester, urged the House to strengthen instead of weaken the blue laws and ban all activities and sales on Sundays.

Branton waved a Bible and read from it, quoting the Ten Commandments' call to observe the sabbath as a day of rest.

Rep. B.L. Hendricks, D-Pickens, said, "The financial loss (from store closings) we will take will be far less than the blessing we will receive if we follow the Bible.1

Government may regulate hang gliders

The free-floating freedom of hang gliding may be grounded a bit in the future by the heavy hand of the federal government.

The Federal Aviation Administration Thursday proposed rules to regulate the growing numbers of hang gliders and so-called ultralight aircraft.

Under the FAA proposals, hang gliders and ultralights under 155 pounds will be subject to certain operational requirements such as visual flight rule criteria, which would have the effect of prohibiting flights in marginal weather. Night flights also would be banned.

RETIREMENT PLANS IN TROUBLE

"No man's life, liberty, or property are safe while the legislature is in session," said South Carolina Libertarian Party chairman Tom Waldenfels of Landrum, "but is is unusual for Congress to attack all three in one act, as they have in forbidding hard asset retirement investments." Waldenfels said the provision in the tax reform act just passed would "deprive most American citizens of the right to provide for their old age by investing their money in assets that would have some protection for them against the inflation that the government is causing." Waldenfels traveled to Washington with the National Committee for Monitary Reform in August "to petition for redress of grievances."

"Either Congress did not know what it was doing," said Waldenfels, an investment counsellor, "or it is trying to reduce older Americans to a state of complete dependency on government handouts by confiscating their savings through high taxes or inflation, as it has been doing for

almost 50 years." While the Libertarian Party favors tax cuts, he added, "the present act has several other things seriously wrong with it; the tax cuts are far too small, and there is no requirement for reducing waste and extravagance in federal spending to ballance the federal budget." Provisions of the tax cut act forbid investing in pension funds, such as IRA's, in art works, gold & silver coins, diamonds, or alcoholic beverages after the end of 1981, and allow the government to extend the list to include other types of tangible per-

Ron Holland, president of Retirement Consultants, Inc., of Taylors, S.C., called provisions of the act "taking away the right of the individual to chose how to invest his own retire-ment funds." He added, "This is the same type of controls that Germany had before World War II. This matter is totally unrelated to plans to reduce taxes, and is a piece of special interest legislation to favor other types of investments by the cruel means of depriving citizens of control of their savings decisions."

Statement of Principles

We, the members of the Libertarian Party, challenge the cult of the omnipotent state and defend the rights of the individual.

We hold that all individuals have the right to exercise sole dominion over their own lives, and have the right to live in whatever manner they choose, so long as they do not forcibly interfere with the equal right of others to live in whatever manner they choose.

Governments throughout history have regularly operated on the opposite principle, that the State has the right to dispose of the lives of individuals and the fruits of their labor. Even within the United States, all political parties other than our own grant to government the right to regulate the lives of individuals and seize the fruits of their labor without their consent.

We, on the contrary, deny the right of any government to do these things, and hold that where governments exist, they must not violate the rights of any individual; namely, (1) the right to life - accordingly we support prohibition of the initiation of physical force against others; (2) the right to liberty of speech and action accordingly we oppose all attempts by government to abridge the freedom of speech and press, as well as government censorship in any form; and (3) the right to property - accordingly we oppose all government interference with private property, such as confiscation, nationalization, and eminent domain, and support the prohibition of robbery, trespass, fraud, and misrepresentation.

Since governments, when instituted, must not violate individual rights, we oppose all interference by government in the areas of voluntary and contractual relations among individuals. People should not be forced to sacrifice their lives and property for the benefit of others. They should be left free by government to deal with one another as free traders, and the resultant economic system, the only one compatible with the protection of individual rights, is the free market.
