### GARDINER ANNOUNCES CANDIDACY

Richard Gardiner, a former Libertarian candidate for the Arlington County Board, has announced that he is running for the Virginia Senate seat representing south and central Arlington. He will be opposed by a local Republican activist, as well as the incumbent, a two-term Democrat.

Gardiner intends to run as an Independent/Libertarian so that the voters of Arlington will again be exposed to Libertarian ideals and solutions and will again have a real choice when they go to the polls in November. In last year's County Board election, the first election in Virginia in which a Libertarian has run, Gardiner received about 3 % of the vote.

This year, Gardiner forsees several areas from which the campaign's issues will arise. Included are transportation (Washington's new Metro rail and bus system continues to lose money by the millions of dollars), education (the ever-rising costs and declining successes of the public school system continue to plague us), and taxation (an increasing burden in support of unnecessary and wasteful government programs). Other issues which may come up are: decriminalization of marijuana, zoning, gun control, and energy. His campaign slogan will be: "Freedom: An Ideal and a Solution."

Gardiner has appointed Warren Zeger of Springfield, Virginia, as his campaign manager and Cindy Ingham of Arlington as his campaign treasurer. Both are long-time supporters of the Libertarian movement. Marguerite Wagner will be responsible for the design and production of Gardiner's campaign literature.

Gardiner is presently employed by the Office of the General Counsel of the National Rifle Association where he has worked since his graduation from law school last fall.

### SUPPORT THE MOVEMENT

Richard Gardiner is one of a handful of libertarian candidiates running for a state legislature this year, and the only libertarian candidate running for a state legislature in the National Capital area. If he can make a strong showing this fall, the leaders of the federal government will know about it. The Gardiner for State Senate Committee, therefore, is looking to all libertarians nationwide to contribute to Gardiner's campaign so that this impact can be as great as possible.

Don't forget that under federal tax law for every two dollars you give to a candidate, you can take a credit of one dollar (up to \$50, or \$100 on a joint return) on your federal income tax return. That means that if you contribute \$100 to Gardiner's campaign, it only costs you \$50. And wouldn't you rather give \$50 to an experienced libertarian candidate than to Uncle Sam? (Corporate contributions are legal in Virginia)

### EDITORIAL REPLY BOARD ORGANIZED

The Virginia Party has set up an Editorial Reply Board for the Washington, D.C./Northern area which Warren Zeger will chair. The primary function of the Board, will be to monitor newspaper, television and radio editorials and to prepare for timely submission to the media editorial replies on issues of major interest to libertarians. The Board will also familiarize itself with the public affairs programming policies of television and radio stations with a view towards making use of existing opportunities, and expanding future opportunities, for the presentation of libertarian positions over broadcast outlets.

In order to attract media attention and maximize the liklihood of recogniton by the media, the Board will style itself as the "Political Policy Bureau of the Virginia Libertarian Party" or some such equally imposing name. Any suggestions on this should be forwarded to Warren Zeger.

The scope of the Board's work will depend largely on developing a corps of activists who are prepared to devote time and effort to the Board's activities. Those interested in participating should contact Warren Zeger at:
