LPVA CONVENTION

The LPVA 1998 convention was a huge success. The business was conducted in a timely manner. Delegates were selected for the National Convention, and officers were re-elected. And, the 58 attendees were rewarded with a stimulating and diverse range of speakers.

After Chairman Johansen opened the convention, Bill Winters led off with a tongue in cheek talk on "rules for LP failure." His satiric speech drove home the points of what the LP needs to do become an electoral success. In the most concise terms it was a call for action and cooperation. The audience joined in during the Q & A to suggest other ways we've discovered

how to fail." This light hearted but substantive presentation was followed by a panel discussing the future of the LP. The panel consisted of nationally known figures and was facilitated with charm by Lawrence Gasman (Cato). The panel included Jim Lark (SIL), Michael Lynch (Reason), Perry Willis (LP National), and Bill Redpath (National Ballot Access). Their vision overlapped sufficiently to establish a harmonious and unifying vision for the LPVA, but was sufficiently diverse to provide an intellectually stimulating session. It couldn't have been better even if it had been scripted.

The first panelist, Jim Lark (SIL) led off with an upbeat appraisal of liberty and student activity. It should also be noted that the success of this convention is to his credit. Michael Lynch made what was the most amusing point of the session. He pointed out that now that the feds are regulating the size of toilet tanks resulting in a black market for the previously larger reservoirs), that "it is not enough to demand the government stay out of our bedrooms, but we must also insist they stay out of our bathrooms." Perry Willis was clearly the most upbeat and optimistic as he described the early progress of the Archimedes Project. Bill Redpath shared his experiences and reflected on the need to make fundamental changes to the electoral process. He also pointed out that Virginia is one of the few remaining states to have never run a statewide LP candidate. James Bovard gave the luncheon talk, which was filled with anecdotes of government folly and fiasco. As he does so well, he presented humorous and numerous examples all the while building an underlying current of foreboding. One walks away from his presentations tickled with amusement, but distinctly unsettled at the statist trend. The business meeting went smoothly. In addition to the selection of delegates and officers there was discus-

LIBERTARIAN QUAKERS

Two years ago, I managed Reams for Congress. One of the first things that Gary Reams told me about himself as hat he was a Quaker. Coincidentally, one of the members of Gary's Quaker meeting was also a Libertarian Party member. Later that year, Gary and I met two other Libertarian Quakers. Quakers are only slightly more numerous than Libertarians, yet they seemed to be everywhere. Recently, at a meeting of the Farlandria LP, I mentioned the relative abundance of Quakers in the LP, and one of the people in room said, "I used to be a Quaker."

I then sent a message on the topic to the 86 subscribers of the LPVA list server. I received one response from a Quaker and three from people with some peripheral association with them. At lunch during the LPVA convention, I mentioned this subject, and one of the other eight people at my table declared himself to be Quaker. The evidence that I have indicates that Libertarians may be twenty to 200 times more numerous among Quakers than among the general population. Obviously, Quakers may be a group from which the LP should be recruiting.

The Quakers are properly known as the Religious Society of Friends, but they are tolerant people who answer to Quaker, and even use the term themselves. Gary Reams describes them as Christian anarchists who believe that if something is right, then it doesn't matter that achieving it may be difficult to the point of near impossibility; working for it is the only thing that counts. They were leaders in the abolitionist and women's suffrage movements, and are influential beyond their numbers. Since many are pacifists, they should find the Libertarian non-interventionist foreign policy appealing. Quakers are often involved in community affairs and are politically active. Though they tend to be left-liberal, they clearly share some cultural similarities with Libertarians. Given their pacifist tendencies, those among them who recognize that government is force would, undoubtedly, find the LP appealing, apparently, many have already joined the LP. If you are Quaker or attend a Quaker meeting, Gary and I would like to meet you and discuss how the Libertarians and Quakers can work together for a noncoercive government. HAMPTON CITY COUNCIL ELECTION

Long time Libertarian Party member Sanford Pankin concluded his campaign for Hampton City Council on May 2. Turnout was very low (about 20%); the winning vote-getter received fewer votes this year than the third-place candidate in '96. Pollsters have indicated voters in this election tended to be over sixty years of age and black. Hampton is very heavily Democrat.

Pankin says there weren't any "deciding issues", although he tried to introduce a few, such as repealing taxes, and rolling back Council salaries. Pankin felt he did achieve name recognition, and also says he ran the best possible race he could run. He believes organizing a larger team of volunteers is most important for future wins.

Mr. Pankin says he raised over \$3,000 in cash donations and the rest was in-kind donations. Pankin would like to thank everyone who donated to and volunteered for his campaign. Many thanks go to Johna Gagnon for coordinating the rally and thanks go also to Gary Alexander and Seth Allen for joining me in support of Johna's efforts. Though the media were busy covering some other protests in the area (there was a biggie in Arlington) and did not cover ours, we had a lot of fun handing out the "Instant Million Dollar Tax Refund, and chatting with the folks. The crowd was heavily in our favor. Only once did I hear "It is a privilege to pay taxes". Twas all I could do to prevent myself from laughing. Privilege? Try declining the privilege sometime and see how much of a privilege it is! But most people took the lit with a smile, and many even asked for more for their friends.

(Charlottsville) James Lark reports on the Jefferson Area Libertarians protest. Last night the J.A.L. held its first annual Tax Protest at the main Charlottesville post office. It is my great pleasure to report that our effort was successful. We distributed a great deal of literature, chatted with many well-wishers, found some prospects, and were seen by hundreds of our neighbors. In addition, we should receive press coverage from WINA radio, the C'Ville Weekly, and (perhaps) WVIR TV. This coverage will come in addition to the publicity we received as a result of the press release I sent to all local media on Monday. WINA gave substantial mention to our protest on Tuesday, based on the press release. Interestingly, as far as I can tell, only one person said anything about us that was derogatory. Greg Cunningham and I were displaying signs for the view of motorists entering the post office parking lot. My sign read "Repeal the Income Tax," and provided the (800) number for the L.P.; Greg's sign proclaimed, "I.R.S. = It Really Steals." A lady shouted at us that "this is a great country, and that you should be ashamed of yourselves." Despite enormous temptation, Greg and I were able to resist the urge to deploy our sardonic wits in response. I wish to thank Greg Cunningham, James Curtis, Becky Kirk, Gerhard Schoenthal, and Gary Westmoreland for their fine work at the protest. In particular, the J.A.L. should recognize the contribution of Mr. Westmoreland, who at his own expense rented a Revolutionary War-era costume and sought to portray Patrick Henry. He was very effective in his effort.

(Prince William County) Phil Hodson reports the Prince William County LP held it's second annual Tax-Day Protest yesterday. Though small, LPPWC is quite active, and this year we expanded to cover two post offices within the county. I have a report that at the Woodbridge post office the postmaster asked us to leave. We are preparing a letter to the Postmaster General with copies to go to the Woodbridge postmaster, Congressman Davis, and whomever else seems appropriate. Perhaps we shall attach a copy of the First Amendment so that hey can actually read it. Since parking at Woodbridge was limited, there were ample opportunities to speak to people in an adjacent parking lot being used by late filers, and our members were undeterred in their First Amendment right to peacefully assemble. They reported favorable reception by the public, if not by the state. The problem may have been caused by handing materials to people entering, rather than to those leaving, the post office. In addition to defending our rights, we will take it as a lesson, and next year we will remind our members to "do the outies." In Manassas we were well received and had both the pedestrian exit and the drive-through covered.

Doug Bandow, and Jacob Sullum. These events garnered substantial publicity in the community, particularly Ms. Davis speech concerning the I.R.S. Also, videotapes of the speakers will be shown on local cable-access TV. Jamie Plummer, president of the Classical Liberal Roundtable, wrote a weekly column for The Cavalier Daily. Mr. Plummer will graduate in May. Law Students for Individual Liberty were not as active as anticipated. Scott Matthews, president of LSIL, is planning several activities for next year. 1) We've just completed a very successful petition drive for this year's 10th District Congressional candidate, Robert Buchanan. To put things in perspective, in 1994, just 3 people conducted most of the drive to get Bob Rilee on the ballot (mostly the candidate himself!). In 1996, we doubled that to 6 key participants getting Gary Reams on. But in 1998, we more than quadrupled: 27 people participated in the ballot drive! Approximately 3,150 raw signatures have been turned into the State Board of Elections for validation. My sincere thanks and congratulations to all of these energetic volunteers: Gary Brown, Robert Buchanan, John Buckley, Irene Carpenter, Ron Crickenberger, David Hales, James Haworth, Chris Hindman, Philip Hodson, Jacob Hornberger, Dana Johansen, Bill Lawry, Max Leonard, Chris Levine, Mike McPadden, Joe Ogulin, Bill Redpath, Gary Reams, Mark Rorabaugh, Bob Snapp, Pat Snider, Shelley Tamres, Clifford Theis, Pete Thomas, Mary Watkins, Ryan Whelan, Rita Wood.

Such widespread participation in the petition drive for Robert bodes well for the future. The 2000 Presidential election is just around the corner. And a U.S. Senate seat will be open that year as well. Virginia has never gotten its own statewide candidate on the ballot. LP National has been forced to pay for a petition drive every four years for our presidential candidates. And we have never run a statewide candidate other than for president. Thanks to your lobbying efforts this past year, signature requirements for statewide candidates have been substantially reduced. I'd like to make 2000 the year that we get our presidential candi-

year that we run our first Senate candidate in Virginia. 2) We still have 2 election law bills before the General Assembly. HB 47 introduces the concept of a party petition (one petition for multiple candidates). HB 48 reduces the retention amount for party recognition from 10% to 5% of a statewide vote. I need your help to contact your representatives and ask them to support these bills! Write them. Speak out at public hearings that they hold for citizen input. Between now and January, we need to round up a sufficient number of "ves" votes to get these bills out of committee. I particularly need your help if you live in the Districts of any of the committee members: Armstrong-H11, Behm-H91, Cox-H66. 3) The petitioning deadline in Virginia for presidential candidates is late August, but the deadline for other statewide candidates is early June. An independent candidate filed a lawsuit over this. The US District court ruled in his favor. But the State appealed and the Circuit Court voided the decision and sent it back for trial. The lawyer in the case is working pro bono, but would like to be reimbursed for expenses. I am collecting contributions for the cause. An extension to the petitioning deadline would greatly assist us for getting a US Senate candidate on the ballot in 2000. It would allow us to petition at the many fairs and events that take place over he summer months and also would allow us to double petition for president and senate at the same time, which is a great savings in time and effort.
