# **Brown Seeks Senate Seat**

LP activist challenges Boxer



eteran Libertarian Party activist Ted Brown will seek the Libertarian nomination for U.S. Senate in 1998. The incumbent is liberal Democrat Barbara Boxer. At this time, there is no clear Republican front-runner.

Brown, 37, is an insurance claims adjuster from San Gabriel. He is a former state chair of the LPC and former chair of the Libertarian Party of Los Angeles County (LPLAC). Brown's prior statewide races for Insurance Commissioner in 1990 and 1994 drew 433.000 and 345,000 votes respectively, making

alternative party candidates for any office in the last generation.


Brown also writes the LPC's ballot arguments against bond measures in the ballot pamphlet each election, making him one of the better known Libertarians in California. Voter agreement with many of these arguments has saved taxpayers over \$5.3 billion in principal and interest on the bonds.

"Boxer is an extreme supporter of big government," said Brown, "and the Republicans have proved they have no intention of cutting government. That's why we need a Libertarian in the U.S. Senate."

Brown's main issues will be ending the drug war, repealing the federal income tax, bringing our troops home from overseas, and eliminating all government agencies not allowed by the Constitution.


## **Art of Socialism**



is a graduate of Stanford

and works as a computer programmer. He became Libertarian in 1988 when, as he puts it, "I found my political home." He has run for partisan offices on four previous occasions. In 1998, he intends to focus on three central points:

local control ("Those who best know a situation are best suited to deal with it);

sunsets on laws ("We need to review laws to ensure that their results are the ones intended and, if not, discard the law."); and the elimination of waste in government. The father of six children, Petersen lives with his wife Marianne in San Jose.

Joseph Farina, a Sacramento defense attorney specializing in criminal cases, will run for Attorney General. A former chair of the Sacramento LP,

> Farina ran for the 10th Assembly District in 1992. Sacramento Libertarians are familiar with Farina as a regular panelist on the long-running cable TV show, "The Libertarian Gang." As a candidate, he intends to focus on such controversial issues as medical marijuana, Indian gaming and tobac-

co litigation. Farina says he has been a philosophical libertarian since 1978,

when he served in the U.S. Army, and became an active member of Region 34 when he moved to Sacramento. He lives with his wife Ann and their eight year old son Anthony.

Jesse Baird, a 27 year old claims adjuster from Stockton, will seek the position of Insur-

ance Commissioner. The LPC platform calls for the abolition of this office — a position with which Baird is in full accord: "Life involves risk," says the candidate, which individuals should be free to take or avoid -

From The Chair:

# **Full Speed Ahead**

his is my fourth column as Chair of the Party. And this is my fourth reminder that we, as a Party, have 3 main goals this year:



- 1. Increase our dues-paying membership to 5,000.
- 2. Raise \$150,000 in revenues.
- 3. Hire at least one paid employee, working in an office.

Last month I told you that LPC Membership Chair Pat Wright was preparing a membership recruitment letter. That letter is now in the mail to 5,000 former dues-paying LP members, and we're hoping for a very good response. Traditionally, this has been a very good prospect list, and we're hoping that the increased benefits provided by our combined membership plan will produce better than average results. We should have a complete report in the next issue of this newsletter.

I've also learned that the national LP organization is currently mailing membership solicitations to nearly 140,000 names, using lists from *Reason* magazine, Laissez Faire Books and other sources. We trust that a significant number of the new members generated by this effort will reside in California. So expect a nice jump in our membership!

Last month, I reported that our fundraising efforts had brought in over \$16,000. That figure is now over \$24,000. We're averaging over \$8,000 in donations per month! If you keep this up, we will definitely reach our \$150,000 revenue goal for 1997. Thanks!

By the time you read this, the third meeting of the LPC Executive Committee (on June 14th in Los Angeles) will be history. Based on your support so far, I'm going to ask the Committee to authorize budget changes to allow me to

hire an employee. If they agree, I'll start the process to find the right candidate for the job. As I mentioned last month, I'm also making arrangements for the LPC to share the offices of the Santa Clara LP (R43). That's still on track.

This month I'm very pleased to say that veteran activists Barbara Goushaw and Michael Cloud have agreed to donate their time and talent to address a major concern of the LPC's local regions: fundraising. Under the membership unification plan, your dues are split three ways — between the regional, state and national parties. That means we all need to make effective fundraising efforts to produce enough money to go around.

Barbara Goushaw was the Fundraising Chair for Jon Coon's recent Senatorial race in Illinois. Michael Cloud has done fundraising for the Harry Browne for President campaign and now works for the LPC. Both will host two upcoming fundraising seminars sponsored by the LPC and designed to support our local regions. (See related article on page 3.)

The regional, state and national Libertarian parties are like a three-legged stool: if any leg is wobbly or missing, the stool won't stand. All three legs need to be strong and healthy. Both the national and California parties are financially sound, and it's my hope that these seminars will provide local activists and candidates with the training they need to build strong local parties and wage effective campaigns.

Speaking of candidates, I'm delighted with the level of interest from Libertarians seeking the party's nominations for statewide offices in 1998. I can't remember the last time we had so many people interested in playing this early in the game.


So, we continue to proceed toward reaching our goals. If you'll continue to support us with donations and monthly pledges, we'll all make progress towards achieving true liberty.



ments did a lot to radicalize me during





presidential candidate Ron Paul but has not commented on his politics since.





# Libertarians Support Talk Radio Host

Southland Libertarians rally behind controversial personality

he Libertarian Party of the San Fernando Valley (R61) has declared its support of Los Angeles' KABC-790 radio talk show host Larry Elder.

Elder, an African American whose talk

show is heard by millions weekdays from 3:00-7:00 p.m., is under fire for his political beliefs. Elder is described by many as conservative, but he has repeatedly called himself a libertarian, and he has often expressed support for the Libertarian Party and its positions.

But what has gotten Elder in hot water are his beliefs that white racism is not the most serious problem facing the black community, that affirmative action preferences are wrong, and that O.J. Simpson committed the murders of which he was acquitted in 1995. As a result of these views, a coalition called The Talking Drum Community Forum has taken it upon itself to get Elder thrown off the air.

"This is a clear case of First Amendment rights," said Kit Maira, Chair of Region 61. "Larry Elder despite what you may think of his opinions - has as much right as anyone to speak. If you don't like what he says, the solution is easy: just turn the dial."

According to the L.A. Daily News, Elder's opponents have resorted to intimidating and threatening his advertisers in the hopes of getting sponsors to pull out of Elder's show. While Elder's opponents certainly have a First Amendment right to be vocal, "They cross the line when they

use coercive and aggressive methods to terrorize businesspeople who advertise on Elder's show," said Maira. "Those kinds of tactics are malicious and wrong, and they merely serve to emphasize what a valuable role Elder is playing in the community if he can get a small group of intolerant scaremongers to go to such lengths against him."

The management at KABC is standing by Elder, and his ratings are strong. But that's no reason to let one's guard down, warns Maira. "Thomas Jefferson said, 'Eternal vigilance is the price of liberty.' We must always be on the lookout for those who would rob us of our basic liberities. Free speech is a cherished liberty in this country, and anyone who cares about free speech should care about what happens to Larry Elder."





# **Ending the War Between the Sexes**

The Myth of Male Power by Warren Farrell, Ph.D Berkley Books (softcover) \$13.00

ccasionally, when I'm lucky, I stumble across a book that changes the way I view the world. I had that pleasure recently when I devoured *The Myth of Male Power* by Warren Farrell, Ph.D.

First published in 1993, *The Myth of Male Power* springs from a growing movement that seeks to redress misconceptions about men and women advanced, in part, by feminism. The author, a former feminist crusader, wrote it after radically rethinking his views on gender roles.

The Myth of Male Power is a devastating rebuttal to feminist attacks on men, but it is not a masculinist version of books like Good Women Who Love Men Who Deserve to Burn in Hell Forever. On the contrary, in addition to its powerful reasoning and original insights, what is remarkable about this work is its author's extraordinary compassion — for both sexes: Farrell doesn't try to reassign the blame for gender disharmony from one sex to the other, further dividing them; instead, his goal is to deepen the understanding between men and women and thus bring them together. The end result is a fascinating, often moving read.

Although Farrell writes in an accessible and entertaining style, it is impossible to do justice to his central points here, let alone convey the persuasiveness of his arguments. That said, I'll try anyway...

As Farrell sees it, men and women are currently in a period of transition between two sets of gender roles, which he defines as Stage 1 ("survival focused") and Stage 2 ("spiritually focused"). For centuries, most men and women inhabited Stage 1 gender roles: women raised the children while men provided for and protected them. Recently, technology has enabled men and women to meet their survival needs more easily and thus freed them to seek other values, like personal fulfillment, in Stage 2 gender roles.

Unfortunately, current circumstances have provided most women with Stage 1 benefits (protection and provision) and Stage 2 benefits (lifestyle options) without requiring them to bear Stage 1 responsibilities (working in the home) or Stage 2 responsibilities (providing for and protecting men). Most men, on the other hand, have lost their Stage 1 benefits (like having a stay-at-home wife) while continuing to bear Stage 1 responsibilities (providing the lion's share of his family's protection and financial support). Most men are also rarely able to enjoy Stage 2 benefits (the option of being supported by a wife), while they are still expected to fulfill Stage 2 responsibilities (being emotionally vulnerable).

In short, women have more options than men — and often more power.

According to Farrell, this adds up to a bad deal for both sexes. Women suffer the loss of self-esteem inherent in being a member of the "protected class;" they are also deprived of experiencing intimacy with their mates, who are encouraged to suppress their vulnerability in order to maximize their effectiveness as protector-providers. For their part, men often find themselves shouldering the traditional responsibilities of protector-providers without receiving the traditional benefits; in addition, they are rarely able to fully

fulfill their emotional needs or pursue non-traditional male roles (such as "house husband") because most women still prefer "strong, powerful" men who will take care of them.

Farrell also demonstrates how men, far from oppressing women, are devoted to protecting and providing for women in both the home and workplace — often at their own expense. To make his case, the author uses statistical evidence (supported by 52 pages of footnotes) to correct a multitude of popular misconceptions about the ways men and woman interact — facts that hit like bombshells.

Both disturbing and uplifting, *The Myth of Male Power* challenges men and women to rethink their ideas about themselves and each other — and offers them hope of finding richer, fuller, more satisfying ways of being and sharing.

Libertarians will take exception to some of the author's positions: occasionally he advocates more government actions to resolve government-created problems. Nevertheless, Farrell possesses a clear understanding of the relationship between rights and responsibilities, which libertarians will applaud, and his insights about men and women are relevant to everyone.

Again, it is impossible for me to convey the full value of this book here — and I may have even done its author a disservice by trying. So judge for yourself. I found reading *The Myth of Male Power* to be an immensely rewarding experience — and I believe you will too.

When I started gathering the animals, I got sued by an animal rights group. And the EPA notified me that I had to file an environmental impact statement on your proposed flood.


