## Libertarians Elect National Officers in Anaheim:

# Harry Browne & Art Olivier for President & Veep

More than 1,100 delegates and attendees met for the LP National Convention in Anaheim on June 30 to July 3. The Libertarian Party elected president and vice president nominees plus a new national chairman. The delegates also selected other national committee members including regional representatives and made changes to the party platform.

### Media Coverage:

- Potential audience of millions watched two days of gavel-to-gavel coverage on C-SPAN.
- Seven talk-show hosts broadcasted live from the convention.
- Fox TV, the Fox News Channel, KABC-TV, KNBC-TV, Orange County News, and KCAL-TV covered the Convention.
- *The Los Angeles Times*, *Worth*, *Maxim*, the *Orange County Register*, and *The Christian Science Monitor*, Associated Press and Reuters sent reporters.

### Platform Changes:

Delegates removed a section from the “Women’s Rights and Abortion” plank that listed specific laws and policies the party opposed, while keeping the statement that government should be kept out of the question [of abortion].

Delegates also voted to make additions to the War on Drugs plank, specifically condemning police profiling policies and civil asset forfeiture,

and describing Drug Prohibition as “a war on the American people.”

Delegates voted to add language to the platform specifically opposing “hate crime” legislation.

A new “Family and Children’s Rights” plank was added (replacing the “Family Life” plank), which explains the Libertarian perspective that families have a right to raise their children without government interference. The new plank underscores the notion that children have rights, and deserve to be treated with justice — while also delineating the rights and responsibilities of parents.

## LETTERS TO THE EDITOR

### 38: MEDICARE FOR PRIVATE SCHOOLS?

Some Libertarian advocates of this measure claim that Prop 38 "will result in a reduction in the tax burden caused by government-run public schools because per-pupil government expenditures are greater than the voucher amount."

Their claim fails to consider the implications of

- (1) additional spending for current private school students,
- (2) "fully fund[ing] the demand for programs offered by the community colleges",
- (3) changing the funding formula for all K-12 students, and
- (4) giving the power to interpret that formula to the Director of the Department of Finance.

Please read the text of the measure and draw your own conclusion.

Even if the theoretical savings were possible, the advertised application of that savings to tax reduction is pure fantasy. The state would experience the increased spending for the vouchers (potentially raising income taxes to pay for them), but it would be up to the counties and school districts to realize the implied "savings" by firing employees and closing public schools. Then, yes, in theory they could "reduc[e] the tax burden" by issuing property tax rebates (of the money they formerly spent on schools) or by lowering property tax rates. That scenario doesn't sound very likely, does it?

Would vouchers benefit private education? Like Prop 38, Medicare was once touted to save money and enhance private health care using similar arguments. Has medical care gotten cheaper—or more expensive? Has government involvement in health care decreased—or increased—since taxpayers started

## OPINION

### From the Chair:

We, as a Party, set two main internal goals this year:

1. Increase our dues-paying membership to 7,000
2. Increase our monthly pledge base to \$6,000 per month.

**Goal 1:** The July 31st membership statistics are NOT good. Our national membership figure now stands at 6138. This is a one-month drop of 235 dues paying members. However, Operation Breakthrough may wipe out that dip. We are submitting new donor names, \$25 or more donated, for membership. Over 500 contributed, but we need to sort out the current paid members from that list. I'll report next month if we're back on track.

**Goal 2:** The new monthly pledge total is being computed and will be reported in the next newsletter. Our new pledgers will be acknowledged in our next printed issue (October).

The National Convention was in Anaheim. I've been attending LP conventions since 1975 and this was the most professionally

run event ever. We selected candidates, revised the party platform and had the opportunity to meet Libertarians from all over the nation.

LPC has endorsed the goal of running 200 candidates in 2000: Operation Breakthrough is in full swing. See Juan Ros's notes on page 6. I'm confident that when the deadline is upon us, we'll have reached our goal (200) and stretched beyond it, nearly doubling our best previous year for the total number of candidates running.

### Money is running short. Isn't it always?

With a new office, new part-time helper, and the expenses of Operation Breakthrough, we have reluctantly had to make some severe cutbacks in the publication of this newsletter. Our revised schedule is printed issues for October and December - all other issues through November will be available online only.



*Libertarians (the New American Patriots) Work to Reinstitute a Constitutional Government*

### **The Libertarian National Convention, June 27- July 3, 2000 • by Jerry Krim**

Author Jerry Krim is a free-lance writer for MEDIA BYPASS. He notes: *I was amazed at the purpose and somber approach the delegates displayed. I saw (maybe) six bottles of beer and zero drunks throughout the complete convention. This is, in my mind, a record for convention attendees and I've been to several hundred. Every delegate I spoke with gave me candid and honest dialogue. The concepts of choice, honesty, truthfulness and responsibility were intact within everyone to whom I spoke. Brother Jim Lorenz, Utah Chair (Emeritus), gave me a Libertarian ball cap which I proudly wore throughout the convention.*

**I**t was a somber sunny day at the town hall when the citizens assembled to discuss the cruel abuses of the distant government under which they lived. The attendees were men of means and intellect, true and honest in their principles, leaders of their communities and had pledged their lives, their property and their *sacred honor* to the task of choosing a lawful government for themselves and their friends. In the final end to this saga, these fifty-six fine-minded men were persecuted, jailed and tortured, and eventually lost their families, their farms and properties, *and* their lives. These were the men who had eventually signed the Declaration of Independence, the *organic* document that formed this great nation.

For five days a similar group met in Anaheim, California, to discuss these same principles, these same complaints and the simple facts that government was again abusing the People whom had given it only *limited* powers to represent them. The Libertarian National Convention was a meeting of men and women who know the *principles* of law; they are educated, mostly entrepreneurs, and they know of the unconstitutional manner in which the

present government is wreaking its havoc. They, as a group, have maintained for over the past two decades that federal and state governments have grown too large to serve our nation, honestly and fairly. Their arguments are all properly based in *principle*, natural law, and reason.

However small in numbers, their voices and their opinions are growing stronger and more understood to the People all across the nation. Their philosophy is probably embraced by many more than their party membership – most likely by a factor of ten times the present participation. An uninitiated public easily absorbs the true solidity and reason encompassed in their philosophy and arguments. The law, or constitutionality, of the issues is sound and historically correct. True patriots, such as the Libertarians, do not exist in the halls of government where the “republicrats” have totally run amok. The Fourth Estate, totally controlled by government, will never tell you the truth about their solutions for a nation foundering into the third millennium. Tom Jefferson warned that we had nothing to fear but “ignorance” itself. Libertarians are attempting to correct that fallacy of good representative government.

Rousing pomp and ceremony was not an order of the day during the nominations for national elections; Libertarians are working quietly to correct their local and state governments – and they are succeeding where they have sufficient numbers. They seek judicial reform; the return of a Judicial Department and the fully informed juries that are the cornerstone of our “government *by* the People”. Political reforms, where the State Constitutional Laws are sacrosanct and their governments are again “government *of* the People,” are proposed. Executive rule by the wasteful federal bureaucracy would be devolved back into a smaller group of republican form of government *representatives* who would respect the rights of the People again in federal (and state) “government *for* the People”.

Libertarians are *rights abiding*, choice driven, principled and honest in their thinking. They are focused and diligent American Citizens that want a better life for their children, families and neighbors. Our great nation’s future progress will depend upon your ultimate participation – dynamic or static – in restoring constitutional government.



### **Libertarian Candidate in Parade!**

Dennis Triglia (candidate for State Assembly District 78) participated in the 26th annual San Diego Gay and Lesbian Pride Parade on July 22, 2000. He got lots of applause including someone yelling, “At last - another party! Go Libertarians.” There were over 110,000 people at the parade.

The driver is Buddy Coyle and the passenger in the front seat is Rick Charboneau. Rick was waving signs “End the Drug War” and “Enact Prop 215 NOW.” Some supporters waved “Triglia for Assembly” signs on the sidelines. The parade was followed by a two-day festival in Balboa Park in downtown San Diego. Dennis went on both days and distributed Libertarian literature.

### CA's "False Child Abuse Central Index"

**R**emember 1692, when leaders of Salem, Massachusetts drew up lists of hundreds of "suspected" witches, then hanged 19 women and "pressed" another to death after sham trials?

*The California Child Abuse Central Index now contains more than TWO MILLION names of suspects and victims*

---

Or, back in the 1950s, when U.S. Senator Joseph McCarthy accused thousands of army officials, media employees and public personalities of communism as chairman of a subcommittee on investigations? McCarthy's charges were never proven, but his "blacklisting" drove many people from public office, destroyed social standing, and ruined careers.

In 1965, the state of California resurrected public hysteria by creating a list of "suspected" child abusers, without providing any notice to suspects. The Child Abuse Central Index now contains more than TWO MILLION names of suspects and victims, and serves as the foundation of state health officials' frequent claims that child abuse has reached epidemic proportions.

The list has effectively PUNISHED hundreds of thousands of Californians by damaging their careers, reputations, finances and child custody - ALL WITHOUT CONVICTING SUSPECTS OF ANY CRIME. The "victims" who normally receive lifelong listings along with suspects, stand to be similarly punished as adults, because they are considered to be potential abusers when they grow up.

Mark Arner de France, a 42-year-old career journalist, was falsely accused of molesting his two young sons by an anonymous person in October 1997, during a post-divorce custody battle. He submitted to an investigation and was promptly told by the investigator that he had been cleared. However, he sought records of the investigation in court and six months later learned that the investigator had added his name to the state's index as a suspected child abuser. Arner filed a \$20,000 lawsuit against the county and forced officials to review the records, admit they made a mistake, and to remove him and his children from the index.

He has since volunteered hundreds of hours of his time to quantify how many other people have similarly been listed, and publicly pushed for new state laws to require others to be notified of listings in writing, and to be given hearings to challenge their listings without having to go to the expense of a lawsuit. Arner's story has been covered this year by several newspapers, two radio stations and by Fox6 television news.

Arner has worked for 20 years as a reporter or editor for five different newspapers in California, Utah and New York. He has reported 15 years for the Union-Tribune Publishing Company, and has specialized in transportation for the past eight of those

### *LPC Director works against August 11 Deadline for Operation Breakthrough*

PHONE HAS BEEN RINGING OFF THE HOOK!

The response to Operation Breakthrough has been excellent. The phone has been ringing off the hook with potential candidates who received our mailing and are interested in running for Special District seats! In fact I had to turn on voice mail because I kept getting interrupted with calls and wasn't getting any other work done!

#### Operation Breakthrough Accomplishments:

- Mailed out 9,696 Operation Breakthrough letters to registered Libertarians in 25 counties on July 14
- Received over two dozen responses in the first 24 hours
- Telephone follow-up to potential candidates began week of July 24
- One previously unknown Libertarian officeholder discovered: Bruce Gordon of the Rancho Santa Fe Community Services District (San Diego County)

#### Also:

- Juan & Alex organized the Titus Street office
- Juan appeared on two television shows since the convention and several talk radio shows, including KVTA in Ventura

#### Two Operation Breakthrough bugs to report:

- (1) In San Diego an unknown number of registered Libertarians received letters saying they were eligible to run for the San Diego "County Water District." It turns out the SD Registrar of Voters had a typo in the list of Special Districts they gave me, and that office should have read "Cambridge County Water District."
- (2) In Riverside County, letters were sent urging Libertarians to run for the Ortega Trail Parks and Recreation District — an agency that was abolished a year ago by Libertarians! (Good job, Gene Trosper and co.!)

While these sorts of hiccups are to be expected, overall the mailing seems to have gone smoothly. Filing closes on August 11. *Let's run as many Libertarian candidates as we can!*

### POLITICS AS USUAL

#### Narcs Posed as Census Workers

Two St. Paul police officers investigating an alleged drug house posed as US census workers. The US Census Bureau manager said that she was “just awed” by the officers’ duplicity and that she was checking with the regional office in Kansas City to determine whether impersonating a census worker constitutes a federal offense. Ramsey County public defenders, who informed the Census Bureau of the ruse by the officers, questioned whether it was legal or ethical. *St. Paul Star Tribune*, June 30, 2000

The Los Angeles City Council voted to give \$4 million to help cover a shortfall facing organizers of the Democratic National Convention in August. *Los Angeles Daily News*, June 24, 2000

#### Anthrax is NOT the Only Enemy

Pentagon officials acknowledged the failure of their ambitious policy to inoculate all military personnel against the deadly anthrax virus. At a hearing of the Senate Armed Services Committee, witnesses described blunder after blunder in the Pentagon’s two-and-a-half year program. The most severe was a shortage of the vaccine caused by the mismanagement and financial problems of the only company licensed to produce it – a company in which a former chairman of the Joint Chiefs of Staff controls an 11 percent stake. Of the 2 million doses given since 1990, 1,404 adverse reactions have been reported. Of those, 73 were considered fatal,

# Summary of LPC Executive Committee Meeting July 4 Meeting in Anaheim, California

The Executive Committee of the Libertarian Party of California met in Anaheim on 4 July 2000.

The minutes of the 18-19 March meeting were approved with corrections. There was discussion of the level of detail that should be included in the minutes.

The Chair reported on fund-raising and matters relating to the new office, including the hiring of the new administrative assistant and purchase of new computer hardware.

The Northern Vice Chair reported on progress in region activation, a generic campaign brochure project, and plans for the region conference in August. The Southern Vice Chair reported on campaign, membership, and publicity activities of various regions.

The Treasurer presented financial statements as of 30 June. There was discussion of the results of the recent fund-raising letter which was mailed to a selected contributor list. There was discussion of expectations for revenue and expenses for the rest of the year.

There was discussion of modifying the budget to allow printing of more issues of the newsletter; instead, the Committee decided that only the October and December issues will be printed.

The Executive Director provided a written report covering media, legislation, campaigns, the Operation Breakthrough candidate recruiting project, region development, fund-raising, and the new office.

The Membership Chair presented a report on ideas for improving membership growth, with emphasis on recovery of lapsed members. There was discussion of new procedures to encourage regions to contact lapsed members and the possibility of a contest among regions for the highest retention rate.

The Committee voted to take positions on all seven measures currently qualified for the November statewide ballot: in favor of measures dealing with the definition of fees, privatized public works contracting, drug treatment, and school vouchers; and in opposition to measures dealing with legislator retirement plans, veterans bonds, and a lower vote requirement for school bonds. A resolution in support of the school voucher measure was adopted.

The Committee heard a presentation concerning an incident in which the Chair decided to exclude someone from attending the 1998 convention. A subcommittee consisting of Ted Brown, Steve Cicero, Frank Manske, and Aaron Starr was

appointed to study the question of establishing policy in this area and report back at the next meeting.

It was decided to delegate to the Operations Committee the selection of candidates for presidential elector, with the restriction that they be either a member, contributor, or elected officeholder.

There was a discussion of Operation Breakthrough. An \$21,000 expense line and corresponding dedicated revenue line were added to the budget for this project.

There was discussion of a complaint by Edison McDaniels that he had been excluded from the presidential primary ballot.

The Committee approved a number of changes to the standing resolutions, mainly deletion of items that no longer seemed needed in light of changes in the Bylaws or membership practices.

Other items briefly discussed included: the possible split of Mono/Inyo back into separate regions, a web site set up by the Secretary, and the modified open-primary legislation that may appear on the November ballot.

The next meeting is scheduled for 16 September in the San Jose area.

This is a summary of the meeting and is not intended to be a complete record of business.


